Maybe Iraqis just don't like foreign US military occupying their country?

Letter to President Bush from Congressmen

Dear Mr. President,

We write to urge you to take immediate steps to begin the withdrawal of U.S. forces from Iraq.

Although the initial invasion of Iraq may have occurred with minimal troop deaths, the subsequent occupation of the country has been anything but successful. Already more than 1,300 American troops have lost their lives since the war began on March 19, 2003. At least 10,000 American troops have been injured as well, and it is impossible to know exactly how many thousands of innocent Iraqi civilians have been killed.

Despite the enormity of the war's casualties, the Iraqi insurgency continues to grow stronger with every passing day.

Iraq is no closer to becoming a stable democracy today than it was two years ago, as evidenced in recent weeks by the daily torrent of insurgent attacks on American forces and Iraqi civilian leaders. On January 4th, insurgents assassinated Ali Haidari, the governor of the Iraqi province that includes Baghdad. Just as devastating to the prospect of democracy, on December 30th, al-Jazeera satellite channel reported that all 700 electoral workers in Mosul quit their posts out of fear of being killed. Two weeks later, on January 10th, the entire 13-member electoral commission in the Anbar province, just west of Baghdad, resigned after being threatened by insurgents. If even Iraqi election officials fear for their lives, how can we possibly expect Iraqi citizens to feel safe going to the polls? How can we continue to put our own troops in harm's way, the continued targets for Iraq's thousands of malcontent insurgents?

It has become clear that the existence of more than 130,000 American troops stationed on Iraqi soil is infuriating to the Iraqi people—especially because Saddam Hussein did not possess weapons of mass destruction and did not have a connection to the tragic events of September 11th, 2001 or to the al Qaeda terrorist organization. Indeed, the very presence of Americans in Iraq is a rallying point for dissatisfied people in the Arab world. The events of the last two years have not only intensified the rage of the extremist Muslim terrorists, they have also ignited civil hostilities in Iraq that have made Americans and Iraqis substantially less safe. Therefore, by removing our troops from the country, we will remove the main focus of the insurgents, rage.

Again, while it may be logistically difficult to immediately remove every American soldier, we urge you to take immediate action to begin the withdrawal of U.S. forces from Iraq. This is the only way to truly support our troops. Thank you for your consideration of this request.

Anti-war advocates plan March 19 "Bring Troops Home Now" Demonstration in N.Y.C.

Anti-war advocates yesterday demanded that U.S. troops be withdrawn immediately from Iraq and announced plans for a March 19 demonstration in New York's Central Park, the second anniversary of the day the U.S. led coalition invaded Iraq.

"Mayor Bloomberg and President [George W.] Bush barred us from holding a rally in Central Park during the Republican convention. That was unnecessary, undemocratic, unconstitutional and it's not going to happen this time," said City Councilman Charles Barron (D-Brooklyn), referring to the GOP national convention last summer.

Barron was joined on the steps of City Hall by former U.S. Attorney General Ramsey Clark, the Rev. Herbert Daughtry of Brooklyn and about 40 other anti-war activists from a group called the Troops Out Now Coalition.

In the weeks and months before the convention, Central Park became a controversial touchstone after the Parks Department denied the group United for Peace and Justice a permit to use the Great Lawn for a rally expected to attract 250,000 people. The department said a crowd that large would damage the lawn.

Dustin Langley, an organizer of the recent rally, said the Troops Out Now Coalition applied last month for a permit to march in Central Park and members of the group already have met with Parks Department officials. "We are being flexible. We have asked for several different areas within the park," Langley said. "We are going in with good faith. Central Park has become symbolic of civil rights."

Kim Rosario, whose son, Pvt. Joshua Morales, 19, has been stationed since September in Ramadi, Iraq, also spoke at the rally. She said true support for the troops does not come with just putting a magnet on your car. "If you truly support our troops, you want them to come home and be safe," Rosario said. "You would speak out and write to politicians, march, you'd protest, because they don't belong there. Bring the troops home now."

Social Security: National Ponzi Scam

Wealthy Foreign Banks Get Money from Your SS!

President Bush promised to take effective measures to save the Social Security program. Total system failure has been projected for this program by several "fund" experts from the insurance industry, and other financial institutions. See the lead editorial in the Wall Street Journal of July 12, 2000 A.D., correctly identifying Social Security as a Ponzi Scheme. As such, it violates many State laws prohibiting insurance fraud (the "I" in "FICA" is Insurance).

Laws of USA require the IRS to deposit all collections daily into the Treasury of the United States (e.g. IRC section 7809). In stark contrast, IRS-written regulations require taxpayers to make all checks and money orders payable to the "Internal Revenue Service." Compare the pertinent constitutional provision: "No Money shall be drawn from the Treasury, but in Consequence of Appropriations made by Law," at Article I, Section 9, Clause 7 ("1:9:7").

The IRS was never created by any Act of Congress; this fact can be confirmed by a careful review of Title 31 of the United States Code, which has been enacted into positive law (unlike Title 26). Therefore, "IRS" is decidedly not the Treasury of the United States. See also Chrysler Corp. v. Brown, 441 U.S. 281 (1979), footnote 23.

Why is there such a glaring and important discrepancy between federal laws and the IRS regulations? Obviously it is fraud, deception, treason.

Here are some practical realistic vital recommendations for saving Social Security.

The Office of President should consider abolition of the federal income tax, and the Internal Revenue Service along with it, as the first and the most important means of preventing a Social Security disaster that is otherwise inevitable and fast-approaching.

In support of this recommendation, please read the Findings in the most recent version of the Date Certain Tax Code Replacement Act, adopted by the House of Representatives on April 13, 2000 A.D., in which the House repeatedly found that the IRC is too complex to be justly administered or enforced. For example, see IRC 7851(a)(6)(A): Title 26 of the United States Code ("this title") has never been enacted into positive law, as such; therefore, none of the statutes in subtitle F has ever taken effect (roughly sections 6000 thru 8000).

The Internal Revenue Code is demonstrably void for vagueness, for violating our fundamental Right to know the Nature and Cause of any accusation, as guaranteed by the Sixth Amendment in the Bill of Rights. That vagueness is intentional. See enclosed letter from Rep. Barbara Kennelly concerning IRC section 3121(e).

By halting the unlawful diversion of massive funds into foreign banks and elsewhere, specifically by appropriate Executive Orders compelling IRS to deposit all tax collections daily into the Treasury of the United States, the Office of the President will take necessary and long overdue control of a rogue agency, presently domiciled in Puerto Rico under color of the Federal Alcohol Administration ("FAA").

The FAA, as you may already know, was declared unconstitutional by the U.S. Supreme Court in U.S. v. Constantine, 296 U.S. 287 (1935). Pursuant to 5 U.S.C. 551(1)(C) ("does not include" U.S. Territories), IRS is not even an "agency" for purposes of the Administrative Procedures Act ("APA"), or the Freedom of Information Act ("FOIA"). It is a money laundry, extortion racket, and conspiracy to engage in a pattern of racketeering activity, violating 18 U.S.C. 1961 et seq. (RICO).

President Bush, your constitutional authority, and duty, to proceed in this fashion, with all deliberate speed, is found at Article II, Section 3 ("2:3") in the Constitution for the United States of America: "he shall take Care that the Laws be faithfully executed". "Shall" is imperative. The Constitution is the supreme Law of this land. Do it.

History of Social Security Program in USA

1940 people everywhere were poor, but old people were especially hard hit and had little chance of recouping what they had lost over the past decade. There was widespread pessimism about the future and, of course, anxiety about saving for the future. But people were out of luck.

The Social Security program was right in line with socialist belief that government was the proper agent to provide the answers and funding to any problem. The idea was to nick a little off of everybody's paycheck with a payroll tax and then give that money to the impoverished elderly. Even better, to disguise this welfare program and cheer everybody up, the tax money was to be redistributed to anybody over the retirement age, and the in-out mechanism was to be called a Trust Fund. And, there were plenty of workers to support this scheme: 41 workers for every one retiree; and the payroll tax was set at about 2%, but that changed today, it's now 12.4% tax on income.

Around 1950 Congress started increasing benefits contrary to the SS law and rules. For example, the definition of who was qualified to receive Social Security was expanded and the money value of the benefits was increased. The result was that the average benefit in 1998 had climbed to \$9,050. (Today, 45 million people are covered by Social Security and annual expenditures top \$400 billion.)

In 2004, SS is actually running a surplus because the Baby Boomers born in the mid 1940's are working like mad, and so the feds are stealing from SS a huge chunk of their earnings to pay other federal programs.

Social Security has big problems ahead. Around 2015, SS will have a cash shortfall; 10 years later SS will have to borrow from general revenues instead of being robbed by the feds, and by 2033 there's only enough money coming in to pay three-quarters of my obligations.

In a word, Social Security has been exposed as an illegal and a huge tax-funded Ponzi scheme! Government is a criminal enterprise!

Americans, especially younger ones, are expressing increased self-confidence about providing for their own future retirement. Self-reliance is in, government dependency is out. Private investment for retirement is the honest plan for retirement, and the money generated are owned by the investor, not subject to political exigencies of government "ownership."

Government-controlled Social Security retirement ponzi scam is the retirement plan of the Old Economy and it is not only too ponderous to respond to a changed world, but is a system that is oppressing young workers. Why not replace it with one that can empower current workers with freedom and liberty from government control, enrich future retirees, propel economic growth and cement the change in the political climate? It's the fair thing to do. NOW.



New Book Release:

The Dark Decade [Anti-Catholic Persecutions in Hawaii]

Author: Emmett Cahill



Freedom of religion is taken for granted in modern-day Hawaii. It's guaranteed by the 1st Amendment to the Constitution for the United States of America, and the Hawaii constitution.

The Hawaiian Kingdom, however, did not tolerate freedom of religion, especially between 1829 and 1839. This shocking reality is detailed in *The Dark Decade*, by Emmett Cahill. His graphic expose of torture and imprisonment imposed against those whose religious beliefs were contrary to the edicts of the Hawaiian Monarchy; and the episodes of discrimination experienced by Catholics in Hawaii will haunt the reader in light of the modern day push for re-establishment of the Hawaiian Kingdom.

By definition, freedom of religion did not exist and can not exist in the contexts of a Hawaiian Kingdom dictatorship.

The shocking abuses and biases against freedom of religion for Catholics are compelling historical evidence that common people suffer most when the government entity is the sovereign. Protestant missionaries and the Hawaiian Monarchy waged a ten-year campaign to exterminate the Catholic religion from Hawaii: beatings, starvation, enslavement, prison terms were commonly used against local Catholics.

Historian Emmett Cahill has compiled this bitter history of the struggle for the minds and souls of the Hawaiian people. [144 pages, by Mutual Publishing, about \$13 wherever books are sold.

Another book, *Faith in Paradise*, by Maggie Bunson [1977], documents 150 years of the Catholic Church in Hawaii. Included are details of Kaluapapa and father Dutton, Catholic schools, and the Calvinists campaign against the Catholic religion. Engaging renditions of acts of faith to help common people, and courageous individuals who withstood critics and the powers of the Hawaiian Monarchy to bring the Scared Hearts to the Hawaiian people. It's an epic story. I have no doubt that some modern-day Catholics on Molokai would have served as well then as they do now.

Thank your Filumena Killigrew for loaning me this fascinating out of print book.

Freedom is the foundation of individual sovereignty I believe God gave to us.

Anyone who agrees with that premise knows that the importance of the Establishment Clause of the First Amendment of our Constitution cannot be overstated or underestimated.

For over 200 years this simple language — Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof — has been a guiding principle of our national government and has been interpreted in numerous Supreme Court decisions to ensure the institutional separation of government and religion and the protection of religious minorities.

Our nation just experienced a national election in which religion and the personal faith of the candidates for public office became a focus point for debate and for some a qualification for holding public office.

The Department of Justice must show no preference for one religious tradition over another, and requires an Attorney General who upholds the current laws and Supreme Court precedents that guarantee religious liberty to all Americans.

Therefore, candidates for public office should be able to reply to these questions with wisdom that comports with our right to be free from government imposition of any facet of any religion.

1. How will your religious faith and values impact your role in carrying out the laws of the United States?
2. In public and private settings, will your use of religious language reflect the language of your religious tradition, or will it be more broadly inclusive?
3. What active steps will you take to show respect for the variety of religious beliefs of the people living in this country?
4. What are your views on the Constitutional guarantee of the separation of church and state?
5. How will you balance the principles of your faith and your pledge to defend the Constitution, particularly when the two come into conflict?

Additionally, given recent media attention to the plight of prisoners in Abu Ghraib, and the role that the nominee has been identified as playing in that situation, I would like to know if Judge Gonzales believes that the revealed abusive treatment of prisoners in Abu Ghraib will lead to the abusive treatment of US prisoners. Further, I would like to know how religious morals and values fit into future conversations around Abu Ghraib.

And finally, the attack on religious sect Branch Davidians at Waco, Texas, by paramilitary BATF and FBI, using military personnel and helicopters and even tanks that resulted in the torture and deaths of over 80 people mostly children and elderly people living peacefully in their church compound demonstrates that the USA has a long way to go as an example of a government that enforces the Bill of Rights, including that part about freedom of religion. And if we believe that the government is our servant, then it is up to each of us to force government to comply with the limits we placed on it, defined in our Constitution and Bill of Rights.

You can romanticize about checks and balances, due process of law, and "Lady Justice" wearing that blindfold, but it's all a load of BS. The government looks out FOR ITSELF, and no one else. If your interests HAPPEN to coincide with the interests of those in power, you're in luck. If not, too bad for you. If you think there is ANY politician or high ranking bureaucrat who would even HESITATE to destroy your life if it would maintain or increase his power, you're living in la-la land.

Fairness? Law? Justice? Are you kidding?

Look at the law: 18 USC 242 that makes it a crime for those in government to deprive anyone of his constitutional rights "under color of law." (For example, by using a bogus "search warrant" as a tool for stealing First Amendment materials.

The government gets LOTS of accusations that government employees have violated individual rights, and even AGREE that there seem to be lots of violations of 18 USC 242. Guess how many get prosecuted? Damn near NONE.

If you are offended by that, you should be. If you are surprised, you need to stop waving the damn flag long enough to look at what this country has become: a Police State! Worse yet, the feds KNOW that government agents are violating the Constitutional rights of THOUSANDS of citizens, and the feds choose to do NOTHING about it in the vast majority of cases.

Just look at Hawaii governor Linda Lingle and Richard Bissen's record of crime!

Also, police officers, prison guards and other government officials who improperly abuse the rights of individual Americans have long been recognized in federal law as a threat to society as a whole. That's why Congress approved Title 18 USC 242 -- a statute making it a crime to deprive any person of their rights 'under color of law.

But, as Justice Department records make very clear, a law on the books does not always translate into a law that is enforced. The latest available Justice Department data show that federal prosecutors declined to file charges against virtually all -- 98.7% -- of the government-employed individuals who the investigative agencies had concluded were in violation of 18 USC 242.

If this message seems a bit "harsh," good. This is what YOUR country has become. You can put your efforts into denying it, and chanting "this is a free country" until you're blue in the face, if you wish. Or you can acknowledge the bleeding obvious: the government is your enemy. It is the enemy of freedom, the enemy of individual rights, the enemy of truth, and the enemy of justice.

Do something about it, and have a Happy New Year 2005 !

STATE TAXATION is UNCONSTITUTIONAL

"The powers not delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people."

The Constitution for the United States of America clearly grants the raising of revenue to the U.S. House of Representatives and NOT in the legislatures of the states. "The Congress shall have Power To lay and collect Taxes, Duties, Imposts and Excises, to pay the Debts and provide for the common Defence and general Welfare of the United States; but all Duties, Imposts and Excises shall be uniform throughout the United States...". The addenda limiting this taxing authority expressly prohibits any direct tax unless uniform across the population. The "direct tax" is a type of excise tax on certain property permitted only in reasonable and just circumstances but not necessarily applied to real estate or land belonging to private parties for their own noncommercial usage. (This is MY OPINION based on a reasonable study of facts and law.)

Direct tax. One that is imposed directly upon property, according to its value. It is generally spoken of as a property tax or ad valorem tax. Distinguishable from an indirect tax which is levied upon some right or privilege such a a license to do business. Black's Fifth Edition.

The right of the people to be secure in their persons, houses, papers, and effects IS the right to own private property against any claim of the state or any of them. "The Congress shall have Power to dispose of and make all needed Rules and Regulations respecting the Territory or other Property belonging to the United States; and nothing in this Constitution shall be construed as to Prejudice any Claims of the United States, or of any particular State."

Real Property Taxes are un-Constitutional, illegal, and immoral!

Crimes of Politicians Must Be Stopped by The People (You are The Militia)





