Very unstable air mass moved from Lanai to Molokai this afternoon, causing loud thunderstorms with exciting lightening flashes with winds gusting up to 60 mph driving the heavy rains that left some people sleepless. No major damages.

The ocean near shore was turned dirt brown from so much runoff water, and the brown waters are considered a health risk as they contain fecal matter and bacteria and toxic chemicals. Swimmers, surfers, divers advised avoid brown water.

The unstable, wet and windy weather is here to stay.. certainly through Friday. The forecast calls for widespread showers for Kauai, Oahu and Molokai.

Some improvement is expected on Friday as the front weakens. But another cold front is right its heels, expected to arrive on Monday. That puts a big question mark on the forecast for the weekend.



Guns in Church for Security Prepared

When a man-made disaster like the Arizona massacre happens, Americans How can such tragedies be averted – or at least minimized? How can such attacks be prevented or discouraged? How can we reduce the carnage tolls when people are driven to mass murder by political oppression or psychological disorders?

There is common-sense, tried-and-true biblical and constitutional prescription is found in a one-of-a-kind book written by an extraordinary man who found himself in the unenviable position of being caught up in the largest and bloodiest terrorist attack ever perpetrated on a church.

But Van Wyk, a trained military man as well as a Christian pastor, was carrying a .38 revolver that night. And when he had the opportunity to secure his own safety in the mayhem, he began returning fire.

While he was outgunned and outmanned, the surprised terrorists fled the scene, pursued only by one armed Christian with a handgun.

While 11 churchgoers were killed in the attack and 53 others wounded, most of congregation was saved from what would have been near-certain death had one man not been prepared to defend himself and others.

There is the Christian imperative to be armed for self-defense. "The Apostle Paul wrote . Jesus said "If you don't have a sword, sell your cloak and buy one." That account also has now been translated into a video documentary.



Plastic Bags Arrested! But Paper Bags maybe Worse?

Plastic Bags Are Out On Neighbor Islands "Did you remember your reuseable bag today?" The Maui county council approved the plastic bag ban in 2008.

Mike Molina fought for the ban . "The bags that we have concern I guess are the T-shirt bags or parachute bags. They get caught up in the wind and float away," said Molina.

Molina said the ban will help clean-up the island and protect marine life, which Maui residents say they appreciate.

Maui resident Jeff Ribillia supports the plastic bag ban. "Anything to save the earth and help the plastic out of the ocean. It kills sea turtles, ocean animals," said Ribillia.

"It's for the generations, you know keep the environment clear," said resident John Comstintino.

HOWEVER:

Maui's County-wide plastic bag ban went into effect yesterday, January 11, 2011. No EIS has been required. Here's what they are hiding:

THREE ENVIRONMENTAL IMPACT REPORTS HAVE BEEN ISSUED From http://www.SaveThePlasticBag.com/>www.SaveThePlasticBag.com LOS ANGELES COUNTY: In 2009, Los Angeles County issued an Initial Study and determined that banning plastic bags may have a significant negative effect on the environment and that an Environmental Impact Report (EIR) must therefore be prepared. On October 28, 2010, the County issued its Final EIR. On November 16, 2010, the Los Angeles County Board of Supervisors adopted an ordinance banning plastic bags and imposing a 10-cent fee on paper bags.

Los Angeles County determined, based on the EIR, that even with a 10-cent paper bag fee "the cumulative indirect GHG (greenhouse gas) emissions resulting from implementation of the recommended ordinances will have the potential to result in significant unavoidable impacts." The County further "determined that the incorporation of mitigation measures [such as promoting the use of reusable bags] is not expected to reduce the potential indirect impact of the recommended ordinances to GHG emissions below the level of significance." THIS IS EXACT-LY WHAT WE HAVE BEEN SAYING ALL ALONG!!!

On December 14, 2010, the San Jose City Council adopted an ordinance banning plastic carryout bags and imposing a fee on paper bags. The initial paper bag fee is 10 cents. The paper bag fee automatically increases to 25 cents in 2014. The City determined in the EIR that a 25 cent paper bag fee is necessary to prevent the ordinance from having a net negative environmental impact, because paper bags are worse for the environment than plastic bags. Simply switching from plastic to paper bags is environmentally harmful. AGAIN, THIS IS EXACTLY WHAT WE HAVE BEEN SAYING ALL ALONG!!!

CITY OF SANTA MONICA: Santa Monica issued an Initial Study and determined that banning plastic bags may have a significant effect on the environment. In June 2010, Santa Monica issued its draft EIR.

CITY OF PALO ALTO: Palo Alto has agreed to prepare an EIR before banning plastic bags at any more stores. (Its present ban affects only four stores.

U.S. Constitution, Article II, Section 1, Clause 5 . . .


No person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President; neither shall any person be eligible to that Office who shall not have attained to the Age of thirty five Years, and been fourteen Years a Resident within the United States.

DEFINITION


The natives, or natural-born citizens, are those born in the country, of parents [both] who are citizens.
