Between the US military invasion and the ensuing civil war, at least 53,000 Iraqi civilians and over 3,000 American soldiers have been killed. Nearly 23,000 US soldiers have been wounded, and several hundred thousand Iraqi's badly injured. And the land scape is contaminated with deadly radioactive depleted uranium dust from DU ammunitions used by USA.

#### Watada Court Martial: UPDATED

Nearly two weeks after hearing arguments in the January 4 pretrial phase of Lt. Ehren Watadas court martial for refusing to deploy to Iraq, and explaining his refusal to the press, military circuit judge Lt.

Col. John M. Head issued brief, tersely worded rulings January 16, 2007. In summation, The defense motion for a hearing on the Nuremburg defense is DENIED. The government motion to prevent the defense from presenting evidence on the legality of the war is GRANTED. The defense motion to dismiss the four political speech charges was also DENIED.

Lt. Watadas civilian attorney Eric Seitz of Honolulu declared, "These rulings exemplify the fact that this is a military disciplinary proceeding, and apparently not an actual trial in which concepts of justice apply. Now let someone ask me if I think Ehren can get a fair trial in a military court. In summation, These rulings are about as horrible and inept as I could have imagined," added Seitz.

Citing the military courts 1967 conviction of Lt. Henry Howe for attending an antiwar protest with a picket sign that read, "Let's have more than a choice between petty ignorant fascists in 1969," military Judge Head dismissed out of hand any inherent protections of political speech for members of the military.

If the [political speech] charges leveled in this case are allowed to proceed, it would mean that service members are completely barred from voicing their honest opinions on political subjects of significant public concern. Silencing speech like Lt Watada's violates the Constitution while it also harms the military and the public at large.


Lead prosecutor Capt. Kuecker says there are two separate prosecutions going on. The first is for Lt. Watada missing movement to Iraqa where his MOTIVE is so irrelevant that it needs to be barred from the military jury. The second prosecution will be for Lt. Watada publicly explaining his MOTIVE! [This passes for military justice?]

Lt. Watada is scheduled to go on trial at Fort Lewis, Washington on February 5. He will face two years imprisonment for missing movement, and four additional years imprisonment for his public statements critical of the Iraq War.

Supporters of Lt. Watada are asked to write Lt. General James Dubik, Commanding General Fort Lewis, 1 Corps Building 2025 Stop 1, Fort Lewis WA 98433. Please request that General Dubik Dismiss all charges, and grant Watada's resignation.

How different American History would have been, had Abraham Lincoln read the entire US Supreme Court decision in Dred Scott v. Sandford:

I realize that Lincoln was not an elected official when that decision was issued by the U.S. Supreme Court; but, history tells us that he was an up-and-coming lawyer who should have known the Law in America. The Law to which I refer is Article I in the U.S. Constitution:

And, notwithstanding Chief Justice Taney's political bent circa 1856, he was entirely correct when he argued that the U.S. Supreme Court had, and still has, NO authority to make law or

to amend the U.S. Constitution: If any of its provisions are deemed unjust, there is a mode prescribed in the instrument itself by which it may be amended; but while it remains unaltered, it must be construed now as it was understood at the time of its adoption.

In other words, the writing was definitely on the wall for slavery in that year, and Taney's long and detailed opinion made it rather obvious that apartheid was the "law of the land" at that time, because it was recognized by the organic U.S. Constitution: "three fifths of all other Persons."

Now, if Lincoln had taken Taney's advice, the future President should have taken steps to draft and promote the proper constitutional amendment, one which we now have no difficulty drafting for him: "The status of Citizen of one of the United States of America shall not be denied or abridged by the United States, or by any State of the Union, on account of race."

Such a simple solution to the crisis created by Black slavery in America would have conferred upon all Blacks the fundamental Right to become, and remain, State Citizens. Instead, however, Congress commenced to make a legal mess of the situation then, by offering Blacks a choice: either become subjects of D.C., or go back to Africa. The 1866 Civil Rights Act did NOT extend a fundamental Right to Blacks, which would have occurred had the U.S. Constitution been properly amended as proposed: see http://www.supremelaw.org/ref/1866cra/

A "civil right" is one that is created by Congress and, as such, "civil rights" fall into the same class of legislation as Acts of Congress creating federal <u>corporations</u>: those "civil rights" are "privileges and immunities" NOT the inalienable God given "Privileges and Immunities" first protected by our Constitution for the United States of America! Surely, you now argue: the lawyers would NOT be so crafty as to create deliberate confusion by making hair-line distinctions between "Privileges" and "privileges". Ha! Read on!! In stark comparison, "fundamental Rights" are those which issue from the fundamental Law, and a Right in that class cannot be touched by Congress under any circumstances:






