911 Lawsuit Against Bush et al Dismissed

Judge says Citizens do not have the right to hold a sitting President accountable!!! The federal class action lawsuit against top Bush Administration officials for, among other things, their roles in engineering and orchestrating the 911 attacks has been dismissed by federal Judge Illston. Anti-Inauguration Jan 20 Protestsby ANSWER

About 250,000 people are expected to attend the first inauguration ceremony since the Sept. 11, 2001, terrorist attacks, according to the Secret Service, which is in charge of security for the event. An additional 500,000 are expected to line the parade route along Pennsylvania Avenue as about 2,500 uniformed police on security and medical duty, an additional 4,700 military troops provide security from terrorists.

A pro-Bush group, freerepublic.com, yesterday criticized a Secret Service edict that prevented members from waving miniature American flags during the inaugural parade.

War-protest groups complain that the security rules violate Freedom of Speech are preventing them from mounting effective demonstrations. Secret Service decided that protestors using wooden supports to hold signs and banners could be used as weapons. [Obviously police want The People to be completely disarmed and vunerable to police violence and other terrorists.]

'They're saying sign posts is a security issue; we think it's a political issue," said Bill Hackwell of the pro-peace group ANSWER.

ANSWER also plans to challenge the Park Service's process for issuing permits.

"Over 95 percent of Pennsylvania Avenue will be people who had to buy tickets," Hackwell said. "They've made it a pay-per-view event." People answering phones at Ticketmaster yesterday said callers needed an invitation and identification number to buy a ticket.

Although Presidential Inaugural Committee officials have repeatedly said that the tickets along the Pennsylvania Avenue route are available to the public, the suit alleges that individual members of the public are blocked from buying them unless they are Bush donors or supporters who have received an invitation and special identification number from the committee.

The lawsuit, filed by the ANSWER Coalition, seeks to stop the National Park Service from cordoning off large sections of Pennsylvania Avenue for Thursday's inauguration. A federal judge is expected to hold a hearing on the case early next week.

"Pennsylvania Avenue is considered American's Main Street," said Mara Verheyden-Hilliard, an attorney with the Partnership for Civil Justice, which helped file the suit. "For the government to come in and take this space, to say you may only have access to this event if your viewpoint is approved by the incoming administration, is a fundamental violation of all of our First Amendment rights."

Most of downtown Washington will be impassable during the ceremony, parade, and inaugural balls. The city's subway system will skip two downtown stations, and the region's airspace will be more restricted than usual on the day of the event. Blackhawk helicopters and fighters will patrol the skies, and the Coast Guard plans to step up security on the Potomac River. Washington police have told residents of some streets close to the parade route or inaugural balls that they may need to show photo identification to get to their homes during the festivities.

The federal income tax is imposed on the "taxable income" of individuals, NOT all income. The very first question that everyone must answer BEFORE diving into the rest of the income tax statutes and regulations is whether THEIR income becomes "taxable income" within the legal meaning of the federal income tax law [most cases it does not].

The reason is simple. If the reader does NOT have "taxable income," no federal income taxes are owed. If the reader DOES have "taxable income," then they may owe federal income taxes (after allowable deductions).

IRS law clearly states the following:

1. NOT ALL income is taxable.

2. The tax code exempts some income from taxation.

3. The Constitution excludes other income from taxation.

4. CPAs and lawyers don't know about the Constitutional exemptions.

5. We need to know WHICH income is exempt in order to determine what we owe. For anyone to accurately determine his "taxable" income, he must FIRST determine what is excluded by statute and what is excluded by the Constitution. Most CPAs and Tax Experts do not know about the limits on taxation imposed by our Constitution: (see Article 71, 26 CFR § 39.22(b)-1 which says that income which American citizens and residents receive from FOREIGN commerce counts as "gross income." Specific mention is also made of the domestic income of nonresident aliens and foreign corporations, and of people and companies getting most of their income from federal possessions (such as Puerto Rico). There is NO MENTION of Americans who receive income from working just in the 50 states. There it is again: NOT all income is taxable. Naturally, before you file that return, you NEED TO KNOW whether some (or all) of your income is exempt from the tax, or you will FAIL TO PROPERLY COMPLY WITH THE LAW. The current regulations say that the common "items" of income sometimes include

Remember, if all you have is a million dollars of EXEMPT income, you owe NOTHING in federal income taxes. So, we need to know what income is taxable and what income is exempt, and THE LAW ITSELF must (and does) tell us. We are not required to pay what "everyone knows" that we owe, or even what the CPAs or lawyers say we owe; we are required to pay WHAT THE LAW SAYS we owe; nothing more, nothing less.

This series introduces you to the sections of the law that have always existed to answer that question, including Subchapter N, Section 861, which until recently has been nearly universally overlooked or misunderstood. What it shows is that income is taxable ONLY if it is derived from international commerce (including the domestic income of foreigners). Most Americans are engaged only in domestic commerce.

IS YOUR income listed as TAXABLE? The list specifically mentions:

1. Americans with foreign income.

2. Foreigners with income from the U.S.

3. Rules about federal possessions (and foreign sales corporations).

There must be specific words of the law that CREATE tax obligations and if those words ARE NOT in the law, then the obligation to pay income taxes does NOT exist. If the law does not say it, the law does not mean it. Past and present, the regulations "expressly describe" certain international income as being subject to the tax, but the domestic income of the average American (most incomes) is not mentioned on the list. According to the decades of written law only income from certain types of INTERNA TIONAL trade is subject to the U.S. federal income tax. The domestic income of the "average" American (most incomes) is NOT. NOTHING is subject to a tax unless it is specifically pointed out in the IRS law. If your income is not listed as taxable, then it is NOT taxable. PERIOD.

The law does NOT lie and the evidence in over 80 years of the law will NOT go away, proving that government lawyers primarily in the Treasury Department have knowingly misrepresented the law to most Americans, leading them to believe that the income tax is a direct tax on their incomes and that all incomes are taxed (when this is not true) in order to STEAL money not owed according to IRS law.

If you do not make the TRUTH your own, then government agents will make the truth for you. Read the law yourself [see 26CFR § 1.863-1 c]: "The taxpayer's taxable income from sources WITHIN OR WITHOUT the United States WILL BE DETER-MINED under the rules of Secs. 1.861-8 through 1.861-14T for determining taxable income from sources within the United States." 26 CFR § 1.861-8 shows that the taxable "sources of income" from within the United States apply only to those engaged in international or foreign commerce (including commerce within federal possessions).

If you approach IRS tax season by assuming that your income is NOT taxable unless the IRS law specifically says it is taxable (which is what the Supreme Court SAYS is the way you should do it), you will conclude from the evidence in the law that you DON'T owe the IRS income tax. http://www.861.info/pgs/861course.php



D&J Ocean Farms is located on the east side of Molokai according to their documents. D&J has been in business for 15 years. This company is owned and operated by Mr. Joseph Manaba and Desmond (Christy) Manaba who are now in violation of several county permit requirements. People of Molokai how can a business of 15 years and of this size have no GRADING AND EXCAVATING PERMITS, this includes all 16 earthen ponds located on this property. D&J is also responsible for a trench dug to divert a natural flow of water in order to stop flooding. This trench dug by D&J now diverts flood waters onto property leased by Oceanic Institute, what a good neigh-



bor. D&J has also constructed 3 building structures ALL WITHOUT BUILDING PERMITS. D&J has also used ASPHALT



to construct or improve a road leading out to Kalaeloa Island, all this passing thru wet lands. Also located on this island is a complete bathroom, running water and flushing toilet. Where is all the gray waste water going? This island sits at or just above sea level all done without proper permits. 




