24th Annual Ka Moloka'i Makahiki Held

After weeks of blustery kona winds, Saturday, January 22 dawned with clear skies and crisp, dry, northerly winds for this year's 24th Ka Moloka'i Makahiki. The annual celebration of agriculture and time of peace drew the largest participation of Neighbor Island schools and began with the rich traditions of ancient Hawai'i. Molokai's public schools and the newest private school, Akaula, packed the participants' bleachers.

Each participating school entered with 'oli, their kupuna and presented ho'okupu representative of their district. Moloka'i kupuna included Kauila Reyes (Kaunakakai), Mollie Tengan (Kualapuu), Alexander Bishaw (Maunaloa), Didi Kaakimaka (Mana'e), Edna Cathcart (Kamehameha Schools' Kapalama campus), Hattie Silva and Kanani Negrillo (Na Pua Noeau Hawai'i Island). Molokai High School, Kua o Ka La, a Puna charter School, Baldwin High School from Maui, and Na Pua No'EAU represented middle school and high school age participants. After the impressive ceremonies hula and pule,

Kindergarten through high school students participated in the traditional Hawaiian skills of Ulumaika, Hakamoa, Uma, Hukihuki, Kukini, Konane through out the morning with a ho'olaule'across at the Mitchell Pauole Cente. Ka Moloka'i Makahiki is a culmination of months of practice and selection of school representatives for each activity in each grade level.

Everyone, including long-time volunteers, teachers and students look forward to a special 25th year celebration next year and hope for the same good weather and the promise of more bleachers for all the participating schools!

Anti-war "Bring Troops Home Now" Demonstration at Bush Inauguration

Despite attempts by the Bush Administration to stage manage the inauguration parade to present the facade of a united front supporting the Bush agenda by prohibiting protesters from being present, over 10,000 protesters from around the country converged on John Marshall Park in Washington DC Jan 21, bringing a powerful antiwar message to the presidential inauguration parade. Demonstrators filled the sidewalks at the start of the parade route.

The first thing that Bush saw as his motorcade began the parade route was antiwar protesters lined 10 deep along the side walks and barricaded behind fences and police.

Atop the bleachers was a giant banner that said, "Iraq is Bush's Vietnam, Bring the Troops Home Now." Protesters unfurled a large banners reading, "From D.C. to Iraq, with occupation comes resistance." Anti-war demonstrators demanded that U.S. troops be withdrawn immediately from Iraq and Afghanistan, and 35 other countries.



After Police sprayed tear gas to disperse demonstrators, several dozen protesters surged toward the security fence, lobbing bottles, trash and snowballs at police, overturned several of the metal security barricades, and some protesters broke through the security fence as Bush drove by. About 80 people were arrested as police attacked them with pepper spray, tasers, and clubs. This was all censored from TV news.

President Bush's motorcade sped up as it passed the commotion, and during his Inaugural speech Bush did not mention Iraq or Afghanistan once, even though 100,000 Iraqi people and nearly 1400 U.S. troops have died because of his colonial war.

[Bush's Inaugural address makes it clear, now more than ever, that Americans have to be a unified mass movement to restore our Constitutional limits on government. The Motto for the American Revolution is: "Resistance to tyrants is obedience to God." Individual sovereign Americans, who today enjoy the fruits of liberty, note that all of America's Founding Fathers were called radicals and traitors by the Tyrant King of England; and, that all obedience is voluntary and conditional, the final authority being God and his perfect and just laws. -MAN]

Poll by Los Angeles Times shows Increase in Opposition to Bush's War on Iraq/Afghanistan

The poll, conducted January 15-17, found that the percentage of Americans who believe the situation in Iraq was "worth going to war over" has sunk to a new low of 39%. The Times also reported that 37% of the public advocates withdrawing at least some troops now, a position The MAN editorial pages has endorsed. 47% said they would like to see most of the troops out within a year. Fifty-two percent want to wait and see what happens after the Iraqi elections. Just 4% would like to send more troops, a position supported by fascist newspapers.

45%, say they believed the war has destabilized the Middle East. A large majority, 65%, said the war in Iraq had harmed the United States' image around the world.

Mainland Kidnapping/Murder suspect Shot by Robbery Victim

Tyler Police Chief Gary Swindle -"Swindle said preliminary reports suggested Williams was shot in the shoulder as he tried to carry out a robbery at a mobile home park in Bowie, Arizona."

Sure enough, retired New York City firefighter Richie Chapman said to police after he shot the would be robber: "He said, 'This is robbery, I want all the money in the cash register.'" And as he said that, he drew a weapon from underneath his shirt, and I drew and fired at him, hitting him in the shoulder, and he ran off.

Police learned the robber had kidnapped the female driver of the van he was driving when he committed the robbery. The female driver was murdered hours before.

Notice that the first time the armed robber ran into an armed victim he got shot, and wounded bad enough to have to go to a hospital where the cops were able to pick him up with no problems at all. If there is a hero anywhere in this story, it is the armed victim who wounded the robber, not the police who "made the collar" at the hospital.

What do you bet that the armed citizen gets no credit at all ?

Filmmaker Michael Moore's bodyguard was arrested for carrying an unlicensed weapon in New York's JFK airport

Police took Patrick Burke, who says Moore employs him, into custody after he declared he was carrying a firearm at a ticket counter. Burke is licensed to carry a firearm in Florida and California, but not in New York. Burke was taken to Queens central booking and could potentially be charged with a felony for the incident.

Moore's 2003 Oscar-winning film "Bowling for Columbine" criticizes what Moore calls America's "culture of fear" and its obsession with guns.

"BODYGUARD BUST" proves Moore is not honest about gun laws; and, that the gun laws of each State conflict with other States so no one knows the laws and can get caught violating a gun law when you believed you were following the law. The only gun law needed in America is the 2nd Amendment: ".....the right of the People to keep and bear arms, shall not be infringed." The Second Amendment is designed to prohibit government to pass any laws infringing on arms possession and bearing.

The arrest of a man identified by Fox News as a bodyguard for anti-gun film director Michael Moore by New York Port Authority Police Wednesday evening proves that Moore is an elitist who thinks it is fine for him to have armed security, while he has endeavored to disarm other law-abiding Americans, the Second Amendment Foundation (SAF) said today.

Adding to the irony, said SAF Founder Alan M. Gottlieb, is the fact that bodyguard Patrick Burke was arrested for violating the kind of Draconian gun law that Moore and his extremist gun control contemporaries support. Burke was reportedly arrested at JFK International Airport when he declared his firearm at the ticket counter, as required by law when traveling.

New York authorities habitually arrest private citizens at airports around the state when they declare firearms as required by law, and do not have a New York firearms license. It is a technicality that has tripped up many travelers who may simply be going through the state on their way to or from other destinations.

"Michael Moore is a world-class hypocrite for campaigning against the gun rights of law-abiding citizens, while having an armed bodyguard," Gottlieb observed. "Unfortunately for Mr. Burke, who is reportedly licensed to carry a firearm in Florida and California, he has been tripped up by the same anti-gun mentality espoused by his elitist employer. Sadly, if criminal charges are pursued, it will be Mr. Burke, not his boss, who takes the fall, possibly losing his gun rights in the process, because possession of an unlicensed gun in New York is a felony.

"Like so many other arrogant Hollywood anti-gunners, Michael Moore obviously considers his life more important than the lives of all the people he would disarm," Gottlieb stated.

"Naturally," Gottlieb concluded, "we would be delighted to recommend a suitable lawyer from the SAF attorney referral list to represent Mr. Burke. And we're certain Malevolent Michael will happily pick up the tab."
