Obama's Aunt Is Illegal Alien

Zeituni Onyango, Obama's aunt on his Kenyan father's side, fights deportation to Kenya. She is pleading for political asylum, and Barack Obama is assisting her from the White House in her fight to stay in USA.

\$10,000 REWARD for Seal Killers

An anonymous donor has pledged \$10,000 to the Surfrider Foundation in an effort to help indict the killers of Hawaiian monk seals found dead last year on Kauai and Molokai.

A **\$5,000 reward** will go to anyone who provides information which leading to the arrest and conviction of the person involved in slaying the male monk seal discovered floating off east Molokai's Kahinapohaku fishpond on Dec. 14. Some \$7,000 will now be offered to those with information regarding the male seal discovered dead April 19 at Kaumakani, in addition to the \$5,000 reward put up last month by the National Oceanic and Atmospheric Administration.


"There are people out there who are still really mad that somebody's doing this and they're willing to give big money to resolve this," Kauai Surfrider's Carl Berg said yesterday. "We really want to find out what's going on and we really want people to understand these are nature's creatures."


Only about 1,100 monk seals remain throughout the Hawaiian archipelago, with about 115 traversing the main islands, NOAA Marine Mammal Response Coordinator David Schofield said yesterday.

Kumu Sabra Kauka, a Kauai native practitioner, reflected "The seals have been in the ocean longer than we've been walking on the earth," she said. "This is something that we as humans need to acknowledge — the fact that we're not the only species on the earth."

"Malama the monk seal," Schofield said. "Recognize they are the kama'aina of the sea."

Legislators for 2010 are proposing new laws to raise the penalty for intentionally harming or killing Hawaiian monk seals from a misdemeanor to a felony. Gary Hooser's bill SB2441 is in the Committee on Water Land, Agriculture, and Hawaiian Affairs. If passed, those convicted would face up to \$100,000 fines and 40 years in prison. Another bill, HB 2767 by Rep. Chris Lee says about the same thing as Hooser's legislation. Lee said he hopes either bill passes and will result in the abatement of the decline in monk keal populations in Hawaii.

Hawai#i Electronic Filing and Service Rules

The Supreme Court of Hawaii seeks public comment regarding proposals of the Hawaii Court Records Rules and Hawaii Electronic Filing and Service Rules.

The Judiciary is planning to implement electronic filing for all cases in the appellate courts and for criminal cases in the trial courts in the year 2010. Civil electronic filing should launch before or during 2012.

The Hawaii Court Records Rules would govern access to court records in both hard copy and electronic form. Hawaii Electronic Filing and Service Rules sets forth procedures by which court documents should be electronically submitted.

Comments about the proposed rules should be submitted, in writing, no later than March 8, 2010, to the Judiciary Public Affairs Office by mail to 417 South King Street, Honolulu, HI 96813, by facsimile to 539-4801, or via the online form on the Judiciary's website at www.courts.state.hi.us.

The cost of justice for Citizens will drop, and your right to control your tribunal and state the law will be facilitated by electronic filing. And, 3.2 Official Court Record. The record of each court case maintained in JIMS is the official court record. Documents electronically filed or recorded in JIMS are deemed original documents for all purposes under any of the Hawai#i Rules of Court. Printed or electronic copies of documents maintained in JIMS may be certified as true and correct copies of the documents in the official record of the case.

At the present time, only attorneys have access to convenient electronic filing, and that is blatant discrimination and obstruction of justice.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

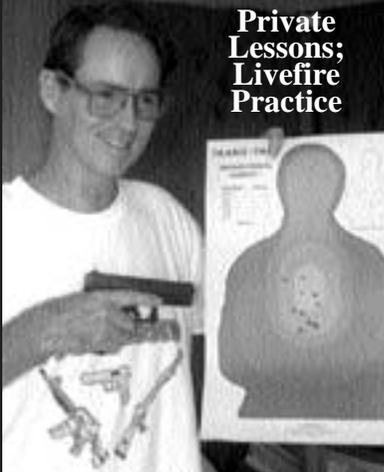

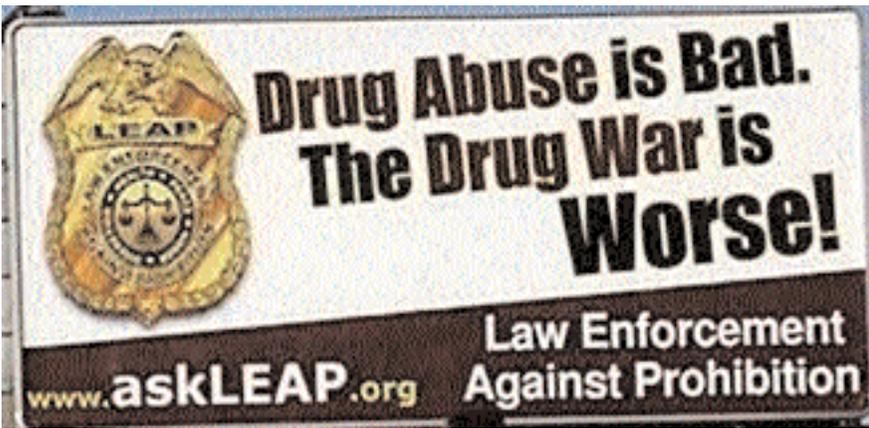

FORGED DRAFT CARD by OBAMA
