Molokai's Cultural Traditions Perpetuated New Year 2011





The Kadomatsu is a new year decoration tradition consisting of bamboo, pine and cherry blossom-- symbols of longevity, health and prosperity, that is in the center of this New Years 2011 greeting to Molokai from Molokai Advertiser-News editor George Peabody and his wife Susan, and their two dogs "HapaGirl" and "Tiger r r". Usually in pairs placed at the entrance to a home, often now, kadomatsu a table decoration for the new year. Sometimes branches of bamboo, and pine are simply tied to the entrance of a home for the eve and New Year's Day. Since we don't have cherry blossoms at this time of the year like they do in Japan, this local style "Molokai kadomatsu" constructed by George and Susan Peabody of Waialua has pink anthurium instead of cherry blossom.

Their authorization comes from the White House, which issued an Executive Order creating the right of Cabinet officials to issue their own "Executive Orders," which are used as end-runs around Congress---and the Constitution. Congress---and the American people---must call these bureaucrats "on the carpet" for that. An unConstitutional "order" cannot create a Constitutional edict

Laws can't be created by the White House, since the Oval Office lacks the power to enact laws. Barack Hussein Obama's plan to rule by Executive Order will grow like a cancer if it is not stopped. Its the most diabolical plan that Barack Obama has devised to date, and it amounts to TREASON.

Hawaii State Taxpayers Lost BILLIONS, Lingle et al Violated State Laws

HONOLULU -- The state has more than \$1.1 billion in "investments" that have been frozen and state taxpayers won't get that money back for at least five years minimum, maybe never the way the Obama-economy is going.

A state audit found the risky securities purchases by the state budget department violated state law and policies, which require the safety and immediate availability – also known as liquidity -- of state investments to be considered over high yields.

That's enough money to erase the state's \$850 million budget shortfall with some money leftover. So, why did Lingle et al say the State has no money and must cut back on everything and have furlough days no pay? Why is that Tax money being used to run limited government? If the State has no money, why is Kip Dunbar getting millions of dollars from Taxpayers for his "conservation scams" [\$2.3 million, and now going for another \$4+million from DLNR]

Lingle et al invested Taxpayer money in very risky securities that crashed when the financial marketeers scams began to fall apart. But of course Lingle's friends in the financial markets at Citigroup Global Market got paid their huge commissions for "handling" the money that belongs to Hawaii Taxpayers, even though we lost BIG TIME.

Why isn't Lingle et al being prosecuted for violations of State law?

In late November, Lingle's state Attorney General Mark Bennett reached a tentative settlement with Citigroup Global Markets, which handled the purchase. "This settlement agreement on a cash-value basis, means that the full amount that was invested will be returned in 2015," said Interim Budget Director Kalbert Young.

Considering that the state faces a projected \$850 million shortfall over the next two and a half years, Young said, "Any revenue or added funds would have definitely helped."

State Sen. Donna Mercado Kim commented: "We'd like to see their policy in writing. The prior administration [Lingle] said they would submit one, they did not submit one. They said they had one, but it was done verbally. So, again, you cannot rely on that," Kim said.

Hawaii Kai State Sen. Sam Slom, responded by saying, "We know that the policies were not followed. And we know that that's our responsibility to make sure that they are followed."

EDITORIAL: the State has so much money being scamed, it is time Taxpayers stop paying taxes, and limit funding for state government to funds that result only from that lost \$1.1 billion dollars; and, cough up all the hidden special funds of more billions that belong to Hawaii Taxpayers; and prosecute Lingle et al and send them to prison by law.

I believe that theHawaii government is authorized to exercise only those powers that we the people delegated to it in the state constitution – no more.

Why do Hawaii Taxpayers pay for Obama's vacation? At least one report tallies the Obama's vacation at almost \$1.5 million dollars with taxpayers footing much of the bill. The U.S. government accountability office, which keeps track of public funds and government spending, estimates the cost of a roundtrip flight from Andrews Air Force Base, just outside Washington D.C., to Hawaii alone is about a million dollars.... tack on costs for Secret Service, Honolulu police and emergency personnel, plus White House staff ...but, White House and secret service won't disclose exact numbers or costs to taxpayers.

But yet...year in and year out, government continues to grow and your liberty continues to diminish as taxes continue to rise against us. And, it doesn't matter who is the governor, or what political party controls Legislature – the growth of power in the government never stops.

Power – the problem we face today is about power – and until we address the absolute fact that theHawaii State government agents have too much power, and going to them to fix problems caused by abuse and usurpation of power – things will never change.

Hawaiian Guns/Products NOT Federal

Firearms needed against Congresscrittes to clean up gun laws , so see this proposed Act to save guns and every product made in Hawaii from federal claws.

The U.S. Declaration of Independence states “... That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed.”

Firearms Freedom Act (FFA). The bill states that:

A personal firearm, a firearm accessory, or ammunition that is manufactured commercially or privately in Hawaii and that remains within the borders of Hawaii is not subject to federal law or federal regulation, including registration, under the authority of Congress to regulate interstate commerce.

Eight states have already passed similar legislation as law – Montana, Tennessee, Utah, Wyoming, South Dakota, Idaho, Alaska and Arizona.

The Constitution for the United States of America gives Congress the authority to regulate Interstate Commerce between the states, and 18 USC 922 makes it unlawful for any person not licensed as a manufacturer or dealer in firearms to engage in the business of manufacturing or dealing in firearms. Collectively, the Interstate Commerce Clause and 18 USC 922 are used by the federal government as a means to regulate, control and often-times ban, firearms.

The Hawaii Firearms Freedom Act addresses this by exempting firearms, firearm accessories, and ammunition manufactured and retained in the state from all federal firearm control laws including registration, as firearms that meet these criteria cannot be regulated by the federal government because they have not traveled in interstate commerce.

Basically, we're saying if the gun is made here, Hawaii is going to say what kind of regulations apply. Hawaiians, not Obama's federal ATF, should be able to determine how to protect themselves , which is why most people have firearms.

Infact, Hawaii could pass a broad IntraState Commerce Act that exempts all products produced in Hawaii and consumed in Hawaii, from federal interstate commerce oversight and controls.

Such proposal provides that all goods grown, manufactured or made in Hawaii and all services performed in Hawaii, when such goods or services are sold, maintained, or retained in Hawaii, shall not be subject to the authority of the Congress of the United States under its constitutional power to regulate commerce. Be it enacted by the General Assembly of (STATE):

SECTION 1.

This Act shall be known and may be cited as the “Intrastate Commerce Act.”

(A) The Tenth Amendment to the Constitution of the United States codifies in law that the only powers which the Federal Government may exercise are those that have been delegated to it in the Constitution of the United States;

(B) The Ninth Amendment to the Constitution of the United States guarantees to the people rights not enumerated in the Constitution and reserves to the people of (STATE) those rights;.....Ok, got the idea? TAKE ACTION !

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!




DEFINITION
