Molokai Clubhouse SAVED from Lingle

Editor's summary of report by Larry Geller

The Grinch Governor Linda Lingle nearly wiped out the Molokai Clubhouse Mental Health facility, just renovated with the help of \$100,000 donated by the Honolulu Metro Rotary Club, by firing the last remaining employee effective December 31. Then the public swung into action, saving his job at the 59th minute of the 11th hour. More than 30 people are served by this clubhouse, the only program of its kind on Molokai.

There are serious, valid and substantiated concerns related to the ethical behavior of our appointed officials. Enough is enough!

This includes Judges, Officers of the Court, Custody Evaluators, Guardian ad Litem, Commission on Judicial Conduct, Office of Disciplinary Counsel, and even the Attorney General. Cronyism abounds and there is no true accountability in a system that is exempt from Sunshine, Oversight, or Prosecution. It appears we are now at a tipping point.

The public's faith, trust, and confidence are broken, along with laws unapologetically broken daily under color of law and public corruption. Trusting in promises of transparency is no longer enough, we must act as one to effect true change.

The Kaho'olawe Island Reserve (defined as the submerged lands and waters within two nautical miles of the island) is divided into two zones; Zones A and B. These zones are defined as:

Zone A: Includes the island of Kaho'olawe and all the submerged lands and waters between the shoreline of Kaho'olawe and the 30-fathom (180 ft.) depth which surrounds Kaho'olawe (HAR 13-261). Unauthorized entry into Zone A is prohibited at all times except in case of emergency.

Zone B: All waters and submerged lands between the 30-fathom (180 ft.) depth surrounding Kaho'olawe and two nautical miles from the shoreline of the island. Unauthorized entry into Zone B is prohibited at all times except for trolling as authorized by KIRC on the days stipulated by the Permitted Trolling Schedule as listed above or in case of emergency. Trollers must remain underway, making way at all times while in Zone B. ALL OTHER FISHING, OCEAN RECREATION, AND ANY OTHER ACTIVITIES ARE STRICTLY PROHIBITED.

Study links Monsanto GM corn to organ failure in rats

Most genetically modified seed corn is produced in Hawaii, look at Molokai, where a large majority of all the corn grown is raised expressly for the production of genetically modified seeds.

Hawaii-grown corn, big business or not, may be bad business for our state's health and our economy. A recent study is getting to the point GMO opponents have long advocated—the study claims that the stuff is bad for humans and other mammals, and environment.

A new study claims to have uncovered new health effects caused by genetically modified corn from the agricultural giant Monsanto. The International Journal of Biological Sciences says GM corn helped cause organ damage in rats. The study's author called Monsanto's GM methods "a very serious mistake, dramatic for public health." Overwhelmed by Air Force Drones

The New York Times reports the military is being overwhelmed by the amount of video captured by drones. Air Force drones collected nearly three times as much video over Afghanistan and Iraq last year as they did in 2007. It would take twenty-four years to watch what was recorded last year by the drones. And that volume is expected to multiply in the coming years as drones are added to the fleet and as some start using multiple cameras to shoot in many directions.

US Military Stockpiles in Israel?

The publication Defense News reports the US Army will double the value of military equipment it stockpiles in Israel, the Jewish Terrorist Nation ally, and that **Israel will be allowed to use the US ordnance! The \$800 million stockpile will include missiles, armored vehicles, aerial ammunition and artillery ordnance, even though** War crimes committed against USA, as well as against Palestinians are documented and widely known, but go unpunished. Three Palestinians died Sunday from an Israeli tank attack in Gaza.

Meanwhile, Israel has announced plans to construct two walls along its southern border with Egypt in an attempt to prevent African refugees and asylum seekers from entering Israel. The two walls will cover a total of seventy miles.

Trying to force Israel to make peace by way of a Loan Guarantee Threat to Israel, US envoy George Mitchell said Washington could penalize Israel financially to force it into making concessions to the Palestinians. Mitchell's comments were widely criticized in Israel as well as by some of Israel's staunchest supporters and the huge Jewish lobby on Capitol Hill, including Zionist Senator Joseph Lieberman. "Any attempt to pressure Israel, to force Israel to the negotiating table by denying Israel support, will not pass the Congress of the United States. In fact, Congress will act to stop any attempt to do that. I don't think we're going to come to that point, because I think the President and his administration understand that."

Obviously, the Jewish lobby forces in the White House with Obama have way way too much power and influence, apparently controlling Obama.

Reading this article prompts me to leak my President's Letter from the soon-to-appear Kokua Council January Newsletter.

As the curtain rises on a new year and a new decade, America faces challenges that are more than economic. We the people, hoping for change in Washington, are learning that we're still the audience rather than the playwrights. We may choose the actors, but we don't write their lines or create the plot.

The current show is titled "Health Care Reform." Its patrons are the wealthy health insurers and drug companies. It's no surprise that they get to write a happy ending for themselves. We may applaud or we may boo, but the show will go on despite the many critical reviews.

Act I was the passage of the House version of the reform bill, which includes a public option. It had its dramatic moments—for example, the last-minute inclusion of an outrageously restrictive anti-abortion provision that reverses a generation of gains in women's rights.

In Act II the scene shifted to the Senate, where the action was punctuated by arrests of audience members demanding that single-payer be put on the table. It never was, though a public option lurked behind the arras until stabbed by a knife-wielding Senator Lieberman.

Critics are left to squabble among themselves whether these bills should be passed because they are the best we can get, or should be defeated because they are far worse than what we have. If we were truly in control of our government, since the majority favor publicly-funded health care, we would have had it already. But politics is out of our hands. Our job as advocates in 2010, an election year, is to somehow reclaim our role and write the playbook ourselves.

Depending on what the Supreme Court decides, reclaiming our role in our own government may prove to be impossible.


The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Obama drops bomb on middle class with health care TAX

Increasingly, Congress' idea of health care reform seems to be a health hazard itself. Today's revelation will not please anyone but the insurance/drug industry capos and the politicians they pay off.

In a meeting at the White House, Obama expressed his preference for the insurance tax contained in the Senate's health overhaul bill, but largely opposed by House Democrats and organized labor, Democratic aides said. The aides spoke on condition of anonymity because the meeting was private.

As a New York Times article points out, the Senate's Proposed Health Care Tax Isn't Aimed at the Rich, It's Aimed at You... In fact, it's a tax that in a few years will hammer millions of middle-class policyholders, forcing them to scale back their access to medical care.

Which is exactly what Obama's tax is designed to do.

The tax would kick in on plans exceeding \$23,000 annually for family coverage and \$8,500 for individuals, starting in 2013. In the first year it would affect relatively few people in the middle class. But because of the steadily rising costs of health care in the U.S., more and more plans would reach the taxation threshold each year.

Within three years of its implementation, according to the Congressional Budget Office, the tax would apply to nearly 20 percent of all workers with employer-provided health coverage in the country, affecting some 31 million people. Within six years, according to Congress's Joint Committee on Taxation, the tax would reach a fifth of all households earning between \$50,000 and \$75,000 annually. Those families can hardly be considered very wealthy.


Hawaii's STUPID Lt. Governor Duke Aiona Is In Conflict Himself

Was Barack Obama Born in Kenya?

Exhibit D: U.S. Law



If only one parent was a U.S. citizen at the time of the birth, that parent must have resided in the United States for at least 10 years, at least five of which must be after the age of 14.
