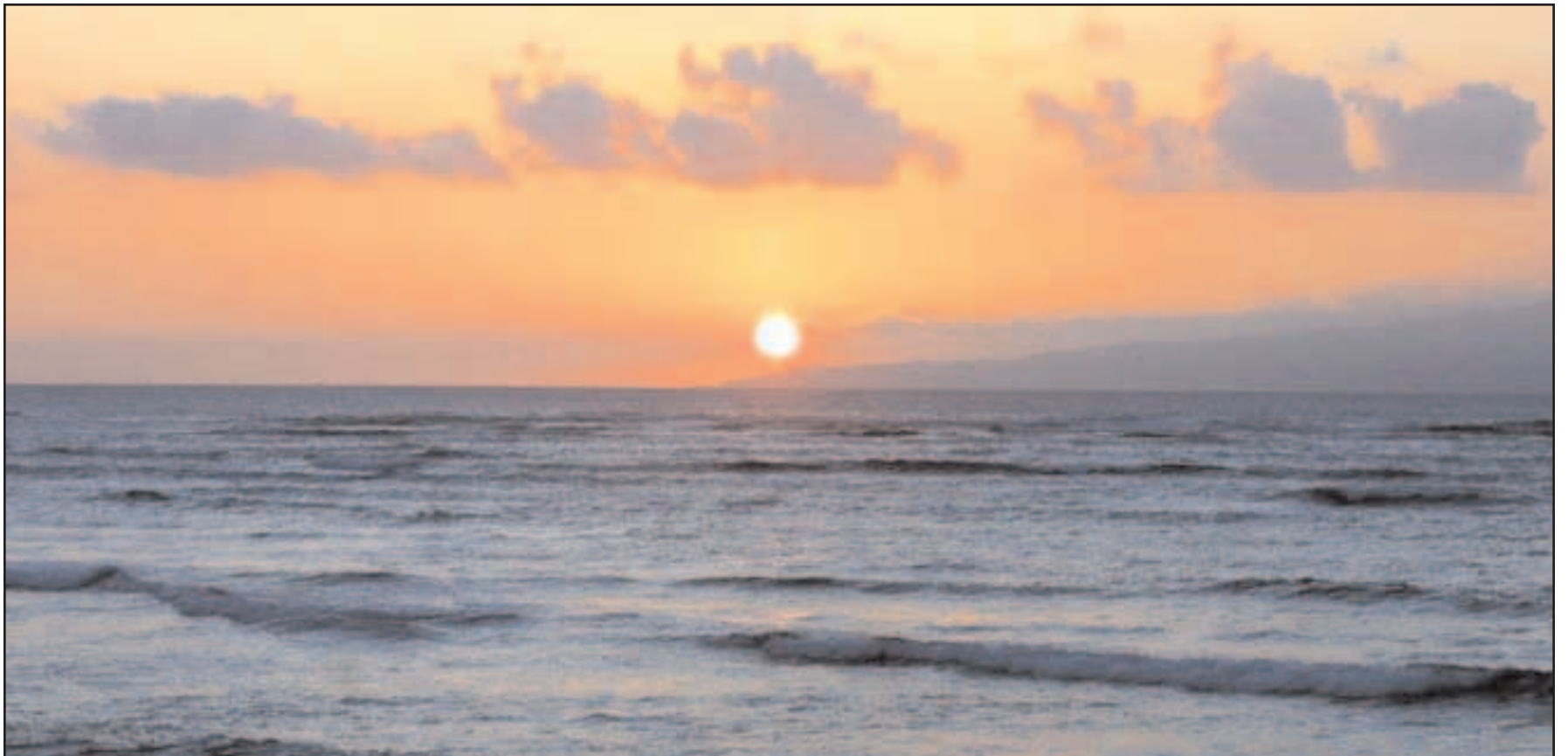

## All I want for New Year09 is Proof of Obama's Citizenship!

SUPREME COURT Conference scheduled for January 9, 2009

America Wants Answers, says AOL Poll

Even Obama's grandmother in Kenya says he was not born in Hawaii, but right before her eyes in Kenya. Now, America Online is asking the nation, "Do you think there is any merit to the controversy surrounding Barack Obama's citizenship?" The national AOL poll reflects the view of more than 81,000 respondents across the Nation: the majority (49%) of the participants believe there's merit in determining whether or not Barack Hussein Obama is a natural born citizen—one of the qualifications for becoming president. A number of "blue states" which had voted for Obama in the election [ CO, NH, NM, PA, and VA) now want to see proof that their candidate is constitutionally eligible to be president, or not.

Writ of Certiorari is still pending and is now scheduled for Conference before U.S. Supreme Court on January 9, 2009. At least 17 lawsuits have been filed over Obama's eligibility to assume the office of the president, many have been dismissed, while others remain pending.

The cases have, in various ways, alleged Obama does not meet the "natural born citizen" clause of the U.S. Constitution, Article 2, Section 1, which reads, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President." Some of the legal challenges have alleged that Obama was not born in Hawaii, but in Kenya. Obama's American mother was too young at the time of his birth to confer American citizenship to her son under the law at the time.

Other challenges have focused on Obama's citizenship through his father, a Kenyan subject to the jurisdiction of the United Kingdom at the time of his birth, thus making him a dual citizen. Such cases contend the Constitution excludes dual citizens from qualifying as natural born, and ineligible to be President. AMEN!

## DLNR To Hold Public Information Meetings to Consider Possible New Fishing REGULATIONS Especially for UHU

HONOLULU – The Department of Land and Natural Resources (DLNR) invites the public to participate in informational meetings to discuss possible regulations for certain marine fish species.

The public discussion will center on using minimum size rules to protect harvested resource fish that may be at risk of being over harvested, and will focus on at least three main fish families that the DLNR feels may be in need of updated regulations. They are: Parrotfish (uhu), Goatfish (weke), and Jacks (uluu/papio). The Division of Aquatic Resources has not yet drafted rule changes.

The following meetings are scheduled:

Maui -- January 14 (Wednesday), from 5:30 to 8:30 p.m. at the Maui Waena Elementary School cafeteria, 795 Onehe'e Avenue in Kahului.

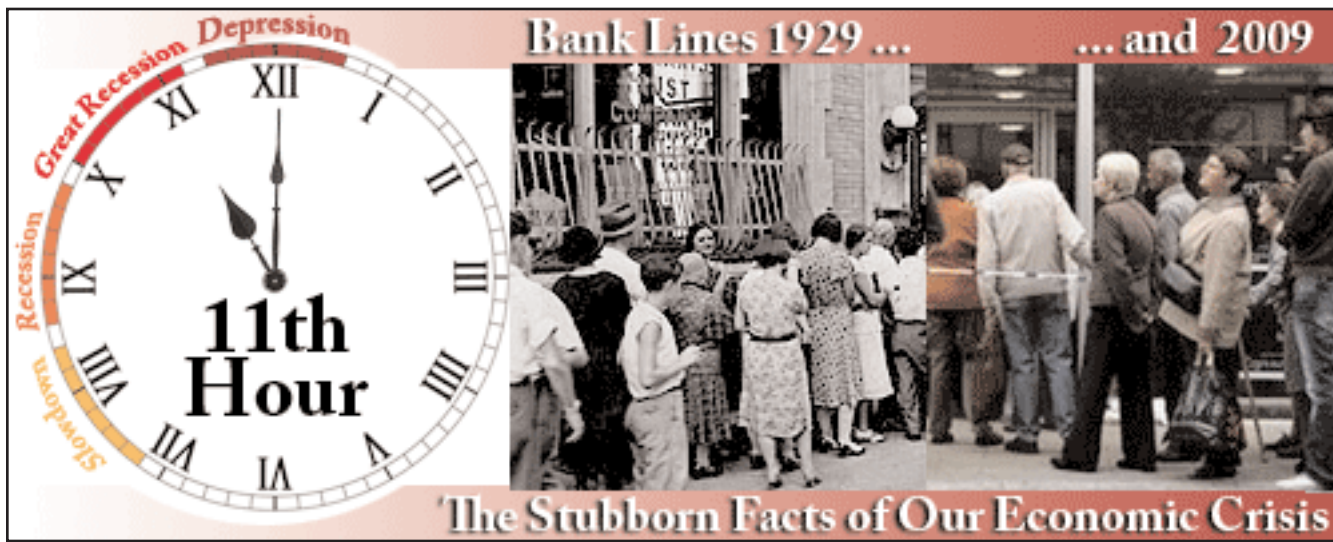
Kaua'i -- January 30 (Friday), from 6:00 to 8:30 p.m. at the Kaua'i Community College, Electronics Technology building, room 114.

"We are holding these public information meetings to listen to concerns and suggestions from the public regarding fishing and protection of these three species," said Laura H. Thielen, DLNR Chairperson. "The input we receive from the public will help the Division of Aquatic Resources design rules that will support the ongoing conservation of our marine resources while balancing the needs of recreational, subsistence and commercial fishers."

Recreational and subsistence fishers have developed a preference for the parrotfish family (also known as uhu), with many spearfishers considering them prized catches.

Commercial harvesting of uhu has also increased, with commercial fishers now supplying uhu to various markets throughout the state. Recent changes in uhu commercial harvesting using specialized and highly effective net- and trap-based fisheries operating in deeper water can remove large amounts of uhu.

These trends have resulted in increased concern over uhu stocks.

## Vehicles Damaged on Rough SuperFerry Transit to Maui

Rough seas on January 5, 2009 resulted in 'minor damage' to 13 vehicles aboard the Hawaii Superferry during its voyage from O'ahu to Maui. The company said the conditions caused some parked vehicles to shift during transit. 'There was no substantive damage to the ship,' said a company statement. 'Affected passengers have been contacted and we are facilitating their claims. This is the first incident in which significant vehicle shifting has occurred,' the statement said. 'Vehicles are now being tied-down in affected areas on days when conditions are unusually rough to mitigate any damage.'

Passengers comments: "My family and I were on this particular voyage...rough doesn't begin to describe the ride. We've caught the Superferry 8 times so far and this was the worst we've ever felt. I can honestly say that this experience has made me decide that I never want to catch the Superferry again. I don't want to take my chances. I estimate that more than 90% of the passengers were vomiting from the moment we passed Diamond Head. There was about 1.5 hours of relative calm while we were sailing between Molokai and Lanai and then the second storm of nauseous attacks began. Our boat was suppose to land at noon, but we docked at around 12:40. I did notice that the captain did slow the boat down at times when the seas seemed insane. My wish is that the Superferry would have some decency to cancel voyages when they know that seas are bad...or at least give passengers the option of rebooking/getting a refund on those days. One thing I may add is that the staff aboard was EXCELLENT & HELPFUL... iron stomachs! 01/05/2009 10:07:24 p.m.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

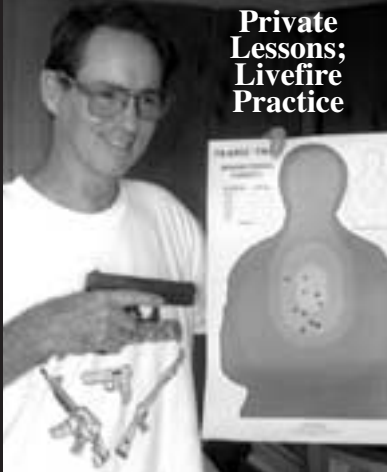

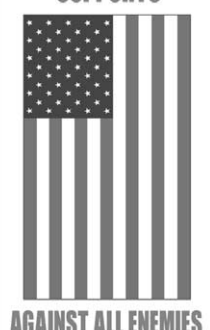

# Fireworks Enforcement Impossible says Legislator

It's that time of the year when many constituents express their frustration over the inability of police to do anything about irresponsible people setting off fireworks in total disregard of the law. Enforcement is near-impossible since the police must actually witness someone breaking the law.

Over the years, I have introduced bills to return the regulation of fireworks to the counties, where it rightfully belongs. After all, what may work on the Big Island may not work on O'ahu. Once again, I will be introducing legislation to ban fireworks in counties with a population of more than 500,000; however, the argument for an outright statewide ban becomes more compelling due to:

\*A noticeable increase in the use of illegal fireworks, including arials and highly explosive devices.

\*A growing number of people who totally disregard the legal time period and set off fireworks at all hours.

\*The desire of businesses to capitalize on the demand, allowing unlimited purchases.

\*The increasing danger of storage and transit of illegal fireworks on the black market.

\*The lack of supervision by adults, resulting in injuries and fires.

"Culture" is the main reason cited to keep this tradition alive. I don't know of any tradition that encourages the breaking of laws, depriving neighbors of their right to a safe and quiet community, and imposing great risks to pets and to those with health problems.

Justices Won't Review Obama's Eligibility to Serve
