## Lingle's Superferry Criminal Enterprise

Hawaii Superferry officials spent more than \$175,000 over three years on lobbying and campaign contributions, including dozens of donations to Gov. Linda Lingle, U.S. Sen. Daniel Akaka, U.S. Rep. Neil Abercrombie and other key state legislators.

An Advertiser computer-assisted study of state and federal campaign records shows that the Superferry, its executives and several of its board members contributed more than \$39,000 since 2004 to local lawmakers and members of Hawai'i's Congressional delegation.

A review of state and federal ethics filings also found that the Superferry spent more than \$136,000 since 2004 to lobby state officials and the federal government.

"You're talking about an extremely large sum of money even by national standards," said Craig Holman, a campaign finance expert with Public Citizen, a Washington, D.C.-based consumer advocacy group. "At the very least, they are trying to buy access, and at the worst they are trying to buy influence."

Superferry officials said there's no connection between the political donations and any legislative

efforts pursued by the company.

The Lingle administration decided in February 2005 to exempt the Superferry project from an environmental assessment, which would take months to complete. That decision was reversed by the Hawai'i Supreme Court in August and now the ferry has been banned from operating until the assessment is finished.

Lingle and state legislators may convene a special session to rewrite the law and allow the ferry to operate while the assessment is conducted.

The 350-foot ferry was to carry passengers and vehicles between O'ahu, Maui and Kaua'i and began service in August before being shut down.

### POLITICAL DONATIONS

The Advertiser's computer-assisted study examined contributions made to Lingle, Hawai'i's Congressional delegation and all 76 state legislators from 2004. The study found that Superferry executives and its board members made more than 30 political contributions between 2004 and 2007.

Here are the highlights:

Lingle's campaign received the most money from the Superferry and its officials, even though Lingle had directed campaign officials not to accept money from Superferry executives, said Miriam Hellreich, who served as the Lingle campaign's finance director from 2002 to 2006.

State campaign spending records show that Lingle's campaign received six donations totaling \$12,000, including \$6,000 in donations in October 2006 from Superferry Chairman and former Secretary of the U.S. Navy John Lehman and company Director Tig Kregel.

Hellreich said the Lingle campaign's policy was to refuse contributions from companies that were negotiating with the state for contracts. Lingle also told campaign staffers not to accept contributions from Superferry executives, Hellreich said.

Hellreich said staffers made "an error" by accepting the \$6,000 in 2006 because negotiations between the state and Superferry were ongoing. Some campaign staffers were not aware of the internal policy against accepting money from Superferry officials, she said.

Hellreich also noted that the Lingle campaign returned about \$10,000 in donations to Superferry officials in 2005 because the state and the company were still in negotiations. Hellreich said the campaign has no plans to return the 2006 donations.

"All the donations associated with people with the (Superferry) were within the law," Hellreich said.

Superferry executives and directors also contributed \$9,200 to Abercrombie's campaign, including a cluster of June 2007 donations from Lehman, Kregel and Superferry President and CEO John Garibaldi.

Abercrombie said he receives support from a broad group of interests including environmental groups.

Federal Election Commission records show that the Sierra Club's political committee contributed more than \$6,000 to Abercrombie's campaigns since 1998 and that the League of Conservation Voters Action Fund has donated nearly \$1,000 to his campaigns since 1998....

Superferry executives made several contributions totaling \$8,800 on Aug. 25, 2006, and Sept. 11, 2006, to Akaka's campaign. Akaka spokesman Jesse Van Dyke said Akaka has taken no position on the issue since it doesn't involve Congressional action and is largely a state issue.

State House Speaker Calvin Say, a Superferry supporter, received \$2,000 from the company on Jan. 24, 2006. That same day State Rep. Joseph Souki received \$1,000 from the Superferry. Say, D-20th (St. Louis Heights, Palolo Valley, Wilhelmina Rise), and Souki, D-8th (Wailuku, Waihe'e, Waiehu), were not available for comment.

## Federal Real ID Postponed by President but, States to be Punished

The Bush administration hit the brakes Friday on a controversial law requiring Americans to carry tamper-proof driver's licenses, delaying its final implementation by five years, until 2017.

A number of states, including the Hawaii Legislature, have balked at the law, objecting to it largely over cost and privacy concerns. But under the administration's new edict, states that continue to fight compliance with the law face a penalty: Their residents will be forbidden from using driver's licenses to board airplanes or enter federal buildings as of May 11 of this year.

Congress passed the Real ID law in 2005 to address security flaws spotlighted by the 2001 terrorist attacks. But 17 states, including Arizona, Colorado and Nevada, have passed legislation calling for its repeal or opposing its implementation, and Hawaii Legislators have opposed the Real I.D. Act.

Come May 2008, Hawaii residents will feel the consequences of the states' resistance, Homeland Security Department spokesman Russ Knocksaid Friday. To board a plane or enter a federal building, those residents will have to use a passport or other form of accepted identification, he said. But what exactly are those other forms of accepted I.D. are not listed.

States like California, that are moving toward implementing the law can request a waiver from the May deadline, and their driver's licenses will remain valid for security purposes, the agency said.

Giving states more time to comply with the law will lower costs, said Homeland Security Secretary Michael Chertoff.

Civil liberties groups disagreed.

"DHS has kicked the can down the road to the next administration," said Barry Steinhardt of the American Civil Liberties Union. Steinhardt disputed that the delayed deadlines would have a major effect on the costs of complying with the law.

A basic problem with the law remains, he said: People will have difficulty obtaining the original documents, such as a birth certificate, that eventually will be required to obtain a Real ID license.

Real ID will require a linked system of databases so that motor vehicle authorities can share information with all other states.

Under the new regulations, by the end of 2009 states must check the legal status of a driver's license applicant with Homeland Security, ensure that the applicant has no licenses in other states and check the validity of the applicant's Social Security number.

By 2014, all license holders born on or after Dec. 1, 1964, will be required to carry a Real ID license.

By 2017, all license holders, regardless of age, will have to carry one.

## The Dollar INFLATED to ZERO?

On the heels of Iran's decision, North Korea has followed suit and also outlawed the use of the American dollar in their country. Finally, Malaysia the next day did the same thing.

Central banks around the world are increasingly diversifying their reserves, including cutting holdings of American dollars, according to a survey sponsored by Royal Bank of Scotland Group PLC, the U.K.'s second-largest bank. Italy, Russia, Sweden and Switzerland have made "major adjustments" in foreign-exchange holdings favoring the Euro and the British pound, according to the poll conducted by Central Banking Publications Ltd. between September and December. "Central banks are open to saying they've been diversifying to improve returns and reduce exposure to devaluation of any single currency," said Sean Callow, senior currency strategist at Westpac Banking Corp. in Singapore. There's no doubt that when they say 'diversification' they mean selling dollars.

Bamlis in Vancouver, BC agreed the dollar is no longer desirable, and they are currently making preparations for the crash of the American dollar!

## New Staph Strain Circulating in Gay, Bisexual Men

Staphylococcus aureus is mutating into strains that are resistant to more and more antibiotics, according to the National Institutes of Health

Health officials are tracking a new type of infection with Staphylococcus aureus that is resistant to even more antibiotics than MRSA, the drug-resistant staph that has spread from coast to coast over the past seven years. (MRSA stands for "methicillin-resistant Staphylococcus aureus".)

So far, nearly all recognized cases of the multiply drug resistant staph have been among gay and bisexual men. The cases are showing up most often in San Francisco, Los Angeles and New York, but, Boston is also an epicenter of the new MDR staph. The city's Fenway Community Health Center, which serves many gay men, first began noticing cases of unusually resistant staph infections about six years ago.

"We initially saw just a few sporadic cases," says Dr. Steve Boswell, the clinic's president and CEO. "But over a period of 18 to 24 months, the number of cases climbed significantly." The infection ranges from mild to very serious; a few men have even died.

MDR staph is related to an MRSA strain called USA-300 that has appeared in schools, prisons and athletic teams around the country. But MDR staph is even more resistant to antibiotics. Boswell says the new variant also causes more-virulent skin infections. "They grow much more rapidly," he says. "Hours can make a difference."

But because doctors often try ineffective antibiotics first, precious time is lost.

"That delay, which can often be days and in some cases even weeks, can result in significant compromises of the patient - in some cases even death," Boswell says.

Among gay men with resistant staph infections, Diep says, about 20 percent in San Francisco and up to 50 percent in Boston "are infected with this more-difficult-to-treat form of USA-300." Incidence of the new variant is 13 times higher in San Francisco's heavily gay Castro neighborhood and surrounding zip codes than in the city's general population.

That concentration - and the fact that many infections appear on the buttocks and the genital region - is leading researchers to suggest that MDR staph is being spread through sexual contact.

Experience suggests the MDR staph won't stay confined to the gay community. "Because USA-300 and other Staph aureus are so easily spread - just through [skin-to-skin] contact transmission - we don't think it will be restricted to the men-who-have-sex-with-men population, but will be spread into the general population," Diep says.

Already, researchers have found the new variant in an 81-year-old woman in New York City. Experts recommend washing hands thoroughly with soap and water or using an alcohol-based hand sanitizer to prevent staph infections.

- Cleaning and covering cuts and scrapes until they are healed.

- Avoiding sharing personal items such as toothbrushes, razors and towels.

Both staph and MRSA can cause more serious skin infections or they can lead to pneumonia or infections of the bloodstream, urinary tract or the lining of the brain. Surgical wounds are often prime targets for these germs.




The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





## But, The Drug War Grinds On

While more than a decade of concerted drug reform activism has produced some encouraging changes, the drug war nevertheless continued to grind on throughout 2007. At mid-year, the Bureau of Justice Statistics announced that the US jail and prison population was at another all-time high, with more than 2.2 million people behind bars, including roughly 500,000 drug offenders. At the end of September, the FBI's annual Uniform Crime Report came out, and it found marijuana arrests and all drug arrests were both at all-time highs, with more than 800,000 pot arrests last year and more than 1.8 million drug arrests. Nothing yet has succeeded in putting the brakes on the drug war juggernaut, and the DARE police grant money scam is a documented failure in prevention.

California, faced with a \$14 billion budget deficit next year, Gov. Arnold Schwarzenegger is considering a proposal to slash ballooning prison spending by granting early release to some 22,000 nonviolent, non-sex offender inmates. There is a long way to go for this proposal, but at least it acknowledges that there might be a better path than just building more prisons for use by the DEA.

With some 172,000 inmates, California's prison system is second only to the federal system in size, and its budget has ballooned by 79% in the last five years to nearly \$8 billion. Still, the system is vastly overcrowded and faces two federal class-action suits seeking to cap inmate populations because overcrowding is resulting in the state not delivering constitutionally adequate medical and care.

According to the California Department of Corrections' latest prisoner census, more than 35,000, or 20.6%, of those prisoners are doing time for drug offenses. Drug offenders, property offenders, and "other" nonviolent offenders together account for half the state prison population.

Arnie is on the right track. Now lets see if Arnie has the brass balls needed to begin the end of the drug war in California. Lingle won't stop it in Hawaii.

As California goes, so go the rest of US. Let our children free.

### CORRUPT COPS on DRUGS

The allure of cocaine profits proves too much for a California highway patrolman and a pair of Brooklyn narcs peddling pills. Let's get to it:

In Santa Ana, California, a California Highway Patrol officer was arrested Monday for allegedly stealing more than a million dollars worth of cocaine from a Highway Patrol evidence room. Officer Joshua Blackburn, 32, a six-year-veteran, is accused of breaking into the evidence room at the patrol's Santa Ana headquarters. Highway Patrol authorities discovered the theft Friday and notified Santa Ana Police, who made the arrest. Blackburn is being held on \$4 million bail at the Orange County Jail.

In New York City, a former Newark police officer was sentenced December 20 to 33 months in federal prison after pleading guilty in a scheme where he, another Newark police officer, and a New Jersey doctor conspired to obtain dozens of illegal prescriptions for Oxycontin, fill the prescriptions, then sell the drugs for cash. Former officer Ronald Pompanio, 42, faced up to 87 months, but got a break for cooperating in the investigation and testifying against the doctor. Both Pompanio and former officer John Hernandez pleaded guilty in September 2006 to one count of conspiracy to possess with intent to distribute oxycodone, the main ingredient in OxyContin, after admitting that they filled the prescriptions and sold the drugs on the street in northern New Jersey. The doctor, Joan Jaszczult of Bloomfield, has also pleaded guilty and faces up to 10 years in prison. The conspirators admitted to trafficking in a minimum of 250,000 milligrams of oxycodone. [Ed: The question always needs to be asked in cases like this, was the doctor a real conspirator, or was the doctor an unwitting victim about whom the drug sellers made up a story to get time off their sentences? Or whose actions the prosecutors misrepresented? Media outlets often rely on the official line without investigating further, so to really know the story in a case like this it might be necessary to independently examine the facts.]

In New York City, two NYPD officers were arrested on December 19 on charges of misconduct and falsifying records in connection with the disappearance of 11 bags of cocaine. Officers Julio Alvarez and Sean Johnstone of the Brooklyn South narcotics unit arrested a man on September 13 and turned over 17 bags of cocaine as evidence, but Johnstone, who was working undercover with Alvarez, was later recorded saying that Alvarez had actually seized 28 baggies of cocaine. This is the same pair of officers who made these pages last week, when we reported on a brewing scandal at Brooklyn South over the use of racial epithets recorded by transmitters they were wearing. It was those same transmitters that recorded the admission of stealing the 11 bags of cocaine. Unlike most defendants in New York's courts, Alvarez and Johnstone were given the courtesy of appearing in court without handcuffs and were allowed to remain free without bail. [Ed: How you figga? Why the special preveliged treatment for cops? ]



## DARE is a SCAM

All recent credible scientific studies have shown that the program is at best ineffective and at worst dangerous.

A DARE Police Officer being criticized is understandably troubled that his efforts as a officer might have resulted in more children using drugs. Or perhaps it os a concern for the source of his paycheck that made him lash out at critics. He has shown us the real face of DARE : the excuses, the denials, the misleading statements, the insults and intimidation directed toward those who question it. All are intended to divert attention from the fact that in spite of its failure, this expensive program relies upon political connections and propaganda for its continued existence.

The program consumes \$700 million annually, and a large bureaucracy has grown up that displays a tendency to put its own interests before the interests of our children.

The most reliable scientific evidence clearly concludes that doesn't work, and DARE police insist the program be judged by its intentions rather than its results.

OK, so what are those results?

A 1993 analysis of all research conducted by the Research Triangle Institute and funded by the National Institute of Justice concluded has "a limited to essentially non-existent effect" on drug use.

A 1998 U.S. Department of Education analysis of more than 10,000 students found other existing programs have better outcomes than DARE .

A 1998 study by the University of Illinois determined children in the suburbs who participated in DARE had significantly higher levels of drug use than those who didn't.

One of the many ironies of the drug war is that it puts cops on the same side as the drug lords: Neither wants to see an end to the policy of prohibition. Prohibition creates the lucrative black market that enables drug lords to make obscene profits. Prohibition also creates opportunities for police departments to claim bigger budgets of federal grants for their War on Drugs. Meanwhile, money for effective education programs and drug-treatment programs is scarce.

Despite overwhelming evidence, our leaders hide behind a smokescreen. The public relations machine has silenced and intimidated parents, teachers, representatives and others.

I know from experience that fascost police state stooges do not hesitate to vilify publicly those who disagree with them about DARE. DARE cops do not intimidate me, but it's not me DARE means to intimidate. **It's you.**

### DRUG WAR SNITCHES are BAD

In Cleveland, Ohio, an informant for the DEA has been convicted of framing innocent people and getting them sent to prison. Informant Jerrell Bray staged drug deals with friends while investigators watched, but gave investigators the names of people not involved in the deals, then testified or gave sworn statements saying that the innocent people were the drug dealers. Bray managed to set up four people, including a woman who had refused to date him, while working under DEA agent Lee Lucas. It is unclear whether Lucas or other law enforcement personnel knew what Bray was up to, but a federal grand jury will meet next month to investigate obstruction of justice, perjury, and weapons charges against Bray "and others." Bray was sentenced to 15 years in prison on perjury and deprivation of civil rights charges, a sentence that will run concurrently with state time for shooting a man in a drug-related robbery. Ironically, Bray can gain a sentence cut on the federal time if he "cooperates fully."

When will they learn ?
