Hawaii: Makaala GMO Salmon

As Sovereign United States Nationals, we have a responsibility to keep our government agents, including the FDA, working in our interest of food safety. But that agency, like so many other government agencies, is again acting unilaterally against We The People in favor of Genetically Modified food lobbyists who do not want their GMP meat [salmon fish-GMO] to carry that label of truth.

The first genetically engineered (GE) meat approved for human consumption might soon be on its way to a supermarket near you - a fast-growing salmon developed by a company called AquaBounty Technologies.

But it gets fishier. If AquaBounty's GE salmon is approved for sale, the FDA might decide to put it right next to normal salmon in the meat case, without any special labeling. Consumers would be none the wiser.

We deserve to know if the meat on our plate is genetically engineered or not. Companies and FDA officials shouldn't keep us in the dark about the foods we eat or feed to our families.

Tell the FDA you want labels on genetically engineered foods so you can make an informed choice.

No labeling is a dangerous precedent to set for genetically modified foods. Recent drug recalls have shown us that just because the FDA approves something doesn't mean it's safe in the long term. Any adverse effects of genetically modified meat on people might not show up until it's already been consumed by a large number of Americans. And by then it's too late. Without labeling, it will be even harder to recognize and track problems that might be caused by GE foods.

AquaBounty Technologies' own scientists are telling the FDA that its GE salmon is perfectly safe. But there's no way they can prove these claims, and we can't dump unlabeled GE salmon into the food supply on the word of the company that stands to make a profit.

The FDA is being heavily lobbied by AquaBounty Technologies about its forthcoming decision, and now needs to hear from concerned consumers like you about whether GE salmon should be labeled or not.

Tell the FDA to require labeling of genetically engineered salmon so that consumers can decide for themselves whether to buy and eat it.

It's up to the FDA to keep our food supply safe, and it's up to us to let the FDA know where consumers stand on GE foods and to make the FDA act to regulate GMO foods at least by requiring truthful labeling of GMO foods so that we can exercise informed choice about our food supply.

Hawaii: Taking Freedom of Speech for Granted Leads to Police State



The Chinese Constitution says that freedom of speech is guaranteed, just like the First Amendment of the Constitution for the United States of America guarantees freedom of speech to United States Citizens. But in China, Nobel Peace Prize winner Mr. Liu Xiaobo was jailed for 11 years starting in December 2009 for expressing his desire to see peaceful political change in China, after being charged with crime of "subverting state power". [Lingle, Aiona, Obama et al]

Government censors appear to be doing what they always do, seeking to wipe away any traces of criticism of the party that would soil its reputation. Chinese officials expressed their anger at Norwegian Nobel Committee president Thorbjørn Jagland who said Mr Liu was "the foremost symbol of the wide-ranging struggle for human rights in China".

Fight for freedom of speech grows. Last week, a group of 23 Communist Party elders in China wrote a letter calling for an end to the country's restrictions on freedom of speech. The letter comes just days after the Chinese dissident Liu Xiaobo was awarded this year's Nobel Peace Prize.

The letter says freedom of expression is promised in the Chinese constitution but not allowed in practice. They want people to be able to freely express themselves on the internet and want more respect for journalists. But, Chinese internet users report that references to the letter on different internet message boards are already being deleted.

Unfortunately, such letters often get the signatories into trouble, although most of those who signed this letter for freedom of speech are quite elderly and probably believe the authorities can't do much to harm them. The signatories describe the propaganda department [PD] as "invisible black hands"

The PD goons violate our constitution, often ordering by telephone that the works of some person cannot be published, or that an event cannot be reported in the media. "The officials who make the call do not leave their names, and the secrecy of the agents is protected, but you must heed their phone instructions.

Many who signed the letter were themselves once influential officials. They include a former personal secretary to the revolutionary leader Mao Zedong, and a former editor of the People's Daily, the official Communist Party newspaper.

The letter, addressed to China's parliament, makes a number of proposals for change: Censorship should be ended; restrictions on book publishing abolished; journalists protected and supported when they investigate official corruption.

Enemy of the State: Camp FEMA Someone Is Attempting To Block Video!

Over the past week, it has come to the attention of film team William Lewis and Gary Franchi that someone is trying to "buy up" all the remaining available Camp FEMA websites. Plastic Bag Reduction Administrative Rules Now Available Online

WAILUKU, Maui, Hawaii-- The County of Maui Department of Environmental Management announced today that the administrative rules governing the Plastic Bag Reduction Ordinance have been posted online at www.mauicounty.gov (link at left on home page). The ordinance goes into effect January 11, 2011.

The administrative rules for the Plastic Bag Reduction Ordinance were written to govern administrative procedures and enforcement of chapter 20.18 of the Maui County Code. Effective January 11, 2011, businesses will no longer be allowed to give out single-use plastic bags with handles to customers at the check-out counter. Businesses will be permitted to provide their customers with all types of paper bags, although the use of recyclable paper bags and reusable bags, as alternatives, is encouraged.

Molokai's Friendly Market has been offering reuseable cloth bags and discounts for bringing your own bags to shop.

The administrative rules were finalized after a series of informational meetings, which were held to gather input from the public. The department developed the draft rules after gathering public input; the rules were presented at an official public hearing held this past August.

The rules will be submitted to the Mayor for approval on January 11, 2011. Once approved, the rules will be submitted to the County Clerk and will take effect 10 days later.

Dear MPD Commission members: We on Molokai need to have an email address to send photos and reports of dirt bikes on highway big noise, and those BOOM BOX cars and trucks photos of them and license plates for ID and police interdiction. MPD Molokai supervisors say they do not have time to watch for noisy dirt bikes on highway, and boom boxe vehicles in east Molokai area between Mapulehu through Waialua Beach, and they say they do not have an email address for public use to send photos of violators, and they refuse to give out their personal Dept email address so the public can send in their complaints and photos and evidence for police follow up. Every day between 4 pm and 6 pm police could observe and arrest at least 3 or four dirtbike riders on the highway, and 6-10 boom-box drivers who are disturbing the peace and violating boombox laws, but MPD Molokai refuses to come out and catch these violators because they say they have too many other calls, yet they refuse assistance from Citizens offering reports and photos and complaints.

Time to encourage public participation in law enforcement, especially for these dirtbike and boom box problems MPD Molokai supervisors say doesn't have time to stop themselves by being here late afternoon for two hours. Government Goons Kidnap Baby Citing the dad's membership with Oath Keepers

A newborn baby was ripped from its mother's arms by officials from the New Hampshire Division of Family Child Services accompanied by police after authorities cited the parents' association with the Oath Keepers organization as one of the primary reasons for the snatch, heralding a shocking new level of persecution where Americans' political beliefs are now being used by the state to kidnap children.

The Oath Keepers organization is not a "militia," as the affidavit claims, it is merely a loose network of current and former military and law enforcement professionals who have sworn not to obey unconstitutional orders such as gun confiscation, warrantless searches and mass internment of Americans. The group is committed to non-violence.

What was supposed to be one of the most joyous occasions of their lives turned into a nightmare for Johnathon Irish and Stephanie Janvrin, after they were told by The Director of Security and the Head Nurse at Concord Hospital that their baby would be taken to be checked by the hospital pediatrician.

"They lied to us - they got us to allow them to take our daughter under false pretenses, we didn't even have a choice," said Irish.

When Irish tried to stop his daughter being taken, the baby was immediately wheeled out in a bassinet, after which Irish saw three men in suits accompanied by uniformed police officers and social workers who proceeded to try to search Irish.

"They forced me to stand up, held my hands behind my back and patted me down," said Irish, before police told him they were taking the baby.


"My fiancé didn't even get any time to bond with the baby - they came in and stole our child," said Irish. The parents were given a couple of minutes with their daughter before being forced by police to leave the hospital. Irish was subsequently told that a "security officer" would follow his every move.

The affidavit to take the child states, "The Division became aware and confirmed that Mr. Irish associated with a militia known as the Oath Keepers." That confirms that political beliefs was the primary factor behind the snatching of the baby. The fact that political affiliations were even mentioned is a frightening indictment of how far Obama's war on Americans who dissent against his regime has advanced.

"It is utterly unconstitutional for government agencies to list Mr. Irish's association with Oath Keepers in an affidavit in support of a child abuse order to remove his daughter from his custody." Talk about chilling speech! If this is allowed to continue, it will chill the speech of not just Mr. Irish, but all Oath Keepers and it will serve as the camel under the tent for other associations being considered a threat to government goons. Thus, it serves to chill the speech of all of us, in any group we belong to that "officials" may not approve of. Don't you dare associate with such and such group, or you could be on "the list" and then child protective services might come take your kids."

The parents were not even full members of the Oath Keepers organization, they were merely on a discussion list related to the group. This makes the case even more shocking - you don't even have to be directly associated with a group that the government deems to be a "militia" to have your baby stolen - you merely have to be involved in online discussions of issues relating to the constitution and freedom in America.

If parents live in fear of having their children stolen by the state because they criticize the government, the United States can rank itself amongst the worst dictatorships in history who invoked the threat of taking people's children if they spoke out against tyranny.

FBI Data Shows That More Guns Means Less Crime

In the United States, more guns correlate with less murder, according to FBI data from 2009. That is good news caused by exercising 2nd Amendment right to keep and bear arms to defend against common criminals and government's.

FBI data show that America has been on a firearms buying spree since the end of 2005. Between November 2005 and October 2009, nearly every month's NICS checks were higher than the year before. Each year's total reported double digit growth over previous year. Data up through 2009 from the FBI indicates that violent crime and even murder has been dropping at an accelerating rate since the end of 2006.

Hawaii has some of the nation's most ultra vires anti-gun laws, but nothing to those compared in Chicago. Just days after the Supreme Court struck down Chicago's handgun ban in the McDonald case, the Chicago City Council approved what the city officials say is the strictist handgun ordinance in the nation after lashing out at the McDonald ruling saying that it makes Chicago more dangerous because it puts more guns in people's hands.

Chicago's new gun ordinance bans gun shops in Chicago and prohibits gun owners from stepping outside their homes, even onto their lanai or in their garages, with a handgun. AUWE !

On the other side, Utah state is helping Americans legally obtain firearms. Fifteen years ago, Utah loosened rules on concealed firearms permits by waiving residency and other requirements. Indeed, the ominous Bureau of Criminal Identification admits at least 120,400 permits issued. But why does such a government entity keep records on law abiding American Citizens? Makaala !

HEAD SHOTS effectively stop threats

Life saving head shot under "live" circumstances to stop a deadly threat.

Saving your life of protecting someone else from deadly threat means delivering head shots in the cranio-ocular cavity (between the moustache and the eyebrows) to be sure that the bullets gets through the soft part of the skull, and not deflected by teeth or jaw, so it penetrates to the brain to immediately stop a threat.

But even with lots of practice at only 3-yards, often the hit is a little low in the head, likely due to sight alignment being a bit low or more likely the shooter being a bit heavy on the trigger. The shooter may have lined up the sights, and as he was focusing on the front sight mentally said to himself, "looks good press the trigger NOW!" which tends to dip the front sight and causes shots to hit low.

How to insure an effective head shot? Do these things: 1] line up the sights; 2] then bring this focus 100% back to the front sight; 3] finally press the trigger until a surprise trigger break occurs for a deadcenter head shot to the cranio-ocular cavity and the bad guy will drop, even with a .22.

If you are using a shotgun with 00 shot, you must dispel any notion that you can just point and shoot a shotgun and every bad guy is taken out. You must use the sights on a shotgun just like any gun or you can miss, even at short distances.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





American military officers against Obama

Upon entering the service of the American military, everyone must take this oath: "I, _____ GRUNT _____, do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign and domestic; that I will bear true faith and allegiance to the same; and that I will obey the orders of the President of the United States and the orders of the officers appointed over me, according to the regulations and the Uniform Code of Military Justice. So help me God"

The oath of an OFFICER of the United States Armed Forces, is as follows:

"I, _____ OFFICER _____, having been appointed an officer in the Army of the United States, as indicated above in the grade of Major do solemnly swear (or affirm) that I will support and defend the Constitution of the United States against all enemies, foreign or domestic, that I will bear true faith and allegiance to the same; that I take this obligation freely, without any mental reservations or purpose of evasion; and that I will well and faithfully discharge the duties of the office upon which I am about to enter; So help me God."

Notice that for an Officer, there is no "promise to obey the orders of the President". Officers duty is to Constitution !

Freedom of Speech in America

There can be no freedom of speech, no freedom of association, no freedom to even open your mouth and "speak truth to power," no freedom AT ALL, if your children can be black bagged and stolen from you because of your political speech and associations — because you simply dare to express your love of country, and dare to express your solidarity and fellowship with other citizens and with active duty and retired military and police who simply pledge to honor their oath and obey the Constitution. Second, a republican form of government recognizes the private independent sovereign nature of each person (man or woman) of competent age and capacity, therefore a Republic must be representative in its nature.

A Republic recognizes Law is unchangeable, or at least that it can only be changed by a higher source than government. In a Republic the concept of "collective sovereignty", i.e. democracy, cannot exist, except with recognition that the State or nation, as a body of sovereigns, can speak through one elected voice; though that one voice can never lawfully interfere with the private rights of the individual sovereigns.

"A Constitutional Republic" is a government created and controlled, at least, by the Law of a Constitution. The Constitution of the United States of America was, in Law, foundationally based on the Bible, the Magna Carta, and The Declaration of Independence. Those documents recognize man's sovereignty, the divine nature of man's creation and man's divine right to Life, Liberty, Property, and the pursuit of happiness.

The founding fathers of our Constitutional Republic lived on their own private land as free natural sovereign independent people with no central government controlling them—they had Liberty. After the French American War they found themselves at odds with Great Britain in its attempt to usurp the power to rule over them as if they were chattel property of Great Britain. As Great Britain's unlawful rule became unbearable Thomas Jefferson wrote the Declaration of Independence, which each of the 13 independent States signed, as the foundational instrument that united the people in a Union of States to unanimously inform one and all of the necessity that they dedicate their lives to fight for Liberty in "The War of Independence" against Great Britain.

Make no mistake.

Obama's Department of Homeland Security was NOT designed to protect Americans from terrorists. It was designed to protect politicians from Americans.




