Undersea cable ship Intrepid was off shore of Alii Fishpond last week feeding fiber optic cable underwater to land based construction crews for DHHL's high speed communications infrastrkture connecting Molokai, Maui, and Oahu.

UnderWater Cable Now landed

The DHHL's highspeed fiberoptic communications undersea cable just reached land near Kaunakakai at Alii Fishpond when the SS Intrepid unrolled the cable into conduit bored under the reef from shore to about 3/4 mile out. The heavy machines and construction crews received the cable which will be connected to the subterranean conduits installed by Sandwich Isles Communications to allow all DHHL homesteaders to be connected to media and each other.

The undersea portion of the DHHL project cost about \$126-million. All the cables to Maui, Molokai, and Oahu are expected to be installed undersea by the end of October 2008.

Land based underground conduits were installed in ditches, and, in the Kaunakakai area in the past few weeks, using a horizontal directional boring technology. The whole project was started in 2004, and is expected to cost almost \$100,000 to service each homestead with high speed computer internet access, TV, telephone, and personal communications do to the efficiencies of fiber optics.



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!







Police Power is for The People

This is republican form of government: the police power stated in the PREAMBLE to the Constitution for the United States of America is the Authority of the People to enforce the law.

WE THE PEOPLE of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.

This is the statement of the POLICE POWER where "Polis" means the inhabitants of the land who know what they want and intend to enforce it by whatever means necessary.

The difference between a republic and other forms of government is that everybody in an egalitarian republic is an equal Citizen© if, indeed, they are a Citizen©. Those not vested with such power have no authority to exercise the law. ALL CITIZENS© are Civil Officers and a constituent element of the state having equal right to administration of affairs of government.

Such things as claiming JURISDICTION to speak law or, literally, dictate justice depend upon being a Citizen© and in the legal practice which has dominated our judicial system you are called upon to STATE your status or forfeit it.

If you are one of the people of the United States as mentioned in the Preamble, and if you make suit in a court of record, then the Constitution authorizes the judicial power of the United States in all suits at common law. See Article III for more detail.
