9/11 UPDATE: AF Pilot Says "No Way!"

Captain Russ Wittenberg, U.S. Air Force — Former Air Force fighter pilot with over 100 combat missions. Commercial pilot for Pan Am and United Airlines for 35 years, flying 707, 720, 727, 737, 747, 757, 767, and 777's. Had previously flown the actual two United Airlines airplanes that were hijacked on 9/11 (Flight 93, which impacted in Pennsylvania, and Flight 175, thesecond plane to hit the WTC).

Regarding Flight 77, which allegedly hit the Pentagon. "The airplane could not have flown at those speeds which they said it did without going into what they call a high speed stall. The airplane won't go that fast if you start pulling those high G maneuvers at those bank angles. — To expect this alleged airplane to run these maneuvers with a total amateur at the controls is simply ludicrous...

It's roughly a 100 ton airplane. And an airplane that weighs 100 tons all assembled is still going to have 100 tons of disassembled trash and parts after it hits a building. There was no wreckage from a 757 at the Pentagon.

"The vehicle that hit the Pentagon was not Flight 77. We think, as you may have heard before, it was a cruise missile and maybe a small drone that launched it."

Pentagon to resume forced anthrax vaccines

The Pentagon on Monday said it will force troops in Iraq, Afghanistan and South Korea to be vaccinated against anthrax, restarting a previously court-halted program before U.S. regulators later declared the shots safe and effective.

But William Winkenwerder, assistant secretary of defense for health affairs, said the Pentagon has no plans to vaccinate troops serving elsewhere, including those in the United States -- site of the only major anthrax attack against Americans, which killed five people in 2001. Anthrax spores can be used in germ warfare to give victims the deadly bacterial disease. The Pentagon argues the shots are needed to protect troops against bioterrorism. "There are terrorists operating in and around Iraq and in that part of the world," Winkenwerder said. "That's a higher threat area."

The move to reopen the mandatory vaccination program follows a final order from the U.S. Food and Drug Administration in 2005 that found the anthrax vaccine safe and effective in preventing anthrax disease.

But attorneys whose lawsuit previously shut down the mandatory anthrax vaccination program said they plan to file a new suit to challenge its resumption. "The forthcoming mandatory program is just as senseless as before and the FDA's new determination remains legally and scientifically flawed," said Mark Zaid, one of the attorneys.

DOD's Winkenwerder, who has not taken the anthrax vaccine, said the FDA's final order settles legal questions and the Pentagon is prepared for a court challenge.

The court's action came after a lawsuit filed by six unnamed military personnel and civilian workers who objected to the vaccinations. Some troops had refused to get the mandatory shots due to worries about side effects, and some had been thrown out of the military. Under the voluntary program, only 50 percent of troops accepted it.

Winkenwerder said those numbers were too low and left U.S. forces unprepared for bioterrorist attacks. He said service members expect a shot to be mandatory if it is important, but he could not say how many troops would be vaccinated under the mandatory program, which should start in 30 to 60 days.

MCA: Corruption of Blood

All Americans will be tainted by the Military Commissions Act 2006 [MCA].

To those dwindling numbers of Americans aware of the total destruction of their Nation, and way of life, ever harsher measures to destroy all dissent were outlined to them this past week by their Military and Police Leaders: U.S. Homeland Security Secretary Michael Chertoff said on Monday. "We now have a capability of someone to radicalize themselves over the Internet," Chertoff said on the sidelines of a meeting of International Association of the Chiefs of Police; Maui Police Department Chief Thomas Phillips has announced his intention to spend \$42,000 in Federal Forfeiture Funds gained by police robbing people with drug problems, on a Mobile Command Post Vehicle to support his special squad of Riot Police he likes to send to Molokai for practice sessions against Sovereign People who are demonstrating against crooked government policies; FBI Director Robert Mueller called on Internet service providers to record their customers' online activities; Pres. Bush has openly declared that he has no intention of obeying privacy laws - or any other laws safeguarding the Constitutional rights of American citizens - if he doesn't want to; the Army's policy for establishing civilian inmate labor program and civilian prison camps on Army installations now located and empty, though guarded, across the Nation.

The Military Commissions Act Congress passed and president Bush signed essentially revokes over 200 years of American principles and values. In a 'signing statement' released when he signed the 2007 Defense Authorization Act on Oct. 17, the president listed two dozen provisions in the act that he indicated he may or may not abide by." Those provisions restrict his ability to hide funding for wars. We cannot trust the president or the courts to follow the Constitution.



For the past three and a half years I have watched in horror the mirror image of another Vietnam unfolding in Iraq. As of this writing over 2,700 Americans have died and nearly 20,000 have been wounded while tens of thousands of innocent Iraqi civilians, many of them women and children, have been killed.

Refusing to learn from the lessons of Vietnam, our government continues to pursue a policy of deception, distortion, manipulation and denial, doing everything it can to hide from the American people its true intentions in Iraq.

Sadly, the "War on Terror" has become a war using terror against civilians in foreign countries, and against American Citizens in the USA.

Never before has this government through its outrageous provocations and violent aggressions placed the citizens of this country in such grave danger. 



Government Charity Perpetuates Poverty

When the federal government forces billions of dollars from the public through taxation, then gives it to other people, it violates every principle of the Constitution and the American Way of Individual Responsibility and Individual Sovereignty, yet none of the perpetrators are arrested, and instead of sounding an alarm, mainstream reporters call for more "funding" for more socialist programs, causing more poverty and dependence.

Charity is a private affair. The Constitution does not contemplate giving the treasury to any selected segment of the population. Taking taxes from the public, so bureaucrats and reporters can promote "charity" is criminal misuse of the public treasury.

Reporters act as if welfare helps, but taking from those who earn money and giving it to those who do not will never end poverty. Wealth redistribution is a proven failure - the socialist opposite of the American Dream that created the prosperity in the first place. It creates hopeless dependency. When the money runs out, socialist economics says take more, forever. The public inexplicably accepts their welfare slavery with the same ignorance guiding reporters.

Instead, try reduce taxes by the amount "stolen for charity." That economic impact would alleviate more poverty than any theft-and-redistribution.

Jury Nullification Means Sovereignty

Juries refused to convict under the Fugitive Slave Act of 1850, during Prohibition 1920 - 30, Vietnam Objectors 1960-1970, Tax Protesters, Medical Marijuana Users, and others.

The defense of our liberties is first at the ballot box, then the soap box, then the jury box, failing all else, the cartridge box. The writers of the US Constitution understood that power always corrupts, and that the people must retain and understand the several processes to defend themselves from the greatest threat to liberty: one's own government.

With more than 20,000 inferior gun laws contradicting the superior or prevailing law of the US Constitution, s Second Amendment, and an increasingly anti-gun, power craving institution of government prosecutors and judges, it is only a matter of time before you or friends are accused of a gun crime, unless gun owners fully understand and effect jury nullification for wrongful accusations of crime.

Corrupted anti-gun prosecutors and judges are common. Anyone can easily become a lawyer or judge. It is just a process. The US is overrun by them.
