## Maui Charter Commission October 24 on Maui

The Maui County Charter Commission will continue making preliminary decisions on what proposed charter amendments should be placed before the public at its next meeting, Monday Oct. 24, Commission Chair Josh Stone announced.

Should the MPD Chief be appointed by the Mayor, for accountability?

The Oct. 24 meeting will be held from 10 a.m. to 4 p.m. at the Planning Commission Conference Room in the county complex on High Street in Wailuku. The general topic areas the commission is reviewing include: the Council elective process; Council approval of department heads; the Mayor appointing Police Chief and approving the appointment of the Fire Chief; changing the County's budget process to a 2-year cycle; changing the rules for initiatives, referendums and recalls; and creating a position of county auditor.

At its last meeting the Commission made tentative decisions to propose: the Council's term of office increasing from two to four-year terms; returning to a partisan election system; and to leave the governance of the Department of Water Supply under the Mayor and County Council. Ultimately, the Commission will make its proposals for changing the Charter to the voters in the 2012 election.

Our goal is to reach tentative approval of these issues before December so that we can take these proposals to public hearing countywide and hear the residents' opinions on these complex and diverse issues. Our plan is to work on each of these issues over the next two months, hopefully approving the less complex or divisive first and saving the hardest ones for last, said Commission Chair Josh Stone.

The Charter Commission is an 11-member board appointed by the Mayor and approved by the Maui County Council to conduct a review of the County Charter. The charter is the equivalent to the County's constitution, the blueprint that sets the structure of county government. The Commission may make recommendations to amend the charter to the voters in the next election.

The commission will also take testimony from the public on any subject related to the County Charter. Oct. 24 meeting 10 a.m. to 4 p.m. at the Planning Commission Conference Room in the county complex on High Street in Wailuku. ## Cops Are Danger to Society

We'd sure would have liked to be a fly on the wall at Hawai'i Island Police Department (HIPD) headquarters when officer James Waiamau got his chewing out, most likely not for what appears to be the actual beating and arrest of news reporter Damon Tucker- but for being so stupid as to pick a guy who has a fair-sized megaphone... a guy you'd think Waiamau would or should have known (although many think he knew exactly who he was harassing). Presumably, with the state-wide publicity and the official HIPD release saying it "recognizes the media and the public have every right to photograph police activity in a public place from a safe distance," you'd pretty much think that the cost of defending, much less settling, Tucker's probable lawsuit would have everyone on their best behavior, especially if a "photographing in public" incident comes up again.

Same thing goes for Maui Police Department Officer Johnson and the beating of reporter on Maui within weeks. Unprovoked unlawful assaults on reporters who are merely taking photographs in a public place of police activity.

Moreover you'd think that when they found out that they had a problem with the report number on Tucker's "Obstructing a Government Operation" summons that he received upon leaving the cell block, the officer they sent to give him the corrected paperwork would have some semblance of an idea of what to do and not to do if someone was there with a video camera, i.e., it is lawful to video police activity, remember?.

But there it is- a video, shot by Big Island Video News' (BIVN) David Corrigan in which Officer K. Veincent orders Tucker to tell Corrigan to stop video taping. Too bad Tucker and David Corrigan did not file harassment and attempted violation of rights under color of law against the cop Veincent by intimidation abuse of authority.

Tucker was there for an interview with BIVN and apparently had agreed to meet up with Veincent there too... at the "scene of the crime." About five minutes into the piece a red late model Dodge Charger with a blue roof light pulls up and Tucker leans into the passenger window. He then turns around, looks into the camera and says "He doesn't want you video taping- he doesn't see the reason why."

The first part is insane enough- police are presumed to have the "persuasive power" so an illegal request comes under harassment and misconduct. But the fact that Veincent presumes that the videographer has to have a reason to continue makes you wonder who the heck is in charge down at HIPD headquarters. Like MPD: Organized Criminals.

As to the rest of the interview- which was attended by Barbara Lively the legislative assistant to Hawai'i County Councilman Fred Blas- Tucker, visibly shaken during and after the meeting with Veincent, shows clearly where the beating and arrest took place as he goes through a "walking tour" of the chronology of the incident.

Then at the end of the piece, he can be seen fighting back tears and saying "as you can see I'm clearly across the street... The fight happened right over here (pointing) so I'm way far away from where the fighting was."

Judging by the official statement, somebody at HIPD clearly recognizes, if not what the right thing to do when an officer comes across someone taping their activities from a "safe distance" is, then at least what it's going to cost the TAXPAYERS !!!




**Obama STARTS Another WAR**

Putative "president of peace" Barack Obama has committed 100 U.S. soldiers to central Africa to fight the Lord's Resistance Army (LRA). That announcement came Friday, two days after deployment. In a letter to House Speaker John Boehner on Friday, Barack Obama wrote "the U.S. forces are combat-equipped," but — not to worry — "they will only be providing information, advice, and assistance to partner nation forces, and they will not themselves engage LRA forces unless necessary for self-defense."

Obama asserted that his action was taken in "furtherance of the Congress's stated policy," citing the LRA Disarmament and Northern Uganda Recovery Act of 2009, which encourages greater "military" cooperation to defeat the LRA. However, he concluded, "I have directed this deployment, which is in the national security and foreign policy interests of the United States, pursuant to my constitutional authority to conduct U.S. foreign relations and as Commander in Chief and Chief Executive." This the 5th war-by-decree, following the still-simmering conflict in Libya aka War #4, without Congressional approval.

Ironically, Obama closed the letter, "I am making this report as part of my efforts to keep the Congress fully informed, consistent with the War Powers Resolution" — an act he is currently violating in Libya.

Some find the hand of George Soros' internationalists behind the intervention. Aaron Klein at WND.com notes: In April 2010 Soros' International Crisis Group, or ICG, released a report sent to the White House and key lawmakers advising the U.S. military run special operations in Uganda to seek Kony's capture...

Soros sits in the ICG's executive board along with Samuel Berger, Bill Clinton's former national security advisor; George J. Mitchell, former U.S. Senate Majority Leader who served as a Mideast envoy to both Obama and President Bush; and Javier Solana, a socialist activist who is NATO's former secretary-general as well as the former foreign affairs minister of Spain.

## Like Hawaii, CA Prohibits Unloaded Open Carry

The Responsible Citizens of California are disappointed with Governor Jerry Brown's decision to sign AB 144, a bill to ban the Unloaded Open Carry of handguns, into law. Furthermore, we express very strong opposition to the passage of AB 809 (long gun registration) and SB 819 (misappropriation of DROS fees) into law.

The right to Open Carry has been legal in the State of California since its inception, and there has never been a single case of an Open Carry advocate ever committing a violent crime in the Golden State's entire 160-year history. Since no problem has ever existed that needs to be addressed or fixed, there was no reason for AB 144 in the first place.

The Responsible Citizens of California will continue to work with other 2nd Amendment organizations to plot the best possible course of action moving forward. Also, it is worth noting that while AB 144 bans the practice of Unloaded Open Carry of handguns in California, this bill does absolutely nothing to limit the civil right to Open Carry long guns (rifles and shotguns). Since the State Legislature and the Governor have chosen to attack the right to carry handguns, law-abiding citizens who wish to be able to protect themselves from violent criminals have no choice but to Open Carry long guns instead.

The right to carry a firearm for personal protection is a basic, fundamental, and enumerated civil right that is guaranteed by the United States Constitution, confirmed by the US Supreme Court's twin landmark rulings in both Heller and McDonald, and Unloaded Open Carry was cited as an important right in California by two federal judges in recent court decisions.

This decision on the part of Governor means that, as of January 1, 2012, the fundamental right to carry a handgun will be denied to the vast majority of law-abiding California residents. It is essential that law enforcement officers understand that Unloaded Open Carry will remain legal until January 1, 2012. Open Carry advocates should be treated with respect and in a manner that does not violate any of their basic, fundamental, and enumerated civil rights.

Compared with the rest of the country, California and Hawaii are behind the times with regards to 2nd Amendment Rights. Most other States have been expanding the basic, fundamental, and enumerated civil right to self defense for their electorate. It is time for our elected officials in California and Hawaii to stop eroding every law-abiding citizen's 2nd Amendment Rights. Instead, our public servants should be working to firmly protect the basic, fundamental, and enumerated civil right to self defense and take deliberate action toward expanding these critical civil rights for all law-abiding natural born United States Citizen Nationals in Hawaii and California.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





# Stop the Socialistic DOE and ObamaCARE Social-Med

During the recent Fox News and Google presidential debate, Ron Paul opined to the crowd, "You ought to have a right to opt out of the public system if you want." Although he could have been drawing comparisons between Obamacare and European socialized medicine, the congressman was actually referencing America's socialized educational system. It was a brilliant point. Just as the "public option" is merely a different term for socialized medicine, public education is simply a euphemized phrase for socialized education.

In the early 1900s, Horace Mann led a movement to replace America's community and parent-controlled school model with Prussian-style public schools. He believed that free education was a right and demeaned religious institutions that already made education available.

Mann's vision was originally met with strong resistance, as parents were reluctant to cede control of their children's education to government bureaucrats. Ultimately, a compulsory attendance mandate was passed — not unlike the individual mandate found in Obamacare. Shortly afterward, private schools began to close.

Three-time New York City teacher of the year John Taylor Gatto notes that archetypal Americans like George Washington, Abraham Lincoln, and Thomas Edison were leading productive, fulfilled lives by the time they were in their teens, and yet "[t]hey were too unpredictable and insufficiently pliable. What better way to (change this) than by removing children from the steadying influences of their families, and placing them instead in the hands of (free government) schools[?]" Just in case parents were unwilling to comply, the powers that be committed school attendance into law."

However, as we all know, "free education" isn't free, but subsidized through tax levies on all citizens — even those with no school-age children and those who have chosen to educate their children privately. Herein lies the genius of the left: by dictating the funding of government-run education and health care programs, millions of families are left with few alternatives outside the government's control. Although the right to enroll their children in private schools remains, this "right," for all practical purposes, often cannot be exercised due to income limitations. The reality is that many middle- and lower-income families cannot afford to pay taxes towards our public schools while also sending their own children to schools of their choice. The same holds true for health insurance policies — thus, freedom of choice is suddenly available only to the elite and wealthy.

## EATING SPEARS?

Asparagus has got to be one of the oddballs of the vegetable kingdom. The edible parts are called spears which are premature leaves called ferns. They can grow 8-9 inches overnight, emerging out of the ground like mushrooms. Compared to most vegetables, which are annuals meaning they complete their life cycle in a year, asparagus is a perennial. A member of the Lily family, asparagus is related to garlic, onions, and leeks, though bear no resemblance to them.

Asparagus thrives in our Molokai climate preferring 75-85 degree days and 60-70 degree nights found in the upper areas. The winter and spring months are ideal for iflushing spearsí. Nutritionally, asparagus is a good source of Vitamin C and Folate, a B vitamin vital in maintaining and producing new cells, and also contains vitamin A, potassium, phosphorus, and iron. It's great for low sodium diets.

There are many varieties of asparagus. New Jersey's Rutgers University has developed many varieties with "Jersey" in its name, but they appear to be more adapted to colder climates. The appeal of Jersey hybrids are that they're all-male. Male plants are more productive and produce three times more than female plants since they don't spend energy producing seeds. However, the California-developed cultivars have performed better in Hawaii, according to Milton Agader of Twin Bridges Farm, asparagus farmers in Waialua, Oahu. California varieties include Apollo, Atlas, Grande, Purple Passion, and the standard, UC 157.

Although asparagus can be grown from year-old roots, few if any seed companies will ship roots to Hawaii, and there's always the chance of bringing in diseases with the roots. Growing seeds in 4" pots for 3 months, fertilizing regularly with dilute balanced fertilizer, will produce healthy plants. Select only the strongest plants for field planting. California-developed asparagus seed are both male and female. Females will produce skinnier spears, but some gourmet markets prefer these because of the perception that the large ones are tougher.

Asparagus prefers sunny conditions with well drained soil. This is critical. The also prefer alkaline soil in the pH range of 6.7 to 7.5. This means adding lots of sand or lime, which is why they grow well in sand. They don't require lots of water once established. Asparagus can withstand saline water and even salt spray occasionally. Asparagus is fairly disease and insect free if you follow proper cultural management techniques, understanding their likes and dislikes.

In growing asparagus, patience is a virtue and you will be greatly rewarded in the end if you're patient. A healthy asparagus plant can remain productive for 20 years or more if well cared for. It's better to forego the first year harvest, setting the plants up for robust root and vegetative growth. Forcing spears is an art, and you can have many flushes each year especially in the cooler months if you know your plants, the seasons, and when to force them. Weeds can be a big problem, but cutting ferns back and burning the surface is a good sustainable strategy for weed control.

## Peace Prize-? Obama Savages Somalia
