



Traitor Obama Wants YOUR Guns, and he is sneaking to a U.N. Treaty for Enforcement

As Sovereign United States Nationals, we have a responsibility to keep or government agents, including the Usurper Barack H. Obama, working to preserve and defend our right to keep and bear arms and our whole Constitution for the United States of America. But Obama and his socialist cohorts, continue acting unilaterally against We The People infavor of United Nations gun ban treaty that will be used to deny American Citizens their right to keep and bear arms that is guaranteed to us by the 2nd Amendment.

In September, several dozen UN representatives met at the University of Massachusetts in Boston to further discuss their plans for global gun control. Obama was sure to have his administration represented at this meeting.

The final report for the Boston Symposium on the Arms Trade Treaty (ATT) is http://www.mccormack.umb.edu/arms_trade_treaty_conference.php online and states that: "In the end, we seek to achieve an ATT that will establish the highest possible common international standards for the import, export and transfer of conventional arms, including small arms and light weapons, in order to contribute effectively towards peace and stability. This Symposium has brought us one step closer to achieving that goal."

What are there goals for our firearms held by American Citizens in USA?

Obama and the U.N. gun banners are very careful not to publicly post specific anti-gun proposals that would excite the American public against them. But reporters Paul Gallant and Joanne Eisen, and Dave Kopel attended these UN meetings, and report that an Arms Trade Treaty would impose:

- * Microstamping on firearms, increasing the cost of each gun by about \$200;
- * Registration of all firearms, which is a prelude to gun confiscation;
- * Restrictions on gun sales, especially private transfers;
- * Embargoes on firearms and materials (such as nickel and tungsten) that would limit access to many of the firearms which are sold in USA.

You might think: "I don't care what the UN imposes on us, I will never comply with their gun controls." Oh really? So, you'll never buy a new gun from a gun dealer? Because if you do -- and that gun has been manufactured according to UN treaty standards -- then the microstamping technology on that gun will cost you a couple hundred dollars extra, and the signature impressions that the firing pin leaves on your spent cartridge cases will be registered with the government under your name. No problem, who cares if the signature from your firing pin is registered with the government. I am not a criminal.

Criminals could easily implicate innocent gun owners by going to gun ranges, collecting the empty casings and dumping them at crime scenes. And, home based reloading of once fired brass cases would disappear overnight.

Do you still think that a UN treaty won't affect you? The "master minds" at the UN plan to register every firearms sale that passes through a gun dealer and to make illegal any private sale that means of circumventing their controls.

Obama and the foreign UN want to make all firearms subject to international prohibition law instead of our Constitution for the United States of America. The Arms Trade Treaty can: prohibit firearm and ammunition manufacturers from selling to the public, and, Require US citizens to deliver any banned firearms they own to the local government collection and destruction center or face imprisonment.

Clearly, the forces behind the Arms Trade Treaty want the public to be kept in the dark. And, while people are distracted by the elections, the anti-gun zealots are scheming to bulldoze this anti-gun rights treaty into international law. Your ability to protect your family and our Sovereignty could be threatened very very soon. Obama's gun ban conspiracy is moving full steam ahead. Obama has already stacked the courts with anti-gun rights justices who will strike down anyone who contests this assault on our 2nd Amendment Right to keep and bear arms. Obama will make sure Americans become walking targets for thugs and criminals and his socialist tyrants trashing our Constitutional limits on powers delegated. If you think government is overreaching now, see what happens if this treaty is passed.

Crimes of Politicians Must Be Stopped by The People (You are The Militia)





Republic vs. "Homeland Security"

Our Constitution for the United States of America, which is the Law of the Land created by We The People, guarantees each sovereign state of the Union a government in republican form.

Dirty Cops in War on Drugs remain free on bail.

LSouth Carolina, the <<http://www.thesunnews.com/2010/10/08/1740781/ex-eriff-gives-not-guilty-plea.html>>former Lee County sheriff pleaded not guilty st Thursday to 47 new charges in what prosecutors are calling a complex drug nspiracy case. Former Sheriff EJ Melvin resigned in May after he and 11 oth- s were charged with a drug distribution conspiracy. In an earlier indictment, itnesses accused Lee of dealing cocaine from his official vehicle and state ource agents said that they had given Melvin a list of possible drug dealers, only ave him use it to tip off the dealers and plan to get money from other dealers xchange for keeping agents away. The second indictment charges that Melvin used his position as sheriff to enrich himself and others through drug dealing, torted kickbacks, and money laundering. He is now facing one count of con- iracy to distribute more than five kilograms of power cocaine, 20 counts of torting kickbacks from drug dealers, three counts of money laundering, one unt of taking more than \$5,000 in victim assistance funds for personal use, ree counts of lying to state and federal agents, and 18 counts of using a tele- one to facilitate drug trafficking. He faces up to life in prison for the drug con- iracy and between 20 and life for the racketeering counts. Amazingly, he has en allowed to **remain free on bail.**

Some 750 agents were involved in the massive eration, which covered the entirety of the US territory. Those rounded up face arges conspiracy to possess with intent to distribute more than five kilograms cocaine and illegal firearms offences. Prosecutors allege the police officers rovided security for drug dealers at up to \$4,500 a pop. If convicted, the defen- ts face from 10 years to life in prison.
