## Molokai Teachers on Furlough? Special Education Students?

The first of Lingle's Furlough Friday for Hawaii's schools is scheduled for October 23. If nothing happens, it will take place as scheduled. Schools will be closed, parents will either have figured out what to do with their kids on that day.

There may be very little parents can do to stop Lingle's furlough plan. Except for parents of special needs students, that is. The DOE/HSTA negotiations didn't change federal law. Attorney Keith Peck said before a meeting of parents on Thursday that by scheduling these days off, the DOE has "anticipatorily repudiated" IEPs (Individual Education Plans).

How to understand an IEP? An IEP is like a contract. If it is done right, it is an agreement between parents and schools that covers the types and location of services to be delivered to a student for a specific period of time and it identifies the service providers. And it is enforceable in federal court.

It is up to parents to enforce the IEP. They do this usually by calling the school to a due process hearing. At the same time, they may make a motion for "stay put," which means that the DOE must continue providing services that are in the IEP until the matter is resolved.

"Stay put" could keep a school open. This has to be tested. The DOE could, if it chooses to obey Lingle's orders, disobey a "stay put" order and bear the consequences. What consequences? Just as an example, a hearings officer or court might decide that the DOE has failed to deliver on its promise of a free appropriate public education for the student, and let the parent move the student to a private school, at DOE expense. This is assuming that the parent is willing to do that. Many parents say that it's a public education that they want, not a remedy involving private school.

Since due process hearings relate to a single student's education, there would be no effect on the school system in general. Enough of these DP cases, though, could throw a monkey wrench into Lingle's DOE's plans.

Another scenario would be one or more class action suits, asking a federal court to stay the Furlough Fridays. It has been reported that attorney Eric Seitz is doing and it could affect all schools, unlike the action taken by a particular parent. It would be like a very big "stay put" affecting everything.

"They cannot violate the federal law with their state act," said another attorney, who focuses on special education.

Fortunately, the state Department of Education, vows some how to continue educating special needs kids as mandated, despite Furlough Fridays.

"We will provide the services that are required in the Individualized Education Plan," Superintendent Pat Hamamoto said last week. "We are looking in some instances at rescheduling, doing makeups. We will work with the parents and schools on what is the best way to get this accomplished."

Bottom line is that Governor Lingle controls the purse strings, and she has shown little love for public education or for the DOE in the past. Ideology drives her to reject tax increases that might ease the cuts to education and other public services. It's also hard to see how the Legislature could restore funding, since they cannot disburse the funds they might make available.

To minimize the impact on the public, most state offices will close all or portions of their operations on two specified Fridays per month.

Under the plan, in accordance with the new HGEA contract, full-time state employees under the Governor's jurisdiction will be placed on furlough for 18 days for the remainder of fiscal year 2010, beginning October 23, 2009 and continuing through June 30, 2010; and 24 days of furlough for fiscal year 2011, starting July 1, 2010 through June 30, 2011. Part-time employees will be placed on furlough on a pro-rated equivalent basis.

The furlough plan applies to HGEA employees in the Executive Branch including 16 state departments and their attached agencies. In addition, the plan applies to non-union "exempt excluded" employees in the Executive Branch. Exempt excluded employees who have been taking three furlough days per month since Sept. 16, will now conform to two furlough days per month as reflected in the new HGEA contract.

Operations that require round-the-clock coverage due to the clientele they serve and responsibilities they handle will remain operational on a 24-hour basis and will stagger or rotate furlough days. These include Kalaupapa, Molokai and Hale Mohalu Hospital operated for Hansen's disease patients; Hawai'i State Hospital; Hawaii Youth Correctional Facility; correctional facilities and community correctional facilities statewide; and geothermal drilling engineering.

This furlough plan does not apply to the Judiciary, Department of Education, University of Hawaii or the Hawaii Health Systems Corporation.

A pair of real life farmers who want to be hemp farmers joined with hemp industry figures and spokesmen to travel across the Potomac River to DEA headquarters in Arlington, Virginia, where, in an act of civil disobedience, they took shovels to the lawn and planted hemp seeds. Within a few minutes, they were arrested and charged with trespassing.

Hoping to focus the attention of the Obama administration on halting DEA interference, North Dakota farmer Wayne Hauge, Vermont farmer Will Allen, HIA President Steve Levine, hemp-based soap producer and Vote Hemp director David Bronner, Vote Hemp communications director Adam Eiding, and hemp clothing company owner Isaac Nicholson were arrested in the action as another dozen or so supporters and puzzled DEA employees looked on.

"Who has a permit?" demanded a DEA security official. "A permit -- that's what we want from the DEA," Bronner responded.

Although products made with hemp -- everything from foods to fabrics to paper to auto body panels -- are legal in the US, under the DEA's strained interpretation of the Controlled Substances Act, hemp is considered indistinguishable from marijuana and cannot be planted in the US. According to the hemp industry, it is currently importing about \$360 million worth of hemp products each year from countries where hemp production is legal, including Canada, China, and several European nations.

The DEA refused to comment on the action or the issue, referring queries instead to the Department of Justice, which also refused to comment beside pointing reporters to its filings in the ongoing hemp lawsuit.

Currently, eight states -- Hawaii, Kentucky, Maine, Maryland, Montana, North Dakota, Vermont, and West Virginia -- have programs allowing for industrial hemp research or production, but their implementation has been blocked by DEA bureaucratic intransigence. This spring, however, President Obama instructed federal agencies to respect state laws in a presidential directive on federal preemption, but it does not change the DEA laws or their racketeering enforcement.

Farmer Hauge is a plaintiff in a lawsuit challengingly the DEA's interpretation of the Controlled Substances Act. That case is now before the 8th US Circuit Court of Appeals in St. Louis. US Reps. Ron Paul (R-TX) and Barney Frank (D-MA) are sponsoring a bill that would allow farmers to plant hemp in states where it is permitted, and the industry is urging President Obama and the Justice Department to follow their own example on medical marijuana and leave hemp farmers alone as long as they are legal under state law.

But despite all their efforts, nothing is happening. Tuesday's civil disobedience was designed to begin breaking up the logjam.

"We're getting frustrated," said Bronner, president of Dr. Bronner's Magic Soaps, which has been using hemp oil in its soaps since 1999. "This is supposed to be change with Obama, and things aren't changing. We just had the DEA and local DA go nuts on the dispensaries in San Diego where I live. We spent money on a lobbying firm to get a statement from the Justice Department along the lines of Holder's statement on medical marijuana, but nothing is happening. This would be easy to do, but it's not happening. We understand that Obama has a lot going on, but we're getting increasingly disappointed and frustrated. We hope this will help catalyze something in this administration."

"We're like the fired-up hempsters, we're keeping Jack Herer's ideas alive," said Eiding, still fired up a day after his arrest Tuesday. "We're beginning a new chapter of hemp activism, and there needs to be a lot more. Civil disobedience has to be part of a comprehensive campaign in the courts, in Congress, and out on the streets, in front of DEA offices all over the country."

"We've passed a law in Vermont that you can grow industrial hemp," said Allen, the white-haired, pony-tailed proprietor of the certified organic Cedar Circle Farm. "The only barrier now is the DEA, so we're trying to convince them to back off. Here, we have a crop that isn't going to get anybody high. We grow organic sunflower and canola, and we'd like to have another oil crop in rotation at our location. It just makes economic sense, and it's a states' rights thing. The DEA should NOT be involved in this; this isn't a drug."

"We want to get some attention for the cause and show the distinction between industrial hemp and marijuana," said North Dakota farmer Hauge, who is licensed by the state to grow hemp and who is a plaintiff in the lawsuit against the DEA now before the 8th US Circuit Court of Appeals. "It's not a drug; it's just another crop that can be grown in rotation. If it wasn't for the DEA, I would be harvesting my crop right now."

"We need industrial hemp here in the US, we need to bring jobs to this country. I'm sick of making all our stuff in China cause that's the only place I can get the raw materials. We sent the message that there is a clear distinction between marijuana and industrial hemp," Nicholson said. "We need the support of our president and our law enforcement branches. They need to understand that the US is missing out on a giant opportunity. The myth that hemp causes any problems in society has been completely dispelled."

Even DEA underlings -- if not their higher ups -- get it, said Nicholson, "One DEA official came out and said, 'What's the connection between weed and hemp?' and we said, 'Exactly.'"

As the hemp movement indeed adopts further civil disobedience actions, it will have added another prong to its multi-prong strategy of pressing for the end of the prohibition on industrial hemp planting in the US. It might be time for other segments of the drug reform movement to start thinking about civil disobedience, too.



## Crimes of Politicians Must Be Stopped by The People (You are The Militia)



**Register Now for December ACT Test**  
Registration is now open for the December 12, 2009 ACT achievement test. This date is a great time for seniors to take the ACT before submitting college applications. Students who wish to take the college admission and placement exam must register before November 6, 2009.

The ACT is a curriculum-based achievement exam. It tests what students have actually learned in school, not their aptitude for learning. The ACT also measures what students need to know to be ready for entry-level college-credit courses based on ACT College Readiness Standards™. Every student's results can be tied directly to these consistent standards.

The ACT has four sections — English, mathematics, reading and science — and takes about three hours to complete. Students who take the ACT Plus Writing complete an optional writing test that requires an additional 30 minutes. Unlike other exams, students are not penalized for guessing or answering all the questions on each test section. In fact, it is beneficial for test takers to answer all questions within the time allowed.

During registration, students may select up to four universities to receive their score reports. ACT scores are accepted by all four-year colleges and universities across the United States. ACT reports scores only when requested to do so by the student. Additional score reports are available for a small fee.

All students complete a detailed inventory of questions during ACT registration. Each test taker receives an ACT score report that includes a wide variety of information to assist with high school course selection, college readiness, career planning, and college admissions.

The cost for the ACT test without writing is \$32. When combined with the optional ACT Writing Test, the total cost is \$47. Students who qualify may apply for a fee waiver through their high school counselor.

The ACT website has helpful information, free sample items, and options to order inexpensive test prep materials to assist test takers get ready for the exam. However, the best preparation is to take rigorous core courses in school, study hard, and learn the academic skills needed in college.

Register online at <http://globalmessaging1.prnewswire.com>, or, students may pick up registration forms from their high school counseling; these forms must be postmarked by November 6, 2009. Late registration is available until November 20, 2009 costs extra \$21 fee.
