



Immigration, legal and illegal, must be reduced....but Obama...

On Thursday, tomorrow, the House Judiciary Committee will hold a hearing on Rep. Jason Chaffetz's legislation and King's amendments HC3012 to eliminate country-specific caps on employment-based green cards.

Support King's amendments that would reduce tens of thousands of greencards each year to foreign workers who compete with unemployed Americans for payroll jobs in construction, manufacturing, hospitality and other service industries.

STOP the Obama insanity of bringing in hundreds of thousands of foreign workers each year while 22 million Americans can't find a full-time job.

SUPPORT Rep. Steve King's proposed three amendments to this bill that would reduce the number of visas available to lower-skilled immigrants. These amendments are: An amendment to eliminate the 10,000 visas for unskilled employment-based immigrants, and reduce employment cap by 10,000 to 130,000.

An amendment to eliminate the 3rd Preference for employment-based immigrants and reduce the employment cap by 40,000 to 100,000. The 3rd Preference includes workers with at least two years of job experience, and workers with a bachelor's degree in a "profession" -- in other words, not a whole lot of skill.

An amendment to eliminate the sibling category and reduce the family preference cap by 65,000 visas to 415,000.

Attention Divers: Lahaina Roi Roundup Spear Fishing Tournament November 6


LAHAINA, MAUI -- The popular "Roi Round-up" Spearfishing Tournament, which first took off on Maui in 2008, is taking place this year in La'haina on Sunday, November 6th. The purpose of the event is to remove invasive fish from the Valley Isle's reefs, including roi or peacock grouper, to'au or blacktail snapper, and ta'ape or blue-line snapper. All three species were introduced to Hawaiian waters in the 1950's. Approximately 60-80 divers will be competing for top honors in several categories, including Most Fish, Largest Roi and Smallest Roi.

Founders and organizers of the Roi Round-up include Brian Yoshikawa of Maui Sporting Goods, local Maui fisherman Darrell Tanaka and his wife Jackie, Stuart Funke-d'Egnuff of Tri-Isle RC&D, and Ku'hea Paracuelles, a local conservation professional.

The official weigh-in begins at approximately 11 a.m. as the divers return to the Hard Rock Café located on Front Street in La'haina. A formal program, including the presentation of awards, will follow beginning at 1 p.m. The restaurant will remain open to the public and patrons are welcome to partake in the event's festivities.

The event organizers pledged to never let any of the fish caught in these tournaments go to waste. In the past years, they have been donated to the Maui Ocean Center in Ma'a'alaea to feed the marine life or donated to an organic farmer for use as fertilizer. Samples of roi are also collected by the State Division of Aquatic Resources to be used in ciguatera research.

The deadline to enter the November 6th tournament is Monday, October 31st. Entry forms are available at Maui Sporting Goods in Wailuku or can be obtained by request via www.roiroundup@gmail.com



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Obama Birth Certificate case and Sen. Marco Rubio have similar eligibility problems: Not being Naturalborn Americans, says birther Orly Taitz

Prominent birther, Orly Taitz recently met with Sen. Rubio's staff during a visit to Washington. "We need the court to finally adjudicate this issue, who is a natural born citizen," Taitz, a California dentist and lawyer declared.

Yesterday I was interviewed at length in regards to Marco Rubio and other issues by Alex Leary, reporter from St. Petersburg times. I have to say, that he was very well informed and respectful during the interview, far outcry from many other reporters and I will continue my dialog with this reporter on a number of other issues. Here is an important Constitutional conundrum, relating to Rubio's eligibility: Does a child of political refugees, who can't go back to his parents country of origin, have split allegiance and ineligible to be the US president? I believe, that this issue needs to be taken by the Supreme Court and adjudicated, as it is an important Constitutional question.

The whole premise of Emer De Vattel, is the child follows the citizenship of his father. Based on this premise a child of a tourist or a foreigner, whose father was here on a student visa, retains citizenship of his father and therefor has split allegiance at birth. This is true not only for Obama, but also true in relation to Bobby Jindal, governor of LA, rumored to be a presidential or vice presidential material on Republican side. The question is, what happens, when a child is born in the US to refugees, who can't go back to their country of origin.

For example, a child born to political refugees from Nazi Germany during World War 2? I remember, when we left the Soviet Union, Soviet authorities took away our passports and tore them up in our presence. I remember, that my little brother didn't even have a passport, he was simply a one line notation in my mom's or my dad's torn passport. Even if a political dissident from the Soviet Union or his child born in the US ever wanted to go back, he couldn't do that, as he no longer had a Soviet citizenship. (for the record, I never heard of any political dissident, who ever wanted to go back to the Communist Soviet Union).

Rubio's parents were political refugees from Cuba. Rubio was born after the Bay of Pigs. So, this issue needs to be adjudicated by the Supreme Court. To an extend, it can help adjudicate this issue once and for all. I will forward this article to Mr. Collins, Rubio's chief legal counsel and Mr. A.J. Sanchez, Rubio's legislative counsel and will ascertain, if Marco Rubio is willing to bring this issue to court and seek adjudication. Indirectly it will help solve the eligibility conundrum not only in regards to Rubio, but also in regards to Barack Obama. In such legal action we would be able to air all issues: not only the issue of constitutional eligibility based on the split allegiance, but also the issues of necessary disclosures and releases of the original birth records, that are being kept sealed under lock and key by officials of the state of Hawaii.

To an extend this issue is similar to Roe v Wade, in that it is a recurring issue that is eluding adjudication. As such, Rubio is a perfect plaintiff to bring this issue to court and seek expedient review on the merits. Orly Taitz



Consequently, Homeland Security Secretary Janet Napolitano has announced that through the use of "prosecutorial discretion" she has effectively given license to illegal aliens to work here in America without fear of deportation. Presumably, they would merely have to vote for Obama and his party next year in return.

Since even the cooked books cannot hide a 9.1 percent unemployment rate and an economy in which at least 14 million American citizens are looking for work, what other explanation could there be?



The next time Usurper Obama feigns concern over the national deficit, Americans should ask him why he does not take a simple step that would free up \$1 trillion a decade, assure his social spending went to his fellow countrymen, and allow one of our allies to rebuild its traditional way of life: He could just deport every illegal immigrant in the United States to cut the welfare bill.

The facts are out: deportation would be considerably less expensive than the unsustainable influx of illegal aliens who all-too-readily enroll in our entitlement programs. On December 3, DHS Security, Nelson Peacock, responded to senators about the costs of deporting all illegal aliens. "Our conservative estimate suggests that ICE would require a budget of more than \$135 billion to apprehend, detain and remove the nation's entire illegal immigrant population," he wrote.

The report assumed "20 percent of the current population [of illegals], or 2.16 million people, would depart before any contact with authorities," that is, they would voluntarily self-deport. The residue would cost \$200 billion to deport. The Center padded the total with another \$85 billion to hold the line for five years.

The Fiscal Burden of Illegal Immigration on U.S. Taxpayers, \$113 billion every year in benefits at the local, state, and federal levels combined.

Under the most liberal estimate, the five-year cost of deporting every illegal immigrant in the United States would pay for itself in 2.5 years. It would be just 14 months according to ICE. Over ten years, the United States would save \$1.13 trillion.

These estimates, of course, only tally economic savings to the government. They do not reflect the substantial economic and personal well-being each American will experience from lower rates of drug trafficking, murders, gang activity, kidnappings, sexualassaults, crime, homeinvasions, overcrowded schools, hospital closures caused by soaring medical costs, job losses, prison detentions, bilingual status, property damage, environmental degradation, and overburdened infrastructure. Obama DREAM Act, would squeeze native-born citizens out of competitive slots in universities and careers; deporting them, as I have suggested, would open up educational and employment opportunities for our own citizens. These benefits are truly incalculable, yet they are never mentioned.

Some may object that deporting 11-13 million illegal immigrants is impossible. History proves not only that it can be done but that it has been done. The most significant effort took place in 1954, when President Eisenhower commenced "Operation Wetback" to deport the illegal immigrants - then as now, mostly from Mexico - whose numbers had grown 6,000 percent in ten years.

President Ike turned the plan over to the commissioner of the Immigration and Naturalization Service (INS), General Joseph Swing. The two generals cleaned house in three months: deported 80,000 illegal immigrants from Texas. Nearly ten times that many illegals (700,000 to be precise) voluntarily left the Lone Star State, with perhaps another half-million self-deporting from Arizona and California. Instead of dumping them at the nearest border town, INS agents shipped them by train or boat deep into the interior of Mexico, to places like Vera Cruz.

Ike's operations solved the problem of cheap illegal labor until the mid-1960s.






