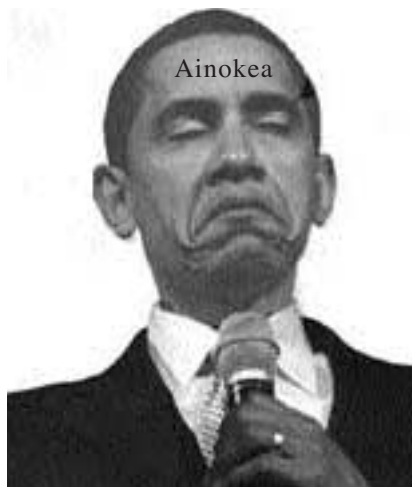

Dictator Obama Declares National Emergency for USA:



Swine Flu Pandemic !??

Friday, October 23, 2009, U.S. dictator Barack Obama aka Barry Soetoro, declared the swine flu outbreak a national emergency, giving his health chief extraordinary non-Constitutional powers.

WTF?!! Just last week the Secretary of HHS Sebelius was on cable news 10-20-09, announcing that the "Swine Flu pandemic" is peaking this week, and the rushed-to-market, un-safety tested, uninsurable vaccines will not be widely available in time to "prevent" the pandemic that was no longer a threat, and we could all relax because there will not be forced vaccination and martial law. Now three days later dictator fraud usurping "President" Obama declares National Emergency? Obama gotta go, end this Obama-nation dictatorship.

Obama Administration officials said the emergency declaration was a pre-emptive move designed to make decisions easier when they need to be made if mandatory vaccinations are ordered, and quarantine for those who refuse.

Health and Human Services Secretary Kathleen Sebelius now has authority to bypass federal rules when opening alternative care sites for vaccinations and quarantine centers for people who refuse the dangerous vaccine.

The national emergency declaration was the second of two steps needed to give Sebelius extraordinary powers during a crisis.

"As a nation, we have prepared at all levels of government, and as individuals and communities, taking unprecedented steps to counter the emerging pandemic," Obama wrote in Saturday's declaration.

He said the pandemic keeps evolving, the rates of illness are rising rapidly in many areas and there's a potential "to overburden health care resources."

Here is gist of the report by AP reporter Philip Elliott issued Saturday 10/24

The declaration, signed Friday night and announced Saturday, says the disease is more prevalent than ever in the USA and vaccine production delays are undercutting the government's estimates that 120 million doses of the vaccine could be available by mid-October.

Health authorities say more than 1,000 people in the United States, including almost 100 children, have died from the strain of flu known as H1N1, and 46 states have widespread flu activity. So far only 11 million doses have gone out to health departments, doctor's offices and other providers, according to the Centers for Disease Control and Prevention officials. Hawaii DOH is shorted.

The government now hopes to have about 50 million doses of swine flu vaccine out by mid-November and 150 million in December. The flu virus has to be grown in chicken eggs, and the yield hasn't been as high as was initially hoped, officials have said. "Many millions" of Americans have had swine flu so far, according to an estimate that CDC Director Dr. Thomas Frieden gave Friday. The government doesn't test everyone to confirm swine flu so it doesn't have an exact count. He also said there have been more than 20,000 hospitalizations.

Underage Alcohol Drinking Meetings Conducted by Maui County

November 19th @ Mitchell Pauole Center, Kaunakakai

Maui County will conduct town hall meetings to discuss and raise awareness of the problem of underage drinking. Department Housing & Human Concerns, and the Maui Police Department, in collaboration with the State Alcohol & Drug Abuse Division (ADAD) is sponsoring these meetings.

Parents, teachers, officials, youth and other community members will be educated about the impact that underage drinking has on the community, and they will develop possible ways to address this issue.

These town hall meetings will serve as a means to increase community awareness on the issue of underage drinking, identify how underage drinking affects the community, and brainstorm possible solutions. Meetings will provide an opportunity for parents, teachers, officials, youth and other community members to voice their concerns and suggest ideas for preventing young people from using alcohol.

Last year, Maui Police Department juvenile investigators made at least 88 arrests for underage drinking. Each day, 7000 children in the U.S. under the age of 16 take their first drink. 48 percent of persons aged 12 and over in the U.S. are drinkers this translates to an estimated 109 million people. Drinking and driving accidents are the number one cause of death among teenagers. More than 12,000 young Americans are killed each year in accidents involving young people and alcohol. Forty thousand Americans are disfigured each year in accidents involving young people and alcohol.

Education is an extremely important part of the treatment of underage drinking. Teens rarely understand the dangers of drinking alcohol. They need to be educated about the health risks they face when they drink. Sometimes teens feel risks don't apply to them because they feel they are invincible, or in total control of themselves and actions.

Any interested individual, families, schools, agencies, organizations and businesses are encouraged to attend. Each of these town hall meetings will include information on the possibility of funding to assist with the problems of underage drinking. Meetings are free and open to the public.

Father Damien to Sainthood

TREMELO, Belgium - Belgian royals and government officials joined the bishop of Honolulu at a Mass on Sunday to celebrate a 19th-century local hero, a week before he will become a saint for his work with lepers on the Hawaiian island of Molokai from 1873 to 1889, when the disease killed him. Hawaii's King Kamehameha V to place sufferers in isolation on Molokai's Kalaupapa peninsula, an area devoid of any amenities until Father Damien's arrival.

The Mass and a day of celebrations lured 20,000 people to this town of 14,000, just northeast of Brussels, where Jozef De Veuster was born in 1840.

The Catholic Church agreed to elevate him to sainthood after Audrey Toguchi of Aiea, Oahu, was cured of terminal cancer apparent miracle since there was no medical explanation. Toguchi said she prayed to Damien and he cured her.

Pope Benedict XVI is due to preside over Damien's canonization. The late priest was beatified - a step toward sainthood - in 1995 by Pope John Paul II. Several elderly Kalaupapa patients will be at the Vatican to watch the canonization.

Toguchi, a retired public school teacher, spoke briefly about her cancer at Sunday's Mass, which was celebrated in Dutch and English. It was attended by King Albert and Queen Paola of Belgium, government members and Bishop Clarence Richard Silva of Honolulu.

"It is an honor to be one of the chosen ones," said Ms. Toguchi, who was part of a Hawaiian delegation. "I feel that he (Father Damien) is offering hope to the rest who also need help. More and more people will ask him for an intercession."

The Mass was conducted by Archbishop Godfried Danneels in Ninde, the birthplace of Father Damien, now part of Tremelo.

There is a statue of Father Damien at the U.S. capitol in Washington and a full size replica stands in front of the Hawaii State Capitol.

Obama Prohibits Christ in Christmass?

Arizona was chosen this year to present 4,000 handcrafted ornaments made by elementary, middle-school, and high-school students to decorate Washington, D.C.'s annual Christmas tree. Official guidelines for the ornaments include specifications, and the directive that "Ornaments cannot reflect a religious or political theme [no Jesus Christ this Christmas] Instead share your interpretation of our theme 'Arizona's Gift, from the Grand Canyon State.'"

But, that is not acceptable to American christians. Legal demands came after a student expressed a strong desire to submit three religious ornaments for the tree: One reading "Merry Christmas," another "Happy Birthday, Jesus," and the third portraying a manger scene with the Christ child.

Each of these ornaments will also honor Arizona, using as a theme the state's history, geography, or motto, "Ditat Deus," which means "God Enriches."

Attorneys with the Alliance Defense Fund (ADF) called on Arizona state and federal officials on Monday to stop enforcing a requirement prohibiting the state's schoolchildren from expressing religious viewpoints through Christmas themes while decorating ornaments for the 2009 Capitol Christmas Tree.

In a letter to federal and state officials, including Arizona Governor Janice Brewer, ADF attorneys wrote: "Banning Christmas from the Capitol Christmas tree is just absurd. Christian students shouldn't be discriminated against for expressing their religious beliefs," said ADF's Jonathan Scruggs.

"The First Amendment does not allow government officials to exclude schoolchildren's ornaments for the capitol's Christmas tree merely because they communicate a religious viewpoint."

ADF attorneys indicate in the letter that they will take legal action if officials do not comply. "It is well established that expression of religious beliefs is protected by the First Amendment of the U.S. Constitution," the letter reads. "Religious expression is speech and is entitled to the same level of protection as other kinds of speech ... even expression that comes through symbols, such as Christmas ornaments."

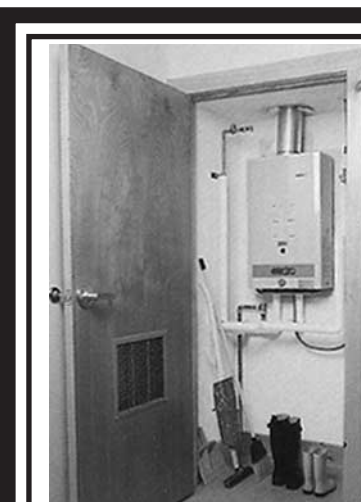



Obama opposes media shield law

The New York Times reports today White House officials told congressional leaders they opposed the legislation pending in the Senate Judiciary Committee that would shield reporters from jail time for failing to reveal sources. Barack Obama's administration White House officials told congressional leaders they opposed the legislation pending in the Senate Judiciary Committee that would shield reporters from jail time for failing to reveal sources. Obama sent to Congress "sweeping revisions" to the bill that "would significantly weaken its protections against forcing reporters to testify."

The current form has provisions requiring prosecutors to "exhaust other methods for finding the source of the information before subpoenaing a reporter, and would balance investigators' interests with 'the public interest in gathering news and maintaining the free flow of information.'"

But under the administration's proposal, those procedures would not apply to leaks of a matter deemed to cause "significant" harm to national security. Moreover, judges would be instructed to be deferential to executive branch assertions about whether a leak caused or was likely to cause such harm.

Maybe Obama can have reporters sent to RENDITION torture in foreign countries to make them divulge their sources of leaks on corruption ??
