**Police Power is for The People**

The police power stated in the PREAMBLE to the Constitution for the United States of America is the Authority of the People to enforce the law.

WE THE PEOPLE of the United States, in Order to form a more perfect Union, establish Justice, insure domestic Tranquility, provide for the common defence, promote the general welfare, and secure the Blessings of Liberty to ourselves and our Posterity, do ordain and establish this Constitution for the United States of America.

This is the statement of the POLICE POWER where "Polis" means the inhabitants of the land who know what they want and intend to enforce it by whatever means necessary.

The difference between a republic form of government, and other forms of government [monarchy, dictatorship, kingdom, socialist/communist] is that every Citizen in an egalitarian republic is an equal Citizen. Those not vested with such power have no authority to exercise the law. ALL CITIZENS are Civil Officers and a constituent element of the state having equal right to administration of affairs of government at their descretion. Civil servants are employees paid for administration of affairs of government and have inferior authority and powers in their capacity as civil servants.

Such things as claiming JURISDICTION to speak law or, literally, dictate justice depend upon being a Citizen; and, in the legal practice which has dominated our judicial system you are called upon to STATE your status or forfeit it.

If you are one of the people of the United States as mentioned in the Preamble, and if you make suit in a court of record, then the Constitution authorizes the judicial power of the United States in all suits at common law.

**Lawful gun ownership lowers violent crime**

I am writing on behalf of Lessons In Firearms Education, a nonprofit service club of NRA-certified basic firearms safety instructors.

The state attorney general's report of a 60 percent increase in gun registrations in Hawaii from 2000 through 2007 should be viewed as a good sign of sovereignty and self government. Unfortunately, one Meda Chesney-Lind, University of Hawaii criminologist, opined that "Any time you increase the number of guns in the community, you increase the likelihood of higher suicide rates and higher homicide rates," but she is wrong. U.H. "experts" has a history of false and misleading politically correct statements, e.g. Chip Fletcher says seawalls cause beach erosion, which is also false, but is adopted by State.

Research on U.S. communities shows that suicide rates remain unchanged and violent crime decreases in communities where lawful gun ownership increases. Data from the Hawaii State Department of Health show Hawaii suicide rates have declined 18 percent from 2000 to 2006 during the same period the AG reports a 60 percent rise in gun registrations; and, Hawaii homicide rates, according to the FBI Uniform Crime report, dropped 45% at the same time.

# Killer-Cop Walks in Ohio Drug-SWAT Raid Shooting by Blaming the Victim

An all-white jury found Lima, Ohio, Police Sgt. Joe Chavalia not guilty on all counts in the January shooting death of 27-year-old Tarika Wilson during a January SWAT team raid on the home of a low-level crack cocaine dealer who was her live-in boyfriend. Wilson was shot and killed as she cowered at the door of a second-floor bedroom holding her infant child, Sincere Wilson, in her arms. The child was also hit; he had a finger amputated because of his wounds.

In the midst of community outrage over the killing of Wilson, whose five other children were in the bedroom behind her, Sgt. Chavalia was indicted in her death -- but only on misdemeanor charges. He faced a maximum of eight months in prison if found guilty in her killing.

During his testimony at the trial, Sergeant Chavalia said that he believed his life was in danger when he entered the home and saw a "shadowy figure" down the hallway at the same time that he heard gunshots. He then opened fire, killing Wilson. Testimony at the trial determined that the gunshots Chavalia heard were in fact fired by two other SWAT team members, who were murdering two pit bulls on the ground floor.

"There was absolutely, positively no doubt in my mind right then and there that whatever this was is shooting and they're trying to kill me," he told the jury.

Chavalia's attorney, Bill Kluge, waged an aggressive case, even stooping to blaming the victim for getting herself killed. Wilson had chosen to live with a drug dealer, he said, and she had failed to identify herself to the yelling intruders who broke down her door.

"Why would she put those children in that position? I don't know the answer to that," Kluge said. "Love is a strange thing."

After hearing 3 1/2 days of testimony in the case, the jury deliberated for three hours before clearing Chavalia.

"We're supposed to take this with a smile? We're supposed to believe in justice?" asked an incredulous Ivory Austin II, Wilson's half-brother, in remarks reported by the Toledo Blade.

"We've got to do better. We've given people the license to kill," Jason Uptegrove, president of the Lima chapter of the NAACP, said afterward.

The Rev. Arnold Manley, pastor of Pilgrim Rest Baptist Church, told the Blade he came to the trial to see justice prevail but that did not happen. "As a pastor, I'm hurt deeply that we can walk away from this and say justice has been done," he said. "How do I go out to tell the people on the streets, 'Let the law prevail'? How do I say that? White man justice. Black man grief."

Darla Kaye Jennings, grandmother of Sincere Wilson responded to Lima's "white man justice" by filing a federal civil rights lawsuit against Chavalia and the city of Lima the day after the verdict was announced. The lawsuit asks for compensation for Sincere's injuries as well as an end to "police abuse by requiring that high risk search warrant executions be limited to situations where they are truly needed and where the least amount of force necessary to the situation is employed."

According to the lawsuit, the shooting that led to Wilson's death and her son's injuries was "excessive, unreasonable, and completely unnecessary." The lawsuit further said that Sergeant Chavalia acted "negligently" when he used deadly force.

Another killer cop has walked. But perhaps the city of Lima will learn a hard lesson when it is forced to pay for its misdeeds.

## MPD DARE Cops Practice Assault



## Maui Police Commission, MPD Cowards, Sneak Into Molokai for “Public” Meeting, Announce Transfer of Caparida to Maui for More DRUG War Tyranny Training

Without notice to The MAN, Molokai's longest lived ever local newspaper, the Maui Police Commission sneaked into Molokai for a “public” meeting to update the community about the Police Department's activities, and maybe hear from Molokai residents about their concerns, providing there is no criticism of MPD, of course. The Dispatch, a sycophant to MPD fascists apparently was notified and two weeks later reporter Marie Nowell wrote that this was the “first appearance [of Maui Police Commission] on Molokai since a resident [George Peabody editor of The MAN] attempted a citizen's arrest on an officer [Chief Thomas Phillips] five years ago. This year's meeting went notably smoother.”

Chief Phillips said he wants Molokai residents to “work with police, having a partnership to help resolve issues.” Obviously that mission does not include bringing him to justice for his crimes with a trial by a Molokai jury.

Chief Phillips' bragged again about MPD's federally funded Green Harvest marijuana eradication missions that bring in big bucks to MPD, and property seizures which we know are used for bogus MPD Employee Development at the rate of \$25,000-50,000 per month. He also announced that MPD employee Stafford Caparida, an aspiring drug warrior, is transferred to Maui to work in the drug busting department.

After learning of the secrete Maui Police Commission meeting, George Peabody wrote a letter to officer Eugene Santiago to complain and express his disappointment in being excluded. He wrote in part the following:

Hi Eugene: it was real cowardly for MPD and MPC not to inform me that the Maui Police Commission was going to hold a meeting on Molokai where I could have presented for the MPC public record my recent complaints against MPD employee Caparida, MPD Policies, MPD training, MPD violations of Constitution for the united States of America, and once again declare Chief criminal Thomas Phillips under Citizen's Arrest to be brought to trial where the facts regarding the charges against him would be heard and his defenses if any weighed by a Molokai jury. Now I will just have to send my complaints by letter to MPC, whose members will, as they have done before, corrupt the record so as to cover up the criminal complaints against MPD employees and the commissioners themselves and their recording secretary. Its a felony to corrupt the record, but so what, the cops and prosecutors are in on the fraud, too, so no worry.

There are others who fear MPD, court system abuses, prison guards, just as do I, but for different reasons. Obviously that is the way Phillips and his gang, prosecutors and judges want their relationship with civilians to continue to be.
