Molokai's Aloha Festivals Parade Na Paniolo Nui O Hawai'i • The Great Cowboys of Hawai'i

More than four decades of the annual fall Aloha Festivals statewide celebration culminated on Molokai with this year's theme: Na Paniolo Nui O Hawaii. The Great Cowboys of Hawaii were honored with floats, pa'u, horse and walking units. This year's Royal Court with Dean and Claire Place reigned over the festivities. Grand Marshall Jimmy Duvauchelle, Molokai Ranch's Paniolo Nui and his outriders led the horse units. The Purdy Ohana carried banner and led riderless horse in honor of 1908 Paniolo Nui Ikua Purdy, whose rodeo performance record he earned in Cheyenne, Wyoming still stands. Kalae's Buzzy Sproat and his son, also represented Na Paniolo Nui. Pau units representing each major island were graceful and poised on beautiful horses, draped in beautiful lei. Floats honored Na Paniolo Nui O Hawai'i including the Sakadas, whose 100th anniversary year is also being celebrated.



**War UPDATED: US Lost Command?
NATO takes command of US. military in Afghanistan !!!
MAKAALA VETS !! Can an American soldier be forced to serve
a foreign power? American sovereignty hangs in the balance!**

NATO assumed command of security across the whole of insurgency-hit Afghanistan last week Thursday when it took command of about 12,000 U.S. troops.

Violence has surged in Afghanistan this year to its most intense since U.S.-led forces ousted the hard-line Taliban five years ago.

"This is a momentous day that again signifies the absolutely unshakable commitment of NATO to Afghanistan, both militarily and politically," the top NATO civilian official in Afghanistan, Daan Everts, told a news conference.

The Afghan mission is the alliance's biggest ground operation in its history. The transfer of U.S. troops is the biggest deployment of U.S. forces under foreign command.

President Hamid Karzai attended a change-of command ceremony at NATO's Kabul headquarters, as U.S. and NATO troops stood to attention and a U.S. coalition flag was lowered and a NATO force flag raised to signify the transfer of command

**MIKE NEW REFUSES Foreign Uniform
When is obedience to an order treason?

On October 10, 1995, the 1/15 Battalion of the 3rd infantry Division of the U.S. Army came to attention at 0900 in Schweinfurt, Germany. All but one of the 550 soldiers were wearing a sky-blue baseball-style cap with a United Nations insignia on the front. One was wearing the olive-drab flat cap that is authorized to be worn with the Battle Dress Uniform. With this simple act of disobeying a direct order, Spc. 4 Michael New set the stage for a legal battle that has profound implications for the future of American soldiers into service of the United Nations without the constitutional permission of Congress.

**New Detainee Measure "Allows Indefinite
Detention of U.S. Citizens"**

26 Sep 2006 -- In recent days, the Bush regime and its House allies successfully pressed for a less restrictive description of how the government could designate civilians as "unlawful enemy combatants," government sources said yesterday. As a result, human rights experts expressed concern yesterday that the language in the new provision would be a precedent-setting congressional endorsement for the indefinite detention of anyone who, as the bill states, "has engaged in hostilities or who has purposefully and materially supported hostilities against the United States" or its military allies. The definition applies to foreigners living inside or outside the United States and does not rule out the possibility of designating a U.S. citizen as an unlawful combatant.

Kate Martin, director of the Center for National Security Studies, said that by including those who "supported hostilities" -- rather than those who "engage in acts" against the United States -- the government intends the legislation to sanction its seizure and indefinite detention of people far from the battlefield.

AIR FORCE CHIEF says: Test Weapons On Unruly Americans

Nonlethal weapons such as high-power microwave devices should be used on American citizens in crowd-control situations before being used on the battlefield, the Air Force secretary said Tuesday.

Domestic use would make it easier to avoid questions from others about possible safety considerations, said Secretary Michael Wynne. "If we're not willing to use it here against our fellow citizens, then we should not be willing to use it in a wartime situation," said Wynne. "(Because) if I hit somebody with a nonlethal weapon and they claim that it injured them in a way that was not intended, I think that I would be vilified in the world press."

Global Research notes that this report suggests that the so-called non lethal weapons which are electromagnetic devices are to be used both in war theaters, against civilians, as well as an instrument of "Domestic Security", directed, for instance, against demonstrators and antiwar activists.

The object is basically public relations. Domestic use would make it easier to avoid questions from others about possible safety considerations, said Secretary Michael Wynne.

"If we're not willing to use it here against our fellow citizens, then we should not be willing to use it in a wartime situation," said Wynne. "(Because) if I hit somebody with a nonlethal weapon and they claim that it injured them in a way that was not intended, I think that I would be vilified in the world press."

The Air Force has paid for research into nonlethal weapons, but he said the service is unlikely to spend more money on development until injury problems are reviewed by medical experts and resolved.

Nonlethal weapons generally can weaken people if they are hit with the beam. Some of the weapons can emit short, intense energy pulses that also can be effective in disabling some electronic devices.

On another subject, Wynne said he expects to choose a new contractor for the next generation aerial refueling tankers by next summer. He said a draft request for bids will be put out next month, and there are two qualified bidders: the Boeing Co. and a team of Northrop Grumman Corp. and European Aeronautic Defence and Space Co., the majority owner of European jet maker Airbus SAS.

The contract is expected to be worth at least \$20 billion (?15.75 billion).

Chicago, Illinois-based Boeing lost the tanker deal in 2004 amid revelations that it had hired a top Air Force acquisitions official who had given the company preferential treatment.

Wynne also said the Air Force, which is already chopping 40,000 active duty, civilian and reserves jobs, is now struggling to find new ways to slash about \$1.8 billion (?1.4 billion) from its budget to cover costs from the latest round of base closings.

He said he can't cut more people, and it would not be wise to take funding from military programs that are needed to protect the country. But he said he also incurs resistance when he tries to save money on operations and maintenance by retiring aging aircraft.

"We're finding out that those are, unfortunately, prized possessions of some congressional districts," said Wynne, adding that the Air Force will have to "take some appetite suppressant pills." He said he has asked employees to look for efficiencies in their offices.

The base closings initially were expected to create savings by reducing Air Force infrastructure by 24 percent.

Hawaii Court Restrains Health Dept. TB Skin-Testing: Student Wins Religious Freedom and School Access

Hilo, HI -A Judeo-Christian minister's daughter won her freedom to return to public school today by order of the Third Circuit Court of Hawaii after being expelled for more than a month. The 14-year-old was ordered to homeschool by health officials due to her family's religious conviction to abstain from TB skin testing and vaccinations.

The restraining order, which has an immediate effect on the Dept. of Health and Dept. of Education in Hawaii, sends a message nationally, as a victory for religious freedom and body sovereignty.

Alena N. Horowitz, a straight "A" student, Varsity athlete, and author of a children's book extolling the virtues of love and natural healing, was effectively "quarantined" from Hilo High School in early September for failing to comply with the State's TB skin testing mandate. The expulsion violated several state and federal laws according to the meritorious complaint scheduled for preliminary hearing on October 12.

Like Rowe vs. Wade, the outcome of this controversial action may set a national precedent restoring choice and religious freedoms increasingly violated or restricted nationally by health department officials that demand TB skin tests and vaccinations for employment or school admission.

Judge Elizabeth A. Strance ordered Dept. of Health officials and school administrators to cease harming the student while the case moves through the courts. "It is further ordered that defendants desist and refrain from denying admission to Alena N. Horowitz to Hilo High School classroom and extracurricular activities."

The court's decision may help determine how far health officials can go in curtailing civil rights and religious freedoms while administering to public health risks in an age of bioterrorism and threatened outbreaks.

In Hawaii, TB skin testing authorities have misrepresented the threat of an outbreak, and claimed no religious exemptions exist for the TB test. To the contrary, state laws evidence allowable religious exemptions and, in fact, TB levels statewide have remained nearly the same low risk level since the legislation took effect in 1996.

Drug War: New York Government thugs handcuff children, kill dog during \$60 marijuana raid

September 20 article in the *Times Union* in Albany, New York:

A police strike team raided a woman's Prospect Street apartment and handcuffed her children and killed her dog early Tuesday in a \$60 pot bust. The woman called it excessive force and a case of mistaken identity, but officers said they stormed the home for a good reason: One of her sons was selling marijuana there.

The Police Department's tactical squad knocked down the front door of the upstairs apartment at 110 Prospect St. and flooded into the apartment shortly after 6 a.m.

"I heard a big boom. My first reaction was to jump out of bed. We were trying to find where our kids were at and all of a sudden we had guns in our faces," said 40-year-old Anita Woodyear, who rents the second-floor flat.

During the ensuing chaos, police handcuffed two of the woman's children, Elijah Bradley, 11, and 12-year-old Victoria Perez, and shot at her dog in the kitchen before killing it in the bathroom, Woodyear said.

Woodyear said she suspected police had intended to search a neighboring home, but had the wrong address on the search warrant. Neighbors said they suspect illicit drugs are dealt at other homes on the block. "No apology, no 'sorry about your dog'," she said.

But police said they have no reason to apologize. They said they raided the house because Woodyear's 18-year-old son, Israel M. Bradley, sold three plastic bags of marijuana there for \$40 on Sept. 15. They allege he sold two other bags of marijuana in the house for \$20 on Aug. 28, they said. In addition, police said Bradley was carrying marijuana in the home on Sept. 1. "We had the absolute right house. We had the absolute right target," said Assistant Chief Michael Seber.

Who do the police think they're helping by breaking down the front door of a family's home, pointing guns in their faces, murdering their dog, and handcuffing the children? Was this for the good of the children? The mother? The neighborhood?

No one wins except perhaps for the government thugs who get jacked up on the adrenaline rush that comes from threatening and persecuting others.





Terror List Loaded with ERRORS: maybe YOUR name is on it?

Mistaken IDs abound on terror list, and GAO report says thousands affected
Thousands of people have been mistakenly linked to names on terrorist watch lists when they crossed the border, boarded commercial airliners, or were stopped for traffic violations, a government report said.

More than 30,000 airline passengers have asked one agency, the Transportation Security Administration, to have their names cleared from the lists, according to the report by the Government Accountability Office that was released Friday.

Hundreds of millions of people each year are screened against the lists by Customs and Border Protection, the State Department, and state and local law enforcement agencies. The lists include names of people suspected of terrorism or of possibly having links to terrorist activity.

"Misidentifications can lead to delays, intensive questioning and searches, missed flights, or denied entry at the border," the report said. "Whether appropriate relief is being afforded these individuals is still an open question."

When questions arose about tens of thousands of names between December 2003 and January 2006, the names were sent back to the agencies that put them on the lists, the GAO said. Half of those were found to be misidentified, the report found.

In December 2003, disparate agencies with counterterrorism responsibilities consolidated dozens of watch lists of known or suspected terrorists into the new Terrorist Screening Center run by the FBI.

People are considered misidentified if they are matched to the database and then, upon further examination, are found not to match. They are usually misidentified because they have the same name as someone in the database.

People are considered mistakenly listed if they were put on the list in error or if they should no longer be included on the list because of subsequent events, the report said.

Problems developed with the watch lists after Sept. 11, 2001.

Maher Arar, a Canadian software engineer, was detained at New York's Kennedy International Airport in 2002 because Canadian officials had asked that he be placed on a watch list. The United States transferred him without court approval to Syria, where he was tortured and imprisoned for a year. A Canadian inquiry found that Arar should not have been on the list because he did not do anything wrong.

The no-fly list given to airlines to make sure terrorists do not board airplanes grew exponentially after the attacks on the World Trade Center and the Pentagon.

Children and such well-known Americans as Senator Edward M. Kennedy, Democrat of Massachusetts, were stopped at airports because their names were the same as those on the no-fly list.

The list has contained the names of President Evo Morales of Bolivia and Nabih Berri, Lebanon's parliamentary speaker, according to a report by CBS's "60 Minutes,"
