The gun culture is in the ascendancy in the United States," says gun law expert John M. Snyder, noted as the Gun Dean by Human Events.

"This has tremendous political implications," he adds. "Even though gun prohibitionists have spent tens of millions of dollars trying to undermine the viability of firearms possession in the United States, the opposite is happening. Americans are telling gun grabbers and their organizations to get lost.

"In a recent Rasmussen survey, respondents were asked if they thought a political candidate's professed pro-gun position would be a positive or negative description. Of the 1,000 asked, 39 percent said positive, 27 percent negative, and 30 percent somewhere in between."

Snyder noted, "This information comes on the heels of revelations that while firearms sales have increased about 30 percent a year, rates of violent crime have been decreasing during the last several years.

"Another important factor is the increasing popularity of permits to carry concealed firearms. Forty-nine states now have some form of permits for law-abiding, qualified citizens to carry concealed firearms."

"This all should come as no surprise," said Snyder. "People know that criminals hesitate to run up against armed citizens. One paramedic in southern California, John Longenecker, even suggests that gun ownership by law-abiding citizens can effect a reduction in violent crime similar to the way qualified citizen CPR use has brought about a decrease in the rates of fatalities from injuries.

"In any event, law-abiding firearm owners know that guns in the hands of qualified law-abiding citizens save lives. Such gun ownership is a positive social benefit."

By Obstruction of Justice, Self Defense Becomes Murder ?

The terrifying yet true story of Murder charges against Harold Fish. Mr. Fish was convicted of 2nd degree murder despite staying on site and rendering aid after being forced to shoot a violent attacker.

Had Mr. Fish fled, the remote area where the shooting took place meant he was unlikely to be identified.

Despite the opinion of the police who investigated the crime scene and a mountain of evidence that proved Mr. Fish acted in self-defense, County filed the murder charge. The violent past of the attacker was ruled to be inadmissible by the judge. Then the judge excluded relevant evidence supporting Fish's defense. Thus prejudiced, Fish was judged guilty of murder.

As an honest citizen, Mr. Fish did the right thing by calling the authorities and then putting his trust in the criminal justice system. Instead of finding salvation and legal protection, his decision cost him three years in prison, and likely will bankrupt his family.

That should never happen in America, but in most states self-defense is an affirmative defense, which means the law-abiding citizen is prosecuted for murder and he has to prove the act of self-preservation was legally justified: the honest citizen becomes the criminal defendant, and the criminal who tried to commit a violent crime is considered the victim. Such an outcome is unacceptable, and every American needs to be outraged, judges and prosecutors put into prison for Obstruction of Justice.

Obama-media has furthered the myth that anyone carrying a gun for self-defense is a crazed vigilante. Since millions of Americans are now legally carrying guns, nothing can be further from the truth.

Everyone wants the victim of a violent attack to notify the authorities after a self-defense shooting, but the persecution of Harold Fish will surely make the next armed citizen reconsider the risk of complying with that law.

The truth is if someone like Harold Fish can end up in jail, anyone can. He was simply going about his normal day when a violent attacker forced him into a no-win situation. Then, an anti-2nd Am prosecutor used Fish's choice to exercise the God-given right to bear arms against him.

Thankfully, Mr. Fish won his appeal after three years in prison, and is currently a free man.

The right to keep and bear arms free from infringement by any government agent is guaranteed by the 2nd Amendment's plain words.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

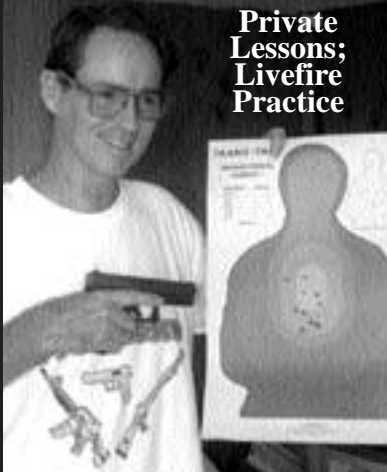

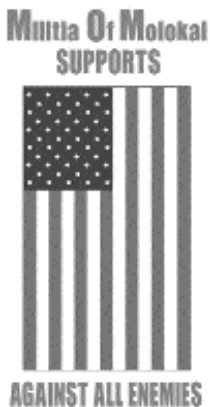

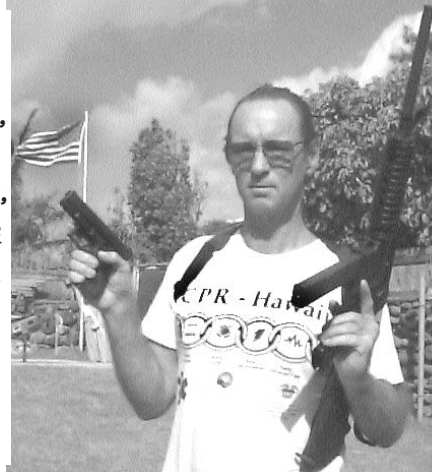

Marshall Islands Shark Sanctuary

The Marshall Islands government has created the world's largest shark sanctuary, covering nearly two million sq km (750,000 sq miles) of ocean. Sharks and their near relatives such as rays are seriously threatened by issues such as habitat loss and fishing. The Pacific republic will ban trade in shark products and commercial shark fishing there.

Tourism, including diving, is a staple of the Marshall Islands archipelago, which is home to just 68,000 people. The momentum for protecting these animals continues to spread across the globe

About a third of ocean-going sharks are on the internationally-recognised Red List of Threatened Species.

"In passing this [shark protection] bill, there is no greater statement we can make about the importance of sharks to our culture, environment and economy," said Senator Tony deBrum, co-sponsor of the bill in Marshallese parliament.

"Ours may be a small island nation, but our waters are now the biggest place sharks are protected."

To put the sanctuary in context, it covers roughly the same area as Indonesia, Mexico or Saudi Arabia, and is about eight times bigger than the UK.

The move will extend the area of ocean in which sharks are protected from about 2.7 million sq km to 4.6 million sq km (1.0 to 1.8 million sq miles). However, there are questions over the capacity of authorities to monitor fully such huge expanses of ocean.

Under the bill, commercial shark fishing and any trade in shark products is banned, and any of the fish accidentally caught must be released alive. Also, certain designs of fishing gear will be banned from Marshallese waters; and violators of all these measures face fines of up to \$100,000.

The Marshallese government has worked on the plan with advisors from the Pew Environment Group, the US-based organisation that identified archipelago nations as providing big marine conservation "wins" because of the vast scale of their territorial waters. Healthy shark populations are vital to our oceans.

The Marshall Islands follows the lead taken by Palau two years ago, whose sanctuary was then the world's biggest. Other nations including the Bahamas have since followed suit including Mexico, Honduras, the Maldives and Northern Mariana Islands signed a declaration announcing they would push for more shark protection across the world.

On September 26, 2011, former U.S. Air Force Staff Sergeant Daryn J. Moran had announced in a video that he had decided to arrest Obama for being "a criminal and a known forger." "The Goal is to Have Obama Tried in Court"

Moran contended that he should have been court-martialed for the stance he took against military homosexuality, Obama's policies and forged birth certificate earlier this year while still in the U.S. Air Force. He was honorably discharged.

They came to understand that what I would do is if I could meet the president, I would walk up there and say, "I want him under arrest; he needs to wait with me until I can turn him over to law enforcement, and people are going to be able to judge him in a court of law." The American people and those who read your paper must understand that the arrest itself is not the ultimate goal. Harming the president is also not the goal. I can call him a coward and say he's a criminal; those things are not physically threatening to the president. The goal is not just an arrest; the goal is to get him before a court of law and determine if he is a criminal, and if so, whether he can be tried.

I explained clearly to the Secret Service, "Look, millions of American people are on one side of this issue called the "birther" issue, and then you have the millions of Americans who are on the other side of it. So we can talk for 75 years until we're blue in the face. That's been proven by the last three years that Obama's been in office, and I haven't been truly involved with much about it until this past summer. So that's already been proven. So the point is, the only way to settle it is in a court. I made them understand that I expect and want Barack Obama to be brought to trial in a court. That's the ultimate goal. It's not to harm him or his family; it's not to be a terrorist. It is extremely important that people understand that, because in no way am I a terrorist or a threat to myself or to others.

"As the unprecedented events of the Arab Spring have unfolded, we have recognized the opportunity presented by the possible emergence of more open, transparent, peaceful, and democratic governments, who will make better neighbors, while remaining vigilant about the risks these changes could present. We know the stakes for Israel are high, and in a situation where neither of us can control outcomes, we are working closely together to chart a common strategy."

Shapiro said that US support for a "two-state solution" is also based on Israeli desires, explaining that he and the Administration are "convinced that a two-state solution is the only way to guarantee Israel's future as a race biased Jewish state. Therefore, he said, Obama's "vigorous pursuit of Israeli-Palestinian peace" also meets the pro-Israel test.

Need to bolster pro-Israel ties among Jewish Americans

Shapiro spoke of the close allegiance that most Jewish Americans feel for Israel, but expressed concern that "much research has shown that growing numbers of younger American Jews feel disconnected, or at best ambivalent, toward Israel.

He said that "a stronger commitment to Zionist education for American Jewish youth could do much to strengthen bonds that we want to be even stronger in the next generation, but may not be if left untended."

Helping Israeli finances even further

Shapiro said that "one of the most fruitful opportunities for deepening ties" between Americans and Israelis is in the economic sphere:

"There are approximately one dozen American-Israel Chambers of Commerce throughout the United States, based in New York, Chicago, Dallas, Miami, Los Angeles, and elsewhere. These organizations are run and organized by Americans who care deeply about the U.S.- Israel relationship and strive to facilitate U.S.-Israel business connections."

1973 War and Shapiro's personal ties to Israel

In his speech, Ambassador Shapiro recounted his personal history:

"I am a proud member of our Jewish community in Washington, DC, active in a Conservative synagogue and the Jewish day school that my children attend and where my wife, Julie, worked for many years. And my profound respect for the State of Israel and its remarkable achievements stems from a lifetime of exposure to the extraordinary people who brought Theodore Herzl's Zionist dream to life."

Shapiro explained that his close attachment to Israel began in 1973 when he was four years old and his family spent a fall semester in Israel. They were there during the war in which Egypt and Syria tried to retrieve land that had been taken by Israel in 1967 when Israel attacked the unarmed USS Liberty and murdered US citizens to coverup the war crimes committed by Israeli military.

Before and during the 1973 war, Saudi Arabia called on the US to pressure Israel to return the lands that it had taken and held since 1967, in violation of international law. Instead, Zionist Henry Kissinger arranged a massive airlift of US weaponry to Israel, saving Israel from losing the war. This support led to the oil embargo against the US that caused a deep depression and cost thousands of Americans their jobs. But it saved Israel, the Jews who attacked USS Liberty.

As historian Donald Neff later wrote, this boycott, induced by Kissinger's weapons to Israel, left "economies around the world shattered and many individuals living poorer lives." Neff wrote that while "Kissinger admitted, 'I made a mistake,' skeptics might wonder whether it was a mistake, or wanton disregard of U.S. interests during a passionate effort to help Israel."

Shapiro explained that the 1973 war had a major impact on his family:

The Lebanon War was also initiated by Israel; fatalities were approximately 25:1 Lebanese to Israelis who were advantaged using free US weapons of war. The ample bookshelves in my parents' home grew laden with studies in Zionism, Jewish history, and Israeli literature.

"A product of the Reform Movement, I nurtured my own connection to Israel primarily through summer camp experiences at the Jewish Olin-Sang-Ruby Union Institute in Oconomowoc, Wisconsin, an unlikely setting for some of the most innovative Jewish and Zionist education to be found anywhere.

"These experiences led me to spend half a year after high school in Israel on a Reform Movement program, living with an Israeli family in Jerusalem, studying at Hebrew Union College, traveling widely throughout the country, and volunteering on Kibbutz Yahel in the Arava.

"I returned for my sophomore year of college at Hebrew University, supplementing my studies with work as a waiter at the wedding hall in the Beit Knesset HaGadol and long walks in Rehavia, where my girlfriend – who is now my wife of 19 years – took an apartment.

"In the years since, I have made Israel, its history and people, its quest for peace and security in the Middle East, and its relationship with the United States, the centerpiece of my academic studies at Brandeis and Harvard, my work on Capitol Hill, and my service in the Clinton and Obama Administrations."

Shapiro said that he is deeply honored that Barack Obama has entrusted him with the "task and responsibility of strengthening and deepening" US ties to Israel.

Shapiro concluded: as a committed Jewish American, I will help make the U.S.-Israel relationship, strong as it is, even stronger in the years ahead.

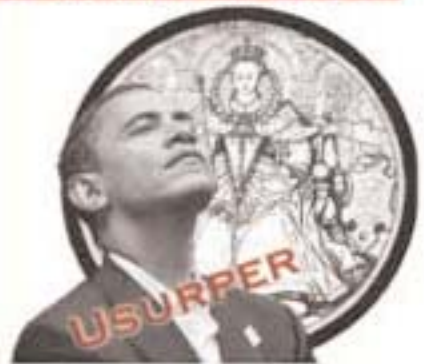

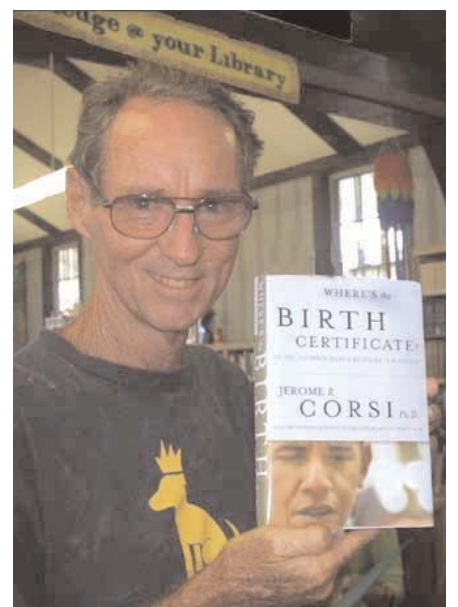
