## War, Recession, Debt based Economy are bane of Liberty

A low interest rates result in consumption and debt. They get the paper money economy moving again. An example: Greenspan moved interest rates all the way down to 1%. It was a desperate move, to stave off a monster recession. But it worked. By turning the housing market into a casino, he was able to put off the monster —until now.

Today, government is throwing every dollar it has at the financial system, to restore confidence in the debt-based papermoney scam. First, the government cuts interest rates, possibly all the way to zero. Even this won't do much. The system has no more capacity to take on debt, and neither does the public. So the government will step in and consume in the public's place. The U.S. government is already the world's largest debtor and spender. That's about to get worse.

Politicians will start buying debts from the banks. Then, they'll start spending money. They'll take on new infrastructure projects. You'll see new highways and bridges in your neighborhood. You'll see new rail transit trains. Who knows, if the recession gets bad enough, maybe they'll start a another war.

Wars make recessions go away. They get everyone working again. And they funnel billions of dollars from the government into the economy.

Where will the politicians get the funds to pay for this consumption? It will raise taxes and issue Treasury bonds. What does it mean for us? INFLATION !

Foreign central banks are the reason. They've absorbed \$2.7 trillion of American government bonds in payment for the goods they've sent to America. Their willingness to hold these bonds has distorted the market and kept bond prices high. In effect, international governments – especially the Chinese, Japanese, and Middle Eastern oil exporters – are giving the U.S. government the green light to inflate as much as it wants. [ example: A \$10 coupon might look fine today, but in 10 years, that same \$10 won't buy a can of soda. When bond traders smell inflation, they cut bond prices.] Add in another trillion bailout dollars that Congress voted to flood the market in order to fight recession – and you've got the makings of a deluge of paper dollars, certainly leading to bigger economic problems.

**ITS THE INFLATION, STUPID !!**

Rampant inflation has resulted within every society when a fiat paper currency has been propagated.

The US dollar which we consider money, is based upon debt, while the Constitutional mandated money is coin of gold and silver. Paper government money continues to steal the users' purchasing power by printing ever more.

## Senate and House Approve \$700-B Bailout for Banksters!

U.S. stocks, after suffering their worst fall in 21 years on Monday after the House of Representatives wisely rejected the bailout, roared back on Tuesday as investors bet Washington would save the package to stabilize banks and markets. They were right, unfortunately for Taxpayers who now bear the burden.

Even Hawaii's Democrat/Socialist Party congress Reps. Mazi Hirono and Neil Abercrombie reversed their previous No vote, and voted to bail out the greedy banksters after Hawaii's U.S. Senators Akaka and Inouye voted in favor of the bailout legislation to which the Senate added 1.5 billion in political pork and FDIC insurance increases [oh, give me a break! Guess how long the govt has to pay back depositors for lost money? 100 years! Do you know ANYBODY personally who ever collected this FDIC "insurance?" Those nice gold FICA certificates on the walls of bank tellers could just as easily say "Tooth Fairy"] and new regulation to the deceptive bailout bill, even though everyone admits that it will NOT solve the problems that caused it: Greedy crooked Banksters, Politicos, and Judges!

Monday, September 29 marked a day that will go down in history, when Congressional Democrats and Republicans alike took on full responsibility to protect the interests of taxpaying Americans, and defeated the deceptive bail out bill, defying the dictates of the Administration, the House Majority Leadership, the House Minority Leadership and the special interests on Wall Street.

Unfortunately, Senators Inouye and Akaka will likely vote for a bailout for WallStreet today, but it won't solve the problem or help the average people. We are told that we must stabilize the WallStree markets in order for the people to be protected. That is false. I think we need to protect average peoples' homes, bank deposits, investments, and pensions, in order to stabilize the market.

The \$700 billion bailout will be added to our existing unbearable load of national debt, trade deficits, and the cost of paying for the war. It will be a disaster for the American public and the government for decades and maybe even centuries to come. The legislation did not resolve in any meaningful way the plight of millions of Americans who are about to lose their homes. Under the \$700 billion bailout plan, Wall Street's PROFITS are Wall Street's profits, and Wall Street's LOSSES are the TAXPAYER'S losses. But another way: Profits are capitalized. Losses are socialized by Congress, inspite of our message: **NO BAILOUT; GO DIRECTLY TO PRISON !**

When the people own the real gold and silver money, they control the government. When the government owns the money as paper, it controls the people.

So it appears Congress feels obliged to fix the economy under the "Commerce Clause" . If so, it is first necessary to abolish the Federal Reserve Board which is doing nothing and return all monetary policy to the United States Treasury. The first item on the agenda must then be to print up ten trillion dollars and make them available to anyone holding public debt papers, because per the Contitution, the public debt will not be questioned, for ninety days. Afterwards, the liability will be recalculated and reduced as soon as possible to nothing. Zero. Toxic liabilities and public debt are resolved, and burden on Taxpayers relieved. But they won't do that, no way, because this economic crash is caused by Organized Criminals who hold high offices in federal Legislaative, judicial, and Execitive branches.

The unexpected immediate result of this Bankster Bailout was this: the world on Monday suffered a modern-day equivalent of a bank run as investors panicked and nervous traders everywhere ran for cover. They shifted capital to safe instruments such as gold, which rose \$33.80 or 4.1 percent, to \$862.70 an ounce. And they flocked to Treasury bonds. The yield, or interest payment, on a three-month Treasury was just over four-tenths of a percent, meaning investors were willing to take almost no profit in hope of simply not losing money in stocks.

And, Oil prices, which hit a record high of over \$147 a barrel in July, fell \$6.07 a barrel, or 6.5 percent, to settle Monday at \$87.81 a barrel on the New York Mercantile Exchange. The slide in oil prices is likely to mean much cheaper gasoline prices for motorists in weeks ahead [hear the cheers!] as recession spreads.

We're on "The Edge of The Abyss"

People are scared and removing their money from the banks and money markets which is intensifying the freeze in the credit markets and driving stocks into the ground. Politicians believing they can "finesse" their way through the biggest economic cataclysm since the Great Depression. It's madness.

Intelligent people are advised to plnt gardens for food, and teach their children that the end has come for debt based economic fraud and unConstitution paper money system. The good news is that physical exercise in the garden and a home grown diet will be a definit improvement in the life style of American children.

Not many years ago, you couldn't turn on the news without seeing a story about AIDS. It was an unimaginable epidemic; a plague that was going to wipe out the world if we didn't all throw all of our attention (and money) into finding a cure. The talk about it was constant, from the media and all the politicians. We were told, day in and day out, that we were ALL one wrong move away from getting AIDS and dying. If you knew anyone who knew anyone who ever slept with anyone who knew anyone who once met someone who might have had AIDS, YOU WERE GOING TO DIE!!! Unless, of course, you threw your money at the problem, and let politicians create various programs and studies. There was an endless stream of heart-breaking stories, of little kids who got it, hemophiliacs who got it, and even celebrities who got it (anyone remember Magic Johnson?). We were all doomed!

Thankfully, in 2001 a cure for AIDS was discovered, and so the crisis was averted, and we stopped hearing about it. Oh, wait. No, it wasn't. A cure was never discovered.

## Wyoming sheriffs Order Feds Stay Out!

Hawaii doesn't have a real sheriff elected by The People. Why not? Look what a real Sheriff can do to protect us from teassonous feds and politicians!

County sheriffs in Wyoming are demanding that federal agents actually abide by the Constitution, or face arrest. Even better, a U.S. District Court agreed according to the Keene Free Press:

The court decision was the result of a suit against both the BATF and the IRS by sheriff Dave Mattis and other members of the Wyoming Sheriff's Association. The suit in the Wyoming federal court district sought restoration of the protections of the US Constitution and the Wyoming Constitution.

Wyoming is a sovereign state and the duly elected sheriff of a county is the highest law enforcement official within a county and has law enforcement powers EXCEEDING that of any other state or federal official. The 10th Amendment is not dead in Wyoming.

Bighorn County Sheriff Dave Mattis comments: "If a sheriff doesn't want the Feds in his county he has the constitutional right and power to keep them out... or retain them in custody....I am reacting in response to the actions of federal employees who have attempted to deprive citizens of my county of their privacy, their liberty, and their property without regard to constitutional safeguards. I hope that more sheriffs all across America will join us in protecting their citizens from the illegal activities of the IRS, EPA, BATF, FBI, or any other federal agency that is operating outside the confines of constitutional law. Employees of the IRS and the EPA are no longer welcome in Bighorn County unless they intend to operate in conformance to constitutional law."

The implications are huge: now, Wyoming sheriffs are flexing their muscles. They are demanding access to all BATF files.

Why? So as to verify that the agency is not violating provisions of Wyoming law that prohibits the registration of firearms or the keeping of a registry of firearm owners. No gun registration in Wyoming, per 2nd Amendment.

The sheriffs are also demanding that federal agencies like IRS and DEA immediately cease the seizure of private property and the impoundment of private bank accounts without regard to due process in Wyoming state courts.

The 10th Amendment means that. of the have a sheriff, "political subdivisions of a State are included within the meaning of the amendment, or that the powers exercised by a sheriff are an extension of those common law powers which the 10th Amendment explicitly reserves to the People, if they are not granted to the federal government or specifically prohibited to the States."

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

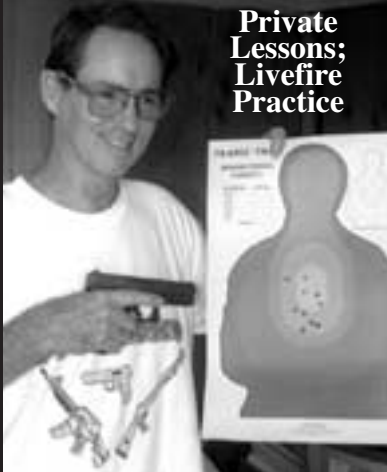
