## Molokai Metal Recycle Starts 11-16

### GOOD NEWS is the First Metal Recycling Event

KAUNAKAKAI, The County Department of Environmental Managements Solid Waste Division has awarded a contract for multiple collection events at the Molokai Metals Facility. The \$200,625 contract for the collection event program was awarded to Kitagawa Towing & Metal Recycling.

The first event begins Tuesday, November 16, 2010. Metals and related materials will be collected, processed and recycled, including junk and abandoned vehicles, motorcycles, appliances, propane tanks, vehicle tires and batteries, ferrous and non-ferrous scrap metals, and miscellaneous metal items such as roofing, gutters, tubs, sinks, faucets, pipes, metal furniture, bicycles, mowers, engine parts, tools, fencing.

The Molokai Metals Facility located inside the existing landfill operation at Naiwa will accept materials from Tuesday, November 16 through Saturday, December 11, 2010 during regular landfill hours, Tuesday through Saturday, from 8:00 a.m. to 2:30 p.m. All metals items must be brought in during the collection event; at the end of this collection event, metals will not be accepted at the landfill until the next collection event is held, sometime in the spring of 2011.

The public is asked separate the metal items from other recyclables and waste materials; stop at the landfill scalehouse; then proceed to MMF; wait to be checked in by the MMF staff and sign for the items delivered. All items must be delivered directly to the MMF staff. These materials may not be dropped off at the scalehouse, recycling center, or landfill face.

Vehicle owners must complete and file a Vehicle Junking form with the Division of Motor Vehicles & Licensing (DMVL) office, and complete and submit a Vehicle Acceptance form at the MMF to scrap a vehicle.

Similar to the landfill procedures, materials from residents homes (non-commercial sources) will be accepted by the MMF at no charge to residents. All materials from commercial sources, such as businesses, agencies, and organizations, will be charged a fee as determined by the MMF contractor.

Community Work Day Program (CWD) will be on Molokai from November 30 to December 11, 2010 clearing metal-related dumpsites around the island. CWD will also be assisting elderly and disabled residents in getting their items to the MMF for recycling. Please call CWD to report areas containing dumped items, or to request assistance, at (808) 877-2524.

A lawsuit has been filed to block the use of full-body scan machines such as the one installed at the airport on Kauai. Details are on the Electronic Privacy Information Center website: EPIC v. DHS.

Even when you cooperate like good sheeple, the individual right of the people "to be secure in their persons, houses, papers, and effects" is being infringed upon regularly by TSA. As I approached the scanner the thought did run through my mind to opt out but I did not want to risk the alternative full-body pat down. Curiously as I exited the scanner, the TSA agent gave me a pat down anyway. Not a full-body version but just down the legs.

A Mainland TSA agent pulled a young lady out of the metal detector line, yelled at her when she politely said she wanted to OptOut and not be groped in a patdown sex assault. TSA then ripped her plane ticket to shreds, called seven TSA agents and twelve [12] police to escort her out of the airport.

Major airline pilot unions are urging their pilots to avoid full-body scans health risks from repeated radiation, along with intrusiveness and TSA behavior. One pilot complained patdown was like "sexual molestation." A stewardess was refused boarding for opting out, and plane delayed three hours.

A California man learned this after being thrown out of the San Diego, airport over the weekend. John Tyner first refused to submit to a full body scan, opting for the traditional metal scanner and a basic pat-down. He then refused a groin check by the TSA guard, saying at one point, "You touch my junk, and I'm going to have you arrested."

Tyner was detained, escorted by police/TSA out of the airport, and TSA has threatened him with a civil suit and a \$10,000 fine for leaving the screening area before it was finished, even though TSA and police ordered him to leave.

If you absolutely, positively must fly, opt out of the scanners. Do it to protect your health and privacy. If you can avoid flying, don't fly. Hit the airlines in the pocketbook until the scanners and gropers are gone. Raise hell. Register your disapproval of the TSA scanners and gropers to your airline, your hotel and all government officials who claim to work for you. Educate your community.

Time to put a spotlight on the dangerous level of radiation they put out. Backscatter X-ray uses ionizing radiation, a known cumulative health hazard, to produce images of passengers' bodies. Children, pregnant women, the elderly, and those with defective DNA repair mechanisms are considered to be especially susceptible to the type of DNA damage caused by ionizing radiation. Also at high risk are those who have had, or currently have, skin cancer. Ionizing radiation's effects are cumulative, meaning that each time you are exposed you are adding to your risk of developing cancer. Since the dosage of radiation from the backscatter X-ray machines is absorbed almost entirely by the skin and tissue directly under the skin, averaging the dose over the whole body gives an inaccurate picture of the actual harm. In their letter of concern, "the dose to the skin could be dangerously high". The eyes are particularly susceptible to the effects of radiation, and as one study found allowing the eyes to be exposed to radiation can lead to an increased incidence of cataracts.

Time to Say "I opt out". When TSA agents direct you to a full body x-ray scanner, tell them: "I opt out." Be prepared for screaming, intimidation and groping. Don't let the TSA agents move you into a back room! Keep an eye on your property and stand your ground. Numerous thefts have been reported at security checkpoints, including incidents that led to the firing of four TSA employees at JFK as ABC News reported. Let every individual see how the TSA is treating peaceful travelers. Better to miss a flight than be violated by TSA nazi. Optout!
