Danger On the Roof



The children were just playing on the driveway under the roof when suddenly they were screaming in pain as there was boiling water falling on them from the roof where the solar water heater panels were suddenly leaking from too much pressure or too high temperature. The safety valve that protects the solar panels and plumbing is called a T&P or Temperature and Pressure relief valve. It worked correctly when the solar pump stopped circulating the water causing the water to super heat and build up steam pressure. But the T&P valve did not protect the children from suffering 2nd degree burns from the boiling water.

PREVENTION of such accidents, the T&P safety relief valve should have a drainage path going from the roof to a safe discharge location. Its that simple.

Installing a solid rain gutter on the edge of the roof to catch any hot water runoff and direct it to a remote area is easy and practical. Another idea is to attach copper pipe to the T&P threads leading to a safe discharge area. If you have to just use a garden hose attached to the T&P, that will work well too.


Make your roof mounted solar water heater safe, for the Keiki.

Some systems already have safe T&P drainage infrastructure, but most do not. Look at the photo above, at the T&P near top on the right corner of the solar water heater panel, and you see there is no drainage control for the T&P. Then look at these below photos, spot the T&P on each one, and see if you can tell if they have safe drainage path for hot water from the T&P.

In yet another effort to silence critics, the Obama has ordered two Environmental Protection Agency employees to take down a YouTube video that was critical of the Obama administration's climate change policy. Fortunately, other youtubers copied it, so it is still available online.

Obama's Hatecrimes Bill

Obama's "hate crimes" bill that will be used to suppress Christian speech, even the reading of the Bible, was signed into law last week by dictator Obama.

The Senate approved the Matthew Shepard and James Byrd, Jr. Hate Crimes Prevention Act by a vote of 68-29 on Oct. 22 after Democrats strategically attached it to a "must-pass" National Defense Authorization Act for \$680 billion defense appropriations plan.

Most Republicans, although normally strong supporters of the U.S. military, opposed the bill because it hands out federal money to states and local governments in pursuit of "preventing" hate crimes. The bill creates federal protections and privileges for homosexuals and other alternative lifestyles but denies those protections to other groups of citizens.

"After more than a decade, we've passed inclusive hate-crimes legislation to help protect our citizens from violence based on what they look like, who they love, how they pray or who they are," he said.

American Family Association President Tim Wildmon warned that the new law "creates a kind of caste system in law enforcement, where the perverse thing is that people who engage in non-normative sexual behavior will have more legal protection than heterosexuals. This kind of inequality before the law is simply un-American."

Wildmon said the legislation creates possible situations where pastors may be arrested if their sermons on sexuality can be linked in even the remotest way to acts of violence. "It threatens free speech and freedom of religion and is totally unacceptable," he said.

U.S. Attorney General Eric Holder admitted a homosexual activist who is attacked following a Christian minister's sermon about homosexuality would be protected by the proposed federal law, but a minister attacked by a homosexual would not be protected by Obama's hate crimes law.

The Alliance Defense Fund blasted the "hate-crimes" bill, calling it "another nail in the coffin of the First Amendment."

"All violent crimes are hate crimes, and all crime victims deserve equal justice," ADF Senior Legal Counsel Erik Stanley said in a statement. "This law is a grave threat to the First Amendment because it provides special penalties based on what people think, feel, or believe. ADF will be on the front line to defend those whose free speech or free exercise of religion rights are violated by this unconstitutional law and to ultimately overturn this attack on freedom."

Opponents point to cases in Canada and Sweden, where Christians have faced criminal prosecution for preaching that homosexual behavior is a sin.

"ADF has clearly seen the evidence of where 'hate crimes' legislation leads when it has been tried around the world: It paves the way for the criminalization of speech that is not deemed 'politically correct,'" Stanley explained. "Hate crimes' laws fly in the face of the underlying purpose of the First Amendment, which was designed specifically to protect unpopular speech."

Stanley said such crimes are already punishable under existing federal, state and local laws.

"Bills of this sort are designed to forward a political agenda and silence critics, not combat actual crime," he said. "The bottom line is that we do not need a law that creates second-class victims in America and that gives the government the opportunity to ignore the First Amendment."

Brad Dacus, president of Pacific Justice Institute, testified before Congress against the hate crimes bill in 2007.

"It is fundamentally unjust for the government to treat some crime victims more favorably than others, just because they are homosexual or transsexual," Dacus said. "This bill is an unnecessary federal intrusion into state law enforcement authority, and it is an unwise step toward silencing religious and moral viewpoints." He said the adoption of hate crimes legislation has led to widespread suppression of speech deemed politically incorrect.

The Pacific Justice Institute noted that in California, hate crimes laws are commonly invoked as a basis for further laws pushing acceptance of homosexuality in public schools and the workplace. The Pacific Justice Institute pledged to come to defend anyone who is prosecuted under the new hate crimes law because of their religious expression.

Liberty Counsel litigation counsel Matt Krause told WND, "It's a very sad day for America and for religious liberties in general."

He said the law will not deter crime or help the law-enforcement system.

"The only thing it will do is silence and scare Christians and religious organizations," Krause said. "It will penalize thoughts and actions, and it will not stop crime. It should be called the 'thought-crimes' bill."



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!







Hawaiian Homelands Trial: Judge says State Liable

The court, having concluded this five-week trial from 8/4/09 through 9/11/09 and having considered the trial evidence and arguments of counsel, determines that Plaintiffs proved by clear and convincing evidence breaches of trust by the Defendant State of Hawai'i ("State") and Defendant Department of Hawaiian Home Lands ("DHHL") during the claims period (August 21, 1959, statehood, through 1988) and that said breaches were a substantial factor or legal cause of eligible Native Hawaiians not being placed on the land in further breach of trust obligations as alleged in the waiting list subclass bifurcated trial. This court suggests that further proceedings on the out-of-pocket damages should involve motions to establish parameters for fairly calculating such damages and appointment of a special master to apply those parameters to individual class member submittals of evidence for review and consideration by the trial court.

The Hawaiian Homelands Trust is an obligation that Hawaii assumed as a condition of statehood. This trial covered a limited time period of 1959 (statehood) to 1988 and asked compensation for losses resulting from delays in awarding homesteads. Many applicants have died while on the waiting list.

Members of the plaintiff class originally filed claims 1991 with an administrative panel charged with compensating them for their losses, but when that went nowhere and the state shut down the panel, the lawsuit was filed, but the state argued that claims could not be brought against it.

The Supreme Court ruled that indeed claims could be brought, and sent it back down to the Circuit Court for trial. Judge Eden Elizabeth Hifo ruled last week that the state was liable for breaches of trust in failing to award homesteads promptly.

This means that there will be another trial to determine how compensation will be paid and whether some kind of blanket settlement or individual settlements must be made. Evidence presented at this trial showed that many awards were of substandard or unusable land, which would be the subject of yet another trial.

Obama opposes media shield law

The New York Times reports today White House officials told congressional leaders they opposed the legislation pending in the Senate Judiciary Committee that would shield reporters from jail time for failing to reveal sources. Barack Obama's administration White House officials told congressional leaders they opposed the legislation pending in the Senate Judiciary Committee that would shield reporters from jail time for failing to reveal sources. Obama sent to Congress "sweeping revisions" to the bill that "would significantly weaken its protections against forcing reporters to testify."

The current form has provisions requiring prosecutors to "exhaust other methods for finding the source of the information before subpoenaing a reporter, and would balance investigators' interests with 'the public interest in gathering news and maintaining the free flow of information.'"

But under the administration's proposal, those procedures would not apply to leaks of a matter deemed to cause "significant" harm to national security. Moreover, judges would be instructed to be deferential to executive branch assertions about whether a leak caused or was likely to cause such harm.
