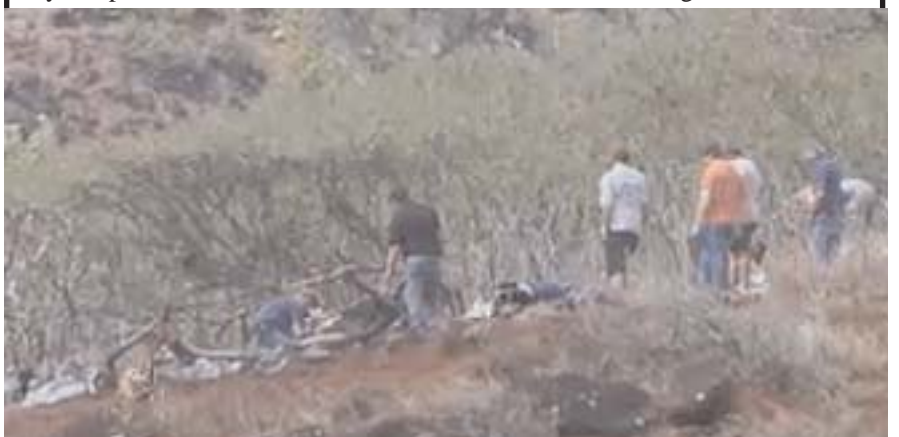

Why We Don't Want Choppers Flying Over Our Homes & Schools: Another Helicopter Crashes and Burns at Ohia

Witnesses saw the Blue Hawaii tourist chopper crash and burn last week at the foothills near Kilohana School and residential areas. As this photo shows, only scrap metal and scortched brush remain for NTSB investigators to examine.



Local residents have been complaining for years about the dangers and noise of tourist helicopters flying over their homes, but Obama's FAA lets it continue. Ohia resident Duke Kalipi gave his eye witness testimony about the crash to TV News.

Maui officials reported that 12:23 p.m. the Maui Fire Department received a 911 call about a helicopter crash on the east end of the island of Molokai. MFD responded MP-13.

According to Maui police the helicopter was a Blue Hawaiian tour that listed five people who were supposed to be on board according to its flight manifest. Fire fighters believe they have found four on the ground and a fifth body at the crash scene but are having trouble retrieving it as it is under the wreckage. Crash victims have been identified as three males (one of them the pilot) and two females. No names are being released at this time.

No injuries have been reported from the school.

Fire officials said the weather conditions in the area consist of rain and a lot of wind. Access to the area is limited to ATV's. Fire fighters said the crash did cause a brush fire but that flames were limited by rain to the crash site only.

county governments. Small business owners are angry about lost revenue and they are inviting others to join them.

The Clubhouse Honolulu Restaurant is in the former Hard Rock Cafe location right across the street from the Hawaii Convention Center. They bought signs welcoming the APEC guests but were greeted by concrete barriers and guns.

"Sure enough not a single person showed up here," said Ernie Inada, Clubhouse Honolulu President. "The police actually blocked the entrance to my parking lot. I could not even come into my parking lot."

He laid off 20 employees. Some haven't come back so he's still closed to train new staff. He's angry enough to file a lawsuit.

"Well I'm hoping that we can recover some damages because in our case it was a whole scale shutdown versus a decline in business," said Inada.

The 14th amendment is basically the right to pursuit of happiness which when they shutdown your restaurant you can't really do that. The 5th amendment says you cannot have an unlawful taking because of a government action and this is what has happened here, said John Carroll. The 5th amendment...is about the unlawful taking of property and this is clearly that kind of a case.

Other businesses are already joining the cause.

"I'll be involved in it yeah," said Terence Yorga, Gadget Guyz Cellular Repairs. Another, "It's a good idea. I don't know how far it will go. When you are dealing with government entities and trying to sue them it's always a long and drawn out process," said Tony Miller, The Eye Glass Shoppe Optician. The Eye Glass Shoppe wasn't seeing any customers because of the security barriers so they closed up during the week of APEC.

"It seems that this APEC event was more for the big guys and be damned with the small independent businesses is what I got out of it," said Miller. "They're into it for themselves...for the politicians to network with other politicians."

"Very unlikely considering the current economic situation and my proclivity to pinch pennies," said Peter Carlisle, Honolulu Mayor, during a press conference on Wednesday. He is supporting Obama's APEC tourist scam martial law. And, governor Neil Abercrombie seemed to agree, and support Obama martial law.

Makaala HR 822 Reciprocity Is A registration SCAM

Gun rights as guaranteed by the 2nd Amendment Right to Keep and Bear Arms is the ONLY law needed in America for gun ownership and carry!

Not only was H.R. 822 -- the Trojan horse gun control bill -- passed out of the House of Representatives this week, it was passed with an amendment that would open the door to federal biometric requirements for concealed firearms permits and a federally-administered database of all permit holders.

Only 7 Republican Members of Congress stood against federal overreach in the concealed carry process by opposing this bill .

The bill was amended this afternoon by ostensibly "pro-gun" Republicans to require a study be done on the ability of law enforcement officers to verify the validity of out-of-state concealed firearm permits.

So. A year from now, the study will come back stating that the only way to "verify" out-of-state permits is through federally-mandated biometric requirements for concealed firearm permits and Congress "must" create a nationally administered database of all concealed weapon permit holders.

One of my biggest concerns about this bill -- the lists of gun owners a permit process creates -- should send shivers down your spine: Imagine Eric Holder and the BATFE with a national database of concealed carry permit holders.

It's bad enough to have those lists exist at a state level. Once Eric Holder and his cronies find a way to request that list from a state, they'll do it -- all the in the name of "implementing H.R. 822."

The legislation now moves to the Harry Reid-run Senate, where companion legislation is expected to be introduced in the coming days. I have no doubt that the anti-gunners in the Senate will use this as an opportunity to make H.R. 822 even worse.

What troubles me most about this battle is the institutional gun lobby has been leading the charge for this legislation. In fact, they've been brow-beating Members of Congress who dare to question the consequences of passing such a broad, overreaching piece of legislation.

Republican Congressman Justin Amash (MI-03) fought back against the institutional gun lobby for its support of H.R. 822:

"It's remarkably bold of the National Rifle Association to send out false and misleading messages regarding H R 822, an unconstitutional bill that improperly applies the Commerce Clause to concealed carry licensing. I would support legislation that gets the federal government out of the way of states that want to recognize other states' concealed carry permits. In contrast, H R 822 will hurt gun rights by conceding broad new authority to the federal government to override state sovereignty.

Gun rights advocates have fought hard to prevent liberal abuse of the Commerce Clause that would restrict gun rights... I am disappointed that the NRA has decided to put its own interests ahead of the interests of gun owners. Fortunately, many other gun rights groups rightly oppose H R 822."





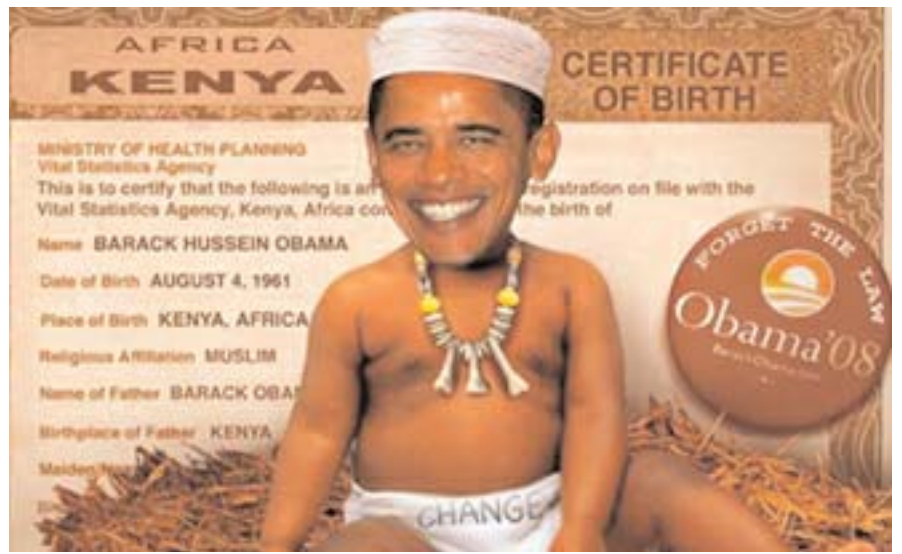

Big An Italian inventor named Andrea Rossi and his scientific consultant, physicist and emeritus professor, Sergio Focardi, have demonstrated a device called the E-Cat or Energy Catalyzer which, according to a 2008 patent application, involves "a method and apparatus for carrying out nickel and hydrogen exothermal reactions," with the production of copper as a result.

The device is said to work by heating hydrogen to an "ignition temperature" using an external heat source, after which a catalyst, which has yet to be explained, causes the hydrogen atoms to "penetrate" the nickel and transform it into copper, producing energy in the process -- essentially a nuclear fusion reaction -- that is self-sustaining (i.e. the external heat source can be removed and the device will continue to function).

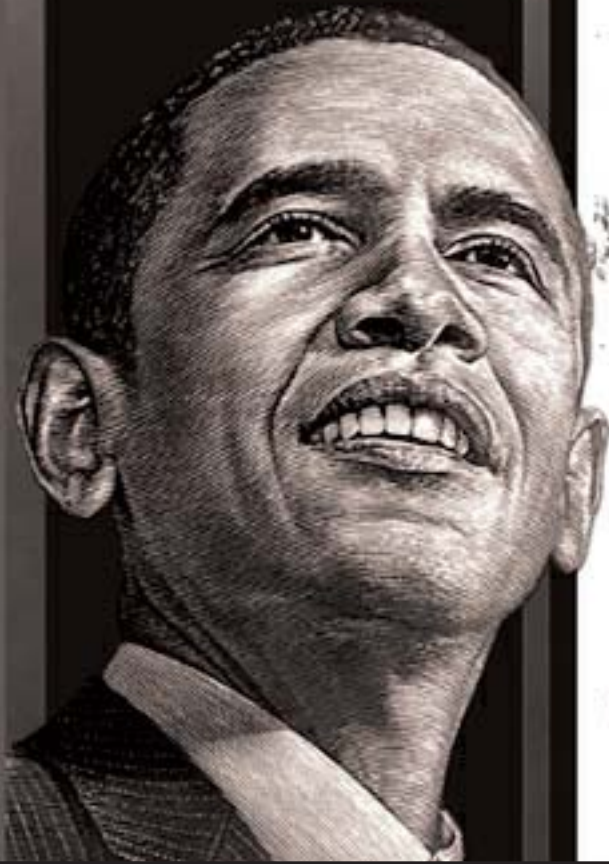
