## Dear Senators Inouye & Akaka: Stop BATF's Gun Registry! It is non-Constitutional!

The BATF has no authority to create a gun registry. The 2nd Amendment right to keep and bear arms is a fundamental right of American Citizens.

Therefore: Please ask the Bureau of Alcohol, Tobacco, Firearms and Explosives, why are they disclosing names and addresses of law abiding American gun owners to the most corrupt Mexican police? Why are they training and allowing corrupt Mexican police to use the BATFE eTrace system? Why have they created a massive gun registration system in violation of the Gun Owners Protection Act of 1986 (18 U.S.C. 926(a))?

BATF's eTrace system does not distinguish between legitimate, erroneous, false, fake, fraudulent or phony traces, and reveals names and addresses of innocent Americans who legally bought a firearm some time in the past - even years ago. This is a grave disservice to Americans. BATFE has created a huge centralized Firearms Registration System (called the Firearms Tracing System) containing over 100 million records of firearms, firearm owners, firearm transactions and firearms dispositions in direct violation of the Gun Owners Protection Act of 1986 (18 U.S.C. 926(a)). eTrace has full access to those records. BATFE claims they only trace "crime guns", but that is a lie. They trace any gun chosen by ATF or other law enforcement whether used in a crime or not, and have no control over traces by Mexican or other foreign police.

If you innocently bought a new Colt AR-15 (or any other gun), later sold it, and it's found in Mexico, BATFE gives your name and address to corrupt Mexican police, and you will be placed on a Mexican and BATFE gun trafficker suspect list. Your innocence is irrelevant. According to BATFE, a traced name and address is never removed.

Mexican President Felipe Calderon admitted that corruption permeates Mexico's low-paid police at all levels. The Mexican Army also has corruption issues. The most corrupt police in all of Mexico have been trained by BATFE to retrieve American gun owners personal information with names and addresses. Worse yet, BATFE plans to give eTrace to all 31 states within Mexico (William Hoover, Assistant Director, ATF Field Operations, Feb. 7, 2008).

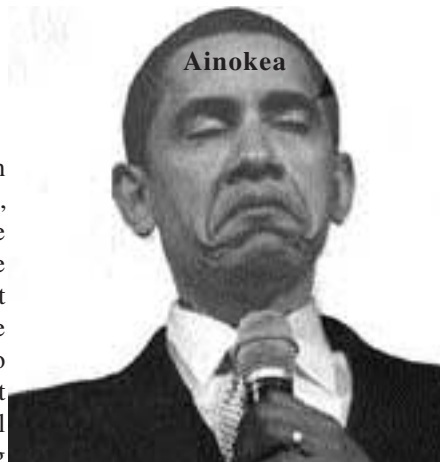
The Mexican Army recently disarmed corrupt Mexican Police in the cities of Tijuana, Nuevo Laredo, and Matamoros, and arrested corrupt Police Commanders in Mexico City - the same cities where BATFE conducted eTrace training sessions in FY08 and 09 (GAO Report 09-709). The Mexican Government reports, "Almost half of Mexican police officers examined this year (2008) failed background and security tests, in the border state of Baja California" (AP).

Should American Citizens be uneasy because corrupt Mexican police officials have our personal information as a result of erroneous or fraudulent traces? The next time we travel in Mexico, will the Mexican Police take a special interest in us because of false traces? When we cross the border, will corrupt Mexican Police pass along our name and address so a drug cartel can visit our homes to collect our firearms while we are gone? Allowing corrupt foreign police access to the eTrace system places Americans at risk when we travel to foreign countries.

In addition to Mexico, BATFE opened a special eTrace center in Columbia - where the police openly admit that many dirty cops work for organized crime. Yet, our BATFE allows access to American gun owners' names and addresses through direct eTrace access in the following countries: Mexico, Columbia, Suriname, Tobago, Guyana, Canada, Germany, Bahamas, Jamaica, The Dominican Republic, Barbados, Anguilla, Antigua, Barbuda, Aruba, Curacao, Dominica, Grenada, St Vincent, The Grenadines, St. Lucia, Belize, Costa Rica, El Salvador, Guatemala, Panama, St. Kitts, Nevis, several other Caribbean police forces, Britain, Australia, and Japan. Many of these countries also have corruption issues - or have a special interest in identifying American gun owners. Stop BATF!

## Obama HealthCare Refusal Could Put You in Prison?

"What I think is appropriate is that in the same way that everybody has to get auto insurance and if you don't, you're subject to some penalty, that in this situation, if you have the ability to buy insurance, it's affordable and you choose not to do so, forcing you and me and everybody else to subsidize you, you know, there's a thousand dollar hidden tax that families all across America are burdened by because of the fact that people don't have health insurance, you know, there's nothing wrong with a penalty."

Sen. John Ensign (R-Nev.) received a handwritten note Thursday from Joint Committee on Taxation Chief of Staff Tom Barthold confirming the penalty for failing to pay for ObamaCARE health insurance fees of up to \$1,900. Violators could be charged with a misdemeanor and could face up to a year in jail or a \$25,000 penalty, Barthold wrote on JCT letterhead.

Under the House bill those who can afford to buy insurance but don't buy it will pay a fine. If they refuse to pay that fine there's a threat - as with a lot of tax fines - of jail time. The Senate Senate Finance Committee said its a bad idea.

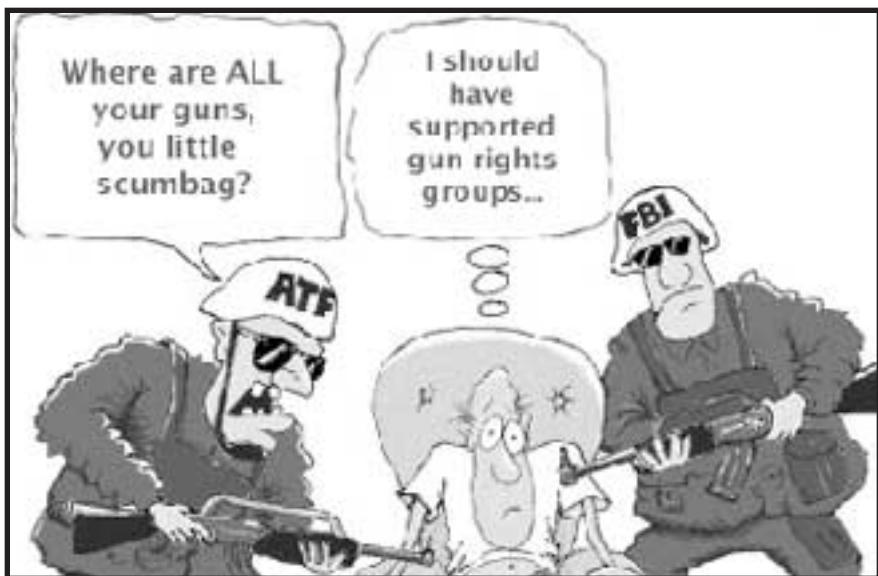
Mr. Obama said penalties have to be high enough for people to not game the system, but it's also important to not be "so punitive" that people who are having a hard time find themselves suddenly worse off, thus why hardship exemptions have been built in the legislation.

"I think the general broad principle is simply that people who are paying for their health insurance aren't subsidizing folks who simply choose not to until they get sick and then suddenly they expect free health insurance. That's - that's basic concept of responsibility that I think most Americans abide by," Mr. Obama said, "penalties are appropriate for people who try to free ride the system and force others to pay for their health insurance."

The President said that he didn't think the question over the appropriateness of possible jail time is the "biggest question" the House and Senate are facing right now. [Obama got that right: the biggest concern should be **IMPEACH OB**]

Think about it!! Is creating a federal national health care program authorized by the Constitution for the United States of America? It it one of the powers enumerated to the federal Congress or the President?

Answer: NO. The role of the federal government is to prevent overly restrictive use of powers by the states, i.e., to protect the rights of Citizens. There is no right to any such socialist Obama-health care insurance.

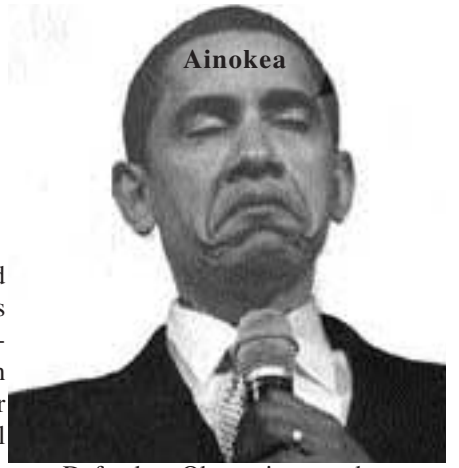

## Obama Agrees to sign on to U.N. Treaty to kill 2nd Am.

Barack Hussein Obama has agreed to sign onto a treasonous United Nations Arms Control treaty [ostensibly to control and limit nuclear weapons] with another call to limit ammunition for small conventional arms (your .22 pistol and shot guns and hunting rifles, etc).

The [November 3, 2009] United Nations Committee on Small Arms and Light Weapons [SALW] members made reference to small arms and light weapons effect on negative security, humanitarian, social, economic, and environmental impacts of illicit proliferation of SALW, estimating that SALW kill at least 300,000 people a year in both conflict and non-conflict situations, maybe as much as 500,000 deaths. Many countries highlighted the links between illegal trading in SALW and trafficking of various kinds, including drugs, prostitution, terrorism and organized crime; and, how SALW proliferation undermines peacekeeping efforts.

[While below is an update Nov. 2009, the United Nations has desired for years to have an international treaty to control all arms and abolish the American Citizens' right to keep and bear arms, like they do in foreign countries. They claim it is for the good of humanity, but fail to explain away the irrefutable truth and research that unarmed citizens are easily murdered by governments gone bad.]

Seven countries referred to SALW as effectively 'weapons of mass destruction', with Thailand's Ambassador Sinhaseni noting that "though small in size, [SALW] continue to cause massive destruction" since "they are much more common and widespread than WMD." Lesotho's Ambassador Ramafole stated that as a small developing country, SALW represent a "more of a threat than weapons of mass destruction".

Most member states reaffirmed their commitment to the UN Programme of Action (PoA) to Prevent, Combat and Eradicate the Illicit Trade in Small Arms and Light Weapons in All its Aspects, agreed in 2001. The Non- Aligned Movement, African Group, and Association of South East Asian Nations all called for increased technical and financial support to developing countries to enable them to fully implement the PoA. Norway's representative expressed frustration that the PoA "had not lived up to any humanitarian expectations," stating that it was "high time to take a more critical look at whether the present PoA provides the best framework to address the humanitarian and developmental challenges posed by small arms." There it is folks. Obama and the U.N. want to take away your guns.

## PETA - India: Elephants Freed

The Central Zoo Authority of India (CZA) has made the decision to prohibit zoos and circuses across India from keeping elephants.

Elephants currently held in Indian zoos will be transferred to undeveloped areas controlled by the Indian Forest Service—and freed from their chains. This is a massive step forward in our efforts to end the captivity of animals in zoos and to help free animals who are used for other forms of "entertainment" around the world. It is a ban that will be heard around the world.

The tide of public opinion is definitely turning against keeping elephants in captivity. Ringling Bros. and Barnum & Bailey—a huge and hideous example of animal cruelty circus faced rock-bottom attendance at the first venues and had to cancel all its performances in Germany and Spain.

In their natural homes, elephants form complex, lifelong social bonds and stay with their families for life. They travel vast distances—an activity that is essential for their physical and mental well-being—and thrive by caring for one another, teaching their babies how to survive, warning each other of dangers, sharing food.

PETA India investigations have revealed animals who are deprived of shelter, forced to forage among garbage, kept chained, and one was tethered by both front legs with a spiked chain that painfully prevented him from moving more than a few shuffling steps in any direction.

On behalf of all elephants in captivity, we at PETA-USA applaud this historic announcement and call on the rest of the world to follow the CZA's lead and ensure that elephants everywhere are allowed to live without chains, free from abuse.

## Obama Bows to Foreign Royals

In our lifetime we have been tremendously lucky to observe the end of the wall in Berlin. The wall came down 20 years ago. And that signaled the end of communism. Until, of course, Obama and his pinko buddies took over USA.

## OBAMA / FEDS NO FAITH in ECONOMIC RECOVERY for USA

The cyclical bull market in stocks and positive print on GDP has caused some on Wall Street and in Washington to claim the recession has ended. Despite all the good economic news, an end to fiscal and monetary stimulus is nowhere in sight, precisely because policymakers know the happy news is artificially derived.

A closer look indicates that neither the administration nor the Federal Reserve believes its own recovery rhetoric. They understand that the economy will not prosper without continued life support.

I believe removing such artificial stimulus is needed so the country can immediately begin de-leveraging and to prevent the accumulation of yet more baneful debt. What is truly amazing is how many people on Wall Street are foolish enough to postulate that our problems have been solved. The stock market will not be so easily fooled for much longer.

The Great Depression Part II was narrowly averted last year by slashing interest rates to near zero. The Fed made money virtually free because the record level of indebtedness (\$34 trillion) in the economy required such low rates so that borrowers could service their obligations. Otherwise a cataclysmic domino effect of defaults and bankruptcies would have occurred. To avoid that scenario, the public sector assumed some of the private sector's debt and then subsequently took on a significant amount more. The debt of the nation continues to increase at a 4.9% annual rate. All public debt is ultimately the responsibility of the private sector to pay off--either directly or through future taxes. As a result, the economy has never been more precarious than it is today.

In spite of this, the stock market appears to be doing quite well. We've seen a 57% rally off the March lows in the S&P 500. However, if you measure the market against other assets its performance is much less impressive. Since the beginning of 2000 the S&P is down about 50% measured in terms of a basket of currencies other than the falling U.S. dollar. The index is down nearly 80% against the real inflation hedge--gold!

The sad truth is that this recent market rally has been produced on the back of a weakening dollar and the slashing of corporate overhead. Cutting payrolls and research and product development projects are not a prescription for sustainable growth. As I like to say, you can't burn your furniture to keep your house warm forever. Eventually, top-line revenue growth must emerge or Wall Street's game of beat-the-expectations will be short lived.

It's also worth noting that a country cannot devalue itself to prosperity and that a bull market cannot survive an inflationary environment for long. In the short run, nominal gains in the averages can occur since everything priced in dollars tends to increase in value. However, the rally will be truncated unless the Fed provides consumers and corporations with a stable currency.

The ramifications of a crumbling currency are vastly misunderstood. A strong dollar is the cornerstone of a healthy economy. It is essential for balanced growth and healthy investment to occur. On the other hand a weak currency decimates the middle class and the corporate sector's ability to maintain earnings growth. Inflation lies behind all infirm currencies, and it is inflation that destroys the purchasing power of consumers. The diminished value of their wallets leaves them with the ability to buy only non-discretionary items. As a direct result, unemployment rates soar and economic output plunges.

I believe we will suffer from a protracted period of stagflation. Money supply, as measured by M2, has increased 5% Y.O.Y. Meanwhile the output of goods and services is falling. As long as the money supply is chasing a shrinking GDP pie, there will be upward pressure on prices.

Making the situation even worse is the manner in which the money supply is growing. The quality of growth is very low because the increase in supply is coming from commercial bank purchases of Treasury debt, rather from an issuance of credit to the private sector for capital goods creation. Total Loans and Leases at Commercial banks are down 8.2% from last year. Meanwhile, the amount of Treasuries held at all commercial banks is up 20% year-on-year.

That means money supply growth is emanating from government's misallocation and redirection of capital. It isn't being loaned out to build mines and factories; it is instead being loaned out to increase consumption and build even more consumer debt.

If the Treasury and Federal Reserve truly believed the economy and the stock market were on a sustainable recovery path, talk of extending and increasing the home buyer's tax credit would be off the table. The Fed would already be reducing the size of the monetary base. The truth, however, is that no one in government really believes in this recovery. If they did, they would be hiking interest rates and the deficit would be shrinking.

The government's realization of our precarious economic condition means its largess will continue. Near term, that may ease some pain. So did the artificial stimulus that gave rise to the housing boom. In the end, a protracted period of a near-zero interest rates, along with endless economic stimulus, will spawn another bubble and not a genuine recovery.

## Obama Health Care is TAX on Middle Class??!! etc.

### OBAMA Health Care Bill is a TAX on Middle Class; Invasions of Privacy and violates 5th Amendment; pushes for legalizing illegal immigrants.

The Baucus bill itself says Obamacare is a tax, the text on page 29 reads: Excise Tax. The consequence for not maintaining insurance would be an excise tax. If a taxpayer's MAGI is between 100-300 percent of FPL, the excise tax for failing to obtain coverage is \$750 per year. However, the minimum penalty for the taxpayer unit is \$1,500. If a taxpayer's MAGI is above 300, the maximum penalty amount a family above 300 percent of FPL would pay is \$3,800.

And who would be enforcing what President Obama insists is not a tax? Heritage's health care team explains:

In order to enforce these provisions, the Baucus bill would require individuals, health insurers, employers, and government health agencies to report detailed health insurance information on all Americans to the IRS, adding significant administrative costs and reducing privacy protections. The IRS would also be required to report personal income data to state exchanges, insurance companies, and employers, because premium credits and out-of-pocket limits would depend on income. Its a backdoor way to investigate every American without your permission because you are required to buy ObamaCare health insurance, and participate in Obama Socialism Medicine.

And the individual mandate is not the only middle class tax hike in the bill:

Beginning in 2013, the bill would impose a new federal excise tax on high cost health insurance plans. The tax would be applied to health plans valued at \$8,000 for single policies and \$21,000 for family policies. Because not all workers in such plans are high income, many will likely be on the receiving end of a middle class income tax increase, which contradicts President Obama's promise that "if your family earns less than \$250,000 a year, you will not see your taxes increased a single dime. I repeat: not one single dime."

Health Care Obama Plan for Illegals?

Obama told the Congressional Hispanic Caucus Institute's Gala that illegal immigrants would not get government funded health insurance under his health care reform, but said the debate over that plan underscores the need to legalize illegal immigrants so they can get that coverage.

"If anything, this debate underscores the necessity of passing comprehensive immigration reform and resolving the issue of 12 million undocumented people living and working in this country once and for all," Obama said. "That's what I've said from the start. That's what I say tonight."

Last month in Guadalajara, Mexico, President Obama said that he was "confident" he would get Congress to enact comprehensive immigration reform that included a "pathway to citizenship" for illegal aliens.

### 45% of Doctors Consider Quitting Under Obamacare

Here's a glimpse of the grim future under Obamacare. It's not just about patients and consumers getting screwed. It's about the enormous disincentives government-run health care would bring to the medical profession.

Investor's Business Daily reports on the results of its heart-stopping poll of doctors: Two of every three practicing physicians oppose the medical overhaul plan under consideration in Washington, and hundreds of thousands would think about shutting down their practices or retiring early if it were adopted, a new IBD/TIPP Poll has found.

The poll contradicts the claims of not only the White House, but also doctors' own lobby — the powerful American Medical Association — both of which suggest the medical profession is behind the proposed overhaul.

It also calls into question whether an overhaul is even doable; 72% of the doctors polled disagree with the administration's claim that the government can cover 47 million more people with better-quality care at lower cost.

Read the whole thing — and don't expect Obama's health care czar's office to report this in its "reality check" series.

...The IBD/TIPP Poll was conducted with 1,376 practicing physicians chosen randomly throughout the country. Major findings included:

Two-thirds, or 65%, of doctors say they oppose the proposed government expansion plan. This contradicts the administration's claims that doctors are part of an "unprecedented coalition" supporting a medical overhaul.

It also differs with findings of a poll released Monday by National Public Radio that suggests a "majority of physicians want public and private insurance options," and clashes with media reports such as Tuesday's front-page story in the Los Angeles Times with the headline "Doctors Go For Obama's Reform."

Nowhere in the Times story does it say doctors as a whole back the overhaul. It says the AMA — the "association representing the nation's physicians" and what "many still regard as the country's premier lobbying force" — is "lobbying and advertising to win public support for President Obama's sweeping plan."

The AMA, in fact, represents approximately 18% of physicians and has been hit with a number of defections by members opposed to the AMA's support of Democrats' proposed health care overhaul.

Four of nine doctors, or 45%, said they "would consider leaving their practice or taking an early retirement" if Congress passes the plan the Democratic majority and White House have in mind.

More than 800,000 doctors were practicing in 2006, the government says. Projecting the poll's finding onto that population, 360,000 doctors would consider quitting.

More than seven in 10 doctors, or 71% — the most lopsided response in the poll — answered "no" when asked if they believed "the government can cover 47 million more people and that it will cost less money and the quality of care will be better." This response is consistent with critics who complain that the administration and congressional Democrats have yet to explain how, even with the current number of physicians and nurses, they can cover more people and lower the cost at the same time.

The only way, the critics contend, is by rationing care — giving it to some and denying it to others. That cuts against another claim by plan supporters — that care would be better.

IBD/TIPP's finding that many doctors could leave the business suggests that such rationing could be more severe than even critics believe. Rationing is one of the drawbacks associated with government plans in countries such as Canada and the U.K. Stories about growing waiting lists for badly needed care, horror stories of care gone wrong, babies born on sidewalks, and even people dying as a result of care delayed or denied are rife.
