## Legislation to Broaden Definition of "Terrorist Act"

Legislation to broaden definition of terrorist act.

The Senate will sit today to pass legislation the Federal Government says could help authorities deal with a specific threat of terrorism.

The Government says the new laws broadening the definition of a terrorist act are urgently needed because of a specific and credible threat of terrorism in the last few days.

It says the legislation will broaden the definition of a terrorist act, enabling people who are plotting an attack to be prosecuted. But Democrats Leader Senator Lyn Allison and the Greens Senator Bob Brown are among those who are suspicious saying it is a bid to deflect attention from the Government's industrial relations (IR) legislation.

"This has all the hallmarks of John Howard manipulating the Parliament to his own political ends," Senator Brown said.

Labor's Arch Bevis says it is a convenient coincidence, but he is not too worried.

"If it is some ploy or smokescreen that will come out in the wash," he said.

Federal Attorney-General Philip Ruddock says the idea of a conspiracy is fanciful.

"Any idea that this was some form of conspiracy to divert peoples attention from other political issues which is being offered as a view by some is just I think very far fetched," he said. He says the Government learnt of a

specific threat of terrorism in the last day or two and acted on it immediately.

"We were convinced on the independent advice received from competent authorities," Mr Ruddock said.

He appears hopeful that the broader counter-terrorism legislation could also enter the Parliament today with the support of a number of state premiers.

Terrorism analyst Clive Williams, from the Australian National University, has told Channel Nine he has information that at this stage the activity is in the early planning stages and involves two people in Sydney talking to others in Melbourne about potential targets.

"One of the persons apparently was identified by an American informant as having attended a LET- a Lashka e Toiba camp in Pakistan and they've been talking to others in Melbourne apparently about what sort of targets they could attack," he said.

"So it's very early stages and that's why the Government wants to change the law in the way it does."

"In any legislation that has an effect upon civil liberties obviously there are concerns, and the comprehensive debate and sufficient time for people to think through the full consequences of such reductions in liberty are obviously wise, and I look forward to the outcome of the inquiry," said senator Robert Hill.

The inquiry is likely to examine the protection of civil liberties under the proposed extension of police powers.

## FCC'S \$7 Billion Ruling

The FCC has introduced a new rule that requires communications companies, Internet service providers and universities to make costly network upgrades by 2007. However, a number of companies and organizations have filed lawsuits to challenge the FCC, according to the Des Moines Register.

Opponents to the new rules argue that they will violate privacy rights because they are meant to help the government monitor Internet usage and Internet based phone usage. The FCC rule seeks to expand a law created in 1994 which forces communications companies to create surveillance technologies for the government. The rule could also damper innovation by forcing companies and consumers into wasting large amounts of money. It is estimated that it will cost universities and colleges \$7 billion to make the network changes.

Critics of the order argue that the FCC is pushing a Big Brother Agenda for the federal government. Meanwhile, law enforcement agencies such as the FBI are claiming that they need access to surveillance technologies in order to fight terrorism.



## Fire the government Monopoly on National Protection

The government says: "We have been at a very high state of alert. Of course if there had been any kind of specific threats we would have dealt with it."

In other words, "We have been telling all of you for the past four years that you should all be very, very careful, so you can't say that we didn't warn you, but just in case any of you taxpaying subjects are wondering for what, exactly, you're paying absolutely massive taxes if it cannot perform the one legitimate responsibility of government, i.e., the protection of human lives and property, you can rest assured that had those ruthless, bloodthirsty, murdering savages been a bit more sporting and given us some advance notice as to exactly where they planned to set off their explosives, we most certainly would have foiled them!" Ha, haahahahaha, AUWE!

The safety and security of human beings is just far too important to be left up to governments. If I had contracted a private security firm to protect my property 24-7, and a gang of cold-blooded killers were successful in breaking into my house and killing some of my family, then obviously that alone would be enough for me to inform that company that their services were no longer required, and I would also demand some kind of refund for their failure to deliver the service contracted.

When it comes to defense and security, it's high time to give government the pink slip. Its there in the Bill of Rights: 2nd Amendment: "A well regulated militia, being necessary for the security of a free state, the right of the people to keep and bear arms shall not be infringed."

## Bird Flu and the Posse Comitatus Act

Montesquieu, famous for his articulation of the theory of separation of powers, said, "There is no crueller tyranny than that which is perpetrated under the shield of law and in the name of justice." The latest test balloon of federal power enhancement comes in the form of public health response to the possibility of an outbreak of pandemic bird flu.

This administration seeks for Congress to grant it the power to use America's military to enforce domestic order and impose martial law.

President Bush stated, "I think the president ought to have all options on the table, all assets on the table to be able to deal with something this significant." That ought to bother us deeply; so deeply that we take decisive action and let our elected officials know that this proposed action is a step too far.

On June 18, 1878, during the Reconstruction, recognizing the inherent danger to liberty posed by using soldiers for civilian law enforcement, Congress passed the Posse Comitatus Act (PCA). Title 18 US Code, Part I, Chapter 67, § 1385, reads: Use of Army and Air Force as posse comitatus. Whoever, except in cases and under circumstances expressly authorized by the Constitution or Act of Congress, willfully uses any part of the Army or the Air Force as a posse comitatus or otherwise to execute the laws shall be fined under this title or imprisoned not more than two years, or both.

Democrats as well as Republicans have been guilty of eyeing-up the PCA for reform. After the Okalahoma City bombing Senator Joseph Biden introduced legislation that would "moderately alter the posse comitatus," and President Clinton proposed an exception to allow the military to aid civilian investigations involving "weapons of mass destruction." In the 1996 presidential campaign candidate Bob Dole pledged to fight the drug war using our military, and candidate Lamar Alexander suggested creating a new branch of the military to replace the Immigration and Naturalization Service and the Border Patrol. If Biden and company had been able to reform the PCA in 1995, could Clinton have sent troops to Florida to stand guard over the ballot recount of 2000?

The gargantuan federal government will never resist the temptation to grant itself additional power. It is up to us at the grassroots level to confront it when it oversteps its bounds. It is incumbent upon us to tell it when it is wrong for the simple fact that they are wrong and not submit to the whims of "our side." Precedent is real and it will be used against us sooner or later. In their turn when they are appointing department heads and granting various political favors, the "other side" will use every privilege we grant the federal government to their benefit.

Exceptions to the PCA already exist: In 1981, Congress created an exception to allow passive military assistance to civilian law enforcement, such as the provision of equipment, information training and advice. Eight years later, the Department of Defense became the "single lead agency" in drug interdiction efforts, requiring the Secretary of Defense to conduct annual briefings regarding the availability of military equipment and expertise to civilian law enforcement. In 1993, the PCA was amended to provide procedures for civilian agencies to purchase "law enforcement equipment suitable for counter-drug activities" through the Department of Defense, such as flash-bang grenades, assault rifles and armored personnel carriers.! The PCA could easily become completely undermined if we do not put a halt to the growing perception of our military as a panacea for all domestic problems. While modifications of the PCA do not necessarily make Americans safer, they do open us up to old abuses and a few new ones.

U.S. Armed Forces are spread across the globe. Further expanding the role of the military on domestic soil would certainly stretch the military to beyond its currently too-thin capacity, weaken or destroy the healthy division between military and civilian duties and most frighteningly, weaken civilian control of the military. This should keep you up at night.

After risking all of this, who can promise that a military solution would work, and not devolve into some unintended consequence? Look at governments around the world and throughout history that tried this quick-fix-easy-answer approach. Looks bad.

This administration claims to be referring to a "catastrophe," in which the Pentagon would be the only agency with enough strength to respond. However, the federalizing of emergency management has not proven itself worthy of expansion. The federal government should instead consider releasing monies back to the states to fund and re-equip National Guard and public health services, which are the proper channels for managing a national, or more accurately state-by-state, health emergency. These first-responders need to have materials, facilities and training (which should include practice drills) in order to make them effective. Governors in each state will certainly be held accountable to fulfill their role as st! ate commander-in-chief by the voting citizenry and the press.

Instead of asserting excessive executive power and trying to centralize, federalize and militarize America, why not just follow the Constitution?
