Yes! Molokai now has an "official" bird proclaimed by government officials who named the kioea [Bristlethighed Culew, *Numenius tahitiensis* is the scientific name]. The kioea is one of the rarest shorebirds in the world. Adults breed in Alaska and return with babies in late spring. Most of the birds seen are young because they remain on Molokai until they are mature and ready for long trip to Alaska. So, Molokai is now the first district in Maui to get an "official" bird.

The ceremony took place at Kaunakakai Elementary School because the kioea bird is often seen and heard from the Duke Maliu Park next to the school.

Water Payments Accepted at DMVL

Mayor Alan Arakawa has announced that all offices of The Division of Motor Vehicles & Licensing (DMVL) will begin accepting Water Payments.

In support of Mayor Arakawa's continuing efforts to improve the delivery of services to the residents of Maui County, the DMVL will be accepting water payments at all DMVL offices beginning Tuesday, November 1, 2011.

Who Owns Molokai?

Puu O Hoku Ranch vs John Dudoit, et al: Summary Judgment Granted, Evidence Excluded, Stricken

At court hearing on Maui October 21, attorney for Lavinia Currier dba Puu O Hoku Ranch, Ltd were granted Summary Judgment against Defendants listed on court records as Robin Dudoit, Leimana Naki, Palmer Naki, Shrene Naki, Florence Kong, and Solomon Kong. [see case Civil No. 11-1-0124-3].

Puu O Hoku Ranch owner Lavinia Currier's attorney Craig Nakamura et al filed their Complaint and Summons against the Halawa Valley Defendants regarding unapproved structures purportedly on Lavinia Currier's Ranch lands: "...this action involves basically some people that are occupying the beach on almost a permanent basis. They've erected permanent structures.....tent like structures that they're erecting on my client's property, clearly my client's property. And I think they do so on the mistaken belief that they have title to the property. And when asked to remove the permanent structures, they've refused and they've actually blocked my client's efforts to do that....and, it's an untenable situation that we can't allow to continue, your Honor, that's why we're proceeding in this matter. We have evidence to show that, and provided evidence that my client has clear title to the property. No evidence has been provided to the contrary.....they are trespassing on the property, and we are entitled to have them removed, and that's the case in summary, your Honor," stated POH attorney Craig Nakamura according to the official transcript.

Summary Judgment is granted by law when "...there are no genuine issues of material fact,...If there are no opposition pleadings in this instance... [he] would be granting of the motion for summary judgment," stated judge Cardoza.

Dudoit Defendants presented two documents in opposition, which the judge summarized as claiming "...the land question is owned by the Kingdom of Hawaii." The judge opined that the records indicate that the Kingdom of Hawaii caused the lands in question to be conveyed to private parties long before the 1893 Overthrow, and leading up to ownership by Puu O Hoku Ranch, Ltd. Thereafter, Cardoza granted Summary Judgment. Lavinia's attorney also requested costs and fees against Defendants.

Inexplicably, Paul Kauka Cullen, who filed an Answer to the Complaint and Summons and stating his unbroken title to the land in question and other surrounding lands in opposition to Lavinia's Currier's claims, was excluded as a Defendant, and not allowed to speak, and not allowed to submit his certified evidence proving genuine issues of material facts in this case. When Cardoza refused to recognize him as a Defendant Party in this case, he tried to show the judge his court filed documents with the judges initials on them, to no avail. He has filed an Emergency Motion to re-consider and move hearing venue to Molokai where the law provides when the lands, Defendants, Plaintiffs are all located.

Hanabusa Wipes Out History of Prince Kuhio and Wilcox

In a September 7 email to supporters, Colleen Hanabusa falsely identified Dan Akaka as the "first person of Native Hawaiian ancestry to serve in the House." Later that day, Richard Rapoza, Director of Communications for the Hanabusa campaign sheepishly admitted: "In our email we said that Senator Akaka was the first person of Native Hawaiian ancestry to serve in the U.S House of Representatives. That honor actually belongs to Jonah Kuhio Kalaniana'ole, known in Hawai'i as Prince Kuhio, who served as Hawai'i's elected delegate to Congress from 1903 until 1922."

E kalamai? Hanabusa still has it wrong! The first native Hawaiian Congressional Representative was Robert Wilcox of the Home Rule Party who served as Hawaii's Territorial Representative from November 6, 1900 – March 3, 1903. Wilcox was followed in office by the second native Hawaiian Representative, Prince Jonah Kuhio Kalaniana'ole (R) who served from 1903 until his death January 7, 1922.

In addition to Prince Kuhio and Robert Wilcox, there were three other native Hawaiian delegates:

- William Paul Jarrett (D) Territorial Delegate to Congress 1923 – 1927
- Victor Stewart Kaleoaloha Houston (R) Delegate to Congress 1927-33
- Samuel Wilder King (R) Territorial Delegate to Congress 1935 – 1943

So Dan Akaka was sixth, not first. But in fairness we should point out that Dan Akaka was first to declare that Hawaiians are really an Indian Tribe.

Samuel Wilder King would become the first native Hawaiian Governor of the Territory of Hawaii from 1953-57.

State Highways Chem Spray is Threat to Aloha Aina

I am disappointed with what the State is doing to our la'au and marine life when the roadside weed spraying herbicide chemicals reaches our water table and flows down to the ocean. I've called them many times before to stop spraying these chemicals on the road sides, but they ignore the complaints and do what they please. I'm worried about our future when my mo'puna's wouldn't have any la'au and marine life if they keep spraying these chemicals.

Is spraying herbicide chemicals a form of population reduction? Is this how they treat tax payers of the State? Is this what they do if they can't get their way by dictating what they can do and what we cannot do?

I know this might sound hard way to control weeds on roadside, but it's good exercise: they need to grab a pick or shovel and hana hana ka aina. They have to do this so we can preserve what is left with our herb and spices that we collect everyday. In the ocean, we gather huluhuluwaina, opae, and oama, etc.

On land we gather uhulua, wild basil, bay leaf, Tinehi, kekania, koli (castor bean), etc. We gather enough to take home and use. We're not here to make any problems with the State of Hawaii, we ask for the State of Hawaii to respect our way of living so our people can live on as Kanaka Maoli.

In my yard, I farm uhulua, popolo berries, tinehi, noni, bay leaf (which is right next to the road side), basil, ulu, taro, guava, banana, star apples, mountain apples, several varieties of citrus trees.

I'm a big tax payer, so please don't come into my neighborhood at Ohia by WaveCrest and do what you please. Remember Federal, State and county, based on the U.S. Constitution, exist to service and assist your citizens at all times.

OBAMA Predictable SCANDALS

The media finally conceded the Obama administration to be inexperienced and inept, reminiscent of the Carter administration — but, they maintained, not possibly involved in any corruption. Then suddenly scandals erupted on nearly every conceivable front: the crony-capitalist half-billion-dollar loan guarantee to a now bankrupt Solyndra; the Fast and Furious gun deal, in which, in lunatic fashion, the U.S. government sold deadly automatic weapons to Mexican drug-cartel killers; the administration's pressure on a four-star general to fudge his testimony as a favor to a big campaign donor whose suspect company, LightSquared, was doing business with the Pentagon; and the politically inspired dropping of investigations by the Civil Rights Division of the Justice Department.

The administration got itself into these messes because it customarily counts on a medieval notion of compartmentalized exemption. In the 2008 campaign, Barack Obama's loud and welcomed hope-and-change promises to end insider influence, lobbying, and earmarks were essential to his well-crafted image of the outsider reformer. Once that liberal narrative was embraced by the media, few seemed to care whether the other, cynical Obama was the first candidate in the history of public financing of presidential campaigns to renounce the program — in order to maximize his campaign stash, much of it pouring in from firms like Goldman Sachs and BP.

OBAMA's FICTIONALIZED FAMILY

In November 2009 President Barack Obama toured China on an official state visit. During that tour, Obama spent roughly five minutes with his half-brother, Mark Ndesandjo, and Ndesandjo's Chinese wife.

Ndesandjo, the son of Barack Obama Sr. and his American-born wife Ruth Baker, had been living and working in China since 2002. CNN did a short piece on his meeting with the president.

What this clip reveals is Obama's chronic failure to keep his story straight. It is obvious: Much of Obama's biography has been fictionalized, and much of that fiction has been written by other people. As a result, Obama appears not to remember what has been written under his name.

In his 1995 memoir, "Dreams from My Father," Obama in 1988 first trip to Africa, but in his 2006 visit to Kenya, however, Obama spoke to a large gathering at a Kenyan University and placed his first visit to Africa in 1987. But, website Africa.com traces Obama's first Kenyan visit to 1983, the summer after college graduation, "when he had come to mourn his late father." [BO Sr RIP 1982]

As Obama tells the story in "Dreams" — and nowhere else — he spent eight weeks on this first journey, an inexplicable luxury for a chronically broke young man no matter what the year.

This kind of fictionalization would not be particularly troubling were it an anomaly. It is not. It is the norm. No one really knows where the lies begin and end. No one has presented authenticated records even of his birth place, though all of Kenya seems to know he was born at Mombasa Hospital in Kenya.

In March, 2007, the New York Times reported four principal owners of SkyTerra (and friends of Obama), had raised more than \$150,000 for Obama since 2004. When questioned about his investment, Obama claimed he had opened a blind trust and "had no knowledge of any stockholding [sic.] with this account at any time." He explained, "After I got [sic.] my [\$1.9 million] book contract, I had money to invest," insinuating that his investment in a company principally sponsored by political allies was mere coincidence. Obama later sold his investment at a loss after assessing the potential political ramifications.

On September 15, 2011, LightSquared Chairman and CEO, Sanjiv Ahuja issued a defensive statement on its website, Lightsquared.com, saying it is "ludicrous to suggest LightSquared's success depends on political connections." During the hearing the same day, House Armed Forces Subcommittee Chairman Michael Turner, R-Ohio, took the opposite opinion, chastising the administration for approving LightSquared proposals and reprimanding FCC Chairman Julius Genachowski for both granting a January 26 waiver to LightSquared, and failing to show up at the hearing to "discuss the significant harm to national security that may result from the FCC's action."

Promising a "possibility of real change" while speaking about campaign finance reform during a speech in 2008, Obama complained that, "special interests drown out the voices of the American people and will continue to erode our politics."

Obama may not have read his own book, at least not recently. How could he forget the two poignant, detailed visits with a new-found brother, visits that consume three pages of book space? Maybe it never happened as he purports?

Gun CC Recognition Bill !

Pro-gun concealed carry recognition bill, H.R. 2900, allows law-abiding citizens who can legally carry concealed in their home state to carry Nationwide.

Titled "The Secure Access to Firearms Enhancement (SAFE) Act," it recognizes that constitutional rights do not become null and void at the state line.

The SAFE Act recognizes that while CCW permits are the "norm" in most states, constitutional carry is the ideal because the 2nd Amendment does NOT require any permits. Vermont is a constitutional carry state. Vermont had it right for over a century. Any person can carry a concealed firearm—whether they are a resident of the state or not—except for use in the commission of a crime. No registration, no paperwork, no arbitrary denials by anti-gun bureaucrats.

Vermont consistently ranks among the safest states in the country.

And other states are finally starting to follow suit. Three states (Alaska, Arizona, and Wyoming) have passed constitutional carry laws for their own citizens. Texas passed a modified version, allowing for a concealed firearm anywhere inside one's vehicle, including motor homes. And since 1991, constitutional carry has been allowed in more than 99% of the state of Montana.

However, reciprocal agreements between states are written in such a way that an actual permit is still required in order to carry concealed from state to state, or there is NO way to legally carry concealed in another state. The SAFE Act addresses this issue in a way that respects the Constitution and in a way that recognizes the unalienable right to defend one's life—without needing a permit from the government.

The SAFE Act also respects the Constitution and states' powers in that it does NOT establish national standards for concealed carry, nor does it provide for a national carry permit or require a state like Vermont to move to a permit system (in order for its citizens to carry out-of-state). This bill simply allows citizens who are able to carry in their home state, to also carry in every other state that allows concealed carry.

Another important distinction is that Rep. Broun's bill, unlike other legislation being debated in Congress, does not rely on an expansive, erroneous interpretation of the Commerce Clause. The SAFE Act instead recognizes the "full faith and credit" protection that is guaranteed in Article IV of the Constitution.

Constitutionally-protected rights, including the right to self-defense, do not disappear at the state line. Rep. Broun's SAFE Act will simply allow lawful gun owners who have the right carry concealed firearms in their home state to also carry in other states.

In Hawaii, where all the police chiefs are violating the state laws that allow concealed carry by a conspiracy to refuse to issue CC licenses to law abiding citizens. They do that because Hawaii law says "may issue" not "shall issue" permits. With this bill, we can go to a Mainland state, get a permit to carry concealed, return to Hawaii, and carry a gun.

ACTION: Please contact your Representative and urge him or her to cosponsor Rep. Broun's SAFE Act.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!






