The First Thanks Giving Tells About Failure of Communism

Wh had all heard the story of the first Thanksgiving repeated endlessly, reenacted with excitement and stage jitters by many a grade school child, with proud parents in attendance. The funny looking clothing, black britches and the hat with the big belt buckle. The story about how the Native Americans, the Pakonoket Wampanoag, led by their sachem Massasoit to be more exact, saved the starving Pilgrims from another brutal winter by showing the settlers how to grow corn in the flinty New England soil. We can all picture the scenes in our minds' eye. But the story we've known all our lives is incomplete.

The first Thanksgiving took place in 1621, as the history books tell us. But it was not so much a celebration of the bounty of nature as it was the last meal of a condemned man. The first winter had been brutal, with forty four of the original one hundred and one pilgrims dying of scurvy and exposure. While the Pilgrims managed to grow some corn that next summer, it wasn't nearly enough. The following winter took more settlers' lives. While the Pilgrims – as hardy, adventurous and motivated a group of settlers as ever lived - knew how to farm, how to husband animals, how to hunt and fish, something kept them from being as productive as they needed to be to feed and clothe themselves throughout the New England winters. When the Pilgrims came to this new land, they had decided that they would pool their resources and share their production. Those more capable would do their part, and those more needy would get their share. Plymouth Colony Governor William Bradford called this system "communism", two hundred ninety six years before the Russian revolution. (The Russians met with the same results, but took seventy years and 30 million dead to figure it out.)

But after two successive harsh, hungry winters had nearly destroyed the Plymouth Colony, the elders of the community, led by Governor Bradford, decreed a change in how food was produced and distributed. In 1623, they allotted a parcel of land to each settler, and allowed them to keep the produce of those parcels for themselves, instead of putting them into the common stores and distributing them equally, which had been the practice up until then. Governor Bradford wrote <http://press-pubs.uchicago.edu/founders/documents/v1ch16s1.html> in his journal that ending communism: "...had very good success, for it made all hands very industrious, so as much more corn was planted than otherwise would have been by any means the Governor or any other could use, and saved him a great deal of trouble, and gave far better content. The women now went willingly into the field, and took their little ones with them to set corn; which before would allege weakness and inability; whom to have compelled would have been thought great tyranny and oppression."

"The experience that was had in this common course and condition, tried sundry years and that amongst godly and sober men, may well evince the vanity of that conceit of Plato's and other ancients applauded by some of later times; that the taking away of property and bringing in community into a commonwealth would make them happy and flourishing; as if they were wiser than God. For this community (so far as it was) was found to breed much confusion and discontent and retard much employment that would have been to their benefit and comfort. For the young men, that were most able and fit for labour and service, did repine that they should spend their time and strength to work for other men's wives and children without any recompense. The strong, or man of parts, had no more in division of victuals and clothes than he that was weak and not able to do a quarter the other could; this was thought injustice. The aged and graver men to be ranked and equalized in labours and victuals, clothes, etc., with the meaner and younger sort, thought it some indignity and disrespect unto them. And for men's wives to be commanded to do service for other men, as dressing their meat, washing their clothes, etc., they deemed it a kind of slavery, neither could many husbands well brook it."

They had tried collectivism and, finding it destructive to human nature, had changed course.

The following November, 1623, saw a Thanksgiving Feast that was truly a celebration of abundance, a bounty created by the enterprise of free men and women, toiling on their own behalf and, in the process, creating a richer society. Today we call this system free enterprise, or the free market. Of all the things that have come down to us from the Pilgrims to today's America, that is their most precious gift to us.

We hope that your Thanksgiving Day celebration will provide you the warmth, sustenance, and joy bequeathed us by the Pilgrim settlers, and their inspiration to lay the foundation of a rich, just and generous America.

Obama's Solar SCAM gets BIGGER!

The Solyndra loan debacle has already cost American taxpayers more than half-a-billion dollars, but it is about to cost them millions more. Each of the company's 1,100 former employees will receive a package of federally funded benefits worth approximately \$13,000 in Trade Adjustment Assistance (TAA), increasing the Solyndra bill by \$14.3

million.

TAA assists workers who have lost their jobs because of trade imbalances due to increased foreign imports or outsourcing.

The Labor Department announced the award on November 18, the day after Energy Secretary Steven Chu testified before Congress that the loan guarantee was apolitical and made entirely on the merits. Chu specifically declined to apologize for the growing scandal.

The newest payout some Republicans outraged. Sen. Orrin Hatch, said, "The failure was blamed on China, but if you cannot even out-compete U.S. companies, it wasn't foreign competition that ruined your business; it was simply a failed business model." Hatch's spokeswoman Julia Lawless (whose surname best describes the Obama administration) added, "This is an embarrassment and shows that TAA is a program of questionable merit."

Understandable as their pique is, GOP outrage should not be directed toward the little people receiving a pittance of \$13,000 apiece (alongside victims of other trade agreements they largely approved). The outrage is the crony loans this administration steered toward its politically connected friends at the top, which total more than 37 times that amount. Solyndra board member Steve Mitchell wrote an e-mail alluding to an "unnatural relationship" in the White House that had dissolved since the initial grant was made. Primary Solyndra investor and Obama campaign bundler George Kaiser met multiple times with Valerie Jarrett, Obama's most intimate adviser. As the company appeared ready to fail, the administration apparently violated the Energy Policy Act of 2005, which clearly states that all government loan guarantees "shall be subject to the condition that the obligation is not subordinate to other financing." If found guilty, that would make the Solyndra loan an impeachable offense. Although House Republicans are investigating the approval process and have subpoenaed all White House documents related to it, Obama simply chose to ignore the subpoena.

None of these expenses – the \$535 million loan guarantee, the \$75 million the company's investors will recoup before taxpayers receive a dime, the \$1 million Obama paid to Lazard Ltd. in an eleventh hour attempt to save the company, nor the \$14.3 million to laid off Americans who were just doing their jobs would exist if Obama were not simultaneously committed to political cronyism and misguided, job-killing environmentalist policies. But even that is not the greatest outrage.

The greatest outrage is the fact that no one in the administration has been held accountable for the illegal shenanigans that assured this fleecing of the American taxpayer ever took place.

Obama Buddy Does Racial Smear on Michele Bachman Appearance on TV

Congresswoman Michele Bachmann is questioning whether the policy priorities of Barack Obama are really in America's interest. "Remember it was Michele Obama who said she is only recently proud of her country and so these are very anti-American views," she said. "That's not the way that most Americans feel about our country. Most Americans are very concerned to have a president who doesn't share those values."

"If we look at the collection of friends that Barack Obama has had in his life," Bachmann told MSNBC's Chris Matthews in 2008, "it calls into question what Barack Obama's true beliefs and values and thoughts are. His attitudes, values, and beliefs with Jeremiah Wright on his view of the United States is negative; Bill Ayers, his negative view of the United States. We have seen one friend after another call into question his judgment but also, what it is that Barack Obama really believes?"

When Bachman appeared on the Jimmy Fallon show Nov. 21, Fallon's black drummer, Ahmir "Questlove" Thompson, chose the song theme Lyin' Ass Bitch deliberately to diss Bachman, and she would not know it because she is ignorant of Black Music. He was evidently proud of the action, tweeting a clue of what was to come to his followers before the show came on the air.

Super Congress FAIL to Find Budget Cuts; Obama Impedes Process FAILURE was Predetermined!

Congress, both Democrats and Republicans, could not control itself. So it punted its failures to a Super Committee and even the threat of massive defense cuts could not prompt Congress to kick its spending addiction.

Now, some members of Congress are even saying "to hell with the defense cuts. We'll stop those cuts." Of course.

But it was all a bunch of smoke and mirrors for one simple reason.

We're going to add ten trillion dollars over the next ten years and all this committee was supposed to do was find \$1.2 trillion to trim over the same ten years, a hundred billion dollars in cuts a year to a trillion dollars in deficits a year.

The math never added up. The Super Committee and the elaborate theater that preceded it were just a bipartisan way to cover up the fact that both Democrats and Republicans have screwed the country out of its life savings while they've been funding their pet projects and special interests.

And this all leads to a calamitous dirty little not so secret that the Democrats have no answer for. If Republicans, who were willing to raise taxes on the Super Committee by the way, gave the Democrats their ultimate dream — taking 100% of all dollars earned from every single person who makes \$200,000.00 a year or more we still wouldn't close Barack Obama's budget deficit.

That leads us in two directions no one in Washington wants to go. Either start raising taxes on the middle class or start cutting significantly from the federal budget.

Because no one in Washington outside of the real conservatives are willing to do either, the Super Committee, the Budget Control Act, and every statement to every reporter by every leader of either party is all smoke and mirrors.

FAILURE Is Obama Standard

Obama did voters a favor: Standard of review in his own words.

During the 2008 campaign and early in his administration, he laid out the standards by which he should be judged. He made it perfectly clear under what conditions he would deserve re-election.

And by his own standard he doesn't deserve a second term.

In February 2009, when employment was at 8.2 percent, he declared, "If I don't get this done in three years, then this is going to be a one term proposition."

Unemployment has yet to return to February 2009 levels, much less fall lower. Based on that standard alone, this should indeed be a "one term proposition."

But consider the President's other promises and self-imposed standards.

On the stimulus: He predicted unemployment below 8 percent. Today: We're not even close.

On Obamacare: He promised accessibility and affordability. Today: Prices continue to skyrocket and many Americans have discovered they cannot keep their current plan.

On the deficit: He promised to cut it in half by the end of his first term. Today: He produced three years of record budget deficits, exceeding \$1 trillion each.

On the debt: He promised to slow its growth. Today: He accelerated it and it has now surpassed \$15 trillion.

On ethics: He promised the most transparent administration in history. Today: The administration has been caught gambling taxpayer money on failed investments like Solyndra for political purposes.

On lobbyists: He promised there would be no lobbyists in his administration and no lobbyist money in his campaign coffers. Today: He has gladly welcomed both.

He promised a thriving economy. It's stalled.

He promised change. We have gotten more of the same.

He promised to unite us. We're divided.

He has so little to run on, Democrats have resorted to pathetically arguing that "it could've been worse."

In 2012, Republicans will hold the president accountable. He laid out the terms on which he wanted to be judged. And we're happy to accept those terms.

It's not our standard. It's not a partisan standard. It's the President's standard. Let's hold him to it.

There are no words more damaging to Obama's re-election prospects than his own. That makes our messaging strategy quite straightforward: Repeat those words—his broken promises—as often as possible.

The case file concerning the Fast and Furious spawned murder of Border Patrol Agent Brian Terry has **DISAPPEARED** from federal court records!

According to the Arizona Star, all of the case information gathered by federal prosecutors is now unavailable, " apparently sealed by a federal judge." " Our office is handling the case and can't comment further " said a spokeswoman for the U.S. Attorney's office in San Diego.

Prosecution of illegal alien Manuel Osorio Arellanes for the December, 2010 Terry killing was originally to be handled by Phoenix U.S. Attorney Dennis Burke. But it was Burke's office which meticulously directed the Arizona based portion of the Fast and Furious gunwalking operation for Attorney General Eric Holder, advising Phoenix ATF Agent in Charge Bill Newell every step of the way in the "loss" of 2000 firearms across the Mexican border. When Burke resigned in a fit of panic as a result of the continuing investigation of his conspiratorial Fast and Furious misdeeds by the Grassley/Issa congressional committees, the Terry case was transferred to San Diego.

And now the file is gone along with every scrap of information it contained. How many key items, how many records preserved in that file are certain to be removed and "misplaced" by DOJ lackeys and lickspittles at the direction of Lanny Breuer, Attorney General Eric Holder's personal Department of Justice toady? A third rifle has already disappeared from the murder scene and three illegals known to have been armed while accompanying Osorio Arellanes on the night of the killing have been deported, charged only with immigration violations by the US Immigration Service.

But the weeks' continuing saga of the Regime's cover-up is not limited to the sudden disappearance of case files.

In 2010, ATF agents in El Paso, Texas confiscated a number of firearms found to have been purchased via the now infamous Phoenix Fast and Furious network of FBI financed straw buyers. But Phoenix ATF Group Supervisor David Voth and Field Agent Hope MacAllister, known by El Paso to have engineered the sales while helping run Fast and Furious, REFUSED to assist the Texas based ATF office in the prosecution of the case! In fact, Phoenix ATF office head Bill Newell is reported to have called the El Paso ATF, demanding they "stand down."

This recalcitrance precipitated an El Paso-generated email threatening subpoenas for the Phoenix agent's testimony just 2 days after the murder of Brian Terry. But the question now is WHY? Why did the Phoenix ATF refuse to assist agents in Texas with their case? Was it some childish unwillingness to share in the glory of the capture, given it was the Phoenix office which was responsible for the very existence of the firearm evidence?

Or was it the fact that these weapons were not SUPPOSED to have been taken by federal agents in the first place! After all, ATF and ICE agents had been ordered on numerous occasions to "stand down" and allow weapons to disappear cross the Mexican border. Had these El Paso agents unknowingly arrested gun runners and interdicted the passage of firearms across the border against the wishes of Phoenix US Attorney Dennis Burke, Phoenix ATF head Bill Newell and the Department of Justice itself?

Were the creators of Fast and Furious concerned that the prosecution of these men could lead to any number of questions which the Obama Regime did not want raised and certainly not answered?

Obama Regime plays a game of political cover up which will shield the guilty from any responsibility for Terry's murder. And the rest of America watches quite helplessly as criminals enjoy federal assistance in the fracture of laws ostensibly designed to protect the public.

Hold On Until Auto Tax Bill In Error is Corrected

WAILUKU, Maui, Hawai'i – Due to a computer programming error, motorists will owe more than is shown on their present December 2011 vehicle registration renewal notice.

The incorrect notices were mailed out on November 18th. Corrected registration renewal notices will be mailed with the words "CORRECTED MOTOR VEHICLE RENEWAL" appearing above the mailing address.

The incorrect notices do not include the current increase in State of Hawaii weight tax and registration fees. The renewal notices for the state are sent out by the City and County of Honolulu. Officials have assured fellow county governments that the programming error has been resolved.

Residents are asked to wait for the corrected notice if they plan to mail in their renewal payment. Mailed in renewals received with the incorrect payment amount will be returned.

Those wishing to renew prior to receiving their corrected renewal notice may renew in person at any Motor Vehicle and Licensing office or online at www.mauicounty.gov/mvrrenewal. Please note: December vehicle registration renewals are due by December 31, 2011.

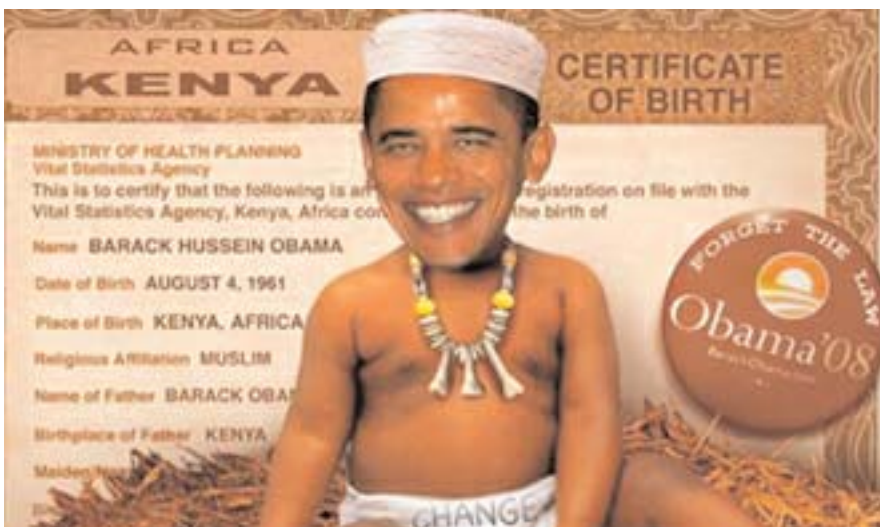

How many times have I heard that stupid expression of hopeless resignation when, to comfortably acquiesce in all laws it would be necessary for a person to assume that there are no bad ones. Obama Muslims complain that the Christian crosses in every room at Catholic University of America are a human rights violation that prevent Muslim students from praying?

That's the complaint to the Washington, D.C. Office of Human Rights filed by a professor from rival George Washington University across town.

GWU Law School Professor John Banzhaf takes the Catholic institution to task for acting "probably with malice" against Muslim students in a 60-page complaint that cites "offensive" Catholic imagery all over the Catholic school, which he says hinder Muslims from praying.

Banzhaf, who already has a pending lawsuit against the university over ending its policy of allowing mixed-gender dormitories and has a history of filing civil rights suits on such topics as childhood obesity and smoking, filed the complaint alleging that Muslim students are not given their own prayer rooms.

He alleges that the university, "does not provide space – as other universities do – for the many daily prayers Muslim students must make, forcing them instead to find temporarily empty classrooms where they are often surrounded by Catholic symbols which are incongruous to their religion," according to the Tower, Catholic University's student newspaper.

"This attorney is really turning civil rights on its head," observed Patrick Reilly of the Cardinal Newman Society. "He's using the law for his own discrimination against the Catholic institution and essentially saying Catholic University cannot operate according to Catholic principles."

The complaint is absurd, writes Thomas Peters on the website CatholicVote.

"Can you imagine a law professor helping Catholic students to sue a Jewish or Muslim school to demand that the schools install crosses, remove their religious symbols, and allow the Catholics to construct a chapel on their property?" wrote Peters. "Can you imagine the argument being that Jewish and Muslims schools using their religious symbols and following their faith traditions would be described in the legal brief as "offensive"?"!

"Normally I would have confidence that this lawsuit will be deemed without merit, but the way things are going these days, I just can't be sure anymore. Simply incredible."

Impeach Obama! Petition

Barack Obama is indeed succeeding in his plans to "transform America," but not in the way voters expected on Election Day in 2008. The number of Obama's actions that arguably qualify as impeachable offenses is staggering.

The question before the country is what to do about it?

True, Obama faces the voters in 14 months, and that will be seen by many as a reason to avoid the turmoil of an impeachment proceeding. But one process has nothing to do with the other. Elections proceed on an established calendar, but if he has committed acts that warrant removal by way of impeachment, that process should proceed independent of the election calendar. Obama has demonstrated contempt for the Constitution and is increasingly resorting to rule by decree. He is recognized by a growing number of Americans as a danger to the republic – certainly a danger to our liberties and also a serious threat to our national security.

It is time for the House of Representatives to take its constitutional responsibility seriously and launch an impeachment investigation. The investigative committee should hold hearings, collect and weigh the evidence, and then present its findings to the Congress and the nation.

Has Obama committed "high crimes and misdemeanors" that warrant impeachment and removal? There is much evidence that says, yes, he has.

Impeachment of an acting president is justified on constitutional grounds if any of the following 12 questions is answered in the affirmative:

Did President Obama have personal knowledge of the illegal "Fast and Furious" project run by ATF and approved by top officials in the Department of Justice, a plan to sell over 2,000 guns to Mexican drug cartels, weapons now linked to numerous crimes on both sides of the border including the murder of Border Patrol Agent Brian Terry?

Did the president have knowledge of the ongoing effort by Attorney General Eric Holder and other Justice Department officials to cover up the true purpose and scope of that ill-conceived, illegal project?

Did the president direct his appointees on the National Labor Relations Board to bring a lawsuit against Boeing as a political payoff to organized labor?

Did the president act contrary to the advice and pleas of his own CIA director, four previous intelligence agency heads of both parties and numerous experts on covert operations when, on April 16, 2009, he made public four internal Justice Department memos on terrorist interrogation techniques, thereby deliberately emasculating our anti-terrorist intelligence operations and endangering the lives of many intelligence agents?

Did the president have knowledge of a plan by the Department of Homeland Security, ordered by Homeland Security chief Janet Napolitano and the deputy commissioner of U.S. Customs and Border Patrol, David Aguilar, to distort and falsify the Border Patrol's southwest border illegal-alien apprehension numbers by means of a deliberate, planned undercount – for the purpose of misleading the public and Congress about the true (abysmal) state of border security?

By choosing not to secure the border against unlawful entry, has the president willfully disregarded his clear duty under Article IV, Section 4, of the Constitution to protect the states from foreign invasion? Did the president admit this in a candid exchange with Sen. Jon Kyl, telling him the reason he was not stopping the cross-border human trafficking was to force Republicans in Congress to strike a deal for amnesty legislation?

Is the president showing contempt for the Constitution, the separation of powers and the rule of law by ordering an "administrative amnesty" for millions of illegal aliens through the implementation of the John Morton memo of June 2011?

Has the Obama demonstrated contempt for the Constitution and violated the separation of powers by issuing numerous executive orders that have no basis in statute and often contradict congressional votes against such actions?

Did the president authorize Labor Secretary Hilda Solis to violate current federal laws against aiding and abetting illegal aliens by signing agreements with foreign countries and pledging to protect and fund educational efforts to inform illegal aliens of their workplace "rights"? Also did these "agreements" she signed with foreign countries violate Article II, Section 2, of the Constitution which clearly establishes the manner in which treaties are to be undertaken and ratified?

Did the president violate his oath of office when he instructed the Department of Justice not to defend the Defense of Marriage Act in federal courts? Does the Constitution permit the person designated by Article II, Section 1, as holding the "executive power" of government to decide unilaterally to not enforce a law he disagrees with?

Did the Obama offer a federal job to Rep. Joe Sestek if he would withdraw from the 2010 Democratic primary race for U.S. senator in Pennsylvania?

Did the Obama violate the War Powers Act by conducting military operations in Libya beyond the 60-day limitation?

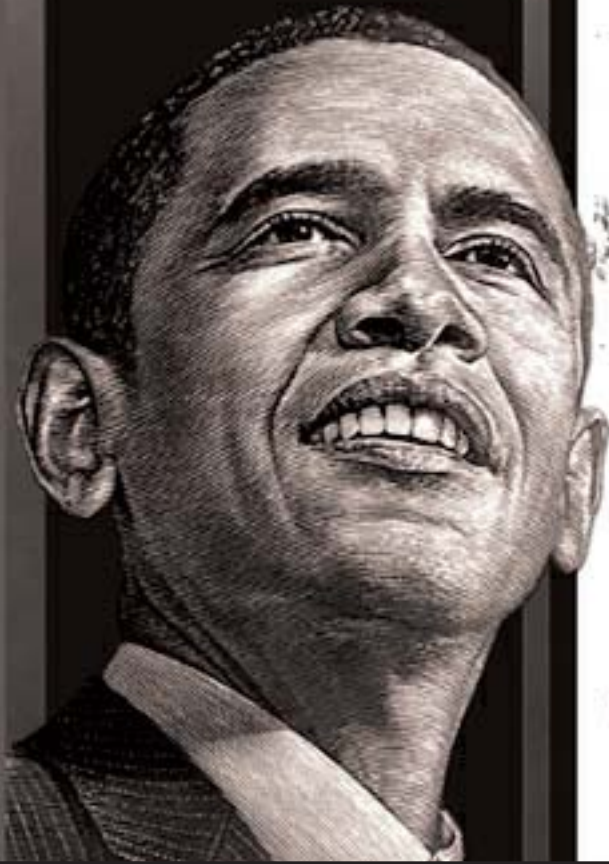

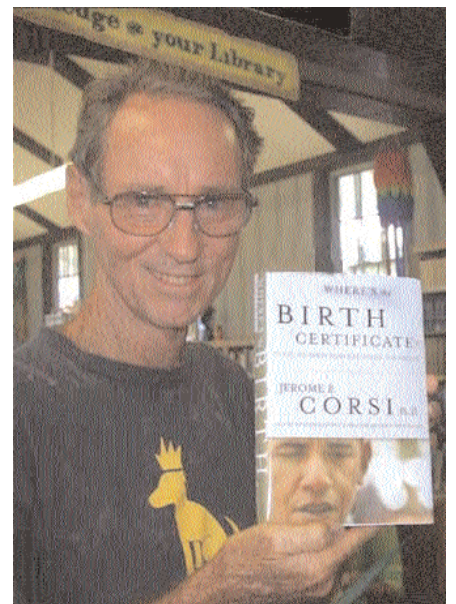

Congress Duty To Impeach Obama! Or Be Impeached!

If the leaders of the House believe that some or all of Obama's actions are indeed impeachable offenses but nonetheless refuse to launch a formal investigation to ascertain all the facts, then there are two parties involved in Obama's assault on the Constitution – the perpetrators and their accomplices. In layman's terms, Obama and his radical cronies are busy robbing the bank, while the House Republican leadership waits in the getaway car.

If some or all of the allegations are adopted as true by the House but rejected by the Senate as inadequate grounds for removal, that means the president of the United States can ignore the particulars of his oath to defend the Constitution. It means he can govern by edict instead of "taking care to faithfully execute the laws of the United States." It means that Barack Obama has indeed succeeded in his plans to "transform America." It means we are perilously close to crossing the line between constitutional republic and dictatorship.

There is no question that the impeachment and removal of Barack Obama is within the proper scope and purpose of the Constitution's impeachment provisions.

The history of the nation's two presidential impeachment cases shows that although treason and bribery are the only crimes mentioned by name, this does not limit Congress' authority to bring an indictment on other serious charges. Constitutionally speaking, "high crimes and misdemeanors" can mean almost anything Congress in its wisdom wants it to mean.

It is also clear from history that the identification and naming of impeachable offenses is as much a political judgment as a legal one. The assignment of separate and distinct roles to the House and the Senate – and the two-thirds vote requirement for conviction and removal – were deemed by the founders as sufficient safeguards against removal of a president for transient or narrowly partisan reasons.

Clearly, the authors of the Constitution did not intend that presidents should be vulnerable to removal for light or petty reasons, hence the use of the adjective "high" in front of the words "crimes and misdemeanors." Nevertheless, what constitutes a "high crime" is up to Congress to decide.

We learned that lesson forcefully in the Clinton impeachment case. Politics can and will play a part in the process, but that is expected and entirely consistent with constitutional principles.

President Clinton was charged with two counts each of perjury and obstruction of justice. The House thought the crimes serious enough to adopt the impeachment resolution in December of 1998. Two months later, the Senate disagreed and voted for acquittal – or more precisely, failed to muster the required two-thirds vote for conviction. In the House vote, only five Democrats voted for impeachment, and in the Senate, not a single Democrat voted for conviction. So much for keeping politics out of the courtroom.

The peculiar and revealing thing about those two Clinton impeachment votes is that no one seriously doubted the guilt of the president on the perjury and obstruction charges. But Democrats in Congress believed that even if true, the charges did not warrant removal from office. They reasoned that the charges dealt with a private matter – Clinton's sexual escapades – and not government business.

The Clinton case illustrates that for both Democrats and Republicans, in the last analysis, what is an impeachable offense is inevitably a political question as much as a legal one. Scholars and lawyers may have an opinion, but Congress' opinion is the only one that matters. Congress' supreme authority on impeachment questions is as much an embodiment of our separation of powers doctrine as the president's broad prerogatives in foreign policy.

Admittedly, the likelihood of the present Democrat-controlled Senate casting a two-thirds vote for conviction and removal is almost zero. However, this does not discharge the House from its constitutional obligation to pursue the matter if – in their considered judgment – the evidence warrants.

The questions posed above all relate to actions affecting national security and unlawful political intervention in the execution of our nation's laws – not mere policy differences. Obama's disastrous economic policies, his ideological war against domestic energy production and his reckless proposals to add new trillions to our national debt – all are policies that are damaging to our nation's well-being. However, such policies are not in themselves impeachable crimes. His contempt for the Constitution and the rule of law is a different matter altogether.

Demand that Obama's records be released. Obama is using tax dollars to keep his I.D. concealed. Over 40 lawsuits fought to keep all his records sealed.

Verbal shots fired in Ruidoso gunfight

Armed citizens in New Mexico, upset by a government disarmament edict, confronted the Ruidoso, New Mexico city council in defiance of an executive order from the mayor banning guns on city property. Yet despite the "powerful emotions," dozens of armed citizens conducted themselves peaceably, controlling themselves and their anger against what activist and New Mexico Militia leader Bob Wright called the act of a "tyrant."

Larry Pratt of Gun Owners of America, who made a special point of flying in and appearing armed, offered a cogent rebuttal to Ruidoso Mayor Ray Alborn's loopy contention that ordering the people he works for disarmed would leave meetings "unprotected": Almost all of the mass murders in our country have occurred in areas just like you're fixing to set up, in gun free zones.

YES. There were powerful emotions and strong words at a city council meeting in Ruidoso, New Mexico Tuesday tonight.

Gun owners from down the road and from around the country, packed council chambers to give the mayor an earful about his executive order banning guns from village government buildings and meetings.

They ignored the ban to prove their point. Guns were very visible but the only shots fired were verbal and they were directed at the mayor.

"You are just as a much a tyrant for requiring someone to surrender their civil rights to carry a firearm in order to participate in their government as you are in asking them to surrender their right to vote or anything else," Bob Wright said.

Speakers were given three minutes to speak and they did not hold back, most of them with their guns holstered by their sides. "Almost all of the mass murders in our country have occurred in areas just like you're fixing to set up, in gun free zones," Executive Director of Gun Owners of America, Larry Pratt, said.

Locals, activists from the NRA and the Executive Director of Gun Owners of America, who flew in from Virginia, took to the podium to take a stand.

In all more than 100 people filled the council chamber to capacity, dozens of them carrying guns, despite signs that say 'no guns allowed.'

Police were on hand but they did not stop them.

Ruidoso Mayor Ray Alborn issued the executive order banning firearms from government property and meetings a month ago, after a citizen refused to give up his gun after taking the podium. "The police chief took it away from him, he filed a suit. At that time I realized how unprotected we in the front of the room, there's 11 of us, plus all of our citizens and employees who were at the meeting, how unprotected we were," Alborn said.

The executive order does not apply to law enforcement.

Critics loudly proclaim he is violating their 2nd amendment rights and that he thinks the law's on his side.

Alborn says if village council shoots down his executive order he might step down. "My responsibility is health, safety and welfare of our employees so if we're not going to be able to do these kinds of things I'm not sure I want to be sitting in this seat," Alborn said.

Protesters called for the mayor and the village attorney to resign. However, in the end the village council put off the vote.

No word when they might vote on the executive order.

The mayor says two state laws give him the authority to ban firearms in village buildings But the National Rifle Association says a New Mexico Supreme Court decision forbids local authorities from making piecemeal changes to the constitutional right to keep and bear arms.

Hows defacto Government Working Out for you?

One branch of the federal government gets the final say in a dispute involving the federal government?

Between 1937 and 1995, the U.S. Supreme Court never once ruled a congressional statute unconstitutional? Not one. Now are you really going to tell me that everything Congress passed in that 58 year span was within the federal government's constitutionally enumerated powers?

James Madison and Thomas Jefferson recognized this inherent conflict of interest and refused to accept the notion that the Supreme Court stood as the final arbiter. In the <<http://www.constitution.org/cons/kent1798.htm>>Kentucky Resolutions of 1798, Jefferson wrote: "The government created by this compact (the Constitution) was not made the exclusive or final judge of the extent of the powers delegated to itself; since that would have made its discretion, and not the Constitution, the measure of its powers; but that, as in all other cases of compact among powers having no common judge, each party has an equal right to judge for itself, as well of infractions as of the mode and measure of redress."

Madison expanded on this idea in his http://www.constitution.org/rf/vr_1799.htm Report of 1800, a defense of the Virginia Resolutions of 1798.

But it is objected that the judicial authority is to be regarded as the sole expositor of the Constitution, in the last resort; and it may be asked for what reason, the declaration by the General Assembly, supposing it to be theoretically true, could be required at the present day and in so solemn a manner.

On this objection it might be observed, first, that there may be instances of usurped power, which the forms of the Constitution would never draw within the control of the judicial department; secondly, that if the decision of the judiciary be raised above the authority of the sovereign parties to the Constitution, the decisions of the other departments, not carried by the forms of the Constitution before the judiciary, must be equally authoritative and final with the decisions of that department. But the proper answer to the objection is, that the resolution of the General Assembly relates to those great and extraordinary cases, in which all the forms of the Constitution may prove ineffectual against infractions dangerous to the essential rights of the parties to it. The resolution supposes that dangerous powers, not delegated, may not only be usurped and executed by the other departments, but that the judicial department also may exercise or sanction dangerous powers beyond the grant of the Constitution; and, consequently, that the ultimate right of the parties to the Constitution, to judge whether the compact has been dangerously violated, must extend to violations by one delegated authority, as well as by another; by the judiciary, as well as by the executive, or the legislature.

However true, therefore, it may be, that the judicial department, is, in all questions submitted to it by the forms of the Constitution, to decide in the last resort, this resort must necessarily be deemed the last in relation to the authorities of the other departments of the government; not in relation to the rights of the parties to the constitutional compact, from which the judicial as well as the other departments hold their delegated trusts. On any other hypothesis, the delegation of judicial power would annul the authority delegating it; and the concurrence of this department with the others in usurped powers, might subvert for ever, and beyond the possible reach of any rightful remedy, the very Constitution which all were instituted to preserve.

The Government formed by the Constitution of the United States was not the exclusive or final judge of the extent of the powers delegated to itself; but that, as in all other cases of compact among parties having no common judge, each party has an equal right to judge for itself.

The founders viewed "we the people" as THE final arbiters of what is and what is not constitutional. Thus, if "we the people" routinely roll over in the face of federal or state overreach, then "we the people" are the problem. Those unelected, unaccountable black-robed oligarchs have consistently elevated "judicial supremacy" over "constitutional supremacy". SCOTUS and the unchecked federal court system have become a menace to constitutional order. The problem as I see it is that most of the politicians who run for any kind of political office are Lawyers who are taught by Law Schools that are in fact teaching that all laws must be subjected to the scrutiny of eventually the Supreme Court. This teaching is basically violates the constitutional confines of government to begin with. They MUST be reigned in or ignored.

Declaration:

"That to secure these rights, Governments are instituted among Men, deriving their just powers from the consent of the governed, That whenever any Form of Government becomes destructive of these ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its foundation on such principles and organizing its powers in such form, as to them shall seem most likely to effect their Safety and Happiness."

And from James Madison:

That this Assembly doth explicitly and peremptorily declare, that it views the powers of the federal government, as resulting from the compact, [the Constitution] to which the states are parties; as limited by the plain sense and intention of the instrument constituting the compact; as no further valid that they are authorized by the grants enumerated in that compact [ie. article 1, section 8]; and that in case of a deliberate, palpable, and dangerous exercise of other powers, not granted by the said compact, the states who are parties thereto, have the right, and are duty bound, to interpose for arresting the progress of the evil, and for maintaining within their respective limits, the authorities, rights and liberties appertaining to them. - James Madison, Virginia Resolution of 1798
