## A Vet Who Understood the Bill of Rights Dies After Expose

Molokai resident Lt. Richard Smith, USN ret. was a victim of military testing of radiation and biological agents in the 1960's, suffering cancers and other ailments. He is concerned for all veterans used in the secretive

military policy of chemical testing, the need for better care for vets, and educating the public about such unethical operations against American citizens perpetrated by the very government agents who violate the Constitution for the united States of America and the Bill of Rights that the vets swore to uphold and defend against enemies, foreign and DOMESTIC. [December 15 is Bill of Rights Day]

Having moved back to Molokai and living with his deceased wife Sadie Wallace's family for a while, Richard told The MAN reporter that he served on the USS Granville S. Hall [YAG40] from 1965 to 1968 as an engineering officer. His ship was exposed to heavy radiation before he came aboard while in Operation Crossroads, Castle, Wigwam, Redwing, but he soon exhibited signs of radiation sores on his face. But that is not all. His ship was used for testing Biological and chemical warfare agents in 1968 at Enewetok Atoll. He was also concerned about the other ship, YAG 39 George Eastman with five tugboats that were used for bio/chem testing. He says he could get no informations from the military to support claims of service disability, not even records of immunization shots given as medical records. Vets with related medical problems have no place to turn, he lamented.

Part of the story became public knowledge in 1996 when the Pentagon admitted that Pesian Gulf War vets had been exposed to chemical and biological weapons when they blew up ammunition dumps in Iraq full of the chem/bio weapons supplied to Saddam Hussein by the US and Allies. Smith documented that the military had lied to vets about the toxic effects just like they lied about Agent Orange in Viet Nam, and radiation from Depleted Uranium ammo that was used by the US in the 1991 War on Iraq.

Smith died November 9, 2009. He was 79 years old, an American patriot.

## Economy & Unemployment

As Maui Pineapple closes down now, it reflects a nationwide problem.

Employers already are squeezed by tight credit, rising health care costs, wary consumers and a higher minimum wage. Now, the surging jobless rate is imposing another cost. It's forcing higher state taxes on companies to pay for unemployment insurance claims.

Some employers say the extra costs make them less likely to hire. That could be a worrisome sign for the economic recovery, because small businesses create about 60 percent of new jobs.

Sam Schlosser, owner of Plymouth Foundry Inc. in Plymouth, Ind., said his unemployment tax bill could double next year. Revenue at the family-owned company, which makes iron castings for machine parts, has fallen about 50 percent, he said. In case of higher taxes, his company may have to consider layoffs, he said. Obama's failed so called "stimulus" only compounds this problem.

A lot of people — including a lot of business owners — don't understand how this works. Because the government cuts the unemployment check, it is widely assumed that it's the government that pays the unemployment benefits. In reality, those benefits are funded by employer taxes. And here's the killer: The more unemployment benefits your former employees collect, the higher your taxes go.

It works like insurance. If the government pays a claim, your rates go up. In fact, if your former employee collects \$10,000 in unemployment payments, you can expect to pay close to twice that in increased premiums. At least that's how it works in my state, Illinois.

Thus, this becomes another cost of doing business that smart owners attempt to control. How do you control it? By making as few hires as possible, by making sure that those hires you do make are as strong as possible, and by combining documented rules with good management.

And now, thanks to the stimulus package, unemployment insurance has been extended as much as an additional 20 weeks. If you've had to lay off 10 people, this could easily result in additional taxes of \$10,000, \$50,000, or even \$100,000. It's a time bomb that won't go off until after employers get their contribution-rate increase in November, but it will go off.

And therein lies the final irony: Even after the economy improves, I'm going to think long and hard before I hire anyone. Thanks to the stimulus package — the stimulus package — the costs, paperwork, and legal exposure associated with hiring employees is on the rise.

Despite a sharp drop in the dollar, a spike in commodity prices, Obama-nomics increases national debt and pretends the economy is in recovery.

The cyclical bull market in stocks and positive print on GDP has caused some on Wall Street and in Washington to claim the recession has ended. Despite all the good economic news, an end to fiscal and monetary stimulus is nowhere in sight, precisely because policymakers know the happy news is artificially derived.

A closer look indicates that neither the administration nor the Federal Reserve believes its own recovery rhetoric. They understand that the economy will not prosper without continued life support, i.e., free paper money debt notes.

Taxpayers must wake up to the truth: All public debt is ultimately the responsibility of the private sector to pay off--either directly or through future taxes. As a result, the economy has never been more precarious than it is today, because the truth is that a country cannot devalue itself to prosperity.

Inflation lies behind all infirm currencies, and it is inflation that destroys the purchasing power of consumers. The diminished value of their wallets leaves them with the ability to buy only non-discretionary items. As a direct result, unemployment rates soar and economic output plunges like on Molokai.

## Obama may put USA under jurisdiction of foreign judges?!

Barack Obama has dispatched a delegation to The Hague to explore issues involving the United States' possible participation in the International Criminal Court, an organization critics charge could be used to prosecute Americans under international legal standards for actions that are not crimes in the U.S.

Ambassador Stephen Rapp said "The Obama administration would like the U.S. to be a party to the court."

Mathew Staver, lead attorney for Liberty Counsel and dean of Liberty University Law School, said U.S. membership in the ICC would be a mistake.

"This administration is globalist and transnationalist and wants to bring this country into the global system. The U.S. stands to have its citizens being prosecuted by the international court in The Hague and have its citizens come under the world court's jurisdiction," he said.

WND columnist David Limbaugh has raised similar concerns.

"Transnationalists," he wrote, "believe that American judges, in interpreting

our Constitution, can resort to this 'community of reason' (foreign laws) to choose between two 'plausible' legal positions."

It is the global community, he wrote, that such transnationalists "look to" to determine standards.

In his book, "Global Deception," author Joseph Klein warns that the International Criminal Court is just one building block of a "brave new world" already under way.

He said the court would have "secret proceedings that would make terrorist trials look open by comparison" and suggested the plan is for them to "take precedence over the U.S. judicial system."

## NOAA Humpback Whale Council Opportunity for MHS

Sanctuary Seeks Applicants for Advisory Council – Including a Newly Created Youth/Student Seat

NOAA's Hawaiian Islands Humpback Whale National Marine Sanctuary is seeking to fill eight primary seats and eight alternate seats on its advisory council.

The council's role is to provide the sanctuary management with advice on resource protection, research, education and outreach programs. Topics that the council is currently addressing include: ocean acidification, protection of areas of cultural and biological importance, response and rescue efforts for marine animals, vessel-whale collisions, proposed development activities within sanctuary waters, and planning to engage communities and seek public input during the review and revision process for the sanctuary's current management plan.

The sanctuary is currently accepting applications for primary and alternate seats representing Native Hawaiians, Fishing, Education, Research, Honolulu County, Hawaii County, Maui County, and Kauai County. Candidates will be selected based on their expertise and experience in relation to the seat for which they are applying, community and professional affiliations, and views regarding the protection and management of marine resources.

Additionally, for the first time, the sanctuary is seeking to fill a non-voting youth/student seat and alternate seat to represent the youth segment of the community, defined as ages 14-17. The interest and enthusiasm of youth under the age of 18 is very important to the sanctuary; these students are our future generation of ocean stewards and leaders. The sanctuary wishes to foster and facilitate these links with youth in sanctuary communities and has added a non-voting youth seat to the advisory council.

## Giving Back Fall Prevention Project of Paia is Recognized

Thomas J. Giving Back has published a training manual for Fall Prevention Project mentors and aims to open four new project sites each year for the next three years. Giving Back's goal is to replicate the program in Hawaii and the mainland US. "Our society worships youth and discards the elderly. I'd like to see that change," says Karen Peterson, founder and executive director of Giving Back®. "This program is about honoring our elders, keeping them healthy and fit so they can give back their gifts to the community."

## Oceanic Study Travel to Midway Available

Nominations Sought for Papahnaumokukea Educators Workshop

Educators and conservation leaders have an opportunity to more intimately understand Papahnaumokukea Marine National Monument's wildlife and cultural resources through a workshop being offered on Oahu and Midway Atoll in 2010. Nominations to attend the workshop are being sought now through Jan. 4, 2010.

This workshop is designed to create a greater understanding of the Monument and to inspire community environmental stewardship at a grassroots level. The program, Papahnaumokukea Ahahui Alaka'i, which was offered for the first time in 2009, will take place June 12-22, 2010.

The first three days will be spent on Oahu preparing, learning natural and cultural history, and meeting with past participants. The remaining seven days will be spent on remote Midway Atoll within the Monument, located 1,250 miles northwest of Honolulu. Participants will need to provide their own transportation to Oahu as well as lodging and meals during the three days in Honolulu. At Midway Atoll transportation, lodging, and food costs will be covered by the workshop.

The Papahnaumokukea Ahahui Alaka'i program is accepting nominations from educators in formal and informal settings, community leaders, and people in positions that support community change and stewardship. Up to 12 people will be chosen to participate. Both U.S. and international nominees are welcome. Participants will be chosen based on their written nominations, their letters of support, and their capacity to fulfill the program's need for a strong variety of skills and abilities. In addition, potential participants are asked to submit a draft plan for an environmental stewardship project that will be modified throughout the workshop and implemented in their communities.
