## Annual Health Fair 11-22

A heavy downpour, a forecast of flash floods did not deter Molokai residents and visitors from participating in the annual Na Pu'uwai, Molokai General Hospital, Molokai Community Health Center and Maui Memorial Health fair on Saturday, November 22 at the Mitchell Pauole Center. Meadow Gold Healthy Baby Contest and the Strong Men and Strong Women Contests show went on following an unplanned "Plan B." Power lifting led off by Kelly Rawlins, Suliama Oto and defending men's lightweight division title holder Shawn Adolpho and defending heavyweight winner Peter Pale were among the participants. From Honolulu, MC Champ and his crew of strong men officials conducted the competition inside the MPC hall instead of the parking lot venue which included competitors from the Big Island.

The day began at 6am for participants in the annual MGH 10K Run, started off in style by Champ. Undaunted by the rain nearly 100 participants slogged their way from Kakahaia Park to Mitchell Pauole Center!

At 10am, just outside on the covered stage, twenty-six entrants in the Meadow Gold Healthy Baby Contest charmed the judges, Crystal Egusa, Dr. Barbara Kelly and Dr. John Engle.

Health conscious Molokai residents gathered information from everything from la'au lapa'au with Auntie Marie Place to educational opportunities from MCC-Molokai Education Center, to on island treatment services from Hospice and Care Resources to Pulama I Na Keiki and Queen Liliuokalani Children's Center—and more. Hawaii Air Ambulance, Molokai's lifeline to critical care off island was offering 50% membership fees for the duration of the health fair.

Many took advantage of the free blood glucose, blood pressure and blood cholesterol offered by Maui Memorial medical staff, MCC Nursing Students, Na Pu'uwai and Ohana Health Care RNs. There was a wealth of health information and services offered at the annual Health Fair.




## Constitutional crisis looming over Obama's citizenship!

With the above history, a new lawsuit "Petition for Writ of Mandate" was filed against CA Secretary of State, Debra Bowen, Barack Obama, Senator Joe Biden, and the California Democratic Party Electors on November 12, 2008 in Superior Court in Sacramento by former U.S. Ambassador Dr. Alan Keyes, who is the Presidential candidate of the American Independent Party.

Alan Keyes unquestionably has standing under California law which clearly states that other candidates for an elected office are among the people who properly have standing to contest election results.

Here is Keyes' main argument against the 2008 Presidential Election results: "There is a reasonable and common expectation by the voters that to qualify for the ballot, the individuals running for office must meet minimum qualifications as outlined in the federal and state Constitutions and statutes, and that compliance with those minimum qualifications has been confirmed by the officials overseeing the election process. Heretofore, only a signed statement from the candidate attesting to his or her meeting those qualifications was requested and received by SOS [Secretary of State], with no verification demanded. This practice represents a much lower standard than that demanded of one when requesting a California driver's license. Since SOS has, as its core, the mission of certifying and establishing the validity of the election process, this writ seeks a Court Order barring SOS from certifying the California Electors until documentary proof that Senator Obama is a "natural born" citizen of the United States of America is received by her. This proof could include items such as his original birth certificate, showing the name of the hospital and the name and the signature of the doctor, all of his passports with immigration stamps, and verification from the governments where the candidate has resided, verifying that he did not, and does not, hold citizenship of these countries, and any other documents that certify an individual's citizenship and/or qualification for office."

## Dear Representative Hirono, Senator Akaka, Senator Inouye:

Article II, Section 1 of the U.S. Constitution mandates that: "No Person except a natural born citizen, or a citizen of the United States at the time of the adoption of this constitution, shall be eligible to the Office of President; neither shall any person be eligible to that office who shall not have attained to the age of thirty five years, and been fourteen years a resident within the United States."

There are numerous questions as to Obama's citizen status raising suspicion and doubt about Obama constitutional qualification to be president. To settle these questions Mr. Obama must produce proof of citizenship!

Documents that must be produced include;

- (a) a certified copy of "vault" (original long version) birth certificate;
- (b) certified copies of all reissued and sealed birth certificates in the names Barack Hussein Obama, Barry Soetoro, Barry Obama, Barack Dunham and Barry Dunham;
- (c) a certified copy Certification of Citizenship;
- (d) a certified copy Oath of Allegiance taken upon age of maturity;
- (e) certified copies of admission forms for Occidental College, Columbia University and Harvard Law School; and
- (f) certified copies of any court orders or legal documents changing his name from Barry Soetoro.

It is reasonable that these documents should be produced considering that his father is Kenyan, his adoptive father is Indonesian, and his grandmother claims to have been present at his birth in Kenya. If he is a natural born U.S. citizen then producing these documents should not be any problem.

These allegations will not go away until Mr. Obama produces proof to federal authorities and the public. If he will not do so voluntarily he must be compelled by every means available. You, as an employee of The People, have sworn an oath to support and defend the Constitution.

We The People are demanding you to make every effort, both public and private, to resolve this fundamental Constitutional question before 20 January.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!



## Cheney and Gonzales Indicted

The seven indictments made public in by District Attorney Juan Angel Guerra, and he said the prison operations-related charges against Cheney and Gonzales are a national issue and experts from across the country testified to the grand jury. Regarding the indictments targeting the VP Dick Cheney and former AG Alberto Gonzales, Guerra said, "the grand jury is the one that made those decisions, not me."

Cheney is charged with engaging in an organized criminal activity related to the vice president's investment of some \$85-million dollars in the Vanguard Group, which holds financial interests in the private prison companies running the federal detention centers. It accuses Cheney of a conflict of interest and "at least misdemeanor assaults" on detainees because of his link to the prison companies.

The indictment accuses Gonzales of using his position while in office to stop an investigation in 2006 into abuses at one of the privately-run prisons.

## CORRUPT COPS REPORTS

A corrupt cop in Arizona is a DARE officer with a penchant for sexual assault.

In Nogales, Arizona, a former Nogales DARE officer was convicted last Friday on numerous charges related to unwanted sexual contact with young women. Ramon

Borbon, 40, was convicted of sexual abuse and obstructing a criminal investigation in the case of a 16-year-old girl whom he forced to touch him inappropriately and threatened to stop her from going to authorities. He was also convicted of sexual assault and kidnapping charges in the case of a 19-year-old woman for restraining and raping her. He was in uniform during both incidents. In a motion ruling during trial, Santa Cruz County Superior Court Judge James Soto wrote that Borbon has "a character trait which gives rise to an aberrant sexual propensity" and that he appeared to have "identified young, vulnerable females with a history of psychological and/or substance abuse problems that are less likely to come forward and if they do, are less likely to be considered credible."

He will be sentenced December 12.

There are also at least four other complaints of sexual abuse against Borbon. The police department internal investigators had earlier found them to be "without merit." [Cops protecting cops is a major corruption problem in Maui, too.]
