## Boat Harbor Channel Blocked Aha Kiolo Legislation is Pau



Early morning Saturday 11-26, approximately 15 Molokai residents who are opposed to the operation of the 145 feet long tourist cruise ship Safari Explorer met at Kaunakakai Wharf to stop the ship from entering the harbor. The protesters used two small boats and about 5 surfboards to block the entrance channel to the harbor so the cruise ship could not enter without endangering the lives of protesters who occupied the entrance channel with intention of interfering with navigation.

Interference with navigation is unlawful per State Law and Federal Law.

HAR 13-231-42 prohibits blocking of State Harbor entrance channel. Interference with navigation. No person shall operate any vessel in a manner which will unreasonably interfere with other vessels or free and proper navigation of waterways. [Mahalos to officer Mat Hillen, Maui DLNR Enforcement, who cited the statute, and added that he expects that if any citations are issued for violating this statute, a court appearance would be required, and the crime would be handled at the misdemeanor level with fines and possible jail time imposed.]

Concerning the channel blockage of the Cruise Boat entering Kaunakakai Harbor November 26, DOT and DLNR officials are meeting this week with U.S. Coast Guard and State Attorney General regarding enforcement of the navigation rights, safety concerns, defining the harbor area limits, and enforcement jurisdiction, according to Randy Awo, Maui DLNR office.

The Safari Explorer captain ultimately rerouted, and opted to go instead to Lanai. Protest leader Walter Ritte reportedly called the protest a success, and a meeting with ships owners was scheduled for today 11-30 at 6pm MPC. His mantra is that the tour operators must sit down and talk to him or keep out. He calls other residents to join his Aha Kiolo, but nobody seems to know specifically what subjects he wants to discuss—money extortion and control? What?

Ahaa! But the ship Captain returned unannounced Sunday morning to Kaunakakai Harbor and docked. Tourists were off loaded into tour vans and headed east to Halawa Valley. Apparently the tour operators are unaware of the Molokai Development Plan that specifies the Kaluakoi area for tourism destinations along with Kaunakakai; and, Manae east Molokai is for residents. Even protesters seemed oblivious about the designated destinations of the Plan.

At least two logs were dropped onto the highway about mile 20 near Honolulu bridge to block the vans from proceeding to Halawa Valley, but nobody wants to take credit for those acts. State DOT workers removed the obstructions, but the tour vans has already rerouted to go west to Hoolehua and maybe westend Kaluakoi. That is where the Community Plan says they belong.

## Aha Kiolo legislation Expired, Pau since June 2011

Molokai Island seems to represent a unique location where the land is best managed by the people who live on it; possible because the human population is low enough that resources of water and land aren't yet overwhelmed—but nearly.

However, the stated purpose of Aha Kiolo legislation was to create an advisory system to State government, not to set up a separate race based police state on Molokai headed by Ritte, who decide and enforce their ideas on everyone else. We get enough of that from the State and Obama regimes already!

Act 212 – the Aha Moku System was A Bill for a race based Act Relating to Native Hawaiians. The law was enacted on July 1, 2007. The Act creates the Aha Kiolo Advisory Committee to advise the Legislature on Native Hawaiian resource management practices; derive a comprehensive set of native Hawaiian best practices for natural resource management. The Act appropriated \$222,000 for years 2007-2009 for administrative costs of the Aha Kiolo Act 212. [cont'd page 4]

## Hawaii vs Obama Lawsuit? State Wants Closed Doors!??

November 30, Honolulu 1st Circuit, Judge Nishimura. Orly Taitz reported the hearing regarding lawful access to Barack Obama's birth certificate demands from Hawaii Dept. of Health director Fuddy defended by Deputy Attorney General of Hawaii, Jill Nagamine, bringing an oral motion to forbid cameras in the courtroom and not televise the proceedings. The judge agreed to do it and asked Nagamine, if she would consent to proceed this way. Nagamine refused. At that point, all we could do, is reschedule."

Taitz also said she filed a voter fraud complaint with the chief elections officer. According to HI elections statute, he has to hold public hearings. She went to Scott Nago office to find out the schedule, but Nago was "Not Available".

George Peabody phoned and emailed to Nago, and got the same answer.



# Its a Hawaiian Coot



Over the past month I've received numerous calls about a black 'duck' or 'chicken' along the highway at the Kaunakakai Wastewater Reclamation Facility. This slate-grey bird is the endangered Hawaiian Coot (Fulica alai), a specific type of waterbird called a rail and one of the two surviving endangered endemic rail species in the Hawaiian Islands that have not gone extinct. Also known as Hina's mudhen, in ancient times it was believed that its nighttime cry or croaking was considered a warning or an alert of pending trouble. Many olelo refer to the species, such as Hanopilo ka leo o ka `alae, said of a person who talks himself hoarse, as in the hoarse call of the mudhen.

The `alae ke`oke`o typically nests on mats of floating vegetation, but at the wastewater facility where nesting material is at a premium, Molokai's elementary school children have donated bodyboards to be used as floating nesting islands to protect the bird from land-based predators. The Hawaiian Coot is fiercely territorial, defends its off-spring from other waterbirds and has been known to kill other species that have wandered across invisible territorial boundaries. The behavior of this gregarious bird can be comical as it runs across the surface of water, a physical ability it has due to webbing on the toes and not between.

On-going research about this endangered species conducted at the wastewater facility has documented round trips between Molokai and Maui and inter-island movements of banded coots from Oahu. Research birds are identified by neck bands with individual three-digit codes. The sudden appearance of the `alae ke`oke`o along the highway is a concern and is believed to be caused by the recent arrival of a hybrid duck species causing an imbalance of the normal habitat safe within the fenced facility. If you observe a Hawaiian Coot that has been struck by a vehicle alongside the road please report it immediately so it may be retrieved.

## Don't Count on Supreme Court to Nullify ObamaCARE

U.S. Supreme Court has agreed to rule on the constitutionality of Obamacare, the president's signature health-care-takeover legislation, but a rights organization that advocates for restoration of recognition of the 10th Amendment says states and consumers should not count on the court to reverse the law, especially with Obama's appointee Justice Elena Kagan now sitting on the bench, too.

"From 1937 to 1995, the Supremes didn't strike down a single federal law as unconstitutional. Not one in nearly 60 years," Michael Boldin, executive director of the Tenth Amendment Center, wrote in a warning about the issue.

"Bottom line? When it comes to limiting federal power, the Supreme Court is NOT to be trusted. Not only have they utterly failed to uphold the Constitution, it's not really in their interest either."

The Supreme Court announced Nov. 14 its acceptance of three Obamacare-related cases. It will hear more than five hours of arguments. A decision isn't expected until the middle of next year.

Essentially, the issue is whether under the Commerce Clause the federal government, under threats of fine and jail, can order citizens to purchase a government-specified product – ObamaCARE health insurance – from a private company. Critics say such power is unconstitutional, and if affirmed, there is nothing the government could not order, from which car to purchase to which foods to how much exercise you must do.

Boldin said his organization has drafted state-level legislation that allows states to reject "the notion of not just health insurance mandates from the federal government, but the very core idea that the federal government is authorized to be in the health care industry at all." Hawaii should pass it, but Democrats won't.

The organization's Federal Health Care Nullification Act declares that Obamacare "is not authorized by the Constitution for the United States and violates its true meaning and intent." These states have passed laws to prevent Obamacare from being implemented in their state: Tennessee, Kansas, Louisiana, Virginia and Idaho, and Ohio Arizona, Missouri and Oklahoma.

## No to Gun Control Treaty !

The Bill of Rights Day is December 15th. Each of you can make at least one other person aware of the day, and of how essential the Bill of Rights has been to American freedom. Wake up now, as Obama and Clinton are pushing a U.N. Treaty to take your guns, and the 2nd Amendment voided! **MAKAALA !**

Representative Joe Walsh has drafted a bill that would block U.S. funding to the United Nations if it seeks to implement gun control affecting U.S. citizens.

Despite victories by gun owners in elections and legislative battles and US Supreme Court ruling that right to keep and bear arms is a fundamental individual right protected by the Bill of Rights throughout the country in recent years, on the international front gun control is moving against gun owners quickly.

Most significantly, in 2012 the UN plans to release a final draft of the Arms Trade Treaty—a treaty with severe consequences for American gun owners.

Meetings are held behind close doors, but from information gathered by GOA we believe that the ATT will, at the very least, require gun owner registration and microstamping of ammunition. The ATT will define manufacturing so broadly that any gun owner who adds an accessory such as a scope or changes a stock on a firearm would be required to obtain a manufacturing license.

It will include a ban on many semi-automatic firearms and demand the mandatory destruction of surplus ammo and confiscated firearms.

Barack Obama, not surprisingly, welcomes the treaty. He knows that he is unlikely to get such radical proposals through the Congress, so the UN Treaty venue provides him a backdoor way to enact gun control.

Secretary of State Hillary Clinton is also on board and began pushing for the treaty as soon as she was confirmed in her position. "The United States is prepared to work hard for a strong international standard in this area," she said.

Since treaties must be ratified by the Senate, GOA is working continually to buck up weak-kneed Senators who might be pressured to ratify the treaty.

But the House, which controls the nations' purse strings, can also play a role in killing the ATT (or any other anti-gun treaty, for that matter).

Rep. Joe Walsh's legislation will cut U.S. funding to the UN if the international body imposes any restrictions on Americans' gun rights.

This is a huge deal, because without the contributions of the United States, the UN would be crippled financially. According to government reports, U.S. taxpayers foot the bill for 22 percent of the UN's regular budget and 27 percent of its "peacekeeping" budget.

American gun owners, in other words, are funding the organization that wants to do away with the Second Amendment!

Rep. Walsh is putting the UN on notice: back off our gun rights, noting that:

- \* It is the constitutional power of Congress to determine United States foreign policy through the ratification of international treaties;
- \* U.S. Presidents signing on to treaties open the door for international organizations to unilaterally regulate the lives of citizens of the United States;
- \* International and transnational organizations force their rules on people of the United States through conventions, multilateral agreements, and nonratified treaties, such as agreements that affect the private ownership of firearms by law-abiding citizens. Obama/Clinton are TRAITORS so BEWARE !

ImAct 212 – the Aha Moku System.....

Establish an Advisory Committee to report to the Legislature, and for allowing each of the thirty-seven moku statewide to actively participate and engage in discussion on the creation of the Aha Moku Council System.

Act 212 was to sunset in June of 2009. However, no funding was ever released by the State. So, Act 39 extended the time frame for the AKAC from 2009 to June of 2011. The `Aha Kiole Commission, through the `Aha Moku System would provide consultation and recommendations to state, county and federal agencies, boards and organizations that have responsibilities and authority for the creation and implementation of regulations and policies for natural and cultural resources management. After that, in 2011, Bill 23 funded another \$64,500 for fiscal year 2011-2012 for an executive director of the `aha kiole advisory council. Bill 23: Aha Kiole Advisory Commission was Vetoed on 7-12-11 - Returned from the Governor without approval. The Governor said some of the measures will not work as they are written. He said others create additional work for departments without funding .

Final Report dated December 2010 sent to Legislature: completed its mandate to initiate the process of best practices for natural and cultural resource management that is based upon the indigenous resource management practices of moku (regional) boundaries, recommended integration into governance regime of the State via establishment of Aha Kiole Commission, Ahupuaa, Moku, and an Kiole, and even recommendations for community law enforcers, i.e., Native Hawaiian rangers recognized and established by State and county governments to enforce the rules and practices of each ahupuaa. Questions arose about whether the would be recognition by the judiciary and police so that citizen citations against violators of natural resource are legal in the judicial system? Because it is a traditional management system, eligibility to participate in the process is based on competency in generational knowledge of natural resources and processes as identified and confirmed by the community (e.g., ahupua`a, moku and/or mokuuni) participating in the management process.

# Obama's SS# is not his !?

Barack Obama should be in handcuffs and being tried in court as a criminal based on prima facie evidence claimed in a voter fraud complaint filed with the Hawaii Office of Elections by attorney Orly Taitz

In 2009 Dr. Taitz received reports from licensed investigators Neil Sankey and Susan Daniels, which show, that according to most reputable national databases for most of his life Barack Obama used a Connecticut Social Security number 042-68-4425, issued in 1977, even though he was never a resident of the state of Connecticut. In 1977, Social Security numbers were assigned according to the state where application were submitted. In 1977 Obama was nowhere near Connecticut, he was a student at the Punahoa school in Hawaii, where he resided. Additionally, national databases showed another birth date, associated with this number, a birth date of 1890. In around of 1976-1977, due to changes in Social Security administration, many elderly individuals, who never had Social Security numbers before, had to apply for their Social Security number for the first time in order to obtain Social Security benefits. It appears, that the number in question was assigned to an elderly individual in CT around March of 1977, the death of this elderly individual was never reported, and from around 1980-1981 this number was fraudulently assumed by Barack Obama. Taitz was a delegate at the Continental Congress Convention in 2009, where she had a discussion on the matter of Barack Obama's fraudulent use of the aforementioned Connecticut Social Security number with a recently retired senior deportation officer from the department of Homeland Security, John Sampson. Mr. Sampson provided her with an affidavit, attesting to the fact, that indeed according to national databases Obama is using a Connecticut Social Security number, even though there is no reasonable justification or explanation for such use by one, who resided in Hawaii in and around the time the Social Security number in question was issued.

In 2010, Barack Obama posted on line on WhiteHouse.gov his 2009 tax returns. As he posted those returns, he forgot to flatten the PDF file, so all of the layers of modification of the file became visible to the public. One of the pages contained Obama's full Social Security number 042-68-4425. Taitz received an affidavit from Adobe Illustrator program expert Chito Papa, attesting to the fact, that initially posted tax returns of Barack Obama contained Connecticut Social Security number 042-68-4425. Thousands of US citizens and individuals around the world were able to obtain the original file with the full Social Security number before Obama reposted after flattening the tax return PDF.

Taitz checked an official site for Selective Service SSS.gov. She entered name Barack Obama, date of birth 08.04.1961 (Obama's alleged birth date) and Connecticut Social Security number 042-68-4425, which Obama is using in his tax returns. She got a verification, showing, that Barack Obama registered for Selective Service, using this CT SSN. Two US government documents, showing Obama using CT SSN 042-68-4425.

Taitz received an affidavit from a witness Linda Jordan, who ran a E-Verify illegal alien check for the above Social Security number 042-68-4425. According to E-Verify, there is no match between Obama's name and the Social security he used in his tax returns and his Selective service application.

US Army officer, Colonel Gregory Hollister, reported he contacted SSNVS (Social Security Number Verification Systems) and found that the number Obama is using was never assigned to him. Additionally, there is a clear pattern of Social Security fraud by Obama's family members and friends. Recently Obama's uncle Onyango Obama was arrested for drunk driving and found to be using for employment a Social Security number, even though he is an illegal alien and not allowed to work. Obama's aunt Zeutuni Obama was stealing tax payer dollars by living in subsidized housing and using a state of Indiana-issued Social Security number, even though she is an illegal alien and was never a resident of the state of Indiana. Obama's close associate William Ayers, in his book "Fugitive Days" admitted to creating over a hundred fraudulent Social Security numbers using names of deceased infants, who did not get their Social Security numbers before their deaths.

For 3 years after his inauguration Obama refused to provide to the public his long form birth certificate. On April 27, 2011, when Obama posted his alleged long form birth certificate on line, just as with his tax returns, he originally did not flatten the file, and the serial number on it is higher, than the numbers issued later by the same registrar. Obviously, Obama's BC is fraudulent forged document. Numerous other parameters lead to the same conclusion by experts, that the document in question is not a copy of a 1961 type written document, but a computer generated forgery, created by cutting and pasting bits and pieces from different documents and filling in the blanks with computer graphics.

It appears, that Obama uses a Social Security number of a deceased elderly individual from the State of Connecticut, as well as a birth certificate number of a deceased infant from Hawaii. Research pointed to the fact little girl Virginia Sunahara was born in Honolulu on August 4, 1961 and passed away the next day. Social Security administration refused to provide even a redacted application for CT SSN 042-68-4425, which Obama is fraudulently using.

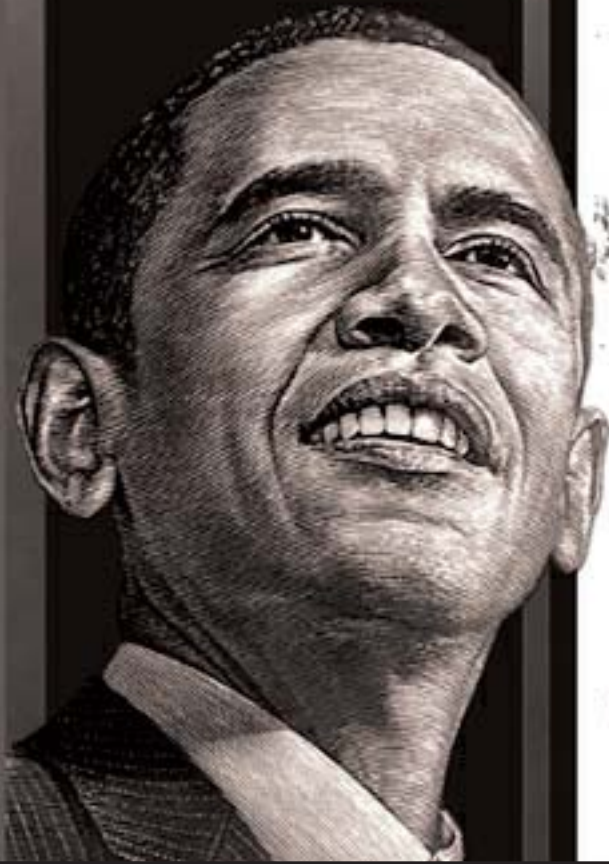

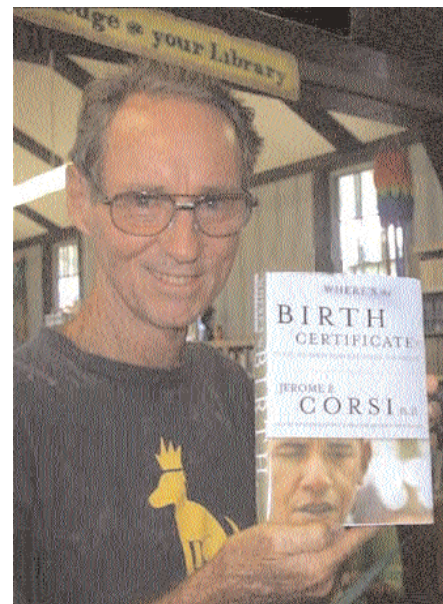
