### Hawaii "Residents" are not Hawaiians?

report by George Peabody......That is what the fascist big media Associated Press Stylebook used by government controlled sycophant newspapers around the country says. Residents of other states proudly identify with their home state, e.g., Californians, Utahians, Nevadians, but big media reporters are now instructed not to report residents of Hawaii as "Hawaiians" unless they are racially Hawaiians indigenous to the Hawaiian Islands. The AP has informed its member organizations [like the Dispatch] of an update to the stylebook that "Hawaii resident" or "islander" describes anyone who lives in the state who is not racially Hawaiian.

Previously, "Hawaiians" was used to describe all residents of Hawaii, regardless of race. And historically, "Hawaiians" was used to describe members of the Kingdom of Hawaii after Kamehameha I made war and dominated all the major islands we now call Hawaii, and made himself King and ruler over all indigenous people, aka, the King's subjects.

AP's new policy is very racist! Get real: "Hawaiian" alone does not define an ethnicity or a cultural group. Neither does it define the descendants of the first human settlers in these islands exclusively. Instead, Hawaiian, without an adjective that modifies the meaning of the noun to indicate race or ancestry, simply identifies the citizenry or flora or fauna of the state of Hawaii. In contrast, the Hawaiian kingdom's majority population of nationals was, and their decendants are, Native Hawaiians whether or not they live in the State of Hawaii. From 1842 on the term Hawaiian meant "of the nation of Hawaii," and this included people of European ethnicity and Asian descent who became subjects of the Hawaiian Crown by Oath or birth.

I say this new AP policy is racist because the definition of racism is the singling out of races for specialized treatment, e.g., Kamehameha Schools' entrance policy; OHA, etc. This racist AP policy is practically re-inventing separate drinking fountains to divide Hawaii.

## **Bird Flue Benefits Government Leaders**

State DOT reports that Honolulu Airport will now have a Quarantine Station for suspected avian flu infected people. These field stations will provide advanced emergency response capabilities, including isolation and communications facilities. State health officers assigned to each station will provide clinical, epidemiologic, and programmatic support, and quarantine public health officers will conduct airport surveillance and military personnel may be used to enforce quarantine pursuant to TITLE 42 § 266. Special quarantine powers in time of war...Surgeon General, is authorized to provide by regulations for the apprehension and examination, in time of war, of any individual reasonably believed to be infected with such disease and... may be detained for such time and in such manner as may be reasonably necessary.

Hmm, better not sneez at the airport if you are politically opposed to government policy.

Persons infected with avian influenza would likely have fever and respiratory symptoms (cough, sore throat, shortness of breath). The cause of a febrile respiratory illness in persons who have traveled in areas where avian influenza is present is more likely to be a common respiratory illness. If flight crew members are concerned that a passenger with symptoms of avian influenza, the captain of an airliner bound for the United States is required by law to report the illness to the nearest U. S. Quarantine Station prior to arrival. Quarantine officials will notify state and local health departments and the appropriate CDC officials.

The prospect of a bird flu outbreak may be panicking people around the globe, but it's proving to be very good news for Defense Secretary Donald Rumsfeld and other politically connected investors in Gilead Sciences, the California biotech company that owns the rights to Tamiflu, the influenza remedy that's now the most-sought after drug in the world.

Rumsfeld served as Gilead (Research)'s chairman from 1997 until he joined the Bush administration in 2001, and he still holds a Gilead stake valued at between \$5 million and \$25 million, according to federal financial disclosures filed by Rumsfeld.

The forms don't reveal the exact number of shares Rumsfeld owns, but in the past six months fears of a pandemic and the ensuing scramble for Tamiflu have sent Gilead's stock from \$35 to \$47. That's made the Pentagon chief, already one of the wealthiest members of the Bush cabinet, at least \$1 million richer.

Rumsfeld isn't the only political heavyweight benefiting from demand for Tamiflu, which is manufactured and marketed by Swiss pharma giant Roche. (Gilead receives a royalty from Roche equaling about 10% of sales.) Former Secretary of State George Shultz, who is on Gilead's board, has sold more than \$7 million worth of Gilead since the beginning of 2005. Another board member is the wife of former Calif.Gov.Pete Wilson. "I don't know of any biotech company that's so politically well-connected," says analyst Andrew McDonald. What's more, the federal government is emerging as one of the world's biggest customers for Tamiflu. Congress is considering a multi-billion dollar purchase.

Against all scientific prudence and normal public health procedure, the world population is being whipped up into a fear frenzy by irresponsible public health officials from the US Administration. The spread of H5N1 virus from one ill person to another has not been reported, and if it does, transmission is not expected to continue beyond one person.

They all warn about the imminent danger that a malicious viral strain might spread from infected birds, primarily in Vietnam and other Asian centers, to contaminate the entire human species in pandemic proportions. The flu pandemic of 1918 which is said to have killed 18 million worldwide, is cited as an example, but historical facts show the crude vaccines of that day caused most of the human deaths, not the disease.

On October 28 the Senate passed an \$8 billion emergency funding bill to address the growing Avian Flu panic. Health and Human Services Secretary Mike Leavitt, in a moment of candor during the debate on the Senate bill told the press, "If it isn't the current H5N1 virus that leads to an influenza pandemic, at some point in our nation's future, another virus will."

In the meantime taxpayer billions will have gone to a handful of pharmaceutical giants positioned to profit.

The only medicine, we are told, which reduce the symptoms of general or seasonal influenza and possibly, might reduce symptoms also of Avian Flu, is a drug called Tamiflu. Today the giant Swiss pharmaceutical firm, Roche holds the sole license to manufacture Tamiflu.

Due to the media panic, the order books at Roche today are filled to overflowing. Roche recently refused a request from the US Congress to lift its exclusive patent rights to allow other drug manufacturers to produce Tamiflu with the improbable excuse that it was in effect, too complex for others to rapidly produce.

The Secretary of Defense, the man who allegedly supported the use of contrived intelligence to justify the war on Iraq, is now poised to reap huge gains for a flu panic his Administration has done everything it can to promote. Rumsfeld stands to make a fortune on royalties as a panicked world population scrambles to buy a drug worthless in curing effects of alleged Avian Flu.

The model suggests the parallel to the brazen corruption of Halliburton Corporation whose former CEO is Vice President Dick Cheney.

Cheney's company has so far gotten billions worth of US construction contracts in Iraq and elsewhere. Coincidence that Cheney's closest political friend is Defense Secretary and Avian Flu beneficiary Don Rumsfeld?

It is another example of what someone has called the principle of modern US corrupt special interest politics: "Concentrate the benefits; diffuse the costs". President Bush has ordered the US Government to buy \$2 billion worth of Gilead Science,s Tamilflu.

But Tamiflu conflicts of interest are perhaps just the tip of the iceberg of the Avian Flu story. There is high-level biological research underway in Britain and presumably also the United States to develop a genetic engineering method to make chickens and other birds "resistant" to Avian Flu viruses.

British scientists are reportedly genetically engineering chickens to produce birds resistant to the lethal strains of the H5N1 virus devastating poultry in the Far East.

Laurence Tiley, Professor of Microular Virology at Cambridge University and Helen Sang of the Roslin Institute in Scotland are involved in developing transgenic chickens, which would have small pieces of genetic material inserted into chicken eggs to allegedly make the chickens H5N1 resistant. Tiley told the Times of London on October 29, "Once we have regulatory approval, we believe it will only take between four and five years to breed enough chickens to replace the entire world (chicken) population."

The real question in this dubious undertaking is which GMO giants are underwriting the research and development of GMO chickens and who will control their products because of patent restrictions. Is this like GMO Terminator Seeds? Looks like it!



## New Book Relesse: ENTRYS Author: Peter Bacho



ith Veterans' Day around the corner, the University of Hawaii's newest book release, ENTRYS brings reminders of another war and another world faced by veterans of the Viet Nam War. Though fiction, the story must tells the story of one Viet Nam veteran. ENTRYS is the story of Rico Divina, an "Indiopino" (half Yakima, half Filipino) who faced return to an uncertain future after being wounded. The story goes from 1968 to 1975, part journal, but all with vivid, earthy, sometimes violent descriptions of a life of what today is acknowledged as PTSD and his attempts to adjust to life by writing his story. ENTRYS is not a story for the fainthearted.

Author Peter Bacho, an award-winning writer who lives and works in Seattle-Tacoma, dredges up memories of youth and innocence lost of the generation who grew up and survived during the tumultuous years of the 60's and 70's. Published by the University of Hawai'i Press [ISBN-0-8248-2945-X, softcover, \$18.95 pp. 229]. --SP

### ATF: NO RULES, just OUTLAWS

The validity of ATF determinations regarding firearms is a serious concern to Americans and the 2nd Amendment. Under current law, it is a felony to receive, possess, or transfer an unregistered NFA firearm. Such offenses are punishable by a fine of up to \$250,000, imprisonment for up to 10 years, and forfeiture of the firearm and any vessel, vehicle, or aircraft used to conceal or convey the firearm.


ATF's Firearms Technology Branch conducts tests to determine whether firearms are subject to the NFA, among other things. Critics of the ATF maintain that there ought to be written or documented testing procedures or protocols for NFA-related firearms testing and evaluation. ATF officials have informed the Congressional Research Service that there is no "firearms testing procedures manual."

Recent Allegations About ATF Testing Procedures by Len Savage proves that ATF's firearms testing procedures were "scientifically invalid." He based his assertion on a court case (U.S. v. Glover, No. 3:03-CR-69 (D. N.C.)), in which an individual was charged with violating the NFA for possessing an unregistered machine gun, but according to Mr. Savage, the ATF firearms enforcement officer who testified against the defendant never disassembled the rifle. Upon subsequent examinations during grand jury proceedings, the firearm was found to be a semiautomatic rifle, which was malfunctioning ("slam-firing") in that it fired more than one cartridge per pull of the trigger. Consequently, the presiding judge dismissed this case (with prejudice).

New law: Fairness in Firearm Testing Act (H.R. 1603) In the 109th Congress, Representative Phil Gingrey has introduced the Fairness in Firearm Testing Act (H.R. 1603) on April 13, 2005. This bill would require ATF to make video recordings of the testing and examination of firearms and ammunition, and would prohibit the agency from editing or erasing any such recording. It would also require ATF to make available a copy of the recording on a digital video disc to: (1) a person who requests and claims an ownership interest in such item; and (2) to a defendant in a criminal proceeding involving such item. In regard to criminal proceedings, the bill would provide that a firearm or ammunition shall not be admissible as evidence unless: (1) the ATF has provided the defendant with a digital video recording of the relevant firearms test.

H.R. 1603 was referred to the Committee on the Judiciary and to the Committee on Ways and Means on April 13, 2005. It was referred to the Committee on the Judiciary's Subcommittee on Crime, Terrorism, and Homeland Security on May 10, 2005. No further action has been reported on this bill.




