Who Owns Molokai? Paul Kauka Cullen vs Lavinia Currier and Puu O Hoku Ranch, Ltd., et al: Judge Dismisses Eviction Case, but allows for re-file

At court hearing on Molokai yesterday November 8, attorney Robert Strand appeared for defendant Lavinia Currier, and he asked the judge to dismiss the Summary Possession and Eviction case [2RC11-1-3105] filed against Lavinia Currier. No attorney appeared to represent Defendant Puu O Hoku Ranch, Ltd., as required by the Court Summons served on Lavinia by deputy sheriff. Strand filed a pleading that stated Lavinia Currier has no knowledge if lands claimed by Paul Kauka Cullen are located in the Molokai District, among other defenses.

Molokai resident and landowner Paul Kauka Cullen filed his petition and Summons in Molokai District Court for summary possession and eviction of Currier et al and PuuOHoku Ranch, Ltd., after he established Default Judgment in his favor in the Quiet Title case [Civil No. 11-1-0124-3] initiated in Maui Circuit Court by her attorneys under Currier's corporation name, Puu O Hoku Ranch, Ltd.

The judge said he did not understand Cullen's petition for Summary Possession and Eviction against Currier and PuuOHoku Ranch, Ltd.; and, he opined that it was a land title case and involved too much money in damages that exceed jurisdictional limits of Molokai District Court authority. The judge then dismissed Cullen's case without prejudice to allow him to refile if desired; he did not grant Currier's request for costs and attorney's fees against Cullen.

Cullen plans to refile against Currier and POH with some small changes in his paper work, he said, because he can show clear title to him from Royal Patent, and that Currier and Puu O Hoku Ranch Ltd, must be removed from his land to stop damages they cause and so he can take lawful possession by law.

Real Property Notice To Owners Receiving An Agricultural Use Assessment

WAILUKU, Maui, Hawai'i –The County of Maui, Real Property Tax Division announced today that approximately 1,200 letters were sent to owners who do not have an agricultural use form on file for the 2012 assessment year.

The deadline to respond to the Director's letter is Friday, December 9, 2011. Failure to respond to the Director's request within 30 days of this notice will result in their agricultural use assessment being discontinued for the 2012 assess year.

Attacked Reporter Vindicated Prosecutor Drops Charge of Obstructing government Ops After Violent Physical Attack by Big Island Police Officer

The State of Hawaii, through the undersigned deputy prosecuting attorney, and Damon Tucker, through his counsel Gerard Lee Loy, Esq., hereby stipulate to entry of a nolle prosequi without prejudice in this case in the interests of justice. Any bail or release conditions should properly be cancelled and bail returned.

News reporter Damon Tucker, was attacked by HPD officer and injured while he was lawfully photographing police making arrests at a business establishment.

"I always knew I would be vindicated when a government official, interested in honesty and integrity in the prosecution process, would review the evidence contained in my video camera and in my iPhone's motherboard, and would know that certain police fabricated the claim of my misconduct," Damon said.

I am hopeful that the prosecutor's review of the police officers' conduct in fabricating claims of my misconduct will lead to better training in the police department about honesty and integrity in preparing police reports, and in selecting honest people to become police.

Further, to reinstate the rule of law and the Law of this Land, the U.S. Constitution and our constitutional republic -

1. Hawaii Senator Inouye Said...?

Inouye on ATF?

The story is one of not covert activity alone," intoned Sen. Daniel Inouye, D-Hawaii, "but of covert foreign policy It is a tale of working outside the system and of utilizing irregular channels and private parties accountable to no one, on matters of national security, while ignoring the Congress and even the traditional agencies of executive foreign policy making. The story is both sad and sordid."

Sen. Inouye was speaking not of the biggest scandal of the Obama administration, but of the biggest scandal of the Reagan administration — the Iran-Contra scandal. In that scandal, the United States sold weapons to parties in Iran in an attempt to free Lebanese-held hostages, then funneled the weapons cash to the anti-communist Contras in Nicaragua. The outcome of that scandal: indictments against the secretary of defense, the national security advisor, the assistant secretary of state, the chief of covert ops at the CIA and several others.

That scandal pales by comparison to the so-called Fast and Furious scandal now bubbling in Washington, D.C. In fall 2009, Eric Holder and the Department of Justice decided on a strategy supposedly designed to combat gun trafficking on the Mexican border. They didn't want the Bureau of Alcohol, Tobacco, Firearms and Explosives to seize illegal firearms anymore; instead, they wanted them to give firearms to members of the Mexican cartels.

According to the Congressional report, "ATFs Phoenix Field Division began allowing suspects to walk away with illegally purchased guns This shift in strategy was known and authorized at the highest levels of the Justice Department." One goal was to identify "straw purchasers" — legal gun purchasers who hand off those guns to illegal owners. Instead of arresting the straw purchasers and their contacts, however, ATF was to allow the guns to continue to flow to the Mexican drug cartels. "ATF and DOJ leadership were interested in seeing where these guns would ultimately end up," the report states. "ATF would only see these guns again after they turned up at a crime scene."

That's exactly what happened. The entire operation ended with only 20 indictments of straw purchasers — indictments that could have happened immediately upon transfer of the weapons, stopping the flow. In fact, the straw purchasers, at issue, were known to be straw purchasers from the get-go.

The indictments only took place at all because U.S. Border Patrol Agent Brian Terry was murdered using the weapons authorized for free flow by ATF and DOJ. Terry wasn't the only person killed because of Fast and Furious — the weapons OK'd by the DOJ and ATF were used in three murders, four kidnappings and an attempted murder in Mexico. They've been identified at 11 other crime scenes in the United States.

So what was the real goal of the DOJ and ATF? It certainly wasn't to shut down access to arms for the cartels — the ATF was agreeing to such access. It wasn't to stop straw purchasers — the ATF was signing off on the straw purchasers. It wasn't to track the movements of the cartel — there was no way to do that. It was, very simply, to establish for political reasons that American guns were being used in crimes by foreign cartels.

This was the Reichstag fire of the Second Amendment. By authorizing the passage of weapons to America's enemies, President Obama and his administration clearly wanted to set up a narrative that America's lax gun laws were killing American troops and law enforcement officers. They wanted their misuse of law enforcement authority to create the impetus for a crackdown on gun sales in the United States.

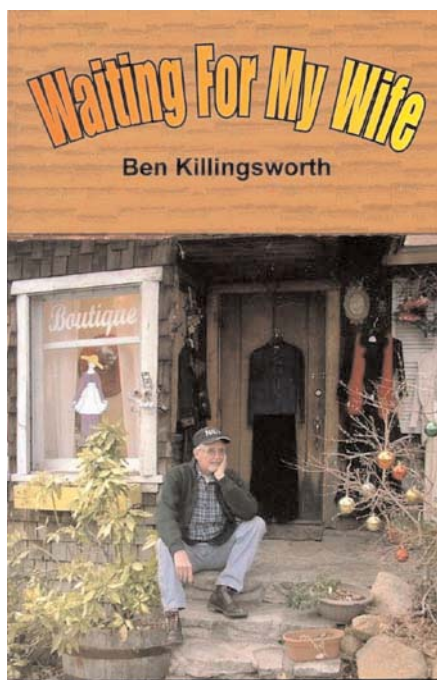

Big Wind: Don't they understand the word NO?

Big Wind hits road blocks from State Procurement Office, Public Utilities Commission & the Association of Hawaiian Civic Clubs. It became apparent that the request from the public for DBEDT to study additional renewable energy technologies as part of the programmatic EIS was an overwhelmingly common theme.

On October 27, 2011, "It seems very short sighted and detached from the subject matter on DBEDT's part that the public had to inform them they should consider solar/photovoltaic and geothermal technologies. DBEDT knew of these technologies at the time they issued the initial solicitation and had the opportunity to include it in the solicitation for proper disclosure and open competition. DBEDT chose the narrow scope of services."

First Wind's Moloka'i proposal collapsed since they could not secure a site.

Recently the PUC opened a docket so that HECO could ask for competitive bids to make up for that 200 MW. The PUC said that any renewable from any island that could connect to O'ahu would be considered.

Hawaiian Electric Company file a Draft Request for Proposal for 200 MW of renewable energy with the PUC. HECO insisted that anyone who proposes a solution using Neighbor Island resources has to have a way of delivering the power to O'ahu, and that anyone who proposes to build a cable to O'ahu from anywhere has to include a cable from Lana'i to O'ahu.

Castle & Cooke is in negotiations with Moloka'i Ranch and Pattern Energy for a 200 MW windfarm on Moloka'i and to increase Lana'i's proposed wind farm from 200 MW to 400 MW.

Thus any other Neighbor Island proposal would be dead on arrival, since proposing a cable to Lana'i requires getting David Murdoch's approval to land a cable on Lana'i and interconnect it to the Lana'i wind farm. Castle & Cooke has veto power over all other Neighbor Island submittals and therefore the DBEDT proposal to look at other Maui alternatives is a sham....

Four groups have requested to the PUC that they be admitted as parties in the RFP regulatory proceedings: (1) Friends of Lana'i, represented by Attorney Isaac Hall; (2) I Aloha Molokai; (3) Lana'i and Moloka'i Hawaiians (Kaulana Kaho'ohalahala, Clarence Halona Kaopuiki, and Matthew Mano) represented by the Native Hawaiian Legal Corp. (NHLC); and (4) Life of the Land....

On October 29, 2011, at the Annual Convention of the Association of Hawaiian Civic Clubs at Turtle Bay, Resolution 11-50 was passed: "Urging Governor Neil Abercrombie and the Hawai'i State Legislature to Support Sustainable, Low Impact Alternative Energy that will make O'ahu Energy Self Sufficient Rather than Dependent upon Lana'i and Moloka'i for its Energy and Protect the Open Spaces, Natural Resources and the Hawaiian Lifestyle of Moloka'i, the last Hawaiian Island."

The Resolution stated in part: "the proposed development of a 200 megawatt industrial farm on Molokai will turn Kaluako'i, Moloka'i into an industrial wasteland with 42-story high towers (tallest Moloka'i building is 3 stories), with 3 blades, each larger than a Boeing 747 wing; 725 ton concrete bases that are 60 feet in diameter and 10-20 feet deep" and "in two surveys on Moloka'i with an accu

Dear Molokai Advertiser-News:

A constellation of Hawaii statutes gives citizens broad autonomy over end-of-life decisions. Acceptance of aid in dying for terminally ill patients is growing.

Aid in dying is openly available in an increasing number of states, and major national healthcare and health-policy groups support it. Hawaii has no explicit legal prohibition to aid in dying.

It is appropriate for the medical profession to handle this practice as they do most medicine: subject to professional standards and best practices.

Hawaii law trusts doctors to set best practices for aid in dying as they have with other end-of-life procedures.

There is nothing more personal than decisions about the end of life.

Those decisions belong to patients in consultation with their family, their doctor and their God.

We must tell residents of Hawaii this choice is available, and physicians that they can provide aid in dying.

People should ask their families and their doctors whether they could support this end-of-life choice.

If I were terminally ill and expected to die within six months, I would want my personal doctor to be able to honor my wish for peace of mind. I trust my personal doctor to aid me in making my end-of-life choices.

Doctors in Hawaii cannot, and should not, be prosecuted for providing prescriptions for medication that terminally ill, mentally competent adults can, if they choose, self-administer to achieve a peaceful death.

Dying patients in unbearable pain should be able to die with dignity.

No one should force a dying person to suffer.
