



Federal ObamaCARE Enforcers Could Be Charged as Criminals in Texas

Governor-elect Neil Abercrombie says he wants to "protect Hawaii", according to his press release about visiting Molokai next week Wednesday with his lieutenant governor, Brian Schatz. Abercrombie is starting his all island inaugural events series of "confirmation ceremonies" called **"To Protect Hawaii."**

Hawaii need protection from state employees who think they have immunity to violate the rights of Sovereign United States Citizens. Recent case in point.

Suit filed against state for violation of demonstrator's civil rights

A state judge last week found two demonstrators not guilty of disorderly conduct filed against them, and in her ruling determined that the religious ceremony at the start of the Hawaii state Senate is unconstitutional as demonstrators stated.

Protester Mitch Kahle stood from his seat in the gallery of the Senate chambers and said, "I object. My name is Mitch Kahle and I object to this prayer on the grounds that it's a violation of the first amendment of the constitution of the United States. I object." Kahle's protest lasted about four seconds. Then he stopped talking and sat down. For that he was attacked and arrested by Senate Sgt at Arms with several sheriff brownshirts. The state now faces charges brought by the demonstrators for assaulting them and violating their civil rights. The incident was caught on camera in the rotunda of the State, and sheriffs tried to prevent the video, too.

Will Abercrombie protect Hawaii from the growing number of similar violations by courtroom sheriffs, and police officers, and DEA, ATF, FBI, Obama et al ?

Probably not, as Abercrombie is a Democrap/Communist/Police State and Obama worshipper who speaks out of both sides of his mouth with lies.

Texans take their rights seriously, and Hawaii lawmakers should do the same thing to protect Hawaii from rights violations perpetrated by public servants:

A bill that has been prefiled for the 2011 state legislative session creates penalties of up to \$5,000 in fines and up to five years in jail for anyone guilty of the "felony" of attempting "to enforce an act, order, law, statute, rule or regulation" of the United States in violation of this chapter.

Texans want to stop public servants who make a mockery of Founding Father James Madison's assurance in Federalist Paper Number 45 that the powers delegated to the federal government are 'few and defined' while those that remain in the state governments are 'numerous and indefinite.'"

Michael Maharrey of the Tenth Amendment Center explains that "The passage of the [ObamaCARE] act opened the eyes of many previously apathetic citizens, making them aware of the rapidly expanding scope and influence of the federal government and its intrusiveness into their everyday lives. They intuitively understand that requiring them to purchase health insurance falls far beyond the powers granted to Congress by the Constitution. He noted that 14 states already have sued to block implementation of Obamacare, and there probably are more than a dozen lawsuits brought by other plaintiffs already, too.

But he explained that the Texas plan takes the issue "a step further."

"While some might call this legislation radical, it rests squarely within the scope of state power as understood by the framers of the Constitution. James Madison wrote in the Virginia Resolution of 1798 that states not only have a right, but a duty to step in when the federal government oversteps its authority," Maharrey wrote.

Audubon Christmas Bird Count

Make your reservations now!

The 111th Audubon Christmas Bird Count (CBC) will take place on Molokai on Thursday, December 23. The Audubon Christmas Bird Count is an annual nationwide count that takes place in established areas during the same time period in the month of December. The information compiled over time provides a useful tool indicating population trends of bird species.

The Topside Molokai count extends 6.5 miles out from a point near Kualapuu and is divided into three locations. Seabirds, shorebirds and waterfowl are counted via a northern pelagic route that includes the cliff known as "Cables" on Dept. of Hawaiian Home Lands, the Molokai Irrigation System's Kualapuu Reservoir, and a second cliff location where seabirds can be viewed. Forest birds are typically counted at the Waikolu Lookout and The Nature Conservancy's Kamakou Preserve (weather permitting). Waders and waterfowl are surveyed along the south shore; Goodfellow Bros. Koheo wetland, the Kaunakakai Wastewater Treatment Plant, the low tide mudflats at the Kapuaiwa coconut grove, the aquaculture farm at Palaauwai, and Kakahaia National Wildlife Refuge in Kawela (if ponds are inundated). The Kalaupapa Peninsula is the fourth route in the count circle and individuals must perform the Topside count in order to participate (This count location is limited to 10 participants and must be permitted one week before the count date).


Reservations are requested for the count, which begins at 7:00 am at the residence of organizer Arleone Dibben, located exactly at the 4 mile marker in Kawela. A \$5 donation benefits the National Audubon Society for count compilation; Participants are published in American Birds. Molokai residents are encouraged to participate – No age is too young to learn about birds and no experience is necessary. Participants are asked to bring water, snacks and a lunch. TSA Funding Cut Proposed !

A Democratic member of the U.S. House of Representatives is now urging Congress to freeze funding for the controversial nude-image scanners being installed in airports around the nation by the Transportation Security Administration.

U.S. Rep. Rush Holt, D-N.J., a Ph.D. physicist and current chair of the House Select Oversight Panel, also has written to ask for a meeting with TSA Administrator John Pistole to discuss his concerns regarding TSA's implementation of X-ray backscatter full-body scanning machines at airports throughout the nation.

On his website, Holt said, "Like many of you, I have serious questions about the Transportation Security Administration's new body imaging technology and pat-down procedures. I have written to the TSA administrator and called for congressional hearings about the need to look more closely at the privacy issues and effectiveness of the screenings, and especially the potential long-term health effects of the new technology."

He said, "We shouldn't be using, much less expanding the use of, technology unless we are sure of the health impact. The GAO, the investigative arm of Congress, is conducting an examination of backscatter technology. As I've urged, Congress should freeze funding for any further full-body scanning devices employing this technology until GAO completes its study and the government establishes a more rational and selective use of these procedures and technology based on sound science."

His letter to the TSA included a long list of other issues with which he was concerned, including the machines' capabilities of storing images and transmitting them.

The statements indicate a clear break by Holt from the Obama policy line that the backscatter machines and invasive pat-downs are necessary for airline security.

Zach Goldberg, spokesman for Holt, confirmed to WND that the congressman wants to make sure the TSA has reviewed the science and studied thoroughly the new screening procedures before expanding those X-ray scanning procedures into airports throughout the nation.

But the letter, dated Nov. 19, supports a request Holt made in August urging congressional leaders to freeze funding for the TSA advanced imaging scanners until questions regarding the X-ray machines had been answered. "As a scientist and chairman of the Select Intelligence Oversight Panel, I appreciate the challenges we face in trying to prevent terrorists from boarding American airliners," Holt wrote. "That same background also gives me an understanding of why TSA's current obsession with fielding body imaging technology is misguided, counterproductive, and potentially dangerous."

Dr. David Brenner of Columbia University's Center for Radiological Research gave a presentation on the potential health effects of the TSA backscatter X-ray devices and he stressed:

The TSA advanced imaging devices in use deliver to the scalp 20 times the average dose that is typically quoted by TSA and throughout the industry;

Brenner also told WND that TSA is relying on "bought and paid for" industry studies and manufacturers' specifications, not scientific research examining the TSA X-ray machines independently, with results being published in peer-reviewed journals.

"A headlong rush to embrace fallible technology will only give the public the illusion of increased security at the expense of their privacy and dignity, with no assurance that the use of these machines will actually deter or detect terrorists before they act," Holt said in his letter to Pistole.

Holt also expressed concern that the TSA had not yet implemented directives prohibiting TSA personnel who are operating AIT units from transmitting or saving the images of individual passengers, or from having video-recording devices such as smartphones on their persons while operating the machines.
