Bill of Rights Day Dec. 15 and, Hawaii's Presidential Electors Vote for U.S. President

Monday, Dec. 15, 2008 is Bill of Rights Day USA. Everyone who calls themselves an American Citizen should read the Bill of Rights and think how they should apply to our daily lives as free sovereign individual American Citizens, and a nation with government in republican form [not a democracy or police state]; then, realize that the defacto government in Hawaii and nationwide now is a police state that ignores limits on power of government agents.

American Citizens must question and challenge usurped authorities and powers that are NOT granted by the Constitution for the united States of America and are actually prohibited to politicians, bureaucrats, cops, IRS, DEA, BATF, CIA, and reserved for The People by the Bill of Rights 10th Amendment. Bill of Rights Day USA December 15, 2008 is a day for REVOLUTIONARY thinking and ACTIONS to restore our once Great REPUBLIC.

December 15, will Hawaii's four Electors certify votes for Obama without proof of Obama's citizenship? Electors, and the employees of the Office of Elections and Lingle et al, as employees of The People, have sworn an oath to support and defend the Constitution. Will they commit TREASON Dec. 15 ?

Presidential candidate Barack Hussein Obama must withdraw, according to at least 18 lawsuits that claim Obama does not meet Constitutional requirements to be the U.S. President. "I am appalled that the main stream media continues to ignore this issue as we are headed to a 'Constitution Crisis.' There is nothing more important than our U.S. Constitution and it must be enforced. I am concerned that our Courts have not yet decided to look into the merits of our allegations. INJUNCTION filed to STOP December 15 ELECTORAL VOTES.

Berg has now filed with the U.S. Supreme Court an Application for an Injunction to Stay the Electoral Votes on December 15, 2008 and to prohibit Vice President Cheney, the House of Representatives and the Senate from counting

any Votes for Obama until Obama Proves he is "Qualified" to be President.

Presidential candidate Alan Keyes along with electors Wiley S. Drake and Markham Robinson, has also filed suit demanding Obama prove his citizenship. Keyes cites the core mission of election officials: certifying and establishing the validity of the election process, and he seeks a Court Order barring certification of the California Electors until documentary proof that Senator Obama is a "natural born" citizen of the United States of America is received. This proof could include items such as his original birth certificate, showing the name of the hospital in Hawaii and the name and the signature of the doctor, all of his passports with immigration stamps, and verification from the governments where the candidate has resided, verifying that he did not, and does not, hold citizenship of these countries, and any other documents that certify an individual's citizenship and/or qualification for office.

Hawaii's four Presidential Electors and the major Hawaii media seem unconcerned about this looming Constitutional crises. Are they ignorant that not one government servant in a decision making, authoritative position requires Obama to show his birth certificate; and Hawaii State DOH saying they have it and it's valid, but Linda Lingle keeping it under lock and key?! Obama's half-sister, Maya Soetoro, has named two different Hawaii hospitals where Obama might have been born, while a video posted on YouTube features Obama's Kenyan grandmother Sarah Obama claiming to have witnessed Obama's birth in Kenya. There are numerous questions as to Obama's citizenship status raising suspicion and doubt about Obama's constitutional qualification to be president. To settle these questions Mr. Obama must produce proof of citizenship!

Hawaii's four Democrat Party's Presidential Electors might cast their votes for Obama at the State Capitol December 15 without valid proof that Obama is qualified to be President. The Bill of Rights, Ratified effective December 15, 1791

Preamble to the Bill of Rights

The Conventions of a number of the States, having at the time of their adopting the Constitution, expressed a desire, in order to prevent misconstruction or abuse of its powers, that further declaratory and restrictive clauses should be added; And as extending the ground of public confidence in the Government, will best ensure the beneficent ends of its institution.

AMENDMENT I

Congress shall make no law respecting an establishment of religion, or prohibiting the free exercise thereof; or abridging the freedom of speech, or of the press; or the right of the people peaceably to assemble, and to petition the Government for a redress of grievances.

AMENDMENT II

A well regulated Militia, being necessary to the security of a free State, the right of the people to keep and bear Arms, shall not be infringed.

AMENDMENT III

No Soldier shall, in time of peace be quartered in any house, without the consent of the Owner, nor in time of war, but in a manner to be prescribed by law.

AMENDMENT IV

The right of the people to be secure in their persons, houses, papers, and effects, against unreasonable searches and seizures, shall not be violated, and no Warrants shall issue, but upon probable cause, supported by Oath or affirmation and particularly describing the place to be searched, and the persons or things to be seized.

AMENDMENT V

No person shall be held to answer for a capital, or otherwise infamous crime, unless on a presentment or indictment of a Grand Jury, except in cases arising in the land or naval forces, or in the Militia, when in actual service in time of War or public danger; nor shall any person be subject for the same offence to be twice put in jeopardy of life or limb; nor shall be compelled in any criminal case to be a witness against himself, nor be deprived of life, liberty, or property, without due process of law; nor shall private property be taken for public use, without just compensation.

AMENDMENT VI

In all criminal prosecutions, the accused shall enjoy the right to a speedy and public trial, by an impartial jury of the State and district wherein the crime shall

have been committed, which district shall have been previously ascertained by law, and to be informed of the nature and cause of the accusation; to be confronted with the witnesses against him; to have compulsory process for obtaining witnesses in his favor, and to have the Assistance of Counsel for his defence.

AMENDMENT VII

In Suits at common law, where the value in controversy shall exceed twenty dollars, the right of trial by jury shall be preserved, and no fact tried by jury, shall be otherwise reexamined in any Court of the United States, than according to the rules of common law.

AMENDMENT VIII

Excessive bail shall not be required, nor excessive fines imposed, nor cruel and unusual punishments inflicted.

AMENDMENT IX

The enumeration in the Constitution, of certain rights, shall not be construed to deny or disparage others retained by the people.

AMENDMENT X

The powers NOT delegated to the United States by the Constitution, nor prohibited by it to the States, are reserved to the States respectively, or to the people.

HAWAIIAN MORTGAGE SCAMMERS

Honolulu Advertiser reported that Native Hawaiian families facing foreclosure on their homes were targeted by scammers and lured by the promise of receiving a \$1 million to pay mortgage payments. The scammers charged people between \$2,500 and \$10,000 to attend seminars on how to avoid foreclosure.

According to the article scammers tell seminar attendees that "a \$1 million "Royal Hawaiian Treasury Bond" will be sent to the homeowners' bank with a letter explaining that it will cover the outstanding balance of the mortgage."

Native Hawaiian families facing foreclosure have become fraud victims, and are believed to have been bilked about \$300,000 so far.

Audobon Christmas Bird Count Dec.15

The 109th Audubon Christmas Bird Count (CBC) will take place on Molokai on Monday, December 15. The Audubon Christmas Bird Count is an annual nationwide count that takes place in established areas during the same time period in the month of December. The information compiled over time provides a useful tool indicating population trends of bird species and is available at <<http://www.audubon.org/bird/CBC/>><http://www.audubon.org/bird/CBC/>

The Topside Molokai count extends five miles out from a point near Kualapuu and is divided into four locations. Seabirds, shorebirds and waterfowl are censused via a northern pelagic route that includes the Molokai Irrigation System's Kualapuu Reservoir, the cliff known as "Cables" on Dept. of Hawaiian Home Lands, the Palaau Lookout, and Molokai Properties' Kualapuu Oxidation Ponds in Naiwa. Forest birds are typically counted at the Waikolu Lookout and The Nature Conservancy's Kamakou Preserve (weather permitting). Shorebirds and waterfowl are surveyed along the south shore at Molokai Sea Farms, the County of Maui's Ohiapilo wetlands and Kaunakakai Wastewater Reclamation Facility, the Goodfellow Bros. Koheo wetland, and Kakahaia National Wildlife Refuge in Kawela. The Kalaupapa Peninsula is the fourth site in the count circle, and will take place on Tuesday, December 16: Individuals must perform the Topside count in order to participate. This count location is by reservation only and is limited to 10 participants. Participants may either walk or fly, and will be picked up at the bottom of the trail at 7:30 am or at the airport at 9:30 am.)

Reservations are requested for the topside counts. This year's count will begin at 7:30 am at the home of organizer Arleone Dibben-Young, located exactly at the 4 mile marker in Kawela. A \$5 donation benefits the Audubon Society for count compilation; Donors are published as observers in American Birds. Molokai residents are encouraged to participate - No age is too young to learn about birds and no experience is necessary. Participants are asked to bring water and snacks for the count period, and to pack a lunch.

Bill of Rights Day USA, and 2nd Amendment Gun Rights

Monday, December 15, marks America's Bill of Rights Day, the anniversary of the ratification of the Bill of Rights, and especially the Second Amendment for the protection of liberty, making a loud and clear statement that Second Amendment rights are inalienable!

The U.S. Supreme Court's June 2008 landmark ruling in the Heller case finally affirmed that the Founders fully intended the Second Amendment to protect an individual right to own and bear arms. The right to own and carry a gun is as fundamental and inalienable as freedom of speech and freedom of religion.

Obama-team efforts are already underway to resume the assault against gun rights. Despite the rhetoric of both Barack Obama and his choice for Attorney General, Eric Holder, they have repeatedly opposed Second Amendment rights, and, any new federal judge appointments will likely be similarly biased.

Got AMMO ?

Happy Holidays: Now dispose of all of your ammunition! Every last round! Soon, you will be able to buy only overpriced ammunition that will be registered to you in a government database.

A small company, Ammunition Accountability--which wants to help anti-gunners price and regulate the Second Amendment out of existence, profit at the expense of our rights, or both--has found radical anti-gun legislators in 18 states willing to introduce bills pushing such tyranny.

So-called "encoded ammunition" or "serialized ammunition" bills would require ammunition manufacturers to engrave a serial number on the base of the bullet and the inside of the cartridge casing of each round of ammunition for popular sporting caliber center-fire rifles, all center-fire pistols, all .22 rimfire rifles and pistols, and all 12 gauge shotguns. In all but one of the bills, people would be required to forfeit all personally owned non-"encoded" ammunition. After a certain date, it would be illegal to possess non-"encoded" ammunition. Reloading would be rendered illegal.

People would be required to separately register every box of "encoded ammunition" and the registration would be supplied to the police. Each box of ammunition would have a unique serial number, thus a separate registration. Gun owners would have to maintain records if they sell ammunition to anyone, including family members or friends. The cost of ammunition would soar. The Sporting Arms and Ammunition Manufacturing Institute estimates it would take three weeks to produce ammunition currently produced in a single day. A tax of five cents a round would be imposed on private citizens, not only upon initial sale, but every time the ammunition changes hands thereafter.

And to what benefit in terms of fighting crime? Criminals already steal guns and would certainly steal ammunition. Congress eliminated a handgun ammunition sale recordation requirement in 1983, because there was no law enforcement benefit. Be on the lookout in Hawaii in the next legislative session for anti-gun politicians who continue their crusade against our Second Amendment rights.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





TSA/Homeland Security Control Travel in America?

Big Brother, May I? Soon, You'll Need Uncle Sam's Permission to Travel Almost Anywhere in U.S.A, the land of the FREE? Starts in January 2009?

Looks like we all soon be on no-fly lists, unless the government gives us permission to leave—or re-enter—the United States. That day has now arrived, but in addition to obtaining Big Brother's permission to travel internationally, a final rule pursuant to the U.S. Transportation Security Administration's "Secure Flight" initiative says we must now get permission to travel from state-to-state."

For now, permission to travel applies only to air transport. However, the TSA could of course extend it to train, bus, or auto travel anytime.

At some point in the future, you'll need to reveal your name, gender, and date of birth when you make a domestic airline reservation. The airline will contact TSA to determine if you're cleared to board. If you're on any of TSA's watchlists (which include such deceased "terrorists" as Saddam Hussein, along with live ones such as Sen. Edward Kennedy), you'll need to provide an official document acceptable for federal identification purposes in order to travel. If you can't produce such a document, you can't board the plane.

This is the first time the U.S. government has restricted the right of sovereign citizens to travel inside the United States since the Civil War. And the TSA is imposing this restriction, despite numerous rulings from the Supreme Court indicating that you have a Constitutional right to travel. According to the court, the right to travel is "not a mere conditional liberty subject to regulation and control under conventional due process or equal protection standards," but "a virtually unconditional personal right." International travel is specifically protected as well, for "Travel abroad, like travel within the country, may be necessary for a livelihood...Freedom of movement is basic to our scheme of values."

In Russia, the internal passport became the prime instrument of Soviet oppression over its citizens. The internal passport is a blueprint for totalitarianism.
