CHINESE PIONEER FAMILIES OF MAUI, MOLOKAI AND LANAI, Edited and compiled by Ken and Nancy Yee, a second generation bilingual couple, chronicles the histories of early Chinese immigrants to Maui, Molokai and Lanai. The fascinating collection of oral histories is filled with the memories of their children and grandchildren who tell stories that recount the lives and how they adapted to their new home and became a part of Hawai'i, even as they held fast to their ties to China. Some of the stories are of the Chinese who were born in Hawaii, second generation Chinese who settled on Maui, Molokai and contributed to the economic growth and ethnic diversity of the communities.

During the last half of the 1800's through the early 1900's many Chinese came with knowledge and experience in farming and became immersed in rice, sugar, and taro cultivation and processing. They also became merchants and skilled craftsmen. Ken Yee's "Introduction" to the book relates that the first Chinese in Hawaii came on whaling and fur-bearing ships sailing the trade routes between Canton and Hong Kong and west coast ports in North America. The first recorded arrival of Chinese were fifty carpenters, blacksmiths, craftsmen and sailors about the British vessels, Felice and Iphigenia, in 1788. These transient voyagers were soon followed by Chinese settlers seeking the prized sandalwood from the islands they called "Tan Heong Shan", the sandalwood mountains. In the 1800s Chinese immigrants played important roles as craftsmen, laborers and entrepreneurs in developing Hawaii's economy, particularly in the early agricultural industries of rice and sugar.

Among the 65 family stories in the book are about the pioneer men and women who left China to seek their fortunes in Hawaii in the last half of the 1800s and early 1900s. They recount the lives of the early immigrants, how they adapted to their new home and became part of the fabric of Hawaii, even as they held fast to their ties in China. Molokai residents will be most interested in the family stories among them: Chin Chu Ping, aka C. Ah Ping (Ah Ping Store and orchard); Kong Yip, aka Aipa (Pukoo Poi Shop); Ng Yee, aka Ah Yee; Yim Kam Chee ("Kam Chee's Store" at Kamalo), Chong You; Wing Kui Ing; Chang Tung; Yun Kee Yuen (Maunaloa, Kualapuu Stores), Chong Ung Pung aka Chong You,

Molokai Seal Killed

NOAA enforcement investigation of the death of an adult Hawaiian monk seal death on Molokai hints at a possible deliberate killing on or about December 14, according to David Schofield of the marine mammal response program. The seal corpse was recovered that morning according to Leimana Naki, culture teacher and caretaker of Kahinapohaku Fishpond who used his kayak to pull it to shore.



A necropsy of the seal on Tuesday determined that it had been killed intentionally, Schofield said. Anyone with information about the seal's death is encouraged to call NOAA's 24-hour enforcement hot line at 800-853-1964.

The seal was a known resident of Molokai and considered by scientists to be in his 20s, robust and in good health, Schofield said. The animal was easily identifiable by the fact one of his rear flippers was amputated sometime prior to 2005.

This year on Kauai, two Hawaiian monk seals have been deliberately killed, alarming conservationists who are working hard to preserve the rare seals, which are found only in Hawaii. The wild population is 1,200 or less and dropping.

One of the Kauai seal-killing cases was solved when 78-year-old Charles Vidinha pleaded guilty to shooting at a pregnant female monk seal on Kauai's Milolii Beach in May, killing her and her unborn pup. Vidinha was sentenced to a 90-day term in federal prison and fined. The potential fine for killing an endangered species is up to \$50,000. Vidinha alleged he didn't mean to kill the seal, just scare it away.

aka Ah You; Chong Ju Lung, aka Chong Ju Lung Kualaa (whose son George carried on the third generation poi making tradition). Grace Pung Apo (R.N. in charge at the Ualapue Medical Center and her sister Daisy Pung Crane, teacher at Kilohana School, who came to Molokai in the 1920s. Included is a brief story of Jack Sing Kong, who was sent to Kalaupapa in 1919 at age twenty-five and lived long useful life with his wife Mary until the late 1970s.

The story of Chung Kon-you, who arrived in Lahaina in 1899, is told in the section on West Maui/Lahaina. Chung Kon-you was a pioneer who worked very hard and with his wife and children grew taro, made poi and was an early entrepreneur. His son Harry Chung, who will be remembered for his Kaunakakai Market tells most of his parents' story. Harry Chung and his wife Rosebud along with their six children have contributed to the Molokai community.

Among the Molokai story writers are Noelani Meyer Keliikipi, Douglas D.L. Chong, Deborah Chun Chang-Tung, Heidi Chang, Diana Crane and Margaret Lee Kaulukukui. Each story, some written or told by children or grandchildren is a gem. Historical details, family and Hawaii history and all told in warm, reminiscent factual style. There are a few photographs, maps and charts, a brief glossary of Chinese terms and a compilation of Hawaiian-Chinese names.

The book was announced with Ken Yee, the co-editor of the book and Puanani Woo, at St. John's Episcopal Church, Keokea-Kula, because of its special history with the Reverend Yin Chin Shim who came to Hawaii in 1899 whose story is featured in the book. He was the first minister of the newly built St. John's Church in 1907, after the Hakka farmers of Kula recruited him as a teacher for their children. The Rev. Shim, originally a Lutheran minister, was accepted by the Anglican Church in Hawaii and was ordained a deacon in 1905.

Published by the University of Hawai'i Press, *CHINESE PIONEER FAMILIES OF MAUI, MOLOKAI AND LANAI*, by Ken & Nancy Wong Yee, [ISBN 978-0-8248-344-4] \$25.00, 400pp. is the fourth in a series of publications telling the oral histories of the early Chinese immigrants to Hawaii that have been sponsored by the Hawaii Chinese History Center.

Kung Hee Fat Choy! The Year of the Tiger will be celebrated with a Parade, Lion Dance, Chinese Martial Arts demonstration and "entry level" Tai Chi session -- on Monday, January 18, beginning at 9am through Kaunakakai. Kenneth Yit-Kong Nip, "retired" teacher, will be among four Chinese Kupuna who will be honored when the parade ends at the War Memorial Park.



Economics Causes Metal Recycle Closure

Molokai Landfill closed its metal recycling facility on Friday, Dec. 11, after reaching its permitted storage capacity. Lawrence Kalilikane of Ray's Rentals further explained that economic realities, increased cost of shipping the scrap metals, processing hazardous oils and battery acids, and bulky tires and auto bodies to recycling in Honolulu, have far exceeded the costs known at the time the contract was initiated with the County thus resulting in delay until more money is allocated for removal of existing scrap irons and tires to make space according to the limits of the State DOH permit for more incoming old cars, tires, scap metals from the Molokai residents. The shipping problem is insurmountable now, so he suggested shut down the facility temporarily to comply with limitations set by the State DOH permit.

Kalilikane added that Ray's Rentals has complied with all requirements for processing the scrap metals, and they can be shipped out immediately, despite some discrepancy in records between those at incoming gate and those actually unloaded at Rays processing facility. He said Molokai people give a count to the clerk at the gate, but we unload it down here and often there is twice as much tires, batteries, etc. People must follow the rules and give accurate count to landfill Clerk to help us keep records consistant to comply with permits, he said.

Kalilikane said he hopes the County will open again next month.

Dear ABC-TV Diane Sawyer

Congratulations on your promotion to the news anchor desk at ABC-TV. With the future of Americans' security and freedom at risk, and the urgent need to defend and protect the Constitution for the United States of America from domestic enemies as my motivation, I respectfully request that you use your new powers and responsibilities to bring these following historical realities of the dangerous effects of gun control laws enforcement to public attention.

1. Police have absolutely no legal duty to protect any American citizen. "A well regulated militia, being necessary to the security of a free state, the right of the people to keep and bear arms shall not be infringed." Exercise the 2nd Amendment.



This third book by author Jim Denny, *A Photographic Guide to the Birds of Hawai'i* includes introduced species and long-distance migrants as well as seabirds, endemic honeycreepers and familiar urban introduced dwellers. Illustrated by two of Hawaii's best nature photographers, the author Jim Denny and Jack Jeffrey. Other photographs were provided by other gifted nature photographers.

In total, 170 species or subspecies are described and illustrated by locale -- "Urban Birds," "Country Birds," "Forest Birds," "Wetland Birds," "Seabirds." The birds included are birds found in the main Hawaiian Islands, and does not include alien and migrant species for which are only one or two records. Species thought to be extinct or those species found only in the Northwestern Hawaiian Islands are not included.

Nature lovers will enjoy the excellent photographs and information about endangered forest birds, the Hawaiian Crow ('Alala), O'ahu 'Elepaio, Palila, Small Kaua'i Thrush, 'Akakane, 'Akeke'e, 'Akiapola'auKaua'i Creeper ('Akikiki), Hawai'i Creeper, Maui Parrotbill, Crested Honeycreeper ('A'kohekohe). This comprehensive guide is an essential resource for those who are interested in identifying, locating, and learning more about the avifauna of Hawai'i.

Ohana Health Center

Listed to Receive Federal Aid Funding

Senator Inouye announced that federal aid is coming to Molokai as part of a \$387 million spending package for Hawaii. The spending provides substantial resources for military personnel and facilities, health care services, education, crime prevention and youth activities.

While many of these initiatives will help Molokai indirectly, one item will give Molokai \$750,000 for the new Molokai Ohana Health Center.

The old Pau Hana Inn was bought by the Molokai Community Health Center in May from the New Hope Christian Fellowship. The Pau Hana Inn -- once one of two hotels in Kaunakakai -- was sold by Molokai Ranch to New Hope in 2002. The inn was built in 1970 and sits on nearly six acres of oceanfront land.

Buildings at the Old Pau Hana Inn are currently being renovated by the Molokai Health Center, so that at least part of the new health center could be opened by the summer of 2010.

During the election cycle candidate John McCain was asked for his birth certificate because he was born in the Panama Canal, which means he is not a natural born American Citizen not eligible to be President. But, the Senate actually passed a non-binding resolution (S-511) to resolve that McCain was a 'natural-born' citizen.] They were unable to do this for Obama however.

The people who want this issue to go away have displayed what they say is a Hawaiian birth certificate. However, that piece of paper is not proof of Hawaiian birth. It is a Hawaiian Certification of live Birth, which John Sampson, a 27-year veteran of ICE contends is different from a Hawaiian Birth Certificate.

"When this issue first was raised, in June of 2008, I was intrigued, being ICE's non-lawyer legal geek for enforcement in Denver. I had an agent who was born in Hawaii bring in his actual Hawaiian birth certificate and I compared it to the document posted on the Daily KOS and Stop the Smears sites," says Sampson. "It is markedly different from a Certification of live birth. The birth certificate has the hospital or other birthing facility where the birth happened, the doctor's name, midwife's name, or other health professional who attended the birth and other information that a certification of live birth lacks. The reason why the certification of live birth does not have this information is because it is issued based upon the unverified report of an adult, usually the parent, or some other person."

Sampson explains that there is no requirement that evidence be supplied that the birth actually occurred in Hawaii. It is issued simply on the attestation of the reporting party. "Furthermore, Hawaiian law allowed for the reporting of a birth of a child born outside the Hawaiian Islands as long as one parent claims to have resided in Hawaii as their principal place of residence for the year prior to the child's birth." (This law was in effect from 1911 to 1972)

"I've been following this, as I said, since June of 2008. Given what I know and what I've seen, I believe there is sufficient evidence to support the belief that Barrack Obama is not a natural born US citizen, applying the law as it existed in 1961," says Sampson. (And the continuing Article II, Section 1 requirements of the Constitution – since 1779)

He explains that the law changed in 1986 in which the residency requirement was relaxed in the U.S. However, there was no retroactivity of that change in the law in 1986 and as such, assuming he (the president) was not born in Hawaii as everyone has been led to believe, then he's not a natural born United States citizen. If he is not born here he is not constitutionally qualified or eligible to hold the office of President of the United States.

"One who acquires their citizenship at a later time, regardless of how soon after their birth, either by derivation or by naturalization, although a U.S. citizen, is not a U.S. 'Natural-Born' citizen by birth. A good example is former Secretary of State Madeline Allbright, who was born in Eastern Europe and who became a naturalized U.S. citizen. She is a citizen of the United States. However, she is not a "natural born U.S. citizen" and as such is constitutionally barred from holding the office of President of the United States.

Obama Nullifies AMERICA'S Sovereignty with CO2 Declaration
