## Who Owns Molokai ? Is it a CRIME for PuuOHoku's Lavinia Currier's Employees to trespass and destroy and remove private property?

The men from Oahu began tearing down the camping structures at Halawa beach Sunday Dec. 18, they said they were working for ML Security [533-6717] hired to remove the structures from lands claimed by Lavinia Currier of Puu O Hoku Ranch. But the occupants protested, erected keep out signs, and demanded to see any court order that would give lawful authorization to them or Lavinia Currier to remove the structures without permission of the owners. The men and the blond woman leading them in the destruction and had no such documents.

Landowner Paul Kauka Naki did not give permission to Lavinia Currier or employees of ML Security to enter onto the real property there at Halawa upon which he allows the structures, and he joined in the protests of the apparently criminal trespassing and destruction of these structures and private property. Naki also backed up his ownership claims with documents showing heirship down to him from Royal Patent, documents that evidence his Title to the same lands claimed now by Lavinia Currier of PuuO Hoku Ranch.

Naki said he intends to file criminal complaint for trespass and property damages against Lavinia Currier, Puu O Hoku Ranch, and the employees involved.



## Merry Christmas: Birth of Jesus Christ THE BIRTH OF CHRIST AND THE BIRTH OF AMERICA ARE LINKED

Having undertaken, for the Glory of God, and Advancement of the Christian Faith, and Honour of our King and Country, a voyage to plant the first colony in the northern parts of Virginia; do by these presents, solemnly and mutually in the Presence of God and one of another, covenant and combine ourselves together into a civil Body Politick, for our better Ordering and Preservation, and Furtherance of the Ends aforesaid; And by Virtue hereof to enact, constitute, and frame such just and equal Laws, Ordinances, Acts, Constitutions and Offices, from time to time, as shall be thought most meet and convenient for the General good of the Colony; unto which we promise all due submission and obedience."

The sentiments and statements of America's founders make it clear that this nation has enjoyed a love and appreciation for the rights and freedoms recognized in Natural Law that is unique in the annals of human history. No other people have such a heritage.

One thing America's founders could not envision was--after they had paid so terrible a price to purchase our liberties--that the time would come when their posterity would be denied the basic freedoms to publicly express their reverence for God. Never could they have imagined that the day would come when citizens of the sovereign states (each with a State constitution protecting religious liberty) would be denied their right to pray in school, or place Nativity scenes on public property, or hang copies of the Ten Commandments on courthouse walls.

I am also confident that America's founders would be completely repulsed by the way the United States has jumped headlong into corporatism, socialism, and globalism. At the national level, Democrats and Republicans alike have created a central government so large that it would be unrecognizable to any Founding Father (even Alexander Hamilton or John Adams). In addition, both Big Business and Big Religion have sold our great country down the old proverbial river. Truly, our Founding Fathers must be rolling over in their graves.

Therefore, at this Christmas season, let us remember well the founding principles of these United States of America. Furthermore, let us renew with vigor the fight for freedom before our liberties and our heritage are gone altogether.



## United Nations Conference Extends International Protection for Kioea

More than 80 governments met from 20 – 25 November in Bergen, Norway, for the tenth Conference of the Parties to the UN Environment Programme's Convention on the Conservation of Migratory Species of Wild Animals (CMS). Proposals to conserve seven migratory species that cross international borders were approved, including the Kioea (Bristle-thighed Curlew, *Numenius tahitiensis*) the Official Bird of Kaunakakai.

The Bristle-thighed Curlew, which winters exclusively on Pacific atolls and islands, is currently listed on CMS Appendix II as a species that needs or would significantly benefit from international cooperation. It was granted full protection by also being added on Appendix I as threatened with extinction throughout all or a significant proportion of its range. The introduction of mammalian predators such as rats, cats and dogs on the wintering grounds is attributed to a sharp decline in the population. Bristle-thighed Curlews are particularly threatened by predators during the molting period, when adults become incapable of flight. Habitat loss and degradation of the wintering grounds pose an additional threat. The appendices grant greater protection to vulnerable species, such as conserving damaged habitats or mitigating obstacles to migration.

## FEMA Concentration Camps

Top members of Congress are secretly meeting now to try to figure out how to jam through a dangerous bill before Christmas, of legislation authorizing Obamat and all future presidents to order the U.S. military to pick up and imprison people, including U.S. citizens — without charging them or trial.

Let's be clear about what this proposal really is: no due process, no trial, and no proof beyond a reasonable doubt — and indefinite military imprisonment based on suspicion alone.

A handful of senators secretly came up with this outrageous indefinite detention provision and attached it to the National Defense Authorization Act. And an even smaller group of House members forced through the House of Representatives a law for worldwide war, and worldwide imprisonment, in virtually any country where a terrorism suspect lives, even here in America.

The House and the Senate are now rushing to come up with a joint version of the bill and ram it through Congress within the next two weeks.

We know Congress is starting to hear from people who are outraged by this proposal. And if we continue to keep the pressure on, we can stop this. But it's going to take all of us.

## Obama and Congress' Spend While Debating Budget Woes

"Robot dragons, video games, Christmas trees, snow cone machines, and chocolate. This is not a Christmas wish list. These are just some of the ways Obama's federal government spent your tax dollars this year." U.S. Senator Tom Coburn wrote that in the introduction to his "Wastebook 2011" report.

This report astounded me, and it didn't even address immoral uses of tax funds like paying for Planned Parenthood's abortion services! Senator Coburn said it best when he released his report yesterday: "Over the past 12 months, Washington politicians argued, debated and lamented about how to reign in the federal government's out of control spending. All the while, Washington was on a shopping binge, spending money we do not have on things we do not need, like the \$6.9 billion worth of examples provided in this report. The result: Instead of cutting wasteful spending, nearly \$2.5 billion was added each day in 2011 to our national debt, which now exceeds \$15 trillion."

Right now, the political volleying taking place on Capitol Hill is both exhausting to observe and impossible to understand: The Senate passed a stop-gap measure extending the tax break for 60 days – then left town. The House rejected the Senate plan, passing a bill that extends the payroll tax break for 12 months. Now the Representatives are calling on Senators to come back to Washington to finish their work.

Sen. Harry Reid is refusing to return and blaming the House Republicans. President Obama is chiding the GOP. Nancy Pelosi is blaming "Tea Party Republicans" and raising money to shut down the movement. Each chamber appears to be engaged in a contest of one-upmanship – while accusing the other of obstructionism.

Yet, in 2011, according to Rep. Coburn, Congress thought nothing of recklessly spending tens of millions of dollars including these examples from his report:

- \$15.3 million for one of the infamous "Bridges to Nowhere" in Alaska.
- \$113,227 for a "video game preservation center" in New York.
- \$550,000 for a documentary about how rock music contributed to the collapse of the Soviet Union.
- \$350,000 to support an International Art Exhibition in Venice, Italy.
- \$10 million for a remake of "Sesame Street" for Pakistan.

Wake Up Ameica: If federal spending is not deeply slashed, America cannot survive. During the three years Obama has been usurping the Office of President, the national debt has increased by nearly \$5 trillion. This kind of profligate spending is totally unsustainable!



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!







Elijah Kaneshiro is a 17-year old Molokai teen of Waialua who has successfully pursued high goals for personal development of spirit and life skills. His family homeschool gives him the freedom to graduate early with a GED and with above average scores, obtain a driver license and his own PU truck, kite surfing, beekeeping business, home cooking, construction, practical applications of math, reading instructions and planning, interpersonal relationships.

Homeschoolers generally score better than average on the GED and SAT. They generally achieve higher GPAs in college as well.

His mother Brenda explains: "The beauty of homeschool is that I as a parent and teacher have the opportunity to develop the curriculum according the specific needs, interests, and learning abilities of each child. Elijah is a hands-on learner... I find myself teaching for life skills rather than test scores. The students will return to Oregon in May and have a graduation in June. From there Elijah plans to return to Honolulu and stay with his grandfather while he attends airplan pilot flight school.

## WE the American People have surely lost our grip.

That having been said, what can be done to reestablish control of our own political destiny? If you want to find out, than read on:

An Association for Lawful Government in every jurisdiction in the United States, working in close cooperation with their Informed Grand Jury, and supporting Sui Juris Filings can defend and perpetuate the Organic American Ideal that was approved by Congress assembled in July 1776. ### JUST POWERS

That to secure these Rights, Governments are instituted among Men, deriving their just Powers from the Consent of the Governed—Declaration of Independence Note the qualifying adjective, "JUST".

During July 1776 the non-amendable Declaration of Independence was recorded by Congress Assembled. It is the Organic Act that established the United States of America. This Constitution, and the Laws of the United States which shall be made in Pursuance thereof; and all Treaties made or which shall be made, under the Authority of the United States, shall be the supreme Law of the Land; and the Judges in every State shall be bound thereby, any Thing in the Constitution or Laws of any State to the Contrary notwithstanding. -Article VI, U.S. Constitution

Why then, do WE the People acquiesce in the creation and enforcing of laws that are not made in Pursuance thereof? Why then, do we permit our servants in government to flagrantly violate their oath of office?

Future historians will surely wonder.

### "SWARMS of OFFICERS"

Although public opinion is likely to be based on things that could never survive Critical Thinking, I would fight with everything that I have to preserve the right of an Individual to vote.

That having been said, and since election results often in time prove disappointing, I urge my fellow Citizens to do much more than vote. The dismissive attitude of "Don't blame me, I voted for -----." displayed on bumper stickers is unworthy of persons endowed with the philosophical limitations on government power provided by the Unanimous Declaration 1776.

Beginning with the Action at Law that we refer to as the Unanimous Declaration of Independence, Americans are morally obliged to understand and defend the Principles supporting that incomparable document. (Rarely mentioned and surely left unread and therefore unconsidered is the Bill of Charges against the Crown.) Those Principles are as relevant today as they were in 1776. Consider this studiously powerful accusation that was openly hurled against the Crown:

He has erected a multitude of New Offices and sent hither swarms of Officers to harass our people, and eat out their substance.

Sound familiar somehow? Replace "He has" with "Lawmakers have" and the words are as relevant today as they were when Thomas Jefferson wrote them in his incomparable style more than two centuries ago.

While awaiting the next election, consider a much deeper involvement in your government by creating and participating in an ALLIANCE FOR LAWFUL GOVERNMENT while keeping in mind that lawful and legal are not synonyms.

(There is an ethical element in lawful that is often painfully absent in legal.)

It is often said that the road to hell is paved with good intentions. And so it was on August 21, 1878 with the founding of the American Bar Association. On that day the monopolizing of the defense and administration of justice by a faction occurred in Saratoga Springs New York. But Liberty and Justice for all cannot safely be left to America's Brotherhood of Juris Doctors alone and here's why:

By a faction, I understand a number of citizens, whether amounting to a majority or a minority of the whole, who are united and actuated by some common impulse of passion, or of interest, adverse to the rights of other citizens, or to the permanent and aggregate interests of the community. --James Madison (Fed#. 10)

### TAKE ACTION: SUI JURIS

If pursuit of the Idea we call The United States of America is to be put back on track WE the People cannot depend on factions and those they favor to do it for us. However, a Sui Juris filing by an Individual with the moral support of an ALLIANCE FOR LAWFUL GOVERNMENT can succeed in this noble endeavor where elections have consistently failed. The final word on Lawful Power often must be spoken and recorded in a court of law if not in the bloody streets.

A system of Legal Precedents has occluded the genuine Law of the Land. That insufferable condition can only be intelligently remedied by the will of a substantial number of WE the Individuals. No election can ever do it for us.

# Obama Drone Over America!



Now the Obama administration has quietly authorized Predator drone use by law enforcement officials in the United States to spy on American citizens.

According to reporting by the Los Angeles Times, "The drones belong to U.S. Customs and Border Protection, which operates eight Predators on the country's northern and southwestern borders to search for illegal immigrants and smugglers. The previously unreported use of its drones to assist local, state and federal law enforcement has occurred without any public acknowledgment or debate."

National attention has focused on a story about a sheriff in North Dakota who called in the reinforcements and an Air Force Predator Drone MQ-9 Reaper to assist in surveillance of a farm and six stray cows. The farm was owned by Rodney and Susan Brossart. And the Brossart family was known locally for being armed and apparently anti-government corruption and anti-Obama's Marxist Police state.

This is part of a pattern by the Obama administration of bringing highly sophisticated military technology developed for war and deploying them against Americans. Law enforcement routinely uses night vision optics, heat sensors, and even armor and military grade firepower in the battle field called America's cities.

Spying on Americans by Predator Drone in the United States could explode in the next year. Also according to the LA Times, "For decades, U.S. courts have allowed law enforcement to conduct aerial surveillance without a warrant. They have ruled that what a person does in the open, even behind a backyard fence, can be seen from a passing airplane and is not protected by privacy laws.

Drones are particularly useful in rural areas that are not blanketed with surveillance cameras the way most major cities are today. Americans living in densely populated major cities can easily spend all day on camera. Just look up. You will be surprised to see camera domes have replaced gargoyles as the building decoration of choice. This combined with greatly improved facial recognition software means everyone can be tracked and traced.

A predator drone flies high out of sight and noise. Using the sophisticated radar, sensors and optics onboard the Predator Drone, operators can identify you, know if you are carrying a firearm, reading the Constitution and Bill of Rights, meeting with a group to vote against Obama, and pinpoint your location and shoot a Hellfire missile at you, just like in Iraq and Afghanistan and Palestine.

Currently their use is limited because of FAA regulations, but two liberal Senators are pushing to change the rules. Sens. Charles Schumer, and Ron Wyden, introduced an amendment to the FAA Air Transportation Modernization and Safety Act this past year, "to increase the number of 'National Airspace System' test sites for 'unmanned aerial vehicles' (UAV) from four to 10, and require that at least one of those test sites include a significant portion of public land."

Schumer said at the time, "drones are more important than ever to our troops overseas, our cops walking the beat and our border patrol agents keeping drugs off our streets, not to mention accurate mapping and more."

So add drones to the list of tools that can be used domestically to spy on you, and murder you with military weapons. The list is getting long. If you are carrying a cellphone, authorities can monitor your conversations, read your texts and emails. If you use a computer, authorities can monitor the websites you visit and the terms you search online.

With this type of technology the surveillance state envisaged by George Orwell in 1984 is here.

The questions we must ask as citizens are does the Constitution for the United States of America allow such powers to any government entity, and do we trust the Federal Government with this nearly omniscient type of information and power. The history of Federal officials abusing information in earlier less technologically proficient eras is legendary. More information only increases the likelihood of more significant abuse of Americans in the future.

There is no question that the impeachment and removal of Barack Obama is within the proper scope and purpose of the Constitution's impeachment provisions.


