

## OBAMACARE Ruled UNCONSTITUTIONAL

On Monday, December 13, 2010, U.S. District Court Judge Henry Hudson, from the Eastern District of Virginia, ruled that the individual mandate in the Patient Protection and Affordable Healthcare Act healthcare law (more commonly known as OBAMACARE) is UNCONSTITUTIONAL!

In rendering his decision on December 13, Judge Hudson ruled that there is no provision in the U.S. Constitution that allows the federal government to force every person to purchase a particular kind of health insurance, let alone fine them with a hefty tax and prison for not complying. Congress can not give such power to Obama because Executive Powers are limited within and by the Law of the Land, i.e., the Constitution for the United States of America.

In his 42-page ruling, Judge Hudson voided the requirement that everyone maintain health care coverage. Part of Judge Hudson's Memorandum Opinion read: "A thorough survey of pertinent constitutional case law has yielded no reported decisions from any federal appellate courts extending the Commerce Clause or General Welfare Clause to encompass regulation or a person's decision not to purchase a product..."

Judge Hudson's decision—which will be appealed by the Obama Administration—cuts the individual mandate from OBAMACARE. The individual mandate requires all Americans to be covered by health insurance, or be heavily taxed for not being insured. Fox News reported that the Obama may file his appeal directly to the U.S. Supreme Court, bypassing the 4th Federal Circuit Court of Appeals which Obama fears is the most conservative federal appellate courts.

The legal trappings of this Obama/Clinton terrible socialist law may finally be starting to unravel. This is a major victory for those of us who want to protect the Constitution, our Freedom, save the economy, and protect the best healthcare system on Earth.

When the appeal is filed, the United States Justice Foundation will file its amicus brief with the court, listing many constitutional reasons why OBAMACARE must be overturned, and thus put another "nail in the coffin" of the ludicrous, unlawful OBAMACARE bill.

OBAMACARE is viewed by the man sitting in the oval Office as his "greatest" legislative agenda achievement! Now, ObamaCARE can be the beginning of the END of Obama's federal power grab and violations of the Constitutional limits on government powers.


## Iwo Jima veterans' Poster



Do Other Airline Travelers 'Feel a Little Safer' Seeing Rape Victim Dragged Across Airport by Police? This is sick!

In an example of how quickly many members of the public have become not only comfortable with and comforted by the harsh and seemingly arbitrary treatment received by others at the airport, 56-year-old rape victim Claire Hirschkind was hurled to the ground and dragged across the airport by police yesterday, reassuring others that the TSA was right on top of things.

"It makes me feel a little safer," noted Emily Protine, one of the other travelers who witnessed the arrest, the consequence of Hirschkind not wanting her breasts felt by TSA agents. "It is for our protection so I have no problems with it," added another witness, one Gwen Washington.

Hirschkind was apparently singled out because she has a pacemaker implanted in her chest, but objected when TSA officials announced they intended to feel her breasts. When she argued there was no due cause "the police actually pushed me to the floor, handcuffed me," Hirschkind report, prompting the feeling of comfort of fellow would-be passengers Washington and Protine.

The TSA insisted that Hirschkind's arrest and her treatment were perfectly in keeping with their orders, and an airport spokesman added that she had the option to "not fly" if she objected to having her breasts groped. The TSA added that only about 3 percent of travelers are actually subjected to the treatment.

## TSA Confiscates Pilot's Service Gun After He videoed TSA Screwups

**“What Big Brother Giveth, he can taketh away, and usually does.”**

A California-based commercial pilot says the Transportation Security Administration retaliated against him after he posted videos online showing what he described as shortcomings in airport security.

The series of videos showed scenes from inside the San Francisco International Airport and were narrated by the pilot, who pointed out the contrast between the passengers who were heavily scrutinized, while a single door separated employees who worked on the airfield from the airport.

"I was trying to bring up the obvious, ludicrous TSA-type of security," the pilot said, referring to the cell phone videos he posted, and later removed, from the popular video-sharing website YouTube.

Within a matter of days, his chief pilot called him to ask him to remove the videos because they were "stirring a commotion."

A few days after that, the pilot was informed by the TSA that he was being suspended from the Federal Flight Deck Officer program. As an officer in the program, he was deputized by TSA to carry a handgun in the cockpit.

"Basically, an air marshal in the sky," the pilot said of the volunteer program. After his suspension, four air marshals and two local deputies showed up at his home near Sacramento, California, to personally confiscate his weapon.

However, when the sheriff's deputies showed up at his house with the air marshals, they also took his California concealed weapons permit. The pilot said this permit was unrelated to his work for the TSA and should not have been taken.

The only answer he could get from the TSA as to why he was suspended from the program was that he may have violated a regulation, he said. "FFDOs must be able to maintain sensitive security information as a condition of the FFDO program," TSA spokeswoman Sarah Horowitz said.

"This is really about getting the message out and demanding intelligent security," Don Werno, the pilot's attorney, said. "No state secrets are being shown here. What's being shown here is a lack of security."

Beyond the TSA action, the pilot's airline had not taken any action against him, and he counts on the support of his union.

There it is. Guns and permits issued by Big Brother are a revocable contract with Big Brother, not the Right to Keep and Bear Arms defined by the Constitution's Second Amendment: "...the Right of the People to keep and bear arms shall not be infringed."

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





## Hawaii State Attorney General Russell Suzuki Involved in UH Corruption Case

According to a report in the Honolulu Star-Advertiser, attorney David Louie of Roeca, Louie & Hiraoka has been nominated by Governor Neil Abercrombie as Hawaii's new Attorney General (Senate confirmation hearings pending).

## Gun Owners of America report: Congress will finally read the CONSTITUTION !

Gun Owners of America reports that the American Citizens' Petition to Congress demanding that the Constitution for the United States of America, the Law of the Land, be read in open session of Congress has succeeded. It may be the first time Nancy Pelosi ever heard it read. And hopefully the clerk will read it nice and slowly to let the words sink in..

The overwhelming response to GOA's petition, found at <http://www.readtheconstitution.org>, shows that Americans want Congress to follow the Constitution. There is no word yet from Senate Majority Leader Harry Reid if the Senate will follow the House's lead, so GOA is still urging people to visit the website and sign the petition.
