Dollar Collapse predicted EARLY 2007

Last week, the Bush administration sent virtually the entire economic "A-team" to visit China for a "strategic economic dialogue" in Beijing Dec. 14 and 15. The Bush administration wanted to get China's cooperation in preventing a dollar collapse.

Fed Chairman Bernanke reportedly left the meeting "pale and in a cold sweat" as the implications of China's decision to dump US dollars seemed to sink in.

China told the U.S. economic delegation last week that they no longer have faith in U.S. Currency for several reasons:

1) The Federal Reserve Bank ceased publishing "M3" data in March, making it nearly impossible for anyone to know how much cash is being printed. China said this act made it impossible to tell how much a Dollar is worth.

2) The U.S. Dollar has lost upwards of thirty percent (30%) of its value against other foreign currencies in the recent past, meaning China has lost almost \$300 Billion simply by holding U.S. Dollars in its reserves.

3) The U.S. has no plans whatsoever to reduce deficit spending on Wars and military installations in Iraq, Afghanistan, and at least 38 other locations worldwide, nor has the ability pay down any of its existing debt without printing money to pay it off.

For these reasons China has decided to implement an aggressive sell-off of U.S. Dollars before the rest of the world does so. China reportedly told the US delegation; "we are the largest holder of U.S. Currency and if the rest of the world unloads theirs before we unload ours, we will lose our shirts."

The implications are enormous: The U.S. Dollar is likely to collapse in value against all other major currencies as early January 2007, maybe earlier.

In January 07, the Fed is going to have to decide which way to go first. If Fed rates go up, the dollar will hold in the 78 range, but the stock market and the economy will tank. If the Fed lowers rates to keep the economy from crashing, the bottom will fall out of the dollar, and it will take the stock market and the economy right with it. This would cause a worldwide sell-off of dollars, create almost immediate "hyper-inflation" in the US and also impact world markets at a level "worse than the Great Depression of 1929." America is financially doomed. It has been killed by Congressional spending with treasonous abandon. **[Be akamai: plant your food gardens now!]**

CRIME by government is CONTAGIOUS !!

United States Supreme Court Justice sometimes do speak with wisdom: we hear the words of Justice Brandeis in *Olmstead v. United States*, 277 U.S. 438. In a government of laws, existence of the government will be imperiled if it fails to observe the law scrupulously. Our Government is the potent, the omnipresent teacher. For good or for ill, it teaches the whole people by its example. Crime is contagious. If the Government becomes a law-breaker, it breeds contempt for law; it invites every man to become a law unto himself; it invites anarchy. To declare that in the administration of the criminal law the end justifies the means to declare that the Government may commit crimes in order to secure the conviction of a private criminal would bring terrible retribution. Against that pernicious doctrine this Court should resolutely set its face.

As the people discover that their public servants violate their Oaths with impunity, perpetrate injustices, allow police to murder Citizens, commit frauds, nepotism, contaminate the election process, and keep it hidden by control of the media, they will, as Justice Brandeis says, gradually disrespect all laws passed by their legislature, because their rules mean nothing. They are made to be ignored. They will say, If my public servants, who swear by an oath to uphold the Constitution, can deliberately violate their oaths with impunity, then why should I comply with any of their fascist laws?

A very reasonable question in the circumstances facing Hawaii, and nationally.

The Public Integrity Section of the federal Department of Justice claims exclusive jurisdiction over allegations of criminal misconduct by federal judges. Section attorneys prosecute selected cases against federal, state, and local officials.

Will the Section prosecute Linda Lingle or MPD chief Thomas Phillips?

Maui police officers just two weeks ago murdered another local resident while responding to a 911 call for help. The man had shot himself in the chest with a carpenter's nail gun during a domestic stressout. Police shot him twice for failing to drop his beebee gun and his fishing spear even though no one claims the victim was making any threats to police or anyone at the time, and he may well have been ready to surrender to police who should have been there to help him rather than take ironfisted control or administer death for failure to comply.

If police knew they were being watched by armed and superior Citizens who expect police to use their training and people-skills to defuse the situation instead of conveniently terminating murder, I guarantee police would be much better behaved or they would be arrested or shot themselves for resisting arrest by Citizens who have hired police to protect lives when possible instead of murdering people. I have demanded Chief Thomas Phillips's resignation and or for Police Commission to fire him; and re-training be mandated for all police so they will protect and preserve lives, and preserve and defend the Constitution for the United States of America; mandate that every homicide by police be tried by jury as a murder. Police State fascism is upon us, and the local police are part of the problem until they are trained and mandated to safe lives.

Kalo Field Day - to harvest huli

It was a perfect day for farmers (real-life and at-heart). Taro and plant lovers slogged through and past running streams from East End from the damp fields and overnight rain over the island to the Molokai Applied Research and Demonstration Farm, Saturday, December 2, for the annual Taro Field Day. Armed with knives, picks, shovels and bags for anticipated huli from the fields, farmer and gardeners were blessed with intermittent rains. The group of nearly forty heard UH Cooperative Extension Specialist Alton Arakaki introduce the kalo varieties, new concept for "feeding" the crops and taste sampling of more than a dozen nutritious table taro varieties, an equal number of kulolo, made from a variety of taro, and three samples of poi. Participants were asked to rate the numbered and alphabet, but not name designated samples. For some tasters, somewhere able to discern differences by taste, color and texture. For some, it all tasted good, especially the nearly 20 kinds of ono Kulolo!

Featured speaker Jerry Konanui from the Big Island expertly shared his knowledge of kalo identification by coloration, shape of leaf and petiole as well as the corm. His common sense and lo'i experience and respect for knowledge gained from kupuna gave meaning to the importance of caring for the few (about 80) known remaining native Hawaiian Kalo varieties. His moving story of a kupuna who was so grateful to see the Kalo Ulaula Poni her late husband had cultivated illustrated the importance of continuing to share and pass on huli to preserve all types of kalo. Whether it be table, poi, red, white, yellow or grey, Kalo is an individual taste and preference. Participants in the Field Day had mostly considered the list and map available and knew what huli they wanted.

Moloka'i kupuna and Kalo expert, "Cowboy" Otsuka praised Konanui's knowledge, "He's the best I've heard," Otsuka said. Mr. Otsuka is frequently consulted by locals for identifying kalo by name and lo'i culture.





IRAQ WAR: Marine SPEAKS OUT

The push to impeach President Bush and Vice President Cheney is once again gathering momentum, and this time it's coupled with a resolution to bring troops home from Iraq. Five percent of the voters in 40 towns across Vermont have signed a petition that would place both questions on ballots as nonbinding resolutions at town meeting in March. It goes hand in hand with a separate resolution to bring troops home from Iraq. The state is also gearing up for a Washington D.C. rally against the war through United for Peace and Justice, an international organization.

I'm sick and tired of this patriotic, nationalistic and fascist crap. I stood through a memorial service today for a young Marine that was killed in Iraq back in April. During this memorial a number of people spoke about the guy and about his sacrifice for the country. How do you justify 'sacrificing' your life for a war which is not only illegal, but is being prosecuted to the extent where the only thing keeping us there is one man's power, and his ego. A recent Marine Corps intelligence report that was leaked said that the war in the al-Anbar province is unwinnable. It said that there was nothing we could do to win the hearts and minds, or the military operations in that area. So I wonder, why are we still there? Democracy is not forced upon people at gunpoint. It's the result of forward thinking individuals who take the initiative and risks to give their fellow countrymen a better way of life.

When I joined I took an oath.

In that oath I swore to protect the Constitution for the United States of America.

I didn't swear to build democracies in countries on the other side of the world under the guise of "national security."

I didn't join the military to be part of an Orwellian ("1984") war machine that is in an obligatory war against whoever the state deems the enemy to be so that the populace can be controlled and ruled up in a pro-nationalistic frenzy to support any new and oppressive law that will be the key to destroying the enemy. Example given the Patriot Act. So named, and totally against the constitution.

President Bush used the reactionary nature of our society to bring our country together and to infuse into the national psyche a need to give up their little-used rights in the hope to make our nation a little safer. The same scare tactics he used to win elections. He drones on and on about how America and the world would be a less safe place if we weren't killing Iraqis, and that we'd have to fight the terrorists at home if we weren't abroad. In our modern day emotive society this strategy (or strategy?) works, or had worked, up until last month's elections.

However this recent, and current influx of nationalistic feeling has created an environment where giving up your rights, going to a foreign country to fight a people who did not ask for us to be there, nor did their leader do anything to warrant us being there, and dying would be considered honorable and heroic.

I don't believe it anymore. I don't believe it's right for any American to go along with it anymore. Yes I know that we in the military are bound by the UCMJ and somehow don't fall under the Constitution (the very thing we're suppose to be defending) but sooner or later there is a decision that every American soldier, marine, airmen and seamen makes to allow themselves to be sent to a war that is against every fiber this country was founded on. I know that when April rolls around I will be thinking long and hard on that decision.

Even though we in the military just doing as we're told we still have the moral and ethi-

cal obligation to choose to do as we're told, or to say, "No, that isn't right." I believe that if more troopers like me and the professional military, the officers and commanders, start standing up and saying that they won't let themselves or their troops go to this illegal war people will start standing up and realizing what the heck is going on over there.

The sad fact of the matter is that we are not fighting terrorists in Iraq. We are fighting the Iraqi people who feel like a conquered and occupied people. Personally I have a hard time believing that if I was an Iraqi that I wouldn't be doing everything in my power to kill and maim as many Americans as possible. I know that the vast majority of Americans would not be happy with the Canadian government, or any other foreign government, liberating us from the clutches of George W. Bush, even though a large number of us would like that, and forcing us to accept their system of government. Would not millions of Americans rise up and fight back? Would you not rise up to protect and defend your house and your neighborhood if someone invaded your country?

But we send thousands of troops to a foreign country to do just that. How is it moral to fight a people who are just trying to defend their homes and families? I think next time I go to Iraq perhaps I should wear a bright red coat and carry a Brown Bess instead of my digitalized utilities and M16.

Notice I never once used the word homeland in any of this. I have a secondary point I want to bring up now. Never once was the term homeland ever used to describe the country of America until Mr. Bush began the department of homeland security after the 9/11 attacks.

Taking a 20th century history class will teach us that the most notable countries in the last century that referred to their country in this way were Nazi Germany and Soviet Russia. Hitler used the term fatherland to drum up support, nationalistic support, for his growing war machine. He used the nationalism he created in the minds of the Germans to justify the sacrifice of their livelihood to build the war machine to get back their power from the oppressive restrictions the English and French had put on them at Versailles. This is the same feeling that has been virulently infecting the American psyche in the last hundred years. This is the same feeling that consoles a mother after her son is killed in an attempt to prosecute an aggressor's war 10,000 miles away. It's also known as Patriotism these days, but I say, "No more." No more nationalistic inanity, no more passing it off as patriotism.

Patriotism is learning, and educating oneself to understand what their country really stands for.

I heard a lot during the memorial service about how the dead Marine did so much good for others and how his helping others was like a little microcosm of America helping because we have the power to do so. Well if we have the power to help people why aren't we helping in Darfur where hundreds of thousands of people have died in the last 10 years. Saddam was convicted and sentenced to death for killing 143 Shiites who conspired to assassinate him. (I know all you "patriotic" Americans would be calling for the heads of anyone who conspired to assassinate supreme leader Bush). And yet we spend upwards of 1 trillion dollars and nearing 3,000 lives to help these Iraqis when they don't even want us there. Not to mention we don't have the legal justification to be there.

I guess we should wait around for the omnipotent W Bush to decide who we should use our superpowerdom to help next. It's about time to throw him and the rest of the fascists out.

Moreover it's about time to start educating Americans about their past and history, and letting them know that imperialistic leaders are not what the founders of this great country wanted.

War Weapons that Cook Your Skin

The crowd is chanting anti war slogans and anti-Bush jokes. Soldiers roll up in a Hummer. Suddenly, the whole right half of your body is screaming in agony. You feel like you've been dipped in molten lava. You almost faint from shock and pain, but instead you stumble backwards -- and then start running. To your surprise, everyone else is running too. In a few seconds, the street is completely empty.

You've just been hit with a new nonlethal weapon that has been certified for use in Iraq -- even though critics argue there may be unforeseen effects. And it can be used on Citizens in American cities, universities, political rallies.

According to documents obtained for Wired News under federal sunshine laws, the Air Force's Active Denial System, or ADS, has been certified safe after lengthy tests by military scientists in the lab and in war games.

The ADS shoots a beam of millimeters waves, which are longer in wavelength than x-rays but shorter than microwaves -- 94 GHz (= 3 mm wavelength) compared to 2.45 GHz (= 12 cm wavelength) in a standard microwave oven.

The longer waves are thought to limit the effects of the radiation. If used properly, ADS will produce no lasting adverse affects, the military argues.


Documents acquired for Wired News using the Freedom of Information Act claim that most of the radiation (83 percent) is instantly absorbed by the top layer of the skin, heating it rapidly.

The beam produces what experimenters call the "Goodbye effect," or "prompt and highly motivated escape behavior." In human tests, most subjects reached their pain threshold within 3 seconds, and none of the subjects could endure more than 5 seconds.

"It will repel you," one test subject said. "If hit by the beam, you will move out of it -- reflexively and quickly. You for sure will not be eager to experience it again."


But while subjects may feel like they have sustained serious burns, the documents claim "some volunteers who tolerate the heat may experience prolonged redness or even small blisters," the Air Force experiments concluded.

The tests ranged from simple exposure in the laboratory to elaborate war games involving hundreds of participants and urban assaults. More unusual tests involved alcohol, attack dogs and maze-like obstacle courses.

68th Anniversary of Marijuana Prohibition

After a decade of U.S. government scare propaganda that convinced Americans that crazed Mexicans, blacks and fans of jazz clubs were pushing marijuana "reefers" on school children and honest youths, turning them into raving murderers, politicians decided to act. The U.S. Congress passed the Marijuana Tax Stamp Act. Growing and selling marijuana were still legal, but only if you bought a \$1 government stamp. And that stamp was not for sale.

On the day the Marijuana Tax Stamp Act was enacted -- Oct. 2, 1937 -- the FBI and Denver, Colo., police raided the Lexington Hotel and arrested Samuel R. Caldwell, 58, an unemployed labourer and Moses Baca, 26. On Oct. 5, Caldwell went into the history books as the first marijuana seller convicted under U.S. federal law. His customer, Baca, was found guilty of possession.

Caldwell's wares, two marijuana cigarettes, deeply offended Judge Foster Symes, who said: "I consider marijuana the worst of all narcotics, far worse than the use of morphine or cocaine. Under its influence men become beasts. Marijuana destroys life itself. I have no sympathy with those who sell this weed. The government is going to enforce this new law to the letter."

Caldwell was sentenced to four years of hard labour in Leavenworth Penitentiary, plus a \$1,000 fine. Baca received 18 months incarceration. Both men served every day of their sentence. A year after Caldwell was released from prison, he died.

DRUG WAR WORSE THAN DRUGS

Last week, the U.S. Supreme Court let stand the mandatory 55-year prison sentence that a lower court imposed on a man who was convicted of carrying a handgun during three marijuana deals in Utah.

By refusing to hear the case, the U.S. Supreme Court ensured that 27-year-old Weldon Angelos will spend just about the rest of his life behind bars for selling three eight-ounce bags of marijuana to an undercover informant.

As his attorneys noted, the sentence he will serve is harsher than the sentence for raping a child or the sentence for detonating a bomb aboard an aircraft. Even the federal judge who was required to issue the mandatory minimum sentence called it unjust, cruel, and even irrational. Yet, the U.S. Supreme Court let the sentence stand without comment.

TV shows law enforcers throwing people down on the ground or jackbooted thugs (S.W.A.T. and others) breaking into people's homes and/or businesses and surrounding unarmed people with automatic and semi-automatic weapons aimed at the victim's head. Electronic mind control games acclimating kids to murder, mayhem, and the false authority of cops and other enforcers of unconstitutional, anti-freedom rules made by dipstick officials.

"Pick your week or month, the evidence keeps rolling in to show this country's vaunted 'war on drugs' is as destructively misguided as our cataclysmic error in invading Iraq. There are 2.2 million Americans behind bars, another 5 million on probation or parole, the Justice Department reported on Nov. 30. We exceed Russia and Cuba in incarcerations per 100,000 people; in fact, no other nation comes close. The biggest single reason for the expanding numbers? Police grant money funding the war on drugs -- a quarter of all sentences are for drug offenses, mostly nonviolent."

America's Injustice System Is Criminal

The Christmas season is a time to remember the unfortunate. Among the most unfortunate people are those who have been wrongly convicted and imprisoned.

The US has 5% of the world's population and 25% of the world's prisoners. The American incarceration rate is seven times higher than that of European countries. Either America is the land of criminals, or something is seriously wrong with the criminal justice system in "the land of the free."

In the US the wrongful conviction rate is extremely high. One reason is that hardly any of the convicted have had a jury trial. No peers have heard the evidence against them and found them guilty. In the US criminal justice system, more than 95% of all felony cases are settled with a plea bargain.

Before jumping to the conclusion that an innocent person would not admit guilt, be aware of how the process works. Any defendant who stands trial faces more severe penalties if found guilty than if he agrees to a plea bargain. Prosecutors don't like trials because they are time consuming and a lot of work. To discourage trials, prosecutors offer defendants reduced charges and lighter sentences than would result from a jury conviction. In the event a defendant insists upon his innocence, prosecutors pile on charges until the defendant's lawyer and family convince the defendant that a jury is likely to give the prosecutor a conviction on at least one of the many charges and that the penalty will be greater than a negotiated plea.

The criminal justice (sic) system today consists of a process whereby a defendant is coerced into admitting to a crime in order to escape more severe punishment for maintaining his innocence. Many of the crimes for which people are imprisoned never occurred. They are made up crimes created by the process of negotiation to close a case.

This takes most of the work out of the system and, thereby, suits police, prosecutors, and judges to a tee. Police do not have to be careful about evidence, because they know that no more than one case out of twenty will ever be tested in the courtroom.

Prosecutors do not have to make decisions about which cases to prosecute or risk losing cases. By coercing pleas, prosecutors can prosecute every case and boast of extremely high conviction rates.

When prosecutors had to decide which cases to prosecute, they had to examine the evidence and to investigate the defendant's side of the story. No more. The evidence seldom comes into play. In place of a determination of innocence or guilt, prosecutors negotiate with lawyers the crimes to which a defendant will enter a plea.

Prosecutors have lost sight of innocence and guilt: the War on Drugs is criminal.


