Stop Killing Seals!



KAUNAKAKAI, MOLOKA'I —The National Oceanic and Atmospheric Administration (NOAA), in cooperation with the Department of Land and Natural Resources, is investigating the deaths of three Hawaiian monk seals on the south shore of Moloka'i.

Last week a dead seal was found, and a young female was found dead two weeks ago. This follows the death of an adult male seal in mid-November. Necropsies indicate that the seals appear to have died under suspicious circumstances and that foul play cannot be ruled out as the cause of death in either case.

"I was saddened to hear of these two incidents, especially the loss of a young female who would have helped restore the diminished seal population," said William J. Aila, Jr., DLNR Chairperson. "Monk seals are an important part of the Hawaiian ecosystem and need to be respected as a valued part of our natural and cultural environment. The harm to one is a blow to Hawai'i," he said.

In June 2010, the Legislature passed Act 165, specifically to increase penalties for taking (which is defined to include harassing or killing) a monk seal. It's a Class C felony (up to 5 years imprisonment). Someone convicted under this law could face a fine of up to \$50,000. It is also against federal law to kill or harm a Hawaiian monk seal.

Hawaiian monk seal moved into his new home at the Waikiki Aquarium on Thursday. KP2, or Ho'ailona, as he'll now be called, will spend the rest of his life after life in the wild on Molokai didn't work out because of cataracts in both eyes and his overly friendly personality with humans.

Ho'ailona now weighs about 200 pounds.

The now 3-year-old monk seal was found abandoned as a pup on Kauai. When researchers released him back in 2008, he ended up making friends with the children on Molokai swimming in Kaunakakai Harbor.

With only an estimated 1,100 Hawaiian monk seals left in existence, scientists said it's everyone's responsibility to ensure their survival.

"Give them the space that they need so that they don't interact with people," said NOAA assistant monk seal recovery coordinator.

We are providing a home and taking care of him. In reality, he belongs to nobody, but he belongs to everybody," said Rossiter.

We are an important part.

For these blessings, I am happy I was raised as a country boy, able to appreciate and perpetuate the good things that make Molokai special. I truly am thankful for all my blessings that transcend the real life challenges. I enjoy good a good wife Susan, my companion dogs, my health, a roof over my head, passion for justice, ocean sports, and a sense of God and country.

We Americans enjoy a fabulous country. Even the poorest among us enjoy opportunities, food, shelter, education, medical care and hope. While the past decade was not good on the world, deadly for many individual lives, here in America, especially on Molokai, at least for today, we carry hope within our hearts and we work toward a better tomorrow for future generations.

Hawaiians in Sikaiana Atoll Excluded by Redistricting?

Two days ago I read the entire redistricting plan and notice an error of omission within it, viz., the Hawai'i Islands within Sikaiana Atoll (Stewart Islands group) about 90 miles Northeast of Malaita Island near the Solomon Islands were included in the Second Congressional District, but were excluded from any of the Senate or House Districts.

On February 18, 1856, the fourth Kamehameha (King of the Hawaiian Islands) and the fourth Kaahumana (Kuhina Nui of the Hawaiian Islands) by Resolution # 2 at a meeting of the Hawaiian Privy Council under the terms of the Hawaii Constitution of 1852, annexed the islands within the Stewart Group (Sikaiana Atoll) into the Kingdom of Hawaii.

I was the agent of 176 native Hawaiians from Sikaiana in a lawsuit before Judge Ezra of the United States District Court against the Hawaiian Sovereignty Elections Council in 1996. At the time this was almost the entire Adult Population (over 18 years of age) from Sikaiana of something over 300 persons.

These Hawaiians want to be in a Senate and House District. Therefore, I request you consider placing them in a Senate and House District. Today I had a telecom with my long time friend and fellow alumnus of the University of Hawaii, the Honorable Senator Sam Slom who agreed to be these native Hawaiian's representative in the Hawaiian State Senate. He has been concerned about their rights as Citizens for many years and asked to be copied with this e-mail and the Commissioners' replies to this e-mail.

On June 21, 1897, Captain George Northmore Arthur Pollard, R.N., of the H.M.S. Wallaroo, landed at Sikaiana Atoll and raised the Union Jack and proclaimed that "In the name of Her Majesty Queen Victoria of the United Kingdom of Great Britain and Ireland, Empress of India," without the consent of the government of the Republic of Hawai'i or the natives of that atoll, that they now have "assumed a protectorate over the group of islands known as the Stewart Islands and named separately Sikaiana, Faroa, Mandoiloru, Barina and Motuava". Yet, we should not forget that history repeats itself. How many of you remember Hawaiian History 101 and La Kuokoa Hawaii, when the third Kamehameha issued the Hawaii Motto "Ua mau ke ea o ka aina i ka pono" at the end of the Protectorate of 1843. Remember, that Queen Victoria and King Louis-Philippe I on November 28, 1843, proclaimed that the government of the United Kingdom or France will "never take possession, neither directly or under the title of Protectorate..."

Yet Captain Pollard did do that ultra vires act anyway.

On April 30, 1900, Congress enacted AN ACT TO PROVIDE A GOVERNMENT FOR THE TERRITORY OF HAWAII. Therefore, these native Hawaiians of Sikaiana Atoll have both United States and Hawaiian Citizenship. In 1901 the United States District Court in Honolulu in the published case of the UNITED STATES v. SAI, 1 U.S.D.C. Haw. 118 (1901) ruled that "The framers of the Act of Congress providing a Territory of Hawaii approved April 30, 1900, intended to refer to the geographical limits of the Hawaiian Islands rather than any political conditions existing therein and that the Hawaiian and American citizenship was to be extended to all persons born in the islands, exempting only those born of persons engaged in the diplomatic service of foreign governments, such as ministers and ambassadors, whose residence by a fiction of public law is regarded as the place of their own country." It was the government of the Republic of Hawaii that truncated its territorial claims as a tactic to get the Treaty of Cession through the United States Senate, e.g., giving up the Midway Islands. Note your exception in Congressional District # 2 in the 2011 redistricting plans. It still did not pass the U.S. Senate, so it was done by Joint Resolution of Congress in 1898 (Newlands Resolution).

When Hawaii was admitted as a State of these United States of America in 1959, the Admission Act excluded Palmyra Atoll (which was part of the City and County of Honolulu) because the United States Department of State could not get the British Government to drop its sovereign claim to Palmyra Atoll under the purported annexation of that atoll by Captain Nichols of the H.M.S. Cormorant on May 29, 1889. However, Sikaiana Atoll was not excluded from the State of Hawai'i and therefore needs to be included in a Senate and House District. You already place Sikaiana Atoll within the Congressional District # 2, so your task is one third completed.

I thank you for your consideration on doing the proper thing for these native Hawaiians.

US Troops Pull Out of Iraq



Early Sunday, as the sun ascended to the winter sky, the very last American convoy made its way down the main highway that connects Iraq and Kuwait.

The military called it its final "tactical road march." A series of 110 heavily armored, hulking trucks and Mine Resistant Ambush Protected vehicles carrying about 500 soldiers streamed slowly but steadily out of the combat zone.

A few minutes before 8 a.m., the metal gate behind the last MRAP closed. With it came to an end a deadly and divisive war that lasted almost nine years, its enormous cost calculated in blood and billions.

United States gave 110,000 items left at city of Adder to the Iraqis, a loot worth \$76 million, according to the military.

The 3rd Brigade Special Troops Battalion, 1st Cavalry Division officially transferred control of Camp Adder to the Iraqis on Friday, though it did not really change hands until the last American departed early Sunday morning.

Staff Sgt. Daniel Gaumer, 37, was on this road in August 2003. It was tense and scary. Sunday morning, the air was decidedly different.

"It's pretty historic," he said about the drive south, hoping he will not ever have to come back through this unforgiving terrain again.

Many other troops crossed the border harboring mixed feelings and doubt about the future of Iraq. "The biggest thing about going home is just that it's home," Gaumer said. "It's civilization as I know it -- the Western world. Sgt. Ashley Vorhees, 29, dreamed of seeing her three children and eating crispy chicken tacos at Rosa's Mexican restaurant in Killeen, Texas. She also looked forward to not having to carry her gun with her to the bathroom. [Keep you gun, girl!]

"We actually had it a lot better than the people did who did the initial invasion," she said. "We're just thankful that we're not getting attacked every day."

When the war was at its worst in 2006, America had 239,000 men and women in uniform stationed in more than 500 bases sprinkled throughout Iraq. Another 135,000 contractors were working in Iraq.

The United States will still maintain a presence in Iraq: hundreds of nonmilitary personnel, including 1,700 diplomats, law enforcement officers, and economic, agricultural and other experts, according to the State Department. In addition, 5,000 security contractors will protect Americans and another 4,500 contractors will serve in other roles. [1,700 diplomats? What the hell for?]

The quiet U.S. exit, shrouded in secrecy until it occurred, closes a war that was unlawful and a lie, from the start and cost the nation more than \$800 billion.

More than 4,500 U.S. troops were killed in Iraq; more than 30,000 wounded.

The whole nation of Iraq was destroyed and population and economy and history destroyed by US invasion. It's impossible to know with certainty the number of Iraqis who have died in Iraq since 2003. But the independent public database Iraq Body Count has compiled reports of more than 150,000 between the invasion and October 2010, with four out of five dead being civilians. DOES THAT SONUND LIKE USA IS EXITING IRAQ? NO!

Even before the last soldiers had left, political crisis was erupting in Baghdad because of the political and social problems created by USA invasion.

The powerful political bloc Iraqiya said it was suspending its participation in parliament, which would threaten Iraq's fragile power-sharing arrangement. Iraqiya accuses Iraqi Prime Minister Nuri al-Maliki of amassing power.

In the months before the brigade deployed in February, it lost 13 soldiers to accidents, some because of driving under the influence of alcohol. At least one death was a suicide.

"Quite frankly we lost more soldiers in peacetime in the nine or 10 months before this brigade deployed due to accidents and risky behavior ... than we lost here in combat," Crissman said. "We want every soldier that survived this combat deployment to survive redeployment and reintegration."

Capt. Mark Askew, 28, said he was worried about the well-being of his soldiers, PTSD, etc. Was the loss, the grief, worth it?

It will depend, he said, on how Iraq shapes its own destiny.

[Umm,that is what should have been done instead of invading Iraq!]



The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!



Dear Editor,

Arizona houses 1,742 Hawaiian inmates in the middle of the desert at the Saguaro and Red Rock prison facilities due to overcrowding and lack on funding to build new prisons in Hawaii. The state of Hawaii has extended the \$45.5 million a year contract to house inmates in Arizona with Corrections Corporation of America (CCA) another three years until June 30, 2014.

Hawaii recidivism rate averages above fifty percent, which is a problem for the state budget and community. Is there a plan that reduces recidivism; Strengthen the community and family bonds (Ohana); Reduces the state budget housing repeat offenders? An article titled "Jail phone calls ring up big bills" states the following:

"The amount of money charged is controversial because studies show that maintaining strong family contact during incarceration through phone calls, correspondence and visits can aid parole success and reduce recidivism."

Just Talk Communications is solving these problems today: Reducing the rate of collect calls; Enabling collect calls to cellular phones; Enabling collect calls to VOIP phones; Reducing recidivism by making communication affordable.

The Hawaiian inmates in Arizona are in trouble. They do not have family members that can visit them due to the distance and high cost of travel. Inmates only make \$0.12 per hour and phone calls cost \$0.25 per minute plus a \$2.00 connection fee. The cost for a 21-minute phone call is approximately \$8.00 with tax. Family members are typical lower income and cannot afford to maintain frequent communications that keeps family members bonded with Hawaiian inmates in Arizona due to the high cost of phone calls. Our studies show that family members invest an average of \$22.00 per month on phone calls from inmates.

Just Talk Communications is in a position to help family members in Hawaii, by lowering the cost of collect calls to a flat \$3.50 per call. That same \$22.00 per month in spending will allow an inmate to talk to his wife or child at least six times a month versus two times per month for the same cost. We have installed the lines in Arizona to make this happen and have been providing service for a few family members in Hawaii over the past couple of months. We are going to do part by offering free phone calls during the most important times of the year; Christmas, New Years, Mother's Day and Father's Day. Those days mean so much to family members, and this is our way to pay it forward. We need this story to get out, which is why I am reaching out to you today. Please consider the family members who are struggling to keep a family bond.

## Obama/Holder/BATF Gun Run To Mexico intended as catalyst to impose gun laws on USA

Documents obtained by CBS News show that the Bureau of Alcohol Tobacco, Firearms and Explosives (BATF) discussed using their covert operation "Fast and Furious" to argue for more restrictive new rules about gun sales.

In Fast and Furious, ATF secretly encouraged gun dealers to sell to suspected traffickers for Mexican drug cartels as a sting operation. But ATF whistleblowers told CBS News and Congress it was a dangerous practice called "gunwalking," and it put thousands of weapons on the street. Many were used in violent crimes in Mexico. Two were found at the murder scene of a U.S. Border Patrol agent.

ATF officials didn't intend to publicly disclose their own role in letting Mexican cartels obtain the weapons.

On July 14, 2010 after ATF headquarters in Washington D.C. received an update on Fast and Furious, ATF Field Ops Assistant Director Mark Chait emailed Bill Newell, ATF's Phoenix Special Agent in Charge of Fast and Furious:

"Bill - can you see if these guns were all purchased from the same (licensed gun dealer) and at one time. We are looking at anecdotal cases to support a demand letter on long gun multiple sales. Thanks."

On Jan. 4, 2011, as ATF prepared a press conference to announce arrests in Fast and Furious, Newell saw it as "(A)nother time to address Multiple Sale on Long Guns issue." And a day after the press conference, Chait emailed Newell: "Bill--well done yesterday... (I)n light of our request for Demand letter 3, this case could be a strong supporting factor..."

This revelation angers gun rights advocates. Larry Keane, a spokesman for National Shooting Sports Foundation, a gun industry trade group, calls the discussion of Fast and Furious to argue for Demand Letter 3 "disappointing and ironic." Keane says it's "deeply troubling" if sales made by gun dealers "voluntarily cooperating with ATF's flawed 'Operation Fast & Furious' were going to be used by some individuals within ATF to justify imposing new requirement for rifles."

### The Gun Dealers' Quandary

Several gun dealers who cooperated with ATF told CBS News and Congressional investigators they only went through with suspicious sales because ATF ordered them to do it even though it was illegal.

Gun stores cooperating with BATF were worried. In 2010 a licensed gun dealer cooperating with ATF wrote We just want to make sure are not viewed as selling to the bad guys....need a letter of understanding from BATF to alleviate concerns of some type of recourse against us down the road for selling these items."

ATF's group supervisor on Fast and Furious David Voth assures the gun dealer there's nothing to worry about. "We (ATF) are continually monitoring these suspects using a variety of investigative techniques which I cannot go into detail."

Two months later, the same gun dealer grew more agitated. "It's like ATF created or added to the Mexican gun problem so they could be the solution to it and pat themselves on the back," says one law enforcement source familiar with the facts. "It's a circular way of thinking."

On April 25, 2011, ATF announced plans to implement Demand Letter 3. The National Shooting Sports Foundation is suing the ATF to stop the new rules. It calls the regulation an illegal attempt to enforce a law Congress never passed. ATF counters that it has reasonably targeted guns used most often to "commit violent crimes in Mexico, especially by drug gangs."

Sen. Charles Grassley is investigating Fast and Furious, as well as the alleged use of the case to advance gun regulations. It's pretty clear that the problem isn't lack of burdensome reporting requirements."

On July 12, 2011, Sen. Grassley and Rep. Darrell Issa, R-Calif., wrote Attorney General Eric Holder, whose Justice Department oversees ATF. They asked Holder whether officials in his agency discussed how "Fast and Furious could be used to justify additional regulatory authorities." So far, they have not received a response. CBS News asked the Justice Department for comment and context on ATF emails about Fast and Furious and Demand Letter 3, but officials declined to speak with us.

"In light of the evidence, the Justice Department's refusal to answer questions about the role Operation Fast and Furious was supposed to play in advancing new firearms regulations is simply unacceptable," Rep. Issa told CBS News.

### Jefferson's Explanation

"But with respect to our rights, and the acts of the British government contravening those rights, there was but one opinion on this side of the water. All American Whigs thought alike on these subjects. When forced, therefore, to resort to arms for redress, an appeal to the tribunal of the world was deemed proper for our justification. This was the object of the Declaration of Independence. Not to find out new principles, or new arguments, never before thought of, not merely to say things which had never been said before; but to place before mankind the common sense of the subject, in terms so plain and firm as to command their assent, and to justify ourselves in the independent stand we are compelled to take. Neither aiming at originality of principle or sentiment, nor yet copied from any particular and previous writing, it was intended to be an expression of the American mind, and to give to that expression the proper tone and spirit called for by the occasion. All its authority rests on the harmonizing sentiments of the day, whether expressed in conversation, in letters, printed essays, or the elementary books of public right, as Aristotle, Cicero, Locke, Sidney, etc. The historical documents which you mention in your possession, ought all to be found, and I am persuaded you will find, to be corroborative of the facts and principles advanced in that Declaration. --Thomas Jefferson ( Letter to Henry Lee, May 8, 1825)

The Unanimous Declaration of the thirteen United States of America --Action by the Second Continental Congress, July 1776:

WHEN in the Course of human Events, it becomes necessary for one People to dissolve the Political Bonds which have connected them with another, and to assume among the Powers of the Earth, the separate and equal Station to which the Laws of Nature and of Nature's God entitle them, a decent Respect to the Opinions of Mankind requires that they should declare the causes which impel them to the Separation.

WE hold these truths to be self-evident, that all Men are created equal, that they are endowed by their Creator with certain unalienable Rights, that among these are Life, Liberty, and the Pursuit of Happiness. That to secure these rights, Governments are instituted among Men, deriving their just Powers from the Consent of the Governed. That whenever any Form of Government becomes destructive to these Ends, it is the Right of the People to alter or to abolish it, and to institute new Government, laying its Foundation on such Principles and organizing its Powers in such Form, as to them shall seem most likely to effect their Safety and Happiness. Prudence indeed, will dictate that Governments long established should not be changed for light and transient Causes; and accordingly all Experience hath shewn, that Mankind are more disposed to suffer, while Evils are sufferable, than to right themselves by abolishing the Forms to which they are accustomed. But when a long Train of Abuses and Usurpations, pursuing invariably the same Object evinces a design to reduce them under absolute Despotism, it is their Right, it is their Duty, to throw off such Government, and to provide new Guards for their future Security. Such has been the patient Sufferance of these Colonies; and such is now the necessity which constrains them to alter their former Systems of Government. The history of the present King of Great Britain [George III] is a history of repeated Injuries and Usurpations, all having in direct Object the Establishment of an absolute Tyranny over these States. To prove this, let Facts be submitted to a candid World.

WE hold these Truths to be self-evident, that all men are created equal, that they are endowed by their Creator with certain unalienable Rights...That which is self-evident is so ingrained in the human psyche that it sparks no debate.

Since every individual is an end in himself, with lawful title to himself, every individual is endowed with precisely the same unalienable rights. Unalienable means precisely that, un-alienable. This is the natural law that never changes. An incomparably eloquent expression of the American Ideal, the declaratory judgment referred to as the Declaration of Independence is the lawful wellspring for American jurisprudence. So then, why have Americans so foolishly relinquished their birthright to Life, Liberty, and the pursuit of Happiness?

## Audit Blasts Hawaii Charter School System

The Charter School Review Panel, which is the agency charged with overseeing charter schools, "has misinterpreted state law and minimized its role in the system's accountability structure," the State Auditor's report states in its summary. It adds that the panel has delegated too much of the monitoring and accountability to the boards of individual schools.

The auditor's two overarching findings were:

1. The Charter School Review Panel fails to hold charter schools accountable for student performance.
2. Charter school operations fail to comply with state law and principles of public accountability.

Most of the information in the report was not news to the officials who oversee the 32-school charter school system, or to members of the public following the numerous nepotism, ethics and other scandals at charter schools around the state.

Officials have already been hard at work to address those, as well as other authority and accountability problems outlined in the report. Earlier this month, a legislative task force — on which some of those officials served — recommended <<http://www.civilbeat.com/articles/2011/12/07/14160-charter-school-task-force-recommends-an-overhaul-of-the-system/>>a complete overhaul of the system.

"We saw a lot of these problems, which is why all the things going on have been going on," said Roger McKeague, executive director of the Charter School Administrative Office, which provides support for the network of schools. "That's why we had the task force. It was all in recognition of the fact that there was issues, and that things needed to be tightened up to make it work better."

McKeague, panel members and other policymakers hope the overhaul will solve the fact that some charter schools have been omitting or misrepresenting critical data, overpaying staff and not abiding by state ethics law — all problems found during the audit.

"The lack of oversight by the review panel, the Charter School Administrative Office, which is responsible for management of the charter school system, and the local school boards has resulted in school spending and employment practices that are unethical and illegal," the report states.

While the overseers of the system agree with the majority of the findings, they take issue with others, and say the report contains some factual errors. The audit, for example, states that schools misrepresented enrollment numbers, on which school funding is based, thereby possibly defrauding the state of hundreds of thousands of dollars. McKeague says the administrative office never based school funding distributions on those misreported numbers, but an official enrollment count that is confirmed by the administrative office.

The panel disputes the claim that it has neglected its responsibility to hold schools accountable, saying it has provided oversight of charter schools "to the extent allowable by law."

McKeague said that despite the disparate interpretations of some of the information in the report, it highlights the need for clearer laws and lines of authority.


