## S.O.S. Beach Lost ! at Rice Patch aka Kakahaia Park

### Going, going, .....Kakahaia Beach Park Eroding Away Fast Seawall and backfilling Needed, NOW! S.O.S

Problem description: Kakahaia Park beach erosion destroying park beachfront lands, trees, must be stopped with seawall and back filling restoration immediately.

I have been complaining about the erosion of this roadside beach park for past 34 years, and now this dead coconut tree, which was alive on the edge of grass just ten years ago, has been left standing alone as a witness and a measure of the land lost to erosion at this popular beach park just five miles east of Kaunakakai. There is not much left of the grassy park, maybe 60 feet at most, where there used to be about 100 feet wide grass to the shoreline high water mark. We need a seawall and backfilling restoration, immediately.

Who will protect the public beaches and land from erosion? The government ignores it, because it is focused on the UH study and set backs instead of the causes of erosion and prevention, along with protection seawalls that protect the land already starting to erode where beaches are gone! We need SAND, man! We need rock wall here to keep the land off the beach and the ocean from eating both away causing loss of Kakahaia Park.

The reef makes sand to protect the land from erosion, not just for people to play on. The beaches, wide sand beaches, are protection for the land from a hostile sea forces. We cannot just adopt setback based on a UH study of erosion rates, we have to STOP the EROSION and STOP the destruction of reefs that produce sand ! Sand and seawalls protect the land and beaches ! Aloha Aina!!

We could likely get the seawall built and back-filled with very little money if the SMA-Fletcher people would get out of the way, reventments built to protect the land from erosion. UH-Fletcher demonizes seawalls as the cause of beach erosion, and state policy is written "to discourage all shoreine hardening....." even though they admit, YES, they ADMIT that a seawall is effective and prudent protection.

Fletcher has been scamming Hawaii with his anti-seawall fraud for at least two decades by manipulating the data of his beach erosion studies and classifications in order to prove his grant money generating fraudulent theory that seawalls cause beach erosion, and keeping his lucrative status with the State by preventing contrary scientific proof of the fraud from qualified Coastal Engineers becoming public knowledge in Hawaii. UH knows best? Its FRAUD!

Meanwhile, SMA and DLNR/State like to argue about it while Hawaii washes into the deep ocean.

Nancy McPherson, Maui County Planning Dept., wrote to me on 10/16/08: " I will confer with our Shoreline Planner, Thorne Abbott and State DLNR, Office of Conservation and Coastal Lands, regarding the situation at the beach park as well as at Waialua, and get back to you as soon as I know more. Perhaps you can give me a tour of all the high erosion areas you know of along the south coast of Molokai, so I can get a better understanding of the problem. Also, Councilmember Danny Mateo is our Molokai representative, and he should be advised of the problem as well, as he may be able to help us find funding for repairs, possible beach renourishment.....



**Medical Marijuana: Whole Plant Better Than Isolated Components in Pain Relief, Italian Study Finds**

Scientists at the University of Milan have published a study finding that whole-plant marijuana extracts provide better relief for neuropathic pain than isolated components of the plant, like THC alone.

The research is an intervention in the ongoing debate between medical marijuana supporters and herbal and alternative medicine advocates on one side and the US government, some politicians, and the pharmaceuticalized medicine industry on the other.

"The use of a standardized extract of Cannabis sativa... evoked a total relief of thermal hyperalgesia, in an experimental model of neuropathic pain,... ameliorating the effect of single cannabinoids," the investigators reported. "Collectively, these findings strongly support the idea that the combination of cannabinoid and non-cannabinoid compounds, as present in extracts, provide significant advantages... compared with pure cannabinoids alone."

Congressional drug warriors like Rep. Mark Souder (R-IN) have long argued that marijuana is not a medicine and that any medicinal compounds in the plant should be isolated or synthesized, as is the case with Marinol, which contains one of the hundreds of cannabinoids found in the plant. The DEA takes a similar approach. But this latest research only adds to the evidence that the DEA's position is mistaken to the point of medical malpractice.

**CORRUPT Drug War COPS**

In Phoenix, a Maricopa County jail guard was arrested Monday for smuggling cocaine in for an inmate. Detention officer Ryan White, 27, accepted sexual favors from two women who were the inmates' roommates in return for sneaking in the coke, which was found in his uniform pocket. He is now charged with two felonies -- promoting jail contraband and assisting in a criminal syndicate.
