New Catholic Church Construction Pau. Dedication is Friday



Its almost a miracl that the new Damien Catholic Church is completed. Located in heart of Kaunakakai, between the Pascua Store bulletin board and the old Brath Building across from FMC and the U.S. Post Office. Dedication and blessing will take place this coming Friday evening, starting 6 pm.

Another great news report is about the Vatican approving the next step toward Sainthood for Kalaupapa nun Blessed Marianne Cope. The Vatican has cleared the way for canonization of a second saint with Hawaii ties. The Vatican's Congregation for the Causes of Saints on Tuesday recommended to the pope that Blessed Marianne Cope be canonized, confirming previous rulings that a second miracle was due to her intercession. Cope succeeded Father Damien in caring for leprosy patients exiled to the Kalaupapa settlement on Molokai. She died of natural causes and was buried there. Damien gained sainthood in 2009.

In 2004, Pope John Paul II declared Mother Marianne "venerable," the first step toward canonization after the Vatican recognized her intercession for the unexplained cure of a dying New York girl.

The Vatican must authenticate the second miracle for her to be declared a saint. That's now expected to happen soon.



December 7, 1941 Pearl Harbor: Did FDR Provoke Japanese to attach Pearl Harbor? Freedom Betrayed: President Herbert Hoover's History WWII

On Dec. 8, 1941, Franklin Roosevelt took the rostrum before a joint session of Congress to ask for a declaration of war on Japan.

A day earlier, at dawn, carrier-based Japanese aircraft had launched a sneak attack devastating the U.S. battle fleet at Pearl Harbor.

Said ex-President Herbert Hoover, Republican statesman of the day, "We have only one job to do now, and that is to defeat Japan."

But to friends, "the Chief" sent another message: "You and I know that this continuous putting pins in rattlesnakes finally got this country bit."

Today, 70 years after Pearl Harbor, a remarkable secret history, written from 1943 to 1963, has come to light. It is Hoover's explanation of what happened before, during and after World War II.

Edited by historian George Nash, "Freedom Betrayed: Herbert Hoover's History of the Second World War and Its Aftermath" is a searing indictment of FDR and the men around him as politicians who lied prodigiously about their desire to keep America out of war, even as they took one deliberate step after another to take us into war.

Yet the book is no polemic. The 50-page run-up to the war in the Pacific uses memoirs and documents from all sides to prove Hoover's indictment. And perhaps the best way to show the power of this book is the way Hoover does it – chronologically, painstakingly, week by week.

Consider Japan's situation in the summer of 1941. Bugged down in a four-year war in China she could neither win nor end, having moved into French Indochina, Japan saw herself as near the end of her tether.

Inside the government was a powerful faction led by Prime Minister Prince Fumimaro Konoye that desperately did not want a war with the United States.

The "pro-Anglo-Saxon" camp included the navy, whose officers had fought alongside the U.S. and Royal navies in World War I, while the war party was centered on the army, Gen. Hideki Tojo and Foreign Minister Yosuke Matsuoka, a bitter anti-American.

On July 18, 1941, Konoye ousted Matsuoka, replacing him with the "pro-Anglo-Saxon" Adm. Teijiro Toyoda.

The U.S. response: On July 25, FDR froze all Japanese assets in the United States, ending all exports and imports, and denying Japan the oil upon which the Japanese military and nation and empire depended.

Stunned, Konoye still pursued his peace policy by winning secret support from the navy and army to meet FDR on the U.S. side of the Pacific to hear and respond to U.S. demands.

U.S. Ambassador Joseph Grew implored Washington not to ignore Konoye's offer, that the prince had convinced him an agreement could be reached on Japanese withdrawal from Indochina and South and Central China. Out of fear of Mao's armies and Stalin's Russia, Tokyo wanted to hold a buffer in North China.

On Aug. 28, Japan's ambassador in Washington presented FDR a personal letter not to be published from Konoye imploring him to meet.

On Sept. 3, the Konoye letter was leaked to the Herald-Tribune.

On Sept. 6, Konoye met again at a three-hour dinner with Grew to tell him Japan now agreed with the four principles the Americans were demanding as the basis for peace. No response from FDR.

On Sept. 29, Grew sent what Hoover describes as a "prayer" to the president not to let this chance for peace pass by.

On Sept. 30, Grew wrote Washington, "Konoye's warship is ready waiting to take him to Honolulu, Alaska or anyplace designated by the president."

No response. On Oct. 16, Konoye's cabinet fell.

In November, the U.S. intercepted two new offers from Tokyo: a Plan A for an end to the China war and occupation of Indochina and, if that were rejected, a Plan B, a modus vivendi where neither side would make any new move. When presented, these, too, were rejected out of hand.

At a Nov. 25 meeting of FDR's war council, Secretary of War Henry Stimson's notes: "The question was how we should maneuver them (the Japanese) into ... firing the first shot...." "We can wipe the Japanese off the map in three months," wrote Navy Secretary Frank Knox.

As Grew had predicted, Japan, a "hara-kiri nation," proved more likely to fling herself into national suicide for honor than to allow herself to be humiliated.

Out of the war that arose from the refusal to meet Prince Konoye came scores of thousands of U.S. dead, Hiroshima, Nagasaki, the fall of China to Mao Zedong, U.S. wars in Korea and Vietnam, and the rise of a new arrogant China that shows little respect for the great superpower of yesterday.

If you would know the history that made our world, war racketeering, spend a week with Mr. Hoover's book. Freedom Betrayed by Herbert Hoover.

Hawaiian Ukulele Star Passes On

Ukulele player Bill Tapia, has died aged 103.

He was "widely believed to be the oldest performing musician ever to take to the stage". The musician, who received his first ukulele aged 7, died at his home in California. He began his career entertaining World War I troops in 1918.



A professional musician by the age of 10, he released his first CD, Tropical Swing, in 2004 aged 96.

The Honolulu-born musician, who was also known as Tappy, passed away just six months after releasing a live album celebrating his 100th birthday. He was inducted into the Ukulele Hall of Fame in 2004 and received a lifetime achievement award from the Hawaiian Academy of Recording Arts.

"He was perhaps the most beloved and revered figure in the ukulele world, and everyone who ever knew him or saw him perform will be forever inspired," the obituary on his website said.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!





Windmill in Scotland Spins Out of Control, Flames out during hurricane

In Scotland almost 40,000 people are still without power after the worst storms in a decade. Yesterday's storms were the worst for a decade with hurricane force gusts bringing down power lines, and over spinning of a giant windmill.

Hawaiian Homes Commission approved an allocation of \$453,059 to the Council for Native Hawaiian Advancement (CNHA) in U.S. Department of Housing and Urban Development (HUD) funds to convert 60 electric water heaters to solar water heating systems in homestead communities Statewide. Since 2009, CNHA has been administering the Homestead Energy Program (HEP), providing grants and loans up to \$6,500 for solar water heaters; and low-interest loans up to \$15,000 to purchase photo voltaic systems in homestead communities.

What Happened to Hawaii's Windmill Farms on Big Island?



According to recent estimates, there are currently 14,000 abandoned wind farms dotting the landscape in the U.S.

Hawaii, for example, has 37 abandoned wind turbines at one site and there are five other abandoned wind sites in the Hawaiian Islands.

In California, there are thousands of such abandoned sites, including Altamont Pass, Techachapi and San Geronio — all considered perfect spots for wind turbines.

So, what happened? Well, first off, when government subsidies stop, the projects die. Secondly, wind power has proven to be unreliable as a consistent source of power. There's either too little wind, too much wind, or it's too cold to operate them. In Britain, the energy industry admitted as long ago as 2008 that wind turbines are idle up to 30% of the time because of the unreliability of the wind. A report from the British <http://www.ref.org.uk/> Renewable Energy Foundation at the time describes the economically disastrous wind turbine industry. Third, hundreds of birds get killed by crashing in to these huge machines and the PETA crowd goes insane. The Altamont site, for example, is shut down four months out of the year to protect migrating birds.

It is unlikely that the Obama Administration will let facts get in the way of their war against fossil fuels and their love affair with solar and wind power. Expect more taxpayer dollars to be flushed down the rathole of solar and wind boondoggles. Expect to see more abandoned wind farms in the future — as long as Obama remains in office and the EPA is run by the climate alarmist zealot Lisa Jackson.

Now, Obama's good buddy Jeff Imelt, who runs General Electric and AES Corporation [a global power project developer] developed a wind farm of 60 turbines in West Virginia. These 60 turbines provide only enough power for 20,000 homes. So what's the great solution to providing a backup system for these turbines? Why, a mere 1.3 million lithium ion batteries the size of a typical C or D battery you use for your flashlights.

And how effective are these 1.3 million batteries in providing needed backup power for the 60 turbines? According to the author, they only hold enough energy to power 5,000 homes for 15 minutes.

Imelt also runs Obama's Council on Jobs and Competitiveness. In addition, AES Wind Generation official Michael Azeka, is on the Wind Turbine Guidelines Advisory Committee for the U.S. Fish and Wildlife Service. This all sounds like cozy corporate "green" welfare, so whats up with that? Obama-nomics, again?

And what do the 20,000 poor citizens of West Virginia get? They get unreliable electricity with a 15 minute backup system for one quarter of them. Only someone who is suffering from a green delusion could think this is a positive thing and is the future of energy in America. Obama says be grateful ?

Part IV: What Law? American Ideals Defended

Drug Prohibition has created an unacceptable precedent for unlawful power. The Legal System of Precedents that has supplanted the legitimate Law of the Land has little to do with justice and everything to do with politics, plundering, and profit. Judges have become haughty revenue collectors and the courts have become instruments of legal extortion. The outrageous legal income that is produced by unlawful prohibition and other unlawful power goes unnoticed by most folks. But Folks, We the People have a moral duty to ourselves and to our posterity to wake to the danger and destroy the ever-growing Bad-law Monster . . . in detail.

The growing Judicial Industry has no interest in ending the evil Drug War or in the repeal of bad law generally. The unfortunate arrested victims and the taxpayers will continue to lose while the judicial plunderers grow richer with every unlawful arrest.

The moral legitimacy and the actual lawfulness of powers that are systematically disregarded with a clear conscience by more than 30 million Americans ought to be seriously questioned by every American worthy of American Citizenship.

DEFENDING THE AMERICAN IDEAL

Lawful and legal are not synonyms. There is an ethical element in lawful that is often painfully absent in legal. Power that is legal can be lawful only when it does not offend a healthy conscience. And if it offends a healthy conscience, it surely contravenes the Principles underpinning the Unanimous Declaration.

No power that contravenes the principles supporting the non-amendable July 1776 Action of the Second Continental Congress can rightly be considered lawful. Legal, yes; but lawful, no. Odd though it may sound to most folks, a growing number of unlawful laws do in fact exist.

So then, since it has long been evident that elections alone will not rid Americans of the burden of the bad laws that support unlawful power, what are concerned citizens to do about it? WE the People surely cannot turn to lawyers and career politicians, a disproportionate number of whom are lawyers. Those who wield power and enjoy the wealth and privilege that power provides are unwilling to relinquish any part of it, even when it is clear that a particular power is downright evil.

Did not Madison warn of such a development in Federalist Number 10? According to Madison: "By a faction, I understand a number of citizens, whether amounting to a majority or a minority of the whole, who are united and actuated by some common impulse of passion, or of interest, adverse to the rights of other citizens, or to the permanent and aggregate interests of the community."

Sixty-three years later, French economist Frederic Bastiat shared the following dreadful conclusion: "The law perverted! And the police powers of the state perverted along with it! The law, I say, not only turned from its proper purpose but made to follow an entirely contrary purpose! The law becomes the weapon of every kind of greed! Instead of checking crime, the law itself guilty of the evils it is supposed to punish!"

In what is now an America ruled – yes, RULED! – by statist, and the law becomes more perverted with each succeeding regime – yes, REGIME! A significant number of Americans are aware of the general perversion yet they remain willing to acquiesce in, and sometimes actively support, truly dangerous exceptions to sound principles. Unfortunately, an accumulation of exceptions has the power to render sound principles powerless. Exceptions must be handled like a grenade with the pin removed, leaving the striker immobilized only by a firm grip on the spoon. The moment you relax your grip, the striker lights the fuse and Mr. Grenade is no longer your friendly personal servant. And so it is with power in the hands of statist.

WE the American People have surely lost our grip.

That having been said, what can be done to reestablish control of our own political destiny? If you want to find out, than read on:

Obama Repeals Military Rule Against Sodomy and bestiality? Hilliary Clinton says gaysexs will be supported by USA

Nigerian leaders unite against same-sex marriages; Ghana gays 'will never be legal; Uganda fury at UK gay aid threat; Saudi Arabia bans homosexuality outright; Afghanistan also prohibits homosexual activity.

Many ambassadors rushed out of the room as soon as Mrs Clinton finished speaking, the Associated Press news agency reported.

The official memorandum does not outline consequences for countries with poor records on gay rights. But it allows US agencies working abroad to consult with international organisations on discrimination.

In the US, Republican presidential candidates criticised the administration's decision, saying that "promoting special rights for gays in foreign countries is not in America's interests and not worth a dime of taxpayers' money".


