## Military Training At Makua Not "Vital"

Last week, judge in the U.S. District Court issued an order denying the U.S. Army's request to conduct live-fire training exercises at Mākua Military Reservation on Oahu prior to completing a comprehensive Environmental Impact Statement (EIS) under the National Environmental Policy Act (NEPA). On October 4, 2001, the Army voluntarily entered into a settlement with community group Mālama Mākua calling for a complete ban on live-fire training at Mākua if it did not complete the EIS by October 4, 2004. Since the Army is more than a year late in completing the EIS, the court held that, "having failed to satisfy the law, the Army may not resume live fire training at Makua."

Noting that training is available to the Army at locations such as the National Training Center in California and Pōhakuloa Training Area on the island of Hawai'i, the court rejected the Army's claims that training at Mākua is vital to prepare soldiers for deployment to Iraq as "vehement pronouncements and speculation." In contrast to the Army's speculative claims, the court found "the record establishes that allowing the Army to conduct live fire training at Makua is likely to significantly degrade biological, cultural, and archaeological resources in Makua....access cultural sites."

Over 100 Native Hawaiian cultural sites have been identified at Mākua, including heiau, ahu, burials and petroglyphs. Fires sparked by training threaten to destroy more than 40 federally listed endangered species and the unique native forest on which they depend for survival.

Earthjustice attorney David Henkin, who represents Mālama Mākua, said "The facts are that, while the Army has many other places it can conduct live-fire training while it complies with NEPA's requirement to complete the EIS, the cultural and biological treasures at Mākua are found there, and nowhere else. If the Army were allowed to destroy these treasures through a training-related fire or misfired artillery shell, they would be lost to the people of Hawai'i forever."

## What Really Happened at State of Union

As most of you have probably heard, I was arrested before the State of the Union Address last night, Tuesday January 31, 2006.

I am speechless with fury at what happened and with grief over what we have lost in our country. There have been lies from the police and distortions by the press. So this is what really happened:

This afternoon at the People's State of the Union Address in DC where I was joined by Congresspersons Lynn Woolsey and John Conyers, Ann Wright, Malik Rahim and John Cavanagh, Lynn brought me a ticket to the State of the Union Address. At that time, I was wearing the shirt that said: 2245 Dead. How many more?

I knew George Bush would say things that would hurt me and anger me and I knew that I couldn't disrupt the address because Lynn had given me the ticket and I didn't want to be disruptive out of respect for her. We went to the Capitol via the underground tunnel. I went through security once, then had to use the rest room and went through security again.

My ticket was in the 5th gallery, front row, fourth seat in. The person who in a few minutes was to arrest me, helped me to my seat.

I had just sat down and I was warm from climbing 3 flights of stairs back up from the bathroom so I unzipped my jacket. I turned to the right to take my left arm out, when the same officer saw my shirt and yelled; "Protester." He then ran over to me, hauled me out of my seat and roughly (with my hands behind my back) shoved me up the stairs. I said something like "I'm going, do you have to be so rough?" By the way, the officers name is Mike Weight.

The officer ran with me to the elevators yelling at everyone to move out of the way. When we got to the elevators, he cuffed me and took me outside to await a squad car. On the way out, someone behind me said, "That's Cindy Sheehan." At which point the officer who arrested me said: "Take these steps slowly." I said, "You didn't care about being careful when you were dragging me up the other steps." He said, "That's because you were protesting." Wow, I get hauled out of the People's House because I was, "Protesting."

I was never told that I couldn't wear that shirt into the Congress. I was never asked to take it off or zip my jacket back up. If I had been asked to do any of those things...I would have, and written about the suppression of my freedom of speech later. I was immediately, and roughly (I have the bruises and muscle spasms to prove it) hauled off and arrested for "unlawful conduct."

After I had my personal items inventoried and my fingers printed, a nice Sgt. came in and looked at my shirt and said, "2245, huh? I just got back from there."

I told him that my son died there. That's when the enormity of my loss hit me. I have lost my son. I have lost my First Amendment rights. I have lost the country that I love. Where did America go? I started crying in pain.

What did Casey die for? What did the 2244 other brave young Americans die for? What are tens of thousands of them over there in harm's way for still? For this? I can't even wear a shirt that has the number of troops on it that George Bush and his arrogant and ignorant policies are responsible for killing.

I wore the shirt to make a statement. The press knew I was going to be there and I thought every once in awhile they would show me and I would have the shirt on. I did not wear it to be disruptive, or I would have unzipped my jacket during George's speech. If I had any idea what happens to people who wear shirts that make the neocons uncomfortable that I would be arrested...maybe I would have, but I didn't.

I have some lawyers looking into filing a First Amendment lawsuit against the government for what happened tonight. I will file it. It is time to take our freedoms and our country back.

I don't want to live in a country that prohibits any person, whether he/she has paid the ultimate price for that country, from wearing, saying, writing, or telephoning any negative statements about the government. That's why I am going to take my freedoms and liberties back. That's why I am not going to let Bushco take anything else away from me...or you.

I am so appreciative of the couple of hundred of protesters who came to the jail while I was locked up to show their support....we have so much potential for good...there is so much good in so many people.

Four hours and 2 jails after I was arrested, I was let out.

People only think they are free in America -- It looks like the USSR to me. It is Soviet Style Government brought to you by the Busheviks. The Capitol Police need to arrest GW Bush for high crimes and misdemeanors. He should be brought before a military tribunal for war crimes and treason. Then he should be IMPEACHED, then criminally prosecuted to jail.

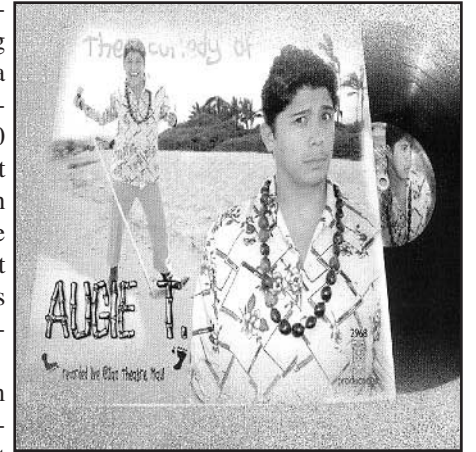

## February is Heart Month

Although heart disease and stroke account for the vast majority of deaths each year in America, there are things you can do to lessen your risk.

**Eat a healthy diet:** Healthy food habits can help you reduce three risk factors for heart attack and stroke -- high cholesterol, high blood pressure and excess body weight. *The American Heart Association Eating Plan for Healthy Americans* outlines a healthy diet. It's based on these dietary guidelines, which are easier to follow than you may think:

- Eat five or more servings per day of fruits and vegetables.
- Eat six or more servings per day of grain products, including whole grains.
- Eat fish at least twice a week, particularly fatty fish, such as mackerel, lake trout, herring, sardines, albacore tuna and salmon.
- Include fat-free and low-fat milk products, legumes, (beans), skinless poultry and lean meats.
- Choose fats and oils with 2 grams or less of saturated fat per serving ( 1 tablespoon). Examples are liquid and tub margarine, and canola, olive, corn, safflower and soybean oils.
- Limit your intake of foods high in calories or low in nutrition, including high-sugar foods like soft drinks and candy.
- Limit foods high in saturated fat, trans fat and/or cholesterol. Examples include full-fat milk products, fatty meats, tropical oils and partially hydrogenated vegetable oils. Egg yolks are high cholesterol.
- Eat less than 6 grams of salt per day. That's equal to about 1 teaspoon of salt.

Following this eating plan will help you enjoy a healthy, nutritious diet. This may help you gain such benefits as a healthy body weight, a desirable blood cholesterol level and a normal blood pressure. Every meal doesn't have to meet all the guidelines. Apply the guidelines to your overall eating pattern over at least several days.

These guidelines may do more than improve your heart health. They could also reduce your risk for type 2 diabetes, some forms of cancer and other health problems.

**Exercise every day:** Balance the number of calories you eat with those you use up each day, to maintain your best weight. Walk or do other physical activities for at least 30 minutes on most or all days. To lose weight, use up more calories than you eat every day. But before you start, check with your doctor.

**Know your blood pressure:** High blood pressure may not have any symptoms. The only way you will know if your pressure is high is to have it checked. If it is high, you may be able to reduce it with diet and exercise, but if that doesn't work, medication will likely be necessary. If you take medication, take it exactly as prescribed, not just when you feel like it.

**Stop smoking:** There are many benefits to giving up tobacco. If you or a loved one need an incentive to quit, check out some of the toxic substances in cigarette smoke: acetone, ammonia, arsenic, benzene, cadmium, carbon monoxide, DDT and formaldehyde.

### Florida Jury clears homeowner who took cop for intruder

"A little more than two years ago, Mario Barcia Jr. was awakened in the dead of night by banging on his door. Startled -- and shaken from two previous robberies -- he grabbed his gun and ran to the front of the house. Within a matter of seconds his life would change forever. Seeing what he described only as a bright light shining through his back door, Barcia fired a single shot. Five shots were returned. Then Barcia fired twice more. His first shot had hit Miami-Dade County police officer Chad Murphy in the back. Barcia was arrested and charged with attempted first-degree murder of a law enforcement officer, a crime that could have left him imprisoned for life. Murphy, wearing a flak jacket, survived with a bloody bruise. On Wednesday, it took a Miami-Dade County jury less than 30 minutes to decide Barcia did nothing wrong in shooting Murphy, who had entered Barcia's property without permission or a warrant." ## Congress extends Patriot Act Again !??

U.S. Congress sent President George W. Bush a second five-week extension of the Patriot Act, which allows federal agents to install wiretaps and conduct secret searches of homes and businesses. But, Congress also demanded an avenue of appeals when the FBI makes demands for people's financial and other private records, including banks, libraries and Internet service providers for records of their customers and clients.

## Patriot Act Creates New Federal Police !!

The "PATRIOT Act" creates a new federal police force with the power to violate the Bill of Rights. You might think that this cannot be true? Go to House Report 109-333 USA PATRIOT Improvement and Reauthorization Act of 2005 and check it out for yourself. Sec. 605 reads: "There is hereby created and established a permanent police force, to be known as the 'United States Secret Service Uniformed Division.'" This new federal police force is "subject to the supervision of the Secretary of Homeland Security."

The new police are empowered to "make arrests without warrant for any offense against the United States committed in their presence, or for any felony cognizable under the laws of the United States if they have reasonable grounds to believe that the person to be arrested has committed or is committing such felony."

The new police are assigned a variety of jurisdictions, including "an event designated under section 3056(e) of title 18 as a special event of national significance".

"A special event of national significance" is neither defined nor does it require the presence of a "protected person" such as the president in order to trigger it. Thus, the administration, and perhaps the police themselves, can place the SENS designation on any event. Once a SENS designation is placed on an event, the new federal police are empowered to keep out and arrest people at their discretion.

The language conveys enormous discretionary and arbitrary powers. What is "an offense against the United States"? What are "reasonable grounds"?

The obvious purpose of the act is to prevent demonstrations at Bush/Cheney events. However, nothing in the language limits the police powers from being used only in this way. Like every law in the U.S., this law also will be expansively interpreted and abused. It has dire implications for freedom of association and First Amendment rights. We can take for granted that the new federal police will be used to suppress dissent and to break up opposition. The Brownshirts are now arming themselves with a Gestapo.

Many naïve Americans will write to me to explain that this new provision in the reauthorization of the "PATRIOT Act" is necessary to protect the president and other high officials from terrorists or from harm at the hands of angry demonstrators: "No one else will have anything to fear." Some will accuse me of being an alarmist, and others will say that it is unpatriotic to doubt the law's good intentions.

Americans will write such nonsense despite the fact that the president and foreign dignitaries are already provided superb protection by the Secret Service. The naïve will not comprehend that the president cannot be endangered by demonstrators at SENS at which the president is not present. For many Americans, the light refuses to turn on.

In Nazi Germany, did no one but Jews have anything to fear from the Gestapo?

By Stalin's time, Lenin and Trotsky had eliminated all members of the "oppressor class," but that did not stop Stalin from sending more millions of "enemies of the people" to the Gulag prisons.

It is extremely difficult to hold even local police forces accountable. Who is going to hold accountable a federal police protected by Homeland Security and the president?
