## “Ambassador of Death” Appointed

Axis Power, the United States, Chooses Israeli National to Head Secret Police, Forces Prepare For Further Global Conquest

In the latest frightening internal move by the United States against the world, we have come to learn that President Bush has appointed the Jewish Israeli national John Negroponte to be the head of all 15 of the US intelligence organizations, and which includes the CIA.

John Negroponte is known throughout the Central American countries as the “Ambassador to Death Squads” and as we can read, “During his years in Honduras, Negroponte acquired a reputation, justified, as an old-fashioned imperialist, and devoted to Realpolitik. At the time Mr. Negroponte was in Honduras, Honduras was a military dictatorship. Kidnapping, rape, torture and executions of dissidents was rampant. The military top and middle ranks were U.S-trained at the School of the Americas (SOA), the Harvard version of the CIA, based in Fort Benning, Georgia. According to Human Rights Watch, graduates of the SOA are responsible for the worst human rights abuses and torture of dissidents in Latin America.”

Negroponte joins a parade of Bush administration senior nominees, including: Alberto Gonzales, confirmed as attorney general: the lawyer who advised the president he could ignore the US War Crimes Act and the Geneva Conventions on torture and create a “reasonable basis in law...which would provide a solid defense to any future prosecution.”

Michael Chertoff, confirmed as Secretary of Homeland Security: the lawyer who looked the other way when 762 innocent immigrants (mostly of Arab and South Asian descent) were swept up in a post-9/11 dragnet and held as “terrorism suspects” for several months. The dictates of PR trumped habeas corpus; the detentions fostered an image of quick progress in the “war on terrorism.” It is clear that Chertoff’s rapid rise to the position of Homeland Security Director is in part because of Chertoff’s willingness to help illegally, immorally and intentionally provoke and not try to stop the 1993 WTC, the 1995 OKC and 9-11 attacks. Chertoff has deliberately used these intentionally orchestrated attacks to provide the pretexts to falsely justify writing unconstitutional laws and lay the groundwork for a US police state. But his rise is also attributable to Chertoff’s willingness to do unethical political and legal favors for those who put him in his new position.

Once again the world is facing a terrifying American militaristic regime headed by cruel Jewish masters who will now control the secret polices forces for the whole country and to the citizens of this insane country there is no protest. It is too easy to say, and even still easier to believe, that the entire citizenship of this once great Nation has gone completely insane.

More Insanity: Washington Post Foreign Service that, “The United States and Japan will declare Saturday for the first time in a joint agreement that Taiwan is a mutual security concern, according to a draft of the document. Analysts called the move a demonstration of Japan’s willingness to confront the rapidly growing might of China.”

## Good News for Apiary Operators: Honey; Processed Food Exemption is in the Legislature

Description: Exempts from processed food requirements and restrictions home-based agricultural producers of honey who sell less than 50 gallons of honey, sell directly to the consumer, and label their product as home-produced and processed.

HOUSE OF REPRESENTATIVES H.B. NO. 1154 SECTION

1. Chapter 147, Hawaii Revised Statutes, is amended by adding two new sections to be appropriately designated and to read as follows:

“§147-Home-based agricultural producer of honey; exemption. A home-based agricultural producer of honey shall not be required to process honey in a certified honey house or food processing establishment, or be required to obtain a permit from the department of health, if the producer:

(1) Sells less than fifty gallons of honey a year; (2) Sells all of the honey directly to the consumer; and (3) Prints on the container in which the honey is sold:

(A) The name and address of the producer; (B) The net weight and volume of the honey, by standard measure; (C) The date the honey was produced; and (D) The statement, “This product is home-produced and processed”; provided that the statement is dominantly printed.

§147- Home-based agricultural producer of honey; inspections. If the department receives a consumer complaint about a home-based agricultural producer of honey, the producer shall be subject to food sampling and subsequent inspection of its premises if its product has been determined to be misbranded or adulterated.”

Other family caregivers and parents are looking for opportunities for preschool experiences for three and four year olds. In one place -- the Mitchell Pauole Center on Saturday, February 12, information, learning and play opportunities were available to families.

Moloka’i Keiki Expo 2005 brought together infants, toddlers, their siblings, parents, grandparents, aunts, uncles AND Molokai’s early childhood and early education service providers. Offering information for parents and activities for children, the Department of Health Public Health Nursing Branch, Molokai Family Support Center and Personal Parenting are Molokai agencies for services for infants and special needs toddlers. Queen Liliuokalani Children’s Center, MHIS: GRADS Program also offered family and parenting support for Molokai’s children and had popular activities such as kaleidoscope making, ID tags and a sample “math” lesson by the new traveling pre-school, Tutu & Me.

Kaunakakai School, Kualapu’u School and Maunaloa School PCNC and office staffs were encouraging Kindergarten Registration fun activities for keiki. Preschool scholarship assistance, Preschool applications to Punana Leo o Moloka’i and Kamehameha Preschool, as well MEO Headstart and All God’s Children Preschool were available -- all in one place at the same time. Kamehameha Schools, Big Brothers Big Sisters, the Moloka’i Community Health Center and Na Pu’uwai also provided information and activities for the whole family.

Early Childhood Educator Uncle Wayne Watkins got the entertainment off to an early start encouraging the busy Expo attendees to sing along with him, his guitar and drum. “Uncle Wayne” had spent the previous day consulting with staff at Na Kamali’i Hoaloha and Punana Leo o Moloka’i who are working toward their accreditation.

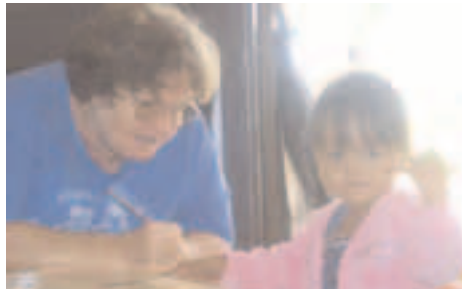

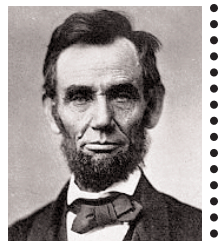
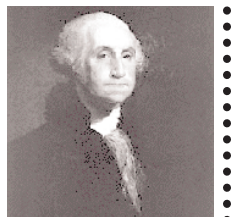

## Molokai's Forum For Freedom Individual's Sovereignty vs Slavery

**All Men are created equal, endowed by their Creator with unalienable Rights, Life, Liberty, Property Ownership. Governments in America are instituted to secure these Rights —D.O.I., 1776**

### Bill of Rights 2nd Amendment:

**“A well regulated militia being necessary to the security of a free State, the right of the people to keep and bear arms shall not be infringed.”**

**Wake up militia! Use it , or lose it ! Got your gun, yet?**

What is the remedy against judges and government executives for their intentional acts of failing to adhere to clear black letter law?

No remedies, as long as we can't enforce such remedies. Most people believe we therefore have no remedy. However, we can enforce such remedies, and it is our constitutional duty to do so, and that means militia and exercising the 2nd Amendment right to keep and bear arms against government tyranny, but to prevail, enough other citizens must support us and become active militia to protect the Constitution and the rights guaranteed therein for all of us. Ultimately, armed revolt against government traitors is what it may come to.

The 1st Amendment Right of Petition is the basis of all others. It is designed to bring government to account under the law of the land, or by force using the right to keep and bear arms recognized in the 2nd Amendment if necessary, for the violation of other rights. It is so powerful that its free use will prevent the hostilities of war between government and governed and the mere promise to respect it can restore peace to warring factions because it is the instrument of justice under law. It is intended to subject government to the compulsory process of law when government does not want to fairly redress the grievance. It is so important that "law" without it, is "law without justice," and that is another name for oppression.

The Supreme Law of the land is binding on government. If either the people or government agents do not like certain constitutional clauses the remedy is to amend the Constitution, not have judges "interpret" it contrary to its express and contextual meanings. The Constitution contains its own terms for amendment, and "judicial fiat" is not among them.

The proper remedy for changing any "Constitutional clauses" is the amendment process. But I would not characterize the Bill of Rights as mere "Constitutional clauses." Unalienable rights are endowed by our Creator, and there is no moral process by which they can be wrested from their sovereign possessors. Especially in light of the Bill of Rights Preamble, I would view any attempt to "amend" any of the unalienable individual rights that are recognized and guaranteed in the Bill of Rights to be in and of itself a act of treason.

There are Four Boxes of Freedom-only four: Soap Box, Jury Box, Ballot Box, and Cartridge Box. They are best used in that order.

The military has a bigger, more powerful Cartridge Box, but, the Armed American Citizenry has millions of smaller, lethal Cartridge Boxes, each full of mini-Tyrant Wannabee Terminators. The Armed Citizens' Cartridge Box can be used with discriminatory precision and, therefore, is a final resort solution with real power-the ability to obtain a desired result.

As governments' agents continue to abuse citizens under the color of law, with the Judiciary's approval, governments' agents create more converts receptive to the idea of going for broke to restore the Constitutional Rule of Law by manifesting a lesson in Trigonometry 101, if the Right to Petition fails to yield a satisfactory redress. In the

interim, a growing pile of layer upon layer of unredressed grievances churn, fueling a rage of anger and alienation. Increasingly, more citizens are approaching zero intolerance for a judiciary that increasingly spreads a virulent form of an unconstitutional bubonic plague: The police can do just about anything they want in the name of public necessity or expediency, and, when their victims sue or defend their rights in court, they are sucker punched and their lawsuits and claims crash into a wall of incestuous police-prosecution relationships and police, prosecutors, and judges who hide behind their immunities. Then, citizens experience a rare, epiphany moment: The Right to Petition and Immunities are mutually exclusive and legal mortal enemies. What good is the Right to Petition when the wrongdoers cannot be held to account because they enjoy incestuous relationships with others in power and all in power rebuke the petitioners and hide behind their immunities?

The Cartridge Box is sanctioned by the July 4th Declaration of Independence and the Second Amendment which empowers the people to retain the pragmatic means to preserve the security of a free state. The core idea is that government is based on the consent of the governed, and when government violates the rules and rules oppressively the People have the right and the duty to rebel.

When the judiciary fails to function as a Guardian of Liberty, what is left? For men born to liberty, the yoke—even when feather light—is never an option.

The Bill of Rights is Mankind's greatest achievement. It is the high water mark of about 8,000 years of tumultuous, gut wrenching, utterly miserable, tragic, recorded human history trying to reach a reasonable accommodation between Government and Citizens. The Constitution's bright lines are supposed to separate Government's powers from Citizens' rights. When Government usurps its powers and refuses to redress a legitimate grievance, a calm peacefulness with an oppressive government cannot endure indefinitely.

The Bill of Rights that is suppose to hold this nation together as a nation under the Constitutional Rule of Law. The Bill of Rights was suppose to end, forever, the Executive's arbitrary rule. But the Judiciary has irresponsibly allowed the Executive, via the police and the prosecution, to function as outlaws, contrary to clearly established law. None of this is hyperbole. It is, sadly, a matter of public record. Thus, the words of Algernon Sidney increasingly have sobering meaning to growing numbers who have been abused by governments' agents: "This hand, enemy to tyrants, By the sword seeks calm peacefulness with liberty."
