U.S. Supreme Court has scheduled another "conference" on a legal challenge to Barack Obama's eligibility

Do NOT AVOID Obama Eligibility Cases

In a stunning move, the U.S. Supreme Court has scheduled a "conference" on a legal challenge to Barack Obama's eligibility to occupy the Oval Office.

Court officials have confirmed that a petition for rehearing in the case brought by attorney John Hemenway on behalf of retired Col. Gregory Hollister has been distributed among the justices, and it will be the subject of a conference on March 4.



Hemenway had submitted a motion for Justices Sonia Sotomayor [photo right] and Elena Kagan [photo left], who were given their jobs by Obama, to recuse, i.e., exclude themselves.

The Supreme Court acknowledged the "motion for recusal" but the Clerk changed it on official docketing pages to a "request," and then reportedly failed to respond to the motion as required by law. [Crooked judicial officers do these obstruction of justice to block legal challenges.]

Hemenway then submitted a request for a rehearing, pointing out that the situation appeared to be violating the rules of the U.S. Supreme Court, and that if justices continue to "avoid" the dispute they effectively will "destroy the constitutional rule of law basis of our legal system."

"We have not exaggerated in presenting the question of the constitutional rule of law being at stake in this matter," Hemenway wrote in a petition for rehearing before the high court. "A man has successfully run for the office of president and has done so, it appears, with an awareness that he is not eligible under the constitutional requirement for a person to be president," he referred to Barack H. Obama who has spent upwards of \$2-million dollars to hide his I.D. from legal challenges based on his being born in Kenya, father not US citizen.

"Despite a vigorous campaign that he [Obama] has conducted to make 'unthinkable' the very idea of raising the issue of his eligibility under the Constitution to be president, the issue has not gone away," Hemenway said.

"Instead it has steadily grown in the awareness of the public. Should we be surprised that [Obama] shows no respect for the constitutional rule of law? What else would we expect?" he wrote.

Hemenway also challenges the justices: He asks whether the justices still are committed to the principle of considering the Founders' intent when ruling on constitutional issues.

Hemenway, who is representing retired Col. Gregory Hollister, alleges Obama never was eligible under the Constitution's requirements for a president to occupy the Oval Office.

Hemenway wrote: "To continue to avoid the issue will destroy the constitutional rule of law basis of our legal system when it is under vigorous assault as surely as if the conscious decision were made to cease preserving and protecting our founding charter."

That the justices are "avoiding" the Obama issue already has been confirmed by one member of the court. It was last year when Justice Clarence Thomas appeared before a U.S. House subcommittee that the issue arose.

"I'm still waiting for the [court decision] on whether or not a Puerto Rican can run for president of the United States," said Serrano, who was born in PR.

Thomas said that Serrano would be better off seeking a seat in the Supreme Court than a chair in the Oval Office. ".....you don't have to be born in the United States," said Thomas, referring to the Constitution, which requires the president to be a natural born citizen but has no such clause for a Supreme Court justice.


"Oh really?" asked Serrano. "So you haven't answered the one about whether I can serve as president, but you answer this one?"

"We're evading that one," answered Thomas, referring to questions of presidential eligibility such as the instant Obama case of ineligibility birth in Kenya.

Hemenway's arguments come in the petition for rehearing that follows the decision last month by the court not to hear the arguments. However, he pointed out in the petition for rehearing that the U.S. Supreme Court appears to have broken its own rules in his case by failing to respond to a pending recusal motion. That circumstance is enough, he argues, for another hearing to be held on the case, and this time without participation by the two justices appointed to

the U.S. Supreme Court by Obama, because, clearly Obama's appointees would have a personal interest in the dispute if Obama was found to be ineligible and his actions, including his appointments, void.

Hemenway submitted such a motion, but since the motion never was given a response, it should be acted on as if it were granted by the court, the petition for rehearing argues. The document prepared for the Supreme Court clearly stated "Motion for Recusal of Justices Sotomayor and Kagan," and a second time, "Petitioners' Motion to Recuse."

"Petitioners would request the court to rehear their petition and in doing so to consider the consequences of their motion for recusal of December 30, 2010 being treated as conceded because it was not opposed in a timely fashion under the rules of this court," said the document, submitted to the court yesterday and expected to be docketed today.

"Rule 21 (4) of the court requires that any motion shall have an opposition to it filed, if one is to be filed, 'as promptly as possible considering the nature of the relief sought ... and, in any event, within 10 days of receipt.' Thus by January 14, 2011, when petitioners' petition was denied without comment, the respondents had failed to respond to the motion," Hemenway wrote.

"Therefore, as a matter of due process of the court, petitioners suggest that the court should have on that day considered the possibility that the motion had been conceded by respondents with an examination of the consequences of that failure," the brief explains.

The brief further argues that because of the lack of a response or acknowledgment by the court, the court should have considered "the law of nations on matters of citizenship such as the phrase in question here as placed in Article II, Section 1, Clause 5, namely, the requirement that a president 'be' a 'natural born citizen.' Thus, it would seem, with all due respect, that if the court is required to and does treat the petitioners' motion for recusal as conceded the court would be required to consider the intent of the Framers of the Constitution in choosing the Article II phrase 'natural born citizen.' That is, of course, assuming that the majority of its members still believe that the intent of the Framers is essential to the constitutional rule of law in this country."

A court spokeswoman declined to respond to the inquiries about the procedures regarding recusal of justices who have a personal stake in such cases -- what ethical guidelines are used by the court to determine those cases and whether there was a violation of the court rules in the case.

If Obama is not constitutionally eligible, the crisis is acknowledged.

"If proven true, those allegations mean that every command by the respondent Barack Obama and indeed every appointment, including the appointment of members [Elena Kagan and Sonia Sotomayor] of this and every other court, may be only de facto but not de jure [by right of law]," stated the pleading.

"Further, his signature on every law passed while he occupies the Oval Office is not valid if he is not constitutionally eligible to occupy that office de jure. Thus, it is not hyperbole to state that the entire rule of law based on the Constitution is at issue. Moreover, it would indicate that the respondent Obama ran for the office of president knowing that his eligibility was at the very least in question," it continued.

The order on Jan. 18 from the high court simply listed case 10-678, Hollister, Gregory S. v. Soetoro, Barry, et al as "denied".

It appears from the court's documentation that Kagan and Sotomayor participated unlawfully in this Supreme Court "conference" about this case.

Two officers from the Transportation Security Administration were arrested Wednesday, accused of stealing \$40,000 in cash from a checked bag at John F. Kennedy Airport, the Queens District Attorney's Office said.

On January 30, the men, identified as Persad Coumar and Davon Webb, allegedly discovered a bag containing \$170,000 using an X-ray machine and removed some of the money inside, the district attorney said.

According to a TSA official, the two men were reported by a fellow TSA employee, prompting an investigation.

The homes of the two men were searched by Port Authority police and all but \$20 was recovered, the district attorney's office said.

The two TSA employees are awaiting arraignment on charges of third-degree grand larceny, fifth-degree conspiracy, third-degree criminal possession of stolen property and official misconduct, according to the district attorney's office. The charges carry a penalty of up to seven years in prison.

The woman who checked the bag boarded the plane and is now in Argentina wondering where her money went.

This incident comes in the wake of 12 previously reported TSA thefts involving checked baggage, X-Rays, over the past three years, according to the TSA.

Paper Dollar Is Money? Not!

We do not fully know what makes some societies more affluent than others; however, we can make some guesses based on correlations. Rank countries according to their economic systems. Conceptually, we could arrange them from those more capitalistic (having a large market sector and private property rights) to the more socialistic (with extensive state intervention, planning and weak private property rights). Then consult Amnesty International's ranking of countries according to human rights abuses going from those with the greatest human rights protections to those with the least. Then get World Bank income statistics and rank countries from highest to lowest per capita income.

Those three lists demonstrate a very strong correlation: Those countries with greater economic liberty and private property rights tend also to have stronger protections of human rights. And as an important side benefit of that greater economic liberty and human rights protections, their people are wealthier.

We need to persuade our fellow man around the globe that liberty is a necessary ingredient for prosperity.

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!



Global Elite Picked Obama Long Before Voters

Man recounts startling tale of first time he heard of Barack Obama—18 years ago in Russia

During the period of roughly February 1992 to mid-1994, I was making frequent trips to Moscow in the process of starting a software development, joint-venture company with some people from the Russian scientific community. One of the men in charge on the Russian side was named V. M.; he had a wife named T.M. V. was a level-headed scientist, while his wife was rather deeply committed to the losing communist cause.

Early in 1992, the American half of our venture was invited to V. & T.'s Moscow flat as we were about to return to the States. As the evening wore on, T. developed a decidedly rough anti-American edge—one her husband tried to quietly rein in.

The bottom line of the tirade she started against the United States went something like this: "You Americans always like to think that you have the perfect government and your people are always so perfect. Well then, why haven't you had a woman president by now?"



You had a chance to vote for a woman vice president and you didn't do it."

The general response went along the lines that you don't vote for someone just because of their sex. Besides, you don't vote for vice president, but the president and vice president as a ticket.

"Well, I think you are going to be surprised when you get a black president very soon," she said. The consensus we expressed was that we didn't think there was anything innately barring that. The right person at the right time and sure, America would try to vote for the right person, be he or she, black or not.

"What if I told you that you will have a black president very soon and he will be a communist?" she said. "Well, you will; and he will be a communist."

One of us asked, "It sounds like you know something we don't know."

"Yes, it is true," she replied. "This is not some idle talk. He is already born, and he is educated and being groomed to be president right now. You will be impressed to know that he has gone to the best schools

He is what you call 'Ivy League.' You don't believe me, but he is real and I even know his name. His name is Barack. His mother is white and American and his father is black from Africa. That's right, a chocolate baby! And he's going to be president."

She became more and more smug as she presented her stream of detailed knowledge and predictions so matter-of-factly—as though all were foregone conclusions. "It's all been thought out. His father is not an American black, so he won't have that social slave stigma. He is intelligent and he is half white and has been raised from the cradle to be an atheist and a communist. He's gone to the finest schools. He is being guided every step of the way and he will be irresistible to America."

She was obviously happy that the communists were doing this and that it would somehow be a thumbing of their collective noses at America: They would give us a black president and he'd be a communist to boot. She made it obvious that she thought that this was going to breathe new life into world communism. She always asserted that communism was far from dead.

She was full of details about him that she was eager to relate. She rattled off a complete litany. He was from Hawaii. He went to school in California. He lived in Chicago. He was soon to be elected to the legislature. "Have no doubt: he is one of us, a Soviet."

Since I had dabbled in languages, I knew a smattering of Arabic. I commented: "If I remember correctly, 'Barack' comes from the Arabic word for 'blessing.' That seems to be an odd name for an American." She replied quickly, "Yes. It is 'African,'" she insisted, "and he will be a blessing for world communism. We will regain our strength and become the No. 1 power in the world."

She said something to the effect that America was at the same time the great hope and the great obstacle for communism. America would have to be converted to communism, and Barack was going to pave the way.

So, what does this conversation from 1992 prove?

Well, it's definitely anecdotal. It doesn't prove that Obama has had Soviet communist training nor that he was groomed to be the first black American president, but it does show one thing that I think is important. It shows that Soviet Russian communists knew of Barack from a very early date. It also shows that they truly believed among themselves that he was raised and groomed communist to pave the way for their future. This report on Barack came personally to me from one of them long before America knew he existed.

Although I had never before heard of him, at the time of this conversation Obama was 30-plus years old and was obviously tested enough that he was their anticipated rising star. ★



FBI- tracking Your cell phone ~!

Obama's FBI and other police agencies don't need to obtain a search warrant to learn the locations of Americans' cell phones, says Obama's Department of Justice attorneys who told that to a federal appeals court.

Obama's DOJ attorney Mark Eckenwiler said There "is no constitutional bar" to acquiring "routine business records held by a communications service provider." He added, "The government is not required to use a warrant when it uses a tracking device."

This is the first federal appeals court to address warrantless location tracking, which raises issues of government surveillance and whether Americans have a reasonable expectation of privacy and their location.

Location data can reveal whether people "have been at a protest, or at a meeting, or at a political meeting" and that rogue governments could misuse

that information to arrest people.

Police are tapping into the locations of mobile phones thousands of times a year, but the legal ground rules remain unclear—that is if they ignore the 4th Amendment on privacy.

When the government acquires historical cell location information, it effectively commandeers our cell phones and turns them into electronic trackers that report, without our knowledge or consent, where we have been and how long we have spent there.


Cellphone tracking! Armed Drone planes to kill suspects.....makaala!!!

The Bureau of Alcohol, Tobacco, Firearms and Explosives is asking the court for an order divulging historical (meaning stored, not future) phone location information because a set of suspects "use their wireless telephones to arrange meetings and transactions in furtherance of their drug trafficking activities." It's unclear how detailed this stored information is; there's some evidence that the FBI can use it to narrow down the location to a city block but perhaps not an individual house.

The Obama regime argues that no search warrant is necessary; it says what's needed is only a court order, which requires law enforcement to show that the records are "relevant and material to an ongoing criminal investigation." Because that standard is easier to meet than that of a search warrant, it is less privacy-protective.

Cell phone tracking comes in two forms: police obtaining retrospective historical data kept by mobile providers for their own billing purposes that is typically not very detailed, or prospective tracking--that reveals the minute-by-minute location of a handset or mobile device.

Tracking cell phones can be useful for law enforcement. Agents from the Drug Enforcement Administration in Arizona tracked a tractor trailer with a drug shipment through a GPS-equipped Nextel phone owned by the suspect. Texas DEA agents have used cell site information in real time to locate a Chrysler 300M driving from Rio Grande City to a ranch about 50 miles away. Verizon Wireless and T-Mobile logs showing the location of mobile phones at the time calls were placed became evidence in a Los Angeles murder trial.


