St. Sophia Church Burns in Mysterious Kaunakakai Fire

Last week Wednesday night, a blaze that gutted Saint Sophia Church in Kaunakakai light up the night sky and left the Catholic church in ruins.

"Over the phone, they said the structure is still standing, but the whole inside was gutted," Kino said. Firefighters got the call at 10:40 p.m. and had the blaze under control by 11:15 p.m., Kino said.

Saint Sophia is the largest of four Catholic churches on Molokai's "topside" which is all the island excluding the Kalaupapa Peninsula, said Patrick Downes, spokesman for the Diocese of Honolulu. [The church was built in 1937 and although old is not considered a historic structure.] "It's an old parish church like many we have in the Islands," Downes said.

The Blessed Damien Catholic Parish had planned to teardown the church to make way for a new, larger church later this year.

Downes said he doesn't know the value of the church's contents, but that the relic of St. Damien that toured Hawaii after his canonization is safe at the Cathedral of Our Lady of Peace in Honolulu.

STATEN ISLAND, NY 4th grade student Patrick Timoney brought a gun to school Tuesday and nearly got suspended for it. Sounds reasonable until you see the gun – a two-inch LEGO toy gun.

Crimes of Politicians Must Be Stopped by The People (You are The Militia)







Protesting Torture and CIA on Campus at UH

Protest at the University of HI Challenges Police State "Intelligence" Community Centers of Academic Excellence & CIA Campus Recruitment

Hawaii activists protested on February 10, 2010, the University of Hawaii's participation with U.S. intelligence agencies in a symposium on national security and called on students and faculty to remember the criminal track record of these agencies in torture, assassination, kidnapping and illegal prisons.

Protesters called on the University administration to reject any request by the federal government to create a National Intelligence Center of Academic Excellence (ICCAE, pronounced "icky") at the University of Hawaii.

Government intelligence agencies, including the CIA, FBI, National Security Agency, Defense Intelligence Agency, and Homeland Security, have created [1] in the past four years twenty-two Intelligence Community Centers for Academic Excellence on university campuses to provide "systematic long-term programs at universities and colleges to recruit and hire eligible talent for [intelligence community] agencies and components" and to "increase the [intelligence recruiting] pipeline of students."

However, not only do the centers recruit, but they seem to provide a launching pad for undercover operations for those associated with the university centers. Stan Dei, the Assistant Director at the Intelligence Community Center for Academic Excellence at Trinity University in Washington, DC, was arrested in January, 2010 with three others for plotting to tamper with the telephone system in the New Orleans office of U.S. Senator from Louisiana Mary Landrieu.

According to an article on Raw Story titled "Landrieu phone plot: Men arrested have links to intelligence community," Dai also was an undergraduate fellow at the Foundation for the Defense of the Democracies (FDD), a national security think tank in Washington, DC with conservative political figures and politicians, among them: former House speaker Newt Gingrich, Sen. Joe Lieberman, editor William Kristol, Rep. Eric Cantor, former Bush official Richard Perle and columnist Charles Krauthammer on its advisory board.

The two day symposium on national security at the University of Hawaii is billed as a "discussion on the role of language and contemporary issues in Asia and in U.S. security issues with networking sessions for students to interact with Intelligence Community personnel and meet with potential employers."

FOOD and GIFTS for Attendance at the conference was increased by providing students with breakfast and lunch each day and a gift card.

Asian and Pacific heritage students are the predominant groups at the University of Hawaii and undoubted the reason for the visit by Dr. Lenora Gant, the Director of all of the Intelligence Community Centers of Excellence. The symposium is co-hosted by the School of Pacific and Asian Studies with faculty members from the East-West Center, which is funded by the U.S. Department of State, and other University of Hawaii faculty members making presentations on language, cultural awareness and cyber challenges in national security along with presentations on "The 21st Century Intelligence Community Enterprise: Challenges and Opportunities" by CIA and other intelligence officials.

GRANT MONEY \$\$: ICCAEs provide grants to universities to begin a "partnership between the Intelligence Community, colleges and universities to incorporate curriculum and related initiatives. The focus of this effort is to increase the pipeline of competitive applicants to attract, recruit and hire with an emphasis on women and racial/ethnic minorities with critical skills in core business and leadership areas."

Once the Intelligence Centers are established on a campus, they use federal funds to provide a cash-strapped university with attractive facilities. At Norfolk State University, a new Video Teleconferencing Training Center was funded through grants from the Office of the Director for National Intelligence (ODNI) and Department of Education.





Outside the School of Korean Studies, the location for the symposium, long-time Hawaii activist Carolyn Hadfield, a coordinator for World Can't Wait and staff member of Revolution Bookstore, reminded students and faculty going into the building that the CIA and other intelligence agencies had asked their employees to commit illegal actions on behalf of the presidential administrations -- crimes of torture, assassination, kidnapping (extraordinary rendition), secret prisons and illegal eavesdropping and wiretapping.

Did they want to be employed by organizations that participate in these criminal actions?

Hadfield also reminded University of Hawaii Chancellor Virginia Hinshaw as she emerged from the conference hall, of the to keep the University system out of the unpopular, but financially lucrative for the university, Department of Defense classified research business University Affiliated Research Center (UARC). Hadfield told the University Chancellor that should they be considering bringing an Intelligence Community Center of Excellence to University of Hawaii, the university administration would face another battle.

Save AKAKU-TV, AGAIN Not only are there several bills in the Hawaii Legislature this session that

Not only are there several bills in the Hawaii Legislature this session that would restrict the sunshine laws, but it seems the attack on public access television continues unabated with a bill that will shred the funding for public access.

Last month the City and County of Honolulu approved a franchise agreement with Oceanic Cable that reportedly will result in service cuts:

It was reported on Friday the 29th of January, in the Pacific Business News, that the new franchise agreement between the The City and County of Honolulu and Oceanic Time Warner Cable "will force more service cuts" for Olelo. Olelo is Oahu's public access service provider. The new Oceanic Time Warner Franchise contract will force more service cuts for Olelo.

At the state level, if HB2902 passes into law, the public's access to TV channels and facilities for making programs to present will be shredded. The state will be diverting 2/3 into the government sector. Bye Bye AKAKU.

Here is part of a statement circulated by long-time defender of public access TV and CEO of Akaku: Maui Community Television, Jay April:

Splitting the PEG [Public, Education, Government] money will effectively destroy successful PEG access on the neighbor islands by diverting 2/3 funds to the state sector which cannot and does not operate with the same mission: "Empowering our Community's Voice through Access to Media" The emphasis in the current model is on OUR COMMUNITY as in Community Access.

Conspiracy theorists may wonder if this is some insidious plot to reduce the public's access to information while corporations run wild with unlimited "free speech" thanks to the Supreme Court. Ok, I wonder that myself.

Legislature Considering A Great bill: Getting government records cheaply, needs YOUR testimony in support

HB2231 - Clarifies cost of reproducing government records from not less than five cents per page to not more than ten cents per page. Contrast that with the \$1 per page MPD charges for copy of public records!

What a great bill for improving transparency. Prevent state agencies like MPD and courts from soaking people who request records from them. This limits what they can charge per page to one thin dime.

I just found out about this one today (Tuesday). It's not a very sexy bill, so no one is out there sign waving about it. If you would dash off some testimony, it would be really great! It's easier than ever to do this session.

Just go to http://capitol.hawaii.gov/emailtestimony/ this page, put in the bill number, HB2231, and you can send your testimony right from the web page (write something first—make sure to say you support HB2231).

The bill is being heard Wednesday at 2 p.m., and since you're probably reading this on Wednesday, please send something right away, no matter how short. The bill gets only this one hearing in the House, so each testimony is important. Too little and it won't pass, so please send something. And thanks! (you'll be saving a lot when you request and have to pay for government records!)
