Arizona and at least nine other states are developing plans that would plug the hole in federal election procedures that in 2008 allowed Barack Obama to be nominated, elected and inaugurated without providing proof of his qualification as a Natural Born American Citizen required by the Constitution.

In Georgia, for example, HB37 by Rep. Bobby Franklin not only demands original birth-certificate documentation, one of the documents Obama has refused to be publicly disclosed, it provides a procedure for and declares that citizens have "standing" to challenge the documentation.

Franklin told WND the least that leaders of the United States, on a state or federal level, can do is to follow the requirements of the law of the land.

His plan, he said, is needed because he saw "requirements in the Constitution that you don't have a code provision to ensure that it happens."

"If we as an entity of civil government don't follow the laws, then what makes us think that our citizens are going to obey anything we enact?" he said. "We need to lead by example."

According to officials with the National Conference of State Legislatures, 10 states already have some sort of eligibility-proof requirement plan.

There is Arizona's HB2544, Connecticut's SB391, Georgia's HB37, Indiana's SB114, Maine's LD34, Missouri's HB283, Montana's HB205, Nebraska's LB654, Oklahoma's SB91, SB384 and SB540, and Texas; HB295 and HB529.

There have been dozens of lawsuits and challenges over the fact that Obama's "natural born citizen" status never has been documented. The "certification of live birth" his campaign posted online is a document that Hawaii has made available even to those children NOT born in the state.

The requirement Obama fails is from the Constitution, Article 2, Section 1, which states, "No Person except a natural born Citizen, or a Citizen of the United States, at the time of the Adoption of this Constitution, shall be eligible to the Office of President."

The challenges to Obama's eligibility allege he does not qualify because he was not born in Hawaii in 1961 as he claims, or that he fails to qualify because he was a dual citizen, through his father, of the U.S. and the United Kingdom's Kenyan territory when he was born and the framers of the Constitution specifically excluded dual citizens from eligibility.

Obama's autobiography book Dreams of My Father makes it clear in Obama's own words as the author where he admits that his father was not an American Citizen, but a foreign student at University of Hawaii.

Governor Neil Abercrombie committed a notable gaff last month when

he proposed to release Obama birth records only to learn, as most Hawaii residents already knew, that state law prohibits what he had in mind. This led to a widely quoted and later retracted report by radio personality Mike Evans: Evans went on to tell KQRS that he talked "with Neil's office, Neil says that he's searched everywhere using his power as governor" at the two hospitals Obama was likely born at in 1961 - Kapiolani Medical Center [photo below] and Queens Medical Center - only to come up empty. Obama's Bankers' Foreclose On Hawaii Homes; Legislature Proposes Moratorium

Obama has left Hawaii homeowners to the mercy of Bankers Mortgage Sharks. Yes, Obama claims he was born in Hawaii, but refuses to show a valid birth certificate and his buddy Abercrombie now governor can't find it either, but it doesn't matter because Obama left Hawaii decades ago to make Mainland his home.

Since then, Obama has looked after bankers making extreme and obscene profits according to Disappeared News reporter Larry Geller, in 2010, total compensation and benefits at publicly traded Wall Street banks and securities firms hit a record of \$135 billion, according to an analysis by The Wall Street Journal. The total is up 5.7% from \$128 billion in combined compensation and benefits by the same companies in 2009...while the average American has been left swinging in the wind. No place is this more clear than in Hawaii, where foreclosures have run rampant. Hawaii has one of the worst foreclosure rates in the country. In January, mortgage fraud was cited as the reason why the state's foreclosure rate is the 11th highest in the nation.

Hawaii house advances Mortgage Foreclosure Moratorium bill, by Rep. Herkes with a proposed 5-month mortgage moratorium on non-judicial foreclosures. He related the story of a family that fell behind in payments briefly, but who then arranged with the bank to come current, and was in fact doing that. Nevertheless, and unexpectedly, they were foreclosed and lost their home to Obama's banker buddies.

Banks are profiting from the profound suffering of average Hawaii citizens. Stopping predatory non-judicial foreclosures is a good first step to protect families.

Rep. Herkes wants a moratorium while the Legislature figures out what to do. The bill number is HB894 and passed both the Consumer Protection and Judiciary committees today. If passed on the House floor, it goes to the Senate.

This bill should not have been necessary, had Obama kept his promise to the American People: Before he took office, Obama repeatedly promised voters and Democrats in Congress that he'd fight for changes to bankruptcy laws to help homeowners—a tough approach that would force banks to modify mortgages.

"I will change our bankruptcy laws to make it easier for families to stay in their homes," Obama told supporters at a Colorado rally on September 16, 2008, the same day Obama bailed out of AIG.

Bankruptcy judges have long been barred from lowering mortgage payments on primary residences, though they could do it with nearly all other types of debt, even mortgages on vacation homes. Obama promised to change that, describing it as exactly "the kind of out-of-touch Washington loophole that makes no sense."

But when it came time to fight for the measure, Obama didn't show up. Some Democrats now say his administration actually undermined it behind the scenes.

Egypt Protestors Want Freedom from their President What America needs is an Egyptian-style grass-root revolution to remove Obama and Zionist Cohorts from our country!

Demonstrations in Egypt defied the curfew with a seventh straight day of protests and announced they were arranging a "million man" march in protest of President Mubarak's government.

Egyptian protesters - who included young and old, Christians and Muslims, students, workers and businesspeople - said they were angry over the cost of living, failed economic policies and corruption. They demanded that President Hosni Mubarak immediately leave the country.

"We breathe corruption in the air," said one demonstrator.

El Baradei, a Nobel laureate, arrived in the country and said the protests were growing because Egyptians "realize the regime is not listening, not acting." He said he would participate in the protests and urged the demonstrators and the government to keep standoffs peaceful. He also said Mubarak should stop detaining and torturing people. "The barrier of fear is broken," he said after arriving from Europe, "and it will not come back."

Ahmed, the protester, said Egypt wants democracy, after the American model, and he was disappointed by the United States' President's reaction to the protests and its support for Mubarak.

"We can't understand how come Obama this leader of the free world is looking the other way when it comes to our rights or freedom," he said. "The despotic regime of President Mubarak that (the U.S.) supports with \$-Billions and military guns and teargas to use against us always demonizes the image of United States ... always putting blame on the United States for everything."

Barack Obama and his national security establishment may be willing to give up Mubarak the person, but they are not willing to give up Mubarak's regime. N.Y. Times reported, the Obama has already managed to persuade the United Kingdom and Germany to back continuing the existing regime with only a change of figurehead. It is notable that the Obama has never supported the Egyptian protestors' demand that Mubarak must go now. Nor has the Obama suspended its \$1.5 billion annual aid package to Egypt, much of which goes to the state security forces oppressing protestors and beating up and arresting journalists.

Mubarak and his chief Omar Suleiman enforced Egypt's regional role in maintaining the American- and Israeli-dominated order, and played a key role in the US "rendition" program, working closely with the CIA which kidnapped "terror suspects" from around the world and delivered them into Suleiman's hands for interrogation, and almost certainly torture.

Jews fear Egypt's current turmoil, and heap high praise for Suleiman's torture for intelligence work with Israeli military brass. Israeli General Amos Gilad: "I always believed in the abilities of the Egyptian Intelligence service."

Suleiman's sinister strategy with Obama quiet on the sidelines and behind the scenes, is to try to ride out the protests and wear out and split the opposition, consolidate the regime under police state's ruthless grip with the backing of the Egyptian army, and then enact cosmetic "reforms" to keep the Egyptian people politically divided and busy while corruption and brutality carries on as usual. Under any Suleiman "transition" political activists, journalists and anyone suspected of being part of the current uprising would be in grave danger.

Responding to Mubarak's announcement that he will not run for re election and would appoint new officials in the meantime, El Baradei told Al-Jazeera news reporters that Egyptians wanted a regime change, not new personnel. "The Egyptian people are saying one thing: President Hosni Mubarak must leave. We have to move towards a democratic state."

The Gun Grabbers are Using Tucson Shooting Against 2A

Since the Tucson tragedy, anti-gun Senator Frank Lautenberg has been hovering like a vulture, waiting to pick the bones of the victims for political advantage. Now he has his chance by adding amendments to the unrelated Federal Aviation Administration (FAA) reauthorization bill consisting of a series of gun control proposals.

Democratic leaders like Senator Richard Durbin are threatening to offer anti-gun amendments, and pro-gun Senators like Tom Coburn are considering amendments to protect gun rights.

There are three amendments which Lautenberg and Representative Carolyn McCarthy have been nursing since Tucson. The first would limit semi-automatic magazines to 10 rounds, in a reprise of the Clinton ban. The second would effectively shut down all gun shows. It would do this by sending any gun show promoter to prison for up to two years if a SINGLE attendee were not informed of his Brady Law obligations. No one would dare sponsor a gun show under these circumstances. The third anti-gun amendment would allow the Obama administration to seize guns from anyone they choose to place on a "watch list." Millions and millions of pro-gun supporters could find their names on an ObamaList with no due process -- and no way to get their names removed. Please note that this administration has already advised law enforcement to treat supporters of the Constitution and gun rights as possible domestic terrorists!

ACTION: Contact your two senators. Ask them to support any pro-gun amendments, and definitely insist they vote against the Lautenberg/Durbin amendments to ban semi-automatic magazines, shut down gun shows, and create a "no guns list" of Second Amendment activists.

1. THAT he is demanding redress of grievance in accordance with the Constitution for the United States of America pursuant to Article III under the judicial power vested in one supreme Court and such inferior tribunals ordained and established by the congress of the United States of America.
2. THAT he has a right to commence a civil action for deprivation of rights under 28 U.S.C. § 1343 in the United States District Court.
3. THAT he is denied and obstructed from enforcing his rights as United States Citizen pursuant to 28 U.S.C. § 1443 in the current municipal chancery Maui 2nd Circuit Court where the case is pending without the consent of George Gary Peabody.
4. THAT for cause shown in accordance with 28 U.S.C. § 1446 the persons operating the state enterprise under color of law are enjoined from proceeding with the execution of judgments or relief against George Gary Peabody.
5. THAT the record of judicial proceedings may be transmitted to the office of the United States District Court with regards to 28 U.S.C. § 1449 or remain in situ for special session of United States Court under 28 U.S.C. § 141 and 28 U.S.C. § 462.

THEREFORE it is the order of this court that jurisdiction is transferred to United States District Court, Hawaii, for the constitutional conduct of his tribunal in republican form and for all other relief as the protection of the law allows.
