Federal Subsidy Schools Open for Draft? No Child Left Unrecruited in Police State!

Should the military be given the names of every high school student in America?

Sharon Shea-Keneally, principal of Mount Anthony Union High School in Bennington, Vermont, was shocked when she received a letter in May from military recruiters demanding a list of all her students, including names, addresses, and phone numbers. The school invites recruiters to participate in career days and job fairs, but like most school districts, it keeps student information strictly confidential. "We don't give out a list of names of our kids to anybody," says Shea-Keneally, "not to colleges, churches, employers -- nobody."

But when Shea-Keneally insisted on an explanation, she was in for an even bigger surprise: The recruiters cited the No Child Left Behind Act, President Bush's sweeping new education law passed earlier this year. There, buried deep within the law's 670 pages, is a provision requiring public secondary schools to provide military recruiters not only with access to facilities, but also with contact information for every student -- or face a cutoff of all federal aid. Schools that do not comply with 9528 of the ESEA could jeopardize their receipt of ESEA funds.

Text of the No Child Left Behind Act's military recruitment provision can be found in 9528 (page 559-560) of the No Child Left Behind Act of 2001:

Question: What are the requirements of 9528 of the ESEA?

A. Each LEA that receives funds under the ESEA must comply with a request by a military recruiter or an institution of higher education for secondary students' names, addresses, and telephone numbers, unless a parent has "opted out" of providing such information.

A notification must advise the parents of how to opt out of the public, nonconsensual disclosure of directory information and the method and timeline within which to do so. Schools that do not comply with 9528 of the ESEA could jeopardize their receipt of ESEA funds.

In addition to the potential for loss of funds under ESEA noted above, an LEA that denies a military recruiter access to the requested information on students after July 1, 2002, will be subject to specific interventions under 10 U.S.C. 503: a senior military officer (e.g., Colonel or Navy Captain) visit the LEA within 120 days. If the access problem is not resolved with the LEA, the Department of Defense must notify the State Governor within 60 days. Problems still unresolved after one year are reported to Congress if the Secretary of Defense determines that the LEA denies recruiting access to at least two of the armed forces (Army, Navy, Marine Corps, etc.). The expectation is that public officials will work with the LEA to resolve the problem.

Additionally, the Department of Defense has developed a national high school data base to document recruiter access. Presently, 95 percent of the nation's 22,000 secondary schools provide a degree of access to military recruiters that is consistent with current law. President Bush Calls for Huge Funding Increase for IRS Enforcement

"Enforcement more than pays for itself," IRS Commissioner Mark W. Everson similarly said. "Particularly in a period of deficit reduction, funding IRS enforcement is a wise investment."

Bush and Congress just don't get it about freedom and taxation: Wages are not taxable income; IRS cannot tax a man's right to work. Wake up America! Makaala!

New Federal Taxes Planned!

Unless The People Rise Up, Here's What's Coming: Slavery by Federal Consumption Taxes, PLUS The IRS!

Presidents Bush's Advisory Panel on Federal Tax Reform held their first public meeting in Washington on Wednesday last week, and recommendations for new taxes are expected this July. The panel's discussion focused extensively on the rapidly growing federal revenue requirements and tax enforcement against The People.

NO discussion took place regarding the impacts of the panel's recommendations on the protection of the rights of People or the Constitutional limitations that explicitly limit the taxing authority of Congress. And furthermore, the 16th and 17th amendments were never ratified: The 16th amendment established the INCOME TAX; The 17th amendment authorized the popular election of Senators

If the projections depicted by the panel for greatly increased federal revenue taxes are passed by Congress and the President, the People of America will soon experience a new, and never-before-seen condition of economic slavery, openly achieved through the tax "laws" of this nation in disregard of the Constitution. The Panel appears headed toward a recommendation that the IRS income tax be made more efficient, in terms of enforcement, but that a federal consumption tax, like those already in place on gasoline, pack of cigarettes and booze, be added to most of the other goods and services that individuals and corporations routinely purchase.

Unless The People Rise Up! No answers, No taxes! Lock & Load!

Although the panel's work has allegedly only begun, it is likely, based on the positions and information offered at this meeting, that the future life for Americans appears to now include not only taxes on wages and salaries, but NEW federal consumption taxes on the products that are purchased with what remains of their paychecks, in order to fund the desires of those at the public trough.

One panel member, Elizabeth Garrett, a professor at the University of Southern California, while commenting on the fact that corporate income taxes have dropped to about 10% of federal revenues said, "That's good. Let's not tax the corporations, let's tax the workers who get their money from the corporations."

WTP Chairman Bob Schulz, who attended the 3-hour session, reports that the Panel appears headed toward a recommendation that the current income tax be made more efficient, in terms of enforcement, but that a federal consumption tax, like those already in place on gasoline, cigarettes and booze, be added to most of the other goods and services that individuals routinely purchase.

Some of the Q&A focused on existing and anticipated problems associated with compliance and enforcement of the existing income tax and a broader based consumption tax.

On Monday, February 14, 2005, three days before the panel meeting, each member of the Panel received written input from the We The People Foundation for Constitutional Education, including a request for answers to 43 specific questions regarding the constitutional and statutory authority behind the current direct, non-apportioned tax on labor. The Foundation advised the Panel members that there can be no meaningful reform until the government answers those fundamental questions. They Followed the Trade Winds African Americans in Hawai'i

Social Process in Hawai'i Volume 43



For more than 50 years, *Social Process in Hawai'i* has been a forum for the social dynamics that occur among people living in Hawai'i. University of Hawai'i Sociology professors Romanzo C. Adams and Andrew W. Lind viewed race relations as a key factor in building a successful story in Hawai'i. *Social Process in Hawai'i* Executive Editor Kiyoshi Ikeda introduces this newest volume as a continuation of the work of Adams and Lind.

Ikeda says in the Forward, "The story of the Black presence in Hawai'i has been sorrowfully neglected in the written social history of Hawai'i. Yet, there has been a presence since the 1790s. Miles M. Jackson and his colleagues have made a giant step in collaborating on *They Followed the Trade Winds*."

Chapters about the early Black men and women who immigrated to Hawai'i in the 19th century included Anthony D. Allen, a refugee from slavery, Carlotta Stewart Lai, an African American Teacher in the Territory of Hawai'i, a chapter about the "Cabo Verde, Africa and Hawaii" connection, Alice Augusta Ball, credited with the development of the early Chaulmoogra Leprosy Cure, and the members of the All-Black 25th Regiment, give a fascinating picture of the lives of early Black settlers and their contributions to their adopted home woven into the history of their time.

"Law and African Americans in Hawai'i" summarizes the importance of African Americans in the political, civil rights and law community of Hawai'i. Given some of the recent events in local schools, Kimetta R. Hairston's chapter on "Transitioning to Paradise -- A Challenging Journey: African American Military Experiences in Hawaii's Public Schools," tells the newcomers' perspective about racial relations and the public schools. Also bringing the African American experience to the present is a conversation about "Labels: A Kanaka Maoli Perspective on the black Presence in Hawai'i" between Marsha Rose Joyner and Poka Laenui (Hayden Burgess). *They Followed the Trade Winds African Americans in Hawai'i*, is an important document about the African American history in Hawai'i. "Multicultural-Multiracial Society or a Fragile Myth?" is surely to be of interest to readers of all ethnic groups. The Panel members were respectfully asked to let the Foundation know if they intended to answer the questions.

With placard in hand, Bob arrived outside the main entrance of the Reagan Building at 8:30 am. Bob and his sign were on hand for the duration of the meeting. No representative from the Panel approached Bob to let him know whether the Panel intended to answer the Foundation's questions. "More revenue is urgently needed by the self-anointed ruling class of intellectual, political and financial elite to support a behemoth, out of control central government with its addiction to money, power, control and social engineering here at home and imperialism abroad," said Schulz. "Unless the working men and women of America find their voice in the next few months and take serious offense over the government's breach of our most fundamental legal and moral codes, the yoke of involuntary servitude will be tightened."

The next public meeting of the tax advisory panel is scheduled for March 3, 2005 in Washington. The should be forced by The People to fully discuss and publish conclusive answers to all of the questions posed by We The People, and other questions regarding claims that 16th and 17th Amendments were never ratified.

Bill Benson is a former revenue collector for the State of Illinois. Back in 1984, Benson was commissioned to conduct an investigation into the ratification of the Sixteenth Amendment to the U.S. Constitution. Benson traveled to all 48 states which had been admitted to the Union at the time of the ratification of this amendment in 1913. He spent close to a year in the bowels of these state archives collecting official documents. What Benson found according to legal researchers was nothing short of a bombshell: Not only was the Sixteenth Amendment - the so-called "income tax amendment" never ratified by the required number of states Benson published a two part volume on the Sixteenth Amendment, 'The Law That Never Was'. He also published another work titled, 'Proof the Seventeenth Amendment was Never Ratified'. Over the past twenty years as a result of Benson's battle to expose the alleged fraud which occurred on these two amendments, Benson has refused to voluntarily file or pay income taxes. While he did spend time in prison, his fiercely fought battles against the government are legendary.

NWVs has now learned that the federal government has once again gone after Benson to, in his own words, "Shut down the truth from the American people." According to Benson in a telephone interview, "The government is calling my documents a theory! Can you imagine that? I have 17,000 documents that we call court certified and the government refers to them as a theory!"

Benson indeed has the 17,000 hard documents he maintains prove his allegations that both the Sixteenth and Seventeenth Amendments were never ratified. One of the most intriguing parts of this filing is that Benson's counsel, Jeffrey A. Dickstein, appears to be turning the table on the government and putting them in a position where in order to prevail, the government must prove the Sixteenth Amendment was ratified - something Benson steadfastly claims they cannot do and states he has the documents to prove it. According to Benson's latest filing:

"As previously discussed, the United States can not prevail as a matter of law unless it can prove Benson "made or caused to be made false or fraudulent statements concerning the tax benefits to be derived from the entity, plan or arrangement" and that "he knew or had reason to know the statements were false or fraudulent." This requires the United States to prove the Sixteenth Amendment was properly ratified, because if it were not properly ratified, Benson's statements would not be false or fraudulent, they would be true, and the United States' action would fail."

On June 21, 2001, Phil Hart, who is now a member of the Idaho State Legislature, filed a Petition for Writ of Certiorari with the United States Supreme Court on this very issue. The court refused to hear his case.

The government has maintained for decades that the Sixteenth Amendment was ratified, it is the legal basis for the income tax and call any arguments to the contrary "frivolous."

The Prosecution of Non-Withholding Business Owner Dick Simkanin endured three grand juries, two trials and a previously suspended federal judge who:

- 1) Denied him the right to present ANY documentary evidence at his trial
- 2) Never forced the DOJ to aver, for the record, ANY specific law that imposed a legal duty to file or withhold taxes from his workers, and
- 3) Directed the jury to find him guilty.

Treasury Department, the IRS and DOJ have been ignoring the Supreme Court and congressional mandates since the Brushaber decision in 1916 in order to perpetuate the "income" tax fraud..... irrefutable evidence in support of the People's proposition that the Executive has been deliberately and fraudulently taxing the People in a way that violates the fundamental law and Supreme Court rulings. The Executive is clearly prohibited from doing what it is doing - taxing the salaries, wages and compensation of the working men and women of this country and forcing the business entities that utilize the labor of ordinary American citizens to withhold and turn over to the IRS a part of the earnings of those workers.

The income tax laws of the U.S. do not apply to ordinary Americans.

Central to this research are new revelations about revisions that were made to the Income Tax Law immediately following the January, 1916 Supreme Court Brushaber decision.

According to the report, in 1913, just months after the purported ratification of the 16th Amendment, Congress attempted to stretch the meaning of the legal term "income" beyond the meaning and intent of the framers of the 16th Amendment, as recorded in EVERY official and professional document of the era: congressional record, congressional reports, law reviews, journals of political science, newspapers of record and so forth.

In the Income Tax Act of 1913, Congress surreptitiously, by stealth and without authority, included an un-apportioned, direct tax on the salaries, wages and compensation of ordinary Americans and instituted withholding at the source.

However, in 1916, the Supreme Court brought the devilish action of Congress and the Executive branch to a screeching halt. The Supreme Court ruled in Brushaber (and the cases bundled with it), that wages are NOT income within the meaning of the 16th Amendment.


