



U.S. In Deep Denial as REVOLUTIONS Against Tyrants Explode in Middle East by Oppressed People Seeking Freedom

Statist Unions' Demands Unrealistic

As the U.S. and the whole World reels under economic turmoil caused by ObamaNation's corruption of the US Dollar as World Reserve Currency, in Wisconsin, there is no revolution, its a "statist uprising"[photo top] -- unions and the Obama political machine helping to push government-dependent citizens into a frenzy to demand that their government benefits not be cut in any way.

Obama-Media is calling it a "Mutiny In America" and NBC's Brian Williams proclaims that citizens are "rising up and saying no to some of the most extreme cuts in the nation," such B.S. is giving new meaning to word hyperbole.

Extreme "Cuts"? We're talking about asking government workers to pay some of their pension plans and an increase from 6% to just 12% in their health insurance costs -- all in an effort to avoid massive layoffs.

In Hawaii, the former Jewish governor Linda "Super Ferry" Lingle's employees claim they are still owed back pay of about \$247,000 after ripping off local Taxpayers for more than \$40-million and making War on local protestors. Lingle et al are lucky to still be out of prison and don't deserve the money Hawaii legislators just approved in new governor Aberblabbercommie's budget.

Still, there is NO REVOLUTION in HAWAII demanding ouster and prosecution of Criminals in High Offices violating Constitutionally defined limits on government powers?? In November, voters sent a clear and revolutionary mandate to lawmakers to dramatically cut the budgets to sustainable levels. We should learn from brave examples of REVOLUTION ongoing now by people who do know how to fight for freedom because they have suffered brutality and oppression for too long.

January 14, a Tunisian fruit vendor struck a match that started a fire that has spread throughout the much of North Africa and the Middle East. Muhammad Bouazizi's self-immolation prompted anti-government protests that toppled regimes in Tunisia and Egypt.

Wherever you go in post-revolt Tunisia, you see people demonstrating – at the airport, in front of the post office, schools, ministries, factories: simply everywhere. After three decades of silence, self-censorship and repression there is an explosion of revolt from all sectors, against all those associated with dictator Ben Ali's rule – political figures, directors of state and private companies, senior civil servants, top security officials – generating a climate of perpetual tension and discontent in a society haunted by the prospect of a return to tyranny. The peaceful nature of this continuous protest movement has ensured that the country remains relatively stable, government in republican form.

Look at Egypt's revolution at Tahrir [Liberty] Square, Egyptians demanding end to 30 years of corruption and brutal oppression [photo 3 left]. millions who have filled Tahrir Square for over two weeks are unlikely to consider their mission accomplished with Mubarak's departure. The forces unleashed by revolution will not fade into the background overnight – but are set to occupy the centre stage of politics in Egypt, as in Tunisia, for the foreseeable future. What is under way are revolutions originating from society's depths: political earthquakes that will transform the entire region. What we are witnessing is nothing short of the birth of the new Middle East.

The tiny but strategically critical country of Bahrain is an American ally and houses the headquarters of the U.S. Navy's Fifth Fleet where Sheikh Isa Qassim described the police and military actions in Manama early Thursday as a "massacre" aimed at quashing free expression. He asked, "Why have you killed the innocent souls?"

The King's security police are largely non-Bahraini. They are recruited from Pakistan, Yemen, Syria and Jordan. Fast-tracked to citizenship and given preferential treatment, they are infuriating protesters. "Some of [the security police] don't even speak Arabic. They have no respect for the people. They have no loyalty to the flag. Their only loyalty is to their paymasters."

Protesters were asking for economic and political reforms, but their demands have changed as King Hamad's foreign mercenaries stepped up force against the people. Now many of them say they want the regime brought down and parliament dissolved. At the funeral of one of the protesters the crowd chanted "death to Khalifa," a reference to King Hamad bin Isa Al Khalifa.

"Human Rights Watch said the nation's king, as commander of the Bahraini Defense Forces, "should immediately order an end to attacks on peaceful protesters." It said the United States, the United Kingdom should suspend military assistance. "The Bahraini army has opened fire on its own people."

Citizens of Panama, Libya, Yemen, Iran, Iraq, Jordan, Kuwait are in revolt to establish their freedom from Tyrants. These people will save themselves!



Obama Agencies Put Price on Your Life?

The beauty of our Constitutionally limited republican form of government is that it begins, not with government, but with us: "We the People." In our Declaration of Independence from Britain, there is a clause that sets us apart from virtually all other nations. Instead of receiving our basic rights, such as the right to life, from a king or despot -- as was the case in older cultures and too many modern ones -- America's Founders saw basic rights emanating from "our Creator" and thus, outside the reach of government and bureaucratic tampering.

But, ObamaSocialists don't give a damn about God given Fundamental Rights of American Citizens being protected by the limitations imposed on government powers by our Constitution for the United States of America!

Various government agencies have come up with formulas for determining how much we are worth. The Environmental Protection Agency (EPA) has set the value of a human life at \$9.1 million. It reached this determination while proposing tighter restrictions on air pollution. During the Bush administration, EPA calculated our value at \$6.8 million. Was the difference in price caused by inflation? The EPA didn't say.

The Food and Drug Administration (FDA) arrived at its own figure for the value of an American life. It says each life is worth \$7.9 million. That, too, is an increase from the \$5 million value FDA had assigned each human American life in 2008. The agency calculated our value while proposing new and tougher warning labels on cigarettes that include pictures of cancer victims.

The Transportation Department -- yes, Transportation -- put our worth at \$6 million while seeking to justify recent decisions to impose regulations the Bush administration had rejected as too costly, such as stronger roofs on cars.

It's nice to know that our government values its citizens beyond what it can extract in taxes. But given the Obama administration's likely pursuit of health care rationing (Dr. Donald Berwick, a wealth redistributionist who heads the Centers for Medicare and Medicaid Services, is a proponent of rationed care) it is easy to forecast where this could lead should human life be regarded as having only that value placed upon it by government, or an agent of the state.

Where could a formula for a governmental valuation of human life lead? If government gets to determine our worth, it could lead to government determining when in its judgment we are worthless. It could lead to government deciding that when we are costing the state more than we are paying in taxes, we might be seen as a bottle, package or can, whose "sell by" date has expired. And that would mean the government could regard us as disposable and allow -- or force us -- to "expire."

Too extreme? "It couldn't happen here," you say? All great horrors begin at the extremes and work their way into the mainstream because of moral weakness or exhaustion, or self-regard, or the rejection of (or ambivalence about) certain fundamental truths. Such neglectfulness paves the way for the great inhumanities, which today are studied in schools. They wonder, "how it could have happened" and "why didn't anyone see this coming?"

How and why, indeed? Consider yourself warned. Makaala, Hawaii !

Hawaii Senator Slom Says Obama's Records Go Public

Hawaii's Senate minority leader is accusing Gov. Neil Abercrombie [aka Aberblabbercommie] of politicizing the state's health department by firing his nominee to replace Chiyome Fukino, a woman best known to the nation as Barack Obama's fraudulent Hawaii birth certificate guardian.

Sen. Sam Slom, the sole Republican in Hawaii's upper house, is denouncing Abercrombie's handling of the nomination of Dr. Neal Palafox to be the successor to Fukino as director of the state's health department. He said he is convinced Abercrombie asked Dr. Palafox to withdraw his nomination because the nominee fired two Hawaii health department employees who were politically connected.

"Palafox was determined to clean up the Hawaii Department of Health and he ran afoul of politics when the people he fired sought retribution," Slom told WND.

"I have known Abercrombie for 50 years, back to when we were both undergraduate students at the University of Hawaii," Slom said. "Abercrombie was pro-communist and I was pro-American."

But Slom adds he would be happy to use the Palafox case if it would permit him to open up to the public any birth records the Hawaii health department has, if any, that evidence Obama was born at Kapi'olani Medical Center as Obama and his supporters have repeatedly claimed without presenting evidence.

"I don't understand why Obama has spent hundreds of thousands of dollars to keep all his records from the public — not just his Hawaii birth records, but his passport records and his school records. All Obama's records should be public, including any Hawaii birth records that exist," said Slom.

Obama's Gun Control via ObamaCARE doomed?

What does the I.R.S and ObamaCARE have to do with gun rights? Read this and take action to shut down gun grabbers and the IRS and the ATF !

Last Friday, Feb. 18, the US House added defunding of the anti-gun ObamaCare law onto the "continuing resolution," which is required to fund the federal government through September 30.

House approved:

* to defund IRS implementation of the ObamaCARE "individual mandate," which forces Americans to provide their medical information which could later be used by the FBI to block gun purchases;

* to defund ATF's efforts to create a new gun registry for gun sales;

* amendments to defund ObamaCare for the next six months.

Gun Owners of America contacted every member of the House of Representatives prior to the vote on the Boren-Rehberg amendment. This is an important provision that will stop the ATF's attempts to illegally register gun owners. ATF has been trying to require licensed firearms dealers to report the sale of two or more semi-automatic rifles that are .22 caliber or greater, that can accept a detachable magazine.

This is all GREAT NEWS: The House's actions last week put us in a position where 41 senators can force Democrats to either:

1. Defund the anti-gun ObamaCare, plus ATF's unlawful gun registry; or
2. Shut down the non-essential functions of the Obama administration, including ATF and IRS.

Shutting down the ATF would represent a boon for gun owners' rights. (<<http://gunowners.org/projectgunrunner.htm>>Click here to see GOA's report on the most recent egregious abuse by the ATF.)

The fight to defang the ATF -- and to repeal ObamaCare -- are two top priorities at Gun Owners of America.

Given that there are 47 Republicans in the Senate -- and 51 senators who purport to oppose ObamaCare's mandate that you buy insurance you don't want -- you would think that defunding ObamaCare and the ATF would be an imminently winnable fight, right? 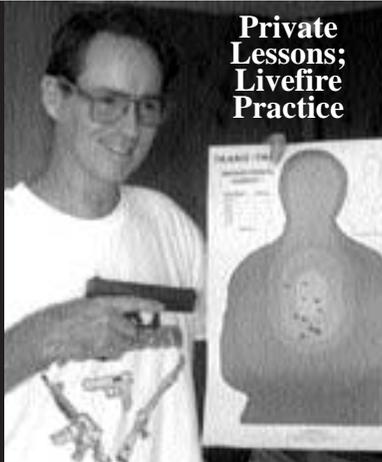

The goal of the founders of America was to restrict government within severe limits and to protect the rights of sovereign individuals. Government has NO rights!

Immigration Reform Needed Immediately, Wake UP!

And now right here in the U.S., state capitals are erupting in rancorous divisions over how to deal with huge budget shortfalls.

The poorly educated immigrant households are costing taxpayers \$87 billion a year. Note that some of these poorly educated immigrants are legal, some illegal -- but they're all a social burden.

\$87 Billion adds up to a TRILLION dollars every 12 years.

NumbersUSA is fighting the things that lead to the above situation by sup-

porting a slew of excellent bills just introduced in Congress:

The bill we are most enthusiastically promoting would get rid of the noxious "family chain migration," which allows legal immigrants who may themselves be well educated to sponsor uneducated and poor distant relatives.

Rep. John Carter (R-TX) has just introduced a bi-partisan bill to make all U.S. businesses use the E-Verify web tool for all its employees. As you'll recall, E-Verify accurately and easily discovers if someone is legally allowed to work in the U.S.

And wouldn't this be wonderful! The new Birthright Citizenship Act of 2011 requires at least one parent to be a legal resident or citizen before their child automatically becomes a citizen (putting us in line with most other nations).

We also are enthusiastically backing a new bill that would end the ludicrous "visa lottery" program, where tens of thousands of precious permanent visas to the United States are given away, literally, at random, and for no apparent reason.

You see, if we drop the number of immigrants, and crack down on the hiring of illegal aliens, we'll save billions in social costs. What are we waiting for? Why would anyone but Obama-socialists oppose these measures? (Maybe its for votes, cheap labor, new church members, future voters, etc.)

Obama's Connection to Terrorist Dictator Gadhafi of Libya

Obama has multiple close ties to activists who have had relationships with Gadhafi. Jeremiah Wright, pastor of Obama's longtime Chicago church, went with Farrakhan to visit Gadhafi in 1984.

During the 2008 presidential campaign, Wright himself noted the trip could cause problems for Obama. "When [Obama's] enemies find out that in 1984 I went to Tripoli to visit [Gadhafi] with Farrakhan, a lot of his Jewish support will dry up quicker than a snowball in hell."

Farrakhan, a close friend and associate of Wright, has been financed by Gadhafi, including with a \$5 million interest-free loan in 1985.

Later that year, Gadhafi spoke by satellite to Farrakhan's Saviour's Day Convention in Chicago, and reportedly told Farrakhan supporters he was prepared to provide weapons to a black army in the U.S. to destroy "white America."

Obama tied to Nation of Islam

Wright and Obama reportedly attended the Million Man March on Washington, which was led by Farrakhan and other prominent black leaders such as Al Sharpton. During the period of Obama's attendance at Wright's Trinity United Church, which practices controversial Black Liberation Theology ideology, the Chicago church was openly allied with Farrakhan and the Nation of Islam.

Obama has appeared at least three times on the cover of Trumpet magazine, founded by Wright. The magazine, to which Obama last year granted a lengthy, exclusive interview, regularly hails Farrakhan.

Obama's face was featured on the cover of a 2006 issue of Trumpet alongside Farrakhan's image. During the 2008 presidential campaign, a photo emerged of Obama's wife, Michelle, posing with Farrakhan and Obama adviser Barrow at a woman's luncheon.

Another Obama connection to supporters of Farrakhan comes from David Axelrod, Obama's chief political strategist. Although he is Jewish, Axelrod sits on the finance committee of St. Sabina, the Chicago Catholic parish that was led by controversial pastor Michael Pflieger, an outspoken Farrakhan supporter who hosted the Nation of Islam chief at his parish several times.

As pressure mounts on the White House to intervene to stop Moammar Gadhafi's bloody crackdown in Libya, many commentators have been wondering why Barack Obama has been cautious in his criticism of the dictator after Obama so fervently supported the removal from office of Hosni Mubarak of Egypt.

Plus! In **2006**, then Sen. Barack Obama had this to say the debt crisis facing the nation: "The fact we are here today to debate raising America's debt limit is a sign of leadership failure. ... Washington is shifting the burden of bad choices today onto the backs of our children and grandchildren."

Today, Obama is making that same choice - fighting tooth and nail to persuade Republicans in the House to **raise the debt limit above \$14.3 trillion**.
